Post-16 Education: Learner participation and outcomes in England 2007/08

- 1 This Statistical First Release (SFR) provides final 2006/07 and provisional 2007/08 estimates of Learning and Skills Council (LSC) funded participation and achievement for post-16 education¹ (excluding schools and Higher Education²) in England. It also includes an early look at 2008/09 apprenticeship and Train to Gain participation.
- 2 This SFR contains information that may provide an early indication of progress against key government targets.

Young People (aged 16-18)

Participation

- 3 In 2007/08, 1,026,500 learners aged 16 to 18 participated in LSC-funded learning (excluding schools and Higher Education). This represents a 2.3 per cent increase from 2006/07. An additional 26,000 LSC-funded under 16 year olds participated in the FE system in 2007/08. Of these 16 to 18 year olds [Table 1]:
 - 356,400 enrolled on full level 3 programmes (up 3.8 per cent from 2006/07)
 - 298,000 enrolled on full level 2 programmes (up 0.4 per cent from 2006/07).

¹ Post-16 education includes provision delivered in FE organisations, sixth form colleges, independent training organisations, local authorities and other providers. This includes programmes such as apprenticeships and Train to Gain. Data regarding schools is not included in this publication.

² Data for all Higher Education organisations, including those that deliver FE provision, is not included unless a provider has submitted an FE individualised learner record return.

4 Of these learners [Table 3]:

- 659,400 attended FE organisations (up 3.3 per cent from 2006/07)
- 146,500 attended sixth form colleges (up 0.5 per cent from 2006/07)
- 220,600 attended other organisations (up 0.6 per cent from 2006/07).

5 107,000 16 to 18 year olds started an apprenticeship framework in 2007/08. This is an increase of 1.9 per cent from 2006/07. An additional 500 under 16 year olds started apprenticeship frameworks in 2007/08 [Table 8].

6 Provisional data³ shows a decrease for 16-18 apprenticeship starts in the first quarter of 2008/09. These provisional data for 2008/09 are likely to increase by around 5 per cent due to the time lag in providers sending data returns to the LSC. 45,700 16 to 18 year olds have started apprenticeships during this period [Table 8]:

- 32,800 started level 2 apprenticeships (down 17.3 per cent from the same period in 2007)
- 12,900 started advanced apprenticeships (down 12.7 per cent from the same period in 2007).

Achievement

7 Provisional data⁴ for 2007/08 as at the end of November show that [Table 4]:

- 135,000 young people achieved full level 2 qualifications in 2007/08. This is an increase of 2.7 per cent from 2006/07
- 158,300 young people achieved full level 3 qualifications in 2007/08. This is an increase of 7.2 per cent from 2006/07.

8 63,000 16-18 year olds successfully completed an apprenticeship framework in 2007/08. This is a decrease of 3.4 per cent from 2006/07. A further 300 under 16 year olds also successfully completed apprenticeship frameworks [Table 9].

Adults aged 19 and over

Participation

9 90,100 19 to 24 year olds started an apprenticeship framework in 2007/08. This is an increase of 14.6 per cent from 2006/07. A further 27,200 25 year olds and over started apprenticeship frameworks, up from 300 the previous year [Table 8].

10 Provisional data for 2008/09⁵ show that between August and October 2008, 27,600 adults aged 19 to 24 started apprenticeships. These provisional data for 2008/09 are likely to increase by around 5 per cent due to the time lag in providers sending data returns to the LSC. This is 3.7 per cent lower than for the same period last year. 16,800 adults aged 25 and over have also started apprenticeships. [Table 8]

- 11 Provisional data⁶ show that the number of Train to Gain (TTG) starts rose to a new high in 2007/08 of 331,800. This is an increase of over 60 per cent from 2006/07 [Table 10].
- 12 Provisional data⁵ shows that between August and October 2008, there were 165,500 TTG starts compared with 67,600 between August and October 2007. Part of this would be attributable to the transfer of NVQs to TTG which were previously part of adult learner responsive. For this period, an initial estimate of the number of NVQs is approximately 60,000 based on the annual total for 2007/08.
- 13 In 2007/08, 3,095,400 learners aged 19 and over participated in LSC-funded learning (excluding Higher Education). This represents a 2.7 per cent decrease from 2006/07 [Table 1]. Of these:
- 317,500 enrolled on full level 3 programmes (up 18.5 per cent from 2006/07)
 - 614,700 enrolled on full level 2 programmes (up 23.7 per cent from 2006/07)
 - 667,800 enrolled on Skills for Life programmes (up 5.5 per cent from 2006/07).

Achievement

- 14 Provisional data⁶ as at the end of November show that 299,000 adults achieved full level 2 qualifications in the 2007/08 academic year, up 44.6 per cent from 2006/07 [Table 6].
- 15 Provisional data⁶ as at the end of November show that 127,900 adults achieved full level 3 qualifications in the 2007/08 academic year, up 14.2 per cent from 2006/07 [Table 6].
- 16 Provisional data⁶ as at the end of November show that 541,500 adults⁷ contributed to the 2010 Skills for Life target in 2007/08, giving a cumulative total of 2,807,600 adults since 2000/01. Of these 42,000 achieved entry level numeracy and 215,100 achieved level 1 literacy [Table 7].
- 17 48,100 19-24 year olds successfully completed an apprenticeship framework in 2007/08. This is an increase of 4.7 per cent from 2006/07. A further 1,200 25 year olds also and over successfully completed apprenticeship frameworks [Table 9].
- 18 Provisional data⁶ show that 169,200 19 year olds and over achieved TTG qualifications in 2007/08. This is an increase of 91.6 per cent from 2006/07⁸ [Table 11].

All Ages (16+)

Participation

- 19 The volume of apprenticeship starts (224,800) in 2007/08 was the highest level ever recorded. This is an increase of 21.9 per cent from 2006/07 [Table 8].
- 20 Following the Leitch review of skills, the government set a Public Service Agreement (PSA) target to increase the number of apprenticeship completions (all ages, 16

plus) to 130,000 by 2010/11. In 2007/08, 112,600 people successfully completed apprenticeship frameworks, up 0.7 per cent from 2006/07 [Table 9].

Success Rates

21 The 2007-08 LSC grant letter, published in October 2006, set the LSC a target apprenticeship framework completion rate of 59 per cent for the 2007/08 academic year and the 2008-09 LSC grant letter, published in November 2007, set an apprenticeship framework completion rate target of 65 per cent in 2008/09. Apprenticeship completion rates for 2007/08 were 63.7 per cent. This is a 4.9 percentage point increase from 2006/07 [Table 2].

SUPPORTING DATA

22 Additional data will be published by 9 January 2009 on the Data Service website. These data are for 2005/06 onwards to show breakdowns by age, gender, ethnicity, learners with learning difficulties and/ or disabilities, region, local authority and organisation type. Data by mode of attendance will also be available for FE provision.

FUTURE STATISTICAL FIRST RELEASES

24 In September 2007, PricewaterhouseCoopers was commissioned by the Department for Innovation Universities and Skills (DIUS) and Department for Children Schools and Families (DCSF) to review ten Statistical First Releases (SFRs) relating to post-16 learning. To address the issues, the review made 24 recommendations for changes to the suite of post-16 SFRs aimed at improving the way statistics relating to post-16 learning are presented, including the publication of quarterly SFRs.

25 It is hoped that this SFR product will continue to improve, and readers are encouraged to comment on the content. They can do this by contacting the Service Desk. Contact details can be found on the cover sheet.

26 The next SFR in this series will be published in March 2009, followed by additional SFRs in June and October 2009. The March SFR will contain final FE participation and achievement data for 2007/08, as well as updated 2008/09 data. It is also due to include schools data.

27 The SFR publication dates have been established for key points in the annual LSC business cycle. The December SFR provides a near-final view of sector participation and achievement, as well as final information for apprenticeships and Train to Gain. The March SFR provides final participation data, as well as final achievement data and a robust view of in-year participation. The June SFR provides an updated view of in-year participation, and the October SFR will provide a first view of full-year participation.

28 In addition to these SFRs, new statistical volumes are due to be published. The content of these is yet to be determined.

NOTES TO EDITORS

32 This SFR provides provisional 2007/08 estimates of participation and achievement for LSC-funded⁹ post-16 education (excluding Higher Education) in England. It also includes provisional participation for the first quarter of 2008/09 for apprenticeships and Train to Gain.

33 The statistics for 2005/06, 2006/07 and 2007/08 reflect the FE and skills system before the introduction of demand-led funding. The volumes shown in this publication will therefore differ from those in publications such as the LSC *Statement of Priorities* for 2009/10, which views the FE and skills system following the introduction of demand-led funding.

34 Information from the different post-16 learning options have been drawn together to give a coherent and comprehensive picture of the participation and achievement of young people and adults after the age of 16. These include:

- FE organisations
- Sixth form colleges
- Local Authorities
- Independent training organisations.

35 These organisations deliver a wide variety of government programmes, including:

- Classroom-based Learning
- Work-based Learning (including Apprenticeships)
- Train to Gain (TTG)
- Adult Safeguarded Learning (ASL).

36 This document contains information that can inform progress against key government PSA targets and commitments made in public documents such as the LSC grant letter.

37 This SFR does not contain information regarding:

- European Social Fund (ESF) provision
- Delivery in School Sixth Forms
- Higher education
- Privately-funded training at FE organisations/ independent training organisations.

38 We would expect this SFR product to develop over time to incorporate these areas, and also report on other areas of interest, for example the Third Sector.

Revisions

39 It has been necessary to revise the SFR as published on 18 December. The revisions made for data relating to 2006/7 and 2007/8 are to correct an inconsistency in the methodology used in breakdowns for the category "Below Level 2 (excluding Skills for Life)" as presented in tables 1 and 3 to 6. This change leads to a downward revision for this category but does not affect the total learner numbers."

PSA Targets

Young People's Participation

40 The LSC has a milestone on the way to all young people participating to 17 by 2013 and to 18 by 2015 that by 2010/11 86 per cent of 17 year olds will be participating in education and work-based learning. As at end 2007, 78.7 per cent of 16-18 year olds were in education and training, the highest ever rate.

41 Official progress against this target is published each June in Participation in Education, Training and Employment by 16-18 Year Olds in England by the Department for Children, Schools and Families at <http://www.dcsf.gov.uk/rsgateway/>

Young People's Attainment

42 The Government set a target to increase the proportion of 19 year olds who achieve at least level 2 by three percentage points between 2004 and 2006, and a further two percentage points between 2006 and 2008, and increase the proportion of young people who achieve level 3. The latest update shows that the first stage of this target was achieved and a baseline for the 2008 target set at 71.4 per cent. As at end 2007, 73.9 per cent of 19 year olds had achieved at least level 2.

43 By 2010/11, 82 per cent of young people should achieve level 2 by the age of 19 and 54 per cent of young people should achieve level 3 by the age of 19. As at end 2007, 48.0 per cent were qualified to at least level 3.

44 Official progress against this target is published each February in Level 2 and 3 Attainment by Young People in England Measured Using Matched Administrative Data: Attainment by Age 19 in 2007 (Provisional) by DCSF at <http://www.dcsf.gov.uk/rsgateway/>

Adult Participation

45 The Government makes a substantial investment in adult skills, focusing on the development of a world class workforce. This includes helping the disadvantaged and low skilled to achieve the training they need for employability and further progression. Particular importance is attached to pre-level 2 learning, and it is expected that there will be a significant increase in the number of adults participating in and achieving a first level 1 literacy or entry level 3 numeracy qualification. Further progress must also be made in supporting adults to achieve a first full level 2 or level 3 qualification.

Adult Attainment

46 There are adult PSA Targets referring to two distinct cohorts:

1) To reduce by at least 40 per cent the number of adults in the workforce who lack level 2 or equivalent qualifications between 2001 and 2010; working towards this, one million adults in the workforce to achieve level 2 between 2003 and 2006. This requires an additional 3.6 million adults in the workforce to be qualified to level 2 or higher by 2010.

2) To raise levels of attainment for men aged 19 to 64 and women aged 19 to 59 so that:

- i) 79 per cent are qualified to at least level 2 by quarter 4 by 2011
- ii) 56 per cent are qualified to at least level 3 by quarter 4 by 2011
- iii) 36 per cent are qualified to level 4 and above by quarter 4 by 2014 with an interim milestone of 34 per cent by quarter 4 2011.

47 In addition, the Leitch Review of skills recommended that the Government set a target of 95% of adults to achieve the basic skills of functional literacy and numeracy by 2020. In 2004 the Government set a PSA target to improve the basic skills of 2.25 million working-age adults (19 and over and 16-19 and not in full-time education) between 2001 and 2010 with a milestone of 1.5 million adults in 2007.

Metrics

49 The metrics used in this SFR are outlined below.

Metric	Definition
Starts	<p>The number of qualifications/ programmes that have begun in a given time period, usually monthly, quarterly or annually. A start is assigned to the month/ quarter/ year that it begun and is only counted once. However, a learner undertaking more than one qualification will be counted for each qualification/ programme. For example, a learner starting a level 2 apprenticeship and then transferring to a level 3 apprenticeship will be counted as two starts.</p> <p>This measure is helpful in determining the take-up of programmes, and is a key performance measure for apprenticeships and Train to Gain.</p>
Learner Numbers	<p>The number of people who are undertaking learning in a given time period, usually annually, or on a fixed date.</p> <p>This measure is helpful for quantifying the number of people that have participated in a given time period, and where a fixed date is used, can</p>

	<p>give an estimate of the percentage of people engaged in learning. Learner numbers in an academic year is historically a key performance indicator for FE colleges.</p>
Completions	<p>Although a learner may complete and not achieve, the term 'completions' refers to learning activities that have been successfully achieved and where appropriate, the certification obtained.</p> <p>A successful apprenticeship 'framework completion' requires all elements of the framework to be completed.</p> <p>This measure is helpful as it shows the number of people achieving qualifications in the sector. It is therefore a good indicator of progress against key government targets aimed at improving the skills levels of the nation. This measure is also a key performance measure for apprenticeships and Train to Gain.</p>
FE Success Rates	<p>The cohort used to calculate FE success rates is based upon the academic year the qualification aim is planned to finish in.</p> <p>The success rate is calculated as the number of learning aims achieved divided by the number of starters, excluding any learners who transferred onto another qualification. Where a learner does transfer to a new qualification they are treated as a start on the new qualification and not the old one. As success rates are calculated at a qualification aim level, learners with more than one qualification aim will be included more than once. Learners who leave their programmes within six weeks of starting are excluded from the calculation.</p> <p>This measure is a key performance indicator and used as part of the OFSTED inspection framework and the Framework for Excellence. It is also used by the LSC in monitoring underperformance of providers.</p>
Apprenticeship Framework Completion Rates	<p>The cohort used to calculate apprenticeship framework completion rates is marginally different from that used for FE. For a given year, the cohort includes all frameworks (i.e. the combined grouping of qualifications and not each individual qualification aim) whose planned end date is during the reporting year which were achieved on or before that planned end date, plus any programmes that went beyond the planned end date and were either achieved or withdrawn from (i.e. are not still in progress) in the reporting year.</p> <p>Where a learner transfers to another framework, they are treated as a start on the new qualification and not the old one. Learners who leave their programmes within six weeks of starting are excluded from the calculations. Learners who leave programmes to take up alternative employment are classified as not having achieved.</p> <p>This measure is a key performance indicator and used as part of the OFSTED inspection framework and the Framework for Excellence. It is also used by the LSC in monitoring underperformance of providers.</p>
Apprenticeship Framework Completion Rates (Old Methodology)	<p>This old measure of apprenticeship success is no longer the prevalent performance measure and is no longer included in this SFR.</p> <p>The old measure of apprenticeship framework completion rates is the number of frameworks (i.e. the combined grouping of qualifications and not each individual qualification aim) successfully completed in a given reporting year divided by the number of learners who have either left training or successfully completed their programme. Learners who have transferred to another programme are excluded until they complete their programme or leave learning.</p>

Data Definitions

50 Detailed data definitions are available in a supplementary document, *DS/SFR1 Data Definitions*, which will be published on the Data Service website.

51 Data published in this document will be categorised as either 'provisional', 'revised' or 'final'. Provisional data will be updated in future documents. It is worth noting that the methodologies used to calculate success rates will not provide final data for a number of years due to learners completing after their expected completion date. This means that figures are revised annually. We will therefore only publish success rates in the latter half of each year when success rate data are less volatile.

Further Education	Further Education refers to post-16 education that is primarily taught in Further Education organisations (see later definition). This includes General FE and Tertiary Colleges, Sixth Form Colleges and Specialist Colleges. For the purposes of this SFR it includes a small element of FE provision delivered in HE organisations where HE organisations have submitted ILR data.
Work-based Learning	Work-based learning includes apprenticeships and Entry to Employment.
Apprenticeships	<p>Apprenticeships are a key work-based route for young people and adults. An Apprenticeship is not a qualification in itself, but it contains the following separately certified elements.</p> <ul style="list-style-type: none"> • A knowledge-based element (the theoretical knowledge underpinning a job in a certain occupation and industry, typically certified via a Technical Certificate) • A competence-based element (the ability to discharge the functions of a certain occupation, typically certified via work-based assessed national vocational qualifications (NVQs)) • Transferable or 'key skills' (literacy and numeracy) • A module on employment rights and responsibilities.
Ufl/ Learndirect	Learndirect is an organisation that offer courses from top up skills in English and maths through to NVQs via a network of online learning centres.
Train to Gain	<p>Train to Gain aims to deliver vocational training to employed individuals in the UK, particularly those who do not already hold a full level 2 qualification. It was launched in April 2006 and rolled out fully in September 2006.</p> <p>Late achievements from the Employer Training Pilots are also reported in this SFR.</p>
Adult Safeguarded Learning	For the purposes of this SFR, data returned in the Adult and Community Learning ILR is classified as 'Adult Safeguarded Learning'.
Higher Education	Higher Education generally takes place in Universities, although a large number of FE organisations also offer HE provision. This learning is excluded from this SFR.
Age	Different age categorisations are used for planning and funding different programmes. As a result, this SFR uses different age categorisations in this publication. In Table 1 and Tables 3 to 9 age is calculated based upon the age as at 31 August of the relevant year. In Tables 10 to 13, age is calculated as at the start of the programme.

Changes to Methodology

53 A change has been made to the way in which work-based learners are counted in Tables 1 to 7. Previous SFRs have counted the number of programmes, meaning that some learners counted more than once. We have changed this methodology so that learners are only counted once. However, for Tables 8 and 9 learners may be counted more than once if they have started or completed more than one apprenticeship framework in an academic year.

54 Previous SFRs have used an alternative measure of success for apprenticeship frameworks. The last SFR, published in May 2008, stated that future SFRs would no longer publish this measure, and the 'overall framework completion' measure would be used in future SFRs. In preparation for this we have published data for both measures for the past 3 years. This SFR does not contain any information regarding the old measure of success.
