- a. Additional funded places awarded following the bidding exercise announced in HEFCE 2003/48, 'Foundation degrees: invitation to bid for additional places and development funds 2004-05' (£21.3 million).
- b. Phased allocations of additional funded places awarded following the earlier bidding exercises, announced in HEFCE 2002/39, HEFCE 01/54, HEFCE 00/39 and HEFCE 99/56 (£42.8 million).
- c. Increases in quota-controlled undergraduate medical intakes (£20.6 million).
- d. Funding for part-time new entrants to prototype foundation degree courses, for projects listed in HEFCE 01/40, 'Foundation degrees: report on funded projects' (£0.9 million).
- e. Funding for additional social work places awarded following the bidding exercise in Circular Letter 24/2003, 'Additional funded places for social work education and training' (£1.7 million).

- 3. <u>Widening participation</u> shows allocations of funding for teaching to recognise the extra costs associated with: recruiting and supporting students from disadvantaged backgrounds currently under-represented in higher education (£49 million); improving the retention of

students most at risk of not completing (£213 million); or supporting students who have a disability (£10 million).

4. Other recurrent teaching grants comprise funding for golden hellos (£5.7 million), the Promising Researcher Fellowship Scheme (£5 million) and Dance and Drama Awards (£4.5 million).

Other funds

- 5. Total research funding comprises:
 - a. QR funding allocated through our main research funding method (£1,037 million)
 - b. The supplement to the 'best 5*-rated' departments (£24 million).
 - c. Research capability funding, allocated to departments rated 3a or 3b in the 2001 RAE in particular units of assessment (£18 million).
- 6. <u>Moderation of teaching and research</u> is a short-term measure to smooth changes in grant. A minimum allocation threshold of £100,000 has been applied.
- 7. Regulated fee income 2004-05 is the tuition fee for students who receive, or are in principle eligible to receive, awards from the Student Loans Company (SLC), the Student Awards Agency for Scotland (SAAS) or the Department for Employment and Learning (DEL) in Northern Ireland. It is calculated on the basis of 2003-04 student numbers. It excludes fee income for students funded by the TTA.

 - a. Adjustments to grant for 2003-04 in the light of recruitment that year. This comprises holdback of grant for exceeding the contract range, holdback for shortfalls against the ASNs awarded for 2003-04, and additional funding for delivery of 2001-02 ASNs at the second attempt.
 - b. Adjustments to prototype foundation degree funding for 2003-04 in the light of recruitment that year.
 - c. Adjustments to fee compensation for outgoing ERASMUS/SOCRATES students.
 - d. Other miscellaneous adjustments and transfers for 2003-04.
- 10. <u>2004-05 Adjustments and transfers</u> includes:

- a. Additional funding for ITT structural diversification, arising from transfers from the TTA.
- b. 2004-05 TPS compensation.
- c. Other miscellaneous adjustments and transfers for 2004-05.
- d. 2004-05 funding for Dance and Drama Awards.

11. 2004-05 Additional funded places includes:

- a. Additional funded places awarded following the bidding exercise announced in HEFCE 2003/48.
- b. Phased allocations of additional funded places awarded following the earlier bidding exercises, announced in HEFCE 2002/39, HEFCE 01/54, HEFCE 00/39 and HEFCE 99/56.
- c. Additional funding for increases in medical intakes.
- d. Funding for additional social work places awarded following the bidding exercise in Circular Letter 24/2003.
- e. Additional funding for increases in part-time student numbers on prototype foundation degree courses.
- 12. Rewarding and developing staff adjustments includes:
 - a. 2003-04 HEFCE-related R&DS funding for HEIs.
 - b. 2003-04 R&DS-related funding within the HE in FE development fund.
 - c. 2003-04 funding for golden hellos.
- 13. <u>2003-04 Regulated fee income</u> is the tuition fee for students who receive awards from the SLC, SAAS or DEL, or who are in principle eligible for means-tested support for such awards. It is calculated on the basis of 2003-04 student numbers and excludes fee income for students funded by the TTA.
- 14. <u>2003-04 Moderation</u> shows, for comparison purposes, any moderation funding provided in 2003-04, either as previously announced in HEFCE 2003/53, or newly allocated in-year as a result of 2003-04 holdback.
- 15. <u>Total adjusted resource 2003-04</u> is the sum of the previous seven columns.
- 16. Total resource 2004-05 is taken from the final column of Table 1.
