Background to the hearing

Pre-appointment hearings

- 1. The Governance of Britain Green Paper, published in July 2007, included a proposal that
 - the Government nominee for key positions [...] should be subject to a preappointment hearing with the relevant select committee [...] The hearings would cover issues such as the candidate's suitability for the role, his or her key priorities, and the process used in selection.1
- 2. The Government's proposal was welcomed by the Liaison Committee, which entered into discussions with the Cabinet Office on the framework for pre-appointment hearings and, in particular, which appointments should be subject to them. A final list of such posts was agreed between the Liaison Committee and the Government in May 2008.² Four posts were deemed suitable for pre-appointment hearings before the then Children, Schools and Families Committee. These are:
 - Chair of the Qualifications and Curriculum Development Agency
 - Chair of Ofqual
 - Children's Commissioner for England
 - HM Chief Inspector of Education, Children's Services and Skills
- 3. The Government made it clear that it would not regard any views expressed by committees on the suitability of any such appointment to be binding; but it undertook to take those views into consideration in deciding whether or not to proceed with the appointment.
- 4. The process of pre-appointment hearings has developed since 2008 and these are now a regular part of select committee business.³

Chair, Social Mobility and Child Poverty Commission

5. The Chair of the Social Mobility and Child Poverty Commission is a new post, created since the August 2009 list of posts subject to pre-appointment scrutiny was agreed. On 15 May 2012 Sarah Teather MP, Minister of State for Children and Families, Department for Education, wrote to the Committee, stating the Government's wish that the new post should be subject to the pre-appointment process. The Committee considered the Minister's letter on 22 May and decided to take up the opportunity to hold a hearing.

- 6. On 25 June the Minister of State wrote again to inform us that the preferred candidate was the Rt Hon Alan Milburn.
- 7. The Minister of State's letters, the candidate's *curriculum vitae* and a memorandum by the Department for Education, Department for Work and Pensions and the Cabinet Office setting out the requirements of the post and details of the recruitment process, are all printed with this Report.
- 8. We accordingly invited Mr Milburn to attend a pre-appointment hearing on 10 July 2012.

2 The post

9. The role of the Social Mobility and Child Poverty Commission is to monitor progress by Government and others in society against the objectives of improving social mobility and reducing child poverty. It is a new advisory non-departmental public body, established under the Welfare Reform Act 2012. The Act sets out that the Commission must on request give advice to a Minister about how to measure socio-economic disadvantage, social mobility and child poverty. Such advice has to be published. The Commission must also publish an annual report, to be laid before Parliament by the Minister, on its views on progress made towards the goals of improving social mobility and reducing child poverty in the United Kingdom. The report must describe measures taken by Scottish Ministers, Welsh Ministers and Northern Ireland departments in accordance with the relevant strategy for those countries, as well as progress towards the implementation of the overall UK strategy. Ministers may also ask the Commission to carry out other tasks relating to these goals.

10. In her letter of 15 May, Sarah Teather stated that "the Chair will be expected to lead the Commission, establishing it as an influential and credible voice on social mobility and child poverty, as well as being an advocate and challenger to external institutions for the social mobility agenda".⁴

3 The candidate

The candidate's background

11. Alan Milburn was the Member of Parliament for Darlington from 1992 until he retired from the UK Parliament at the general election in 2010. He held various shadow frontbench posts in Opposition (Shadow Health Minister from 1995 to 96; Shadow Treasury Minister from 1996 to 97) and also worked with Shadow Chancellor Gordon Brown MP to formulate the Labour Party's fiscal and macro-economic policy framework in preparation for government. After the 1997 general election he became Minister of State for Health (1997-98) and then joined the Cabinet as Chief Secretary to the Treasury (1998-

99). He was also Secretary of State for Health (1999-2003) and Chancellor of the Duchy of Lancaster (2004-05). He resigned from the front bench in 2005. In 2009 he was appointed Chair of the Panel on Fair Access to the Professions and went on to be appointed by the Coalition Government in 2010 as Independent Reviewer on Social Mobility to review and report on child poverty and social mobility.⁵

Lines of questioning

12. In line with the guidance drawn up by the Liaison Committee on the conduct of preappointment hearings, our questioning sought to test the professional competence and personal independence of the candidate. The Liaison Committee also observes that a candidate will need to be able to withstand parliamentary and public scrutiny should they take up the post, and that questioning may therefore be robust.

- 13. In the evidence session we explored the following areas with Alan Milburn:
 - Suitability for the post, including experience and independence;
 - Setting up and leading the Commission;
 - The child poverty targets and the Government's child poverty strategy;
 - The principle of social mobility, Mr Milburn's previous work in this field and the Government's social mobility strategy.

A transcript of the oral evidence session is printed with this report.

The Committee's views on the suitability of the candidate

14. The Committee considers that Alan Milburn has demonstrated his suitability for the post of Chair of the Social Mobility and Child Poverty Commission. We are grateful to the Minister of State for giving us the opportunity to hold this hearing and we endorse the Government's choice of candidate.

Letter from Sarah Teather (14 May 2012)

Social Mobility and Child Poverty Commission: Chair – Pre-Appointment Hearing

The Social Mobility and Child Poverty Commission is being established to monitor progress, by Government and others in society, against the objectives of improving social mobility and reducing child poverty, reporting annually to Government on progress made. An exercise to appoint the Chair and Members to the Commission has begun, all of which will be Ministerial appointments. The Chair will be expected to lead the Commission, establishing it as an influential and credible voice on social mobility and child poverty, as well as being an advocate and challenger to external institutions for the social mobility agenda.

As you will be aware, the current published list of posts subject to pre-appointment scrutiny by Select Committee was agreed in August 2009, therefore, this post is not included. My Ministerial colleagues have agreed that, given the high profile of the Commission and the role of the Chair, they would like to make the post of Chair subject to pre-appointment scrutiny.

I am offering the Education Select Committee the opportunity to hold such a hearing. I would appreciate it if this hearing would be conducted before the end of June. This is so that the formal appointment can be made before summer recess, enabling the Chair to be involved in the interviews for the Members, expected to take place in August. I realise that this is a demanding timescale and I will ensure that officials in the Child Poverty Unit provide full assistance to the Committee if the Committee agree to take up this opportunity.

Please could you let me know if the Education Select Committee is willing to hold this pre-appointment hearing?

Social Mobility and Child Poverty Commission: Chair

I am writing to invite the Education Select Committee to hold a pre-appointment hearing with our preferred candidate, Alan Milburn, for the post of Chair of the Social Mobility and Child Poverty Commission.

I understand that 10th July has been identified as the date on which this hearing could take place and that officials have been liaising with the Committee to ensure that you will have all the information required. Enclosed is a short memorandum which contains the background to this post and information on the appointment process.

I look forward to your embargoed report on the hearing before it is published. As set out in the guidance for pre-appointments, the Committee's views will be considered before confirming the appointment.

Appendix 2: Memorandum by the Department for Education, Department for Work and Pensions and the Cabinet Office

Chair – Social Mobility and Child Poverty Commission

Background

Commission

The Welfare Reform Act, which received Royal Assent on 8 March 2012, provides for the establishment of a Social Mobility and Child Poverty Commission. This Commission will be an Advisory Non Departmental Public Body established to monitor progress, by Government and others in society, against the objectives of improving social mobility and reducing child poverty. In doing so, it will consider the broad range of child poverty, life chances and social mobility indicators, set out in the Social Mobility and the Child Poverty Strategies. It will publish annual independent report/s to Government on progress made towards improving social mobility and reducing child poverty. It will consist of a Chair, a Deputy Chair and up to 7 members, two of whom will be appointees of the Scottish and Welsh Governments (one each).

Child Poverty Strategies

The Child Poverty Strategy 'Tackling the Causes of Disadvantage and Transforming Families' Lives' sets out the framework to tackle child poverty from 2011-2014, and provides this Government's first step towards laying out a new approach for ending child poverty. It focuses on a broad set of policies that target the drivers of poverty and incentivises action, and is founded on the understanding that poverty is not just about income and must also build the wider life chances of children to increase opportunity and aspiration.

The Government aims to reduce child poverty across the United Kingdom. However, there is recognition that many of the policy levers which are needed to reduce child poverty are the responsibility of the Devolved Administrations and that many of the actions outlined in the strategy will only apply to England. Each of the Devolved Administrations is responsible for producing their own strategy on child poverty and for taking action in those areas where policy is devolved.

The Child Poverty Strategy for Scotland sets out the Scottish Government's approach to tackling child poverty. It makes clear that tackling child poverty is a long term undertaking, with many factors influencing child poverty levels. It highlights the case that the causes and effects of poverty and inequality are complex and multidimensional, and require a range of interventions and responses. These must address the underlying causes of poverty, not just the symptoms, as poverty is about much more than a lack of income. On this basis, the strategy sets out 2 main aims in respect to tackling child poverty. They are: to maximise household resources; and to improve children's wellbeing and life chances. The strategy focuses on policy matters that are devolved to the Scottish Parliament and Scottish Ministers, and sets out a range of policies that will be applied over the course of the strategy.

The Child Poverty Strategy for Wales sets out the Welsh Government's vision and strategic objectives for reducing child poverty in Wales. These are to: reduce the number of families living in workless households; improve the skills of parents and young people living in low income households so they can secure well-paid employment; and reduce inequalities that exist in health, education and economic outcomes of children and families by improving the outcomes of the poorest.

The strategy gives a clear account of what the Welsh Government can achieve in helping to reduce poverty with a specific focus on policies devolved to them. The strategy sets out a distinctive Welsh approach to the provision of public services that can address the long-term root causes of poverty.

Social Mobility Strategy

The Social Mobility Strategy "Opening Doors, Breaking Barriers" set out the Government's vision of a socially mobile country where no-one is prevented from fulfilling their potential by the circumstances of their birth, and established improving social mobility as the principal goal of the Government's social policy.

The strategy focuses on relative inter-generational social mobility—the extent to which people's success in life is determined by who their parents are—and aims to break the link between social background and outcomes at every stage of life: from the Foundation Years through school and the transition into adulthood and work.

The strategy developed a set of leading indicators of long-term improvements in social mobility, looking at the gaps by social background in outcomes at each life stage. These have been included in Departmental Business Plans, ensuring that social mobility is placed at the heart of Whitehall policymaking and giving the public the information necessary to hold the Government to account.

The Key Requirements of the Post of Chair

The Chair will be required to:

- establish the Commission as an influential and credible voice on social mobility and child poverty;
- lead the Commission and set its agenda; chair meetings;
- ensure that the Commission provides, and publishes, the requested advice and/or research in its annual progress report/s to Government; and
- be an advocate and challenger to external institutions for the social mobility agenda.

In order to fulfil these, the Chair must be able to:

- Demonstrate commitment and success in improving long-term outcomes for children and/or social mobility;
- Demonstrate a very high level of organisational leadership, providing outstanding strategic direction and delivery in either the public or private sector; and
- Demonstrate that they have a proven record in building and sustaining effective working relationships with a range of stakeholders.

Role and Person Specification

Role specification

The Chair will need to ensure the Commission fulfils its remit, as set out in legislation, by:

- Establishing the Commission, identifying and securing Ministerial agreement to the key priorities for the Commission, and setting them out in an annual Business Plan;
- Leading the Commission, setting its agenda and chairing meetings to provide the best possible progress report/s on the Social Mobility and Child Poverty Strategies and targets;
- Ensuring the Commission responds appropriately, effectively, and in a timely manner to requests for advice by the Minister/s of the Crown;
- Being an advocate for the social mobility agenda: holding to account and challenging key institutions in areas such as Higher Education and the professions;
- Building and sustaining effective working relationships with a range of stakeholders, including Ministers, senior Government officials, representatives from local communities and experts in the field;
- Being the public spokesperson for the Commission;
- Utilising the expertise and experience of Commission members and securing Ministerial agreement to its commissioning;
- Ensuring active engagement by all members in the business of the Commission, including encouraging them to sustain their knowledge and understanding of the issues, reviewed through an annual appraisal of each member.

Person specification

Candidates were also expected to demonstrate:

Essential

- An in-depth and up-to-date understanding and knowledge of issues relating to social mobility and/or child poverty, including the wider policy context;
- A track record of strong negotiation, persuasion, advocacy and diplomacy skills in challenging and influencing high-level decision makers in a range of public, private and/or voluntary organisations;
- The ability to think strategically about wider social mobility and child poverty issues, working with a range of individuals and communities to set strategic direction within the wider policy context to achieve results;
- Excellent leadership and interpersonal skills to manage differing, strongly held opinions and agree clear, unequivocal ways forward;
- Excellent communication and networking skills to communicate with, and gain the confidence of, a variety of audiences: Ministers, researchers, those in the social mobility and child poverty sectors and media representatives in a professional and credible manner; and
- Personal integrity, with commitment to maintaining high standards in public life and promoting sound corporate governance.

Desirable

Experience of working with, and delivering effective outcomes for children, young people and/or families.

Terms and Conditions

The appointments will be made by Ministers for a period of no longer than five years, subject to a satisfactory annual review.

These posts are unremunerated. However, reasonable expenses will be reimbursed, including travel expenses and subsistence. As a post holder appointed for a limited duration, you will not be eligible for compensation upon the ending of your appointment.

Process

The process has been managed by the Commission Team in the Child Poverty Unit, jointly sponsored by the Department for Education, the Department for Work and Pensions and HM Treasury. As with all public appointments the process for the appointment of the Chair of the Social Mobility and Child Poverty Commission is required to follow the Code of Practice of the Commissioner for Public Appointments

(OCPA), and an OCPA assessor, Olivia Grant, has overseen the process, including being part of the sift and interview panel.

The keeping with Cabinet Office guidance, the post was advertised on their public appointments website. Other activities included:

- Advertising it on the Knowledge Hub, administered by the Local Government Association;
- All Individuals on the Register of Interest for Public Appointments in Scotland were contacted;
- links were made on the Scottish Government website and it was also published on the Employability and Tackling Poverty Learning Network;
- The advert was also directly sent to organisations across Wales that have links with Welsh Government in relation to Child Poverty.
- In addition, over 900 stakeholders working in the social mobility and child poverty areas were also contacted via email which included a link to the public appointments website.

The Selection Process

Sifting of applications

The panel met to consider applications from 8 candidates, each of which provided evidence and examples of their ability to meet the criteria as set out in the role and person specification. The panel unanimously selected a shortlist of 4 for panel interview. References on the shortlisted candidates were also obtained. Ministers were advised of the successful candidates.

Final Interviews

The panel included consisted of: Olivia Grant, Office for the Commission for Public Appointments Assessor, who was the Chair of the panel; Sue Owen, Director General, Strategy Group Department for Work and Pensions; Tom Jeffery Director General, Children, Young People and Families Department for Education; and Caleb Deeks, Head of Deputy Prime Minister's Research and Analysis Division, Cabinet Office. A note taker from the Child Poverty Unit was also present.

The candidates started the interview with a short presentation on: "How would you lead the Commission to contribute to the government's goals of ending child poverty and improving social mobility?

Following this were questions which covered the following areas:

- Why the candidate had applied for the post;
- Strategic thinking and direction setting;
- Leadership skills and interpersonal skills;
- Negotiating, persuasion and advocacy section;

- Personal integrity and standards of public life;
- Conflicts of interest; and
- Time commitment.

All the candidates were assessed against the key criteria. 2 candidates were assessed as being appointable as Chair and our preferred candidate for the post of Chair is Alan Milburn.
