Summer AS and A level entries for England: Provisional Figures April 2014

Key points

This release presents figures on the number of entries for AS and A levels submitted to exam boards ahead of the exams sat between May and June 2014. These figures are provisional. They represent the number of entries submitted by schools and colleges to awarding organisations by 21st April 2014.

The key findings for this release are:

- Overall entries for AS are up 3 per cent, while overall A level entries are down 3 per cent.
- Subjects with the largest increases at AS are computing (up 29 per cent to 29,000), geography (up 17 per cent to 51,000 and Spanish (up 16 per cent to 10,000). Entries for critical thinking, general studies and ICT decreased.
- Subjects with the largest increase at A level include computing (up 10 per cent to 4,000) and religious studies (up 5 per cent to 20,000). There have been large declines for general studies (down 24 per cent to 24,000) and physical education (down 13 per cent to 12,000).

Introduction

Ofqual regulates qualifications, exams and assessments in England, and vocational qualifications in Northern Ireland. Under the Apprenticeships, Skills, Children and Learning Act 2009, one of our objectives is to improve public confidence in regulated qualifications and assessments by raising awareness and understanding of the qualifications that we regulate.

In this release, we present data on the number of entries for AS and A levels in England received by exam boards as at 21st April 2014 for the May to June exam series. Schools and colleges enter students with exam boards to sit exams in the summer and 'cash in' or complete the qualifications. The figures for entries change daily up to the day of exams. The figures presented here are the provisional figures as received by exam boards at 21st April 2014.

To help with interpretation of the content, a glossary of terms is available towards the end of this release, followed by the data tables in the appendix.

Key statistics

The total entry in England for all AS qualifications is up by 3 per cent, while the total entry for all A levels is down by 3 per cent. This is broadly in line with school census figures from the Department for Education (DfE) for January 2014, which show an increase of 5 per cent in the number of Year 12 (AS) students in maintained and special schools and a decrease of less than 1 per cent in the number of Year 13 (A level) students.

AS makes up half the A level qualification, so many of the students taking AS this summer will go on to take A levels in summer 2015.

Students in England this summer were unable to take any AS or A2 units in January 2014 – they have to take all units in the summer exam series. This was expected to result in an increase of entry numbers this summer for individual units, as students had fewer or no opportunities to take those exams early, but it was not expected to affect the total number of entries for AS and A level qualifications, since most students already enter for the qualifications in the summer.

This is the first year that we have collected these data. In future we will be able to map the trends of these exam entries over a longer period of time to see how AS and A level entries and cohort changes interact.

The notable changes to AS and A level entry patterns in England are set out below. We have grouped subjects according to the categories used in August by the Joint Council of Qualifications (JCQ) when they report results.

AS

The total entry for all AS qualifications in England increased by 3 per cent, but there were a number of subjects where the increases were much greater than this. For example: computing (up 29 per cent to over 10,000), English (up 9 per cent to 125,000), geography (up 17 per cent to 51,000), history (up 14 per cent to 75,000), political studies (up 12 per cent to 21,000), religious studies (up 12 per cent to 34,000) and Spanish (up 16 per cent to 10,000). Many of these increases reflect a trend in recent years towards more traditional subjects.

In contrast, critical thinking entries have declined by 32 per cent to 6,000, General studies entries are down 16 per cent to 49,000 and ICT entries are down 8 per cent

to 23,000. The decrease in ICT entries is likely to be partly explained by the increase in entries for computing.

A level

Unlike at AS, the total entry for all A levels in England has dropped by 3 per cent. In some cases, A level entry patterns match those at AS, but in many subjects they do not. For example, computing entries are up 10 per cent to 4,000 and religious studies entries are up 4 per cent to 20,000.

In a number of subjects where the AS entries have increased this summer, the A level entries have seen only small increases, or entries have dropped but by less than the average. For example, geography entries increased by 1 per cent to 29,000, history entries declined by 1 per cent to 47,000 and Spanish entries are up less than 1 per cent to 7,000.

Subjects that have seen the largest falls in A level entries are critical thinking (down 43 per cent to just over 600), French (down 8 per cent to 9,000), general studies (down 24 per cent to 24,000), law (down 11 per cent to 11,000), physical education (down 13 per cent to 12,000) and political studies (down 9 per cent to 13,000 in contrast to the 12 per cent increase in A level entries).

Background notes

In this release we present figures on the number of entries for AS and A levels submitted to exam boards ahead of the exams sat between May and June 2014. These figures are provisional. They represent the number of entries submitted by schools and colleges to exam boards by 21st April 2014.

Data source

The five exam boards that provide AS and A levels submit information to us about the number of entries for each qualification available in May to June 2014. The entries are for England, Wales and Northern Ireland, regardless of the age of the student and the type of school or college. This release shows the number of entries broken down by subject and country.

Limitations of data

Data are collected at an appropriate point when they are reasonably complete, in this case 21st April 2014. However, schools and colleges can continue to make late entries right up to the day of the exam, so the total entry numbers can change on a daily basis. We have agreed the date of 21st April with the exam boards as the date when the majority of entries will have been submitted.

We cannot guarantee that the number of entries sent to us is correct, although we do expect exam boards to send us correct data. The figures reported in this release reflect the entries submitted by exam boards at the time of data collection.

We carry out quality assurance procedures to ensure the accuracy of the data and challenge or question it where necessary. We may also defer publication if the statistics are not considered fit for purpose.

Comparisons in this release are only made with entry figures from the same time the previous year. They do not represent the final entry figures for the qualifications. This is to ensure a like-for-like comparison.

Geographical coverage

In this release we present data on the number of entries for AS and A levels for the May to June 2014 exam series in England. In Tables 2, 3, 5 and 6, we publish entry figures for Northern Ireland and Wales for comparison. Similar statistics for Scotland are not published until after their exams.

Revisions

Once published, data on the number of entries for any qualification are not usually subject to revision, although we may revise subsequent releases to insert late data or to correct an error.

Completeness of the data

Exam boards send us entry data for all regulated qualifications classified as AS or A levels. We contact any exam board that has not returned a complete set of data within the collection period to make sure that the data are as complete as possible. For this release, we received data from all the exam boards that were in a position to award qualifications.

Rounding

To aid user interpretation, we have rounded all figures in the report to the nearest 1,000. Where the figures used in the commentary are less than 1,000, we have rounded to the nearest 100.

Users of these statistics

These statistics are of particular interest to Ofqual, the DfE and to exam boards. Ofqual and the exam boards use these statistics to inform understanding of the potential impact of entry patterns on the overall results.

Useful information

The data behind these statistics are available on our website, along with the publication schedule for our next releases.⁶

Glossary of terms

A level – a qualification mainly taken by 18-year-old students, which is made up of AS units and more demanding A2 units.

AS – a qualification mainly taken by 17-year-old students, which is the first half of an A level.

Cash in – schools and colleges enter students who are completing a qualification with awarding organisations.

Level – qualifications are assigned a level from entry, then Level 1 through to Level 8. Descriptions of the levels are available in our *Glossary* – *Statistical Publications*.⁷

Regulated qualification – a qualification is said to be regulated after it has been accredited. An accredited qualification is one that has met the relevant criteria as set by the regulators of qualifications in England, Wales and Northern Ireland. On accreditation, a qualification will be issued with a Qualification Accreditation Number, and specific dates set for the period for which the qualification will be accredited.
