The aim of this consultation is to seek the views of key stakeholders on proposed changes to the Fees and frequency of inspections regulations, with a view to regulations coming into force in April 2016.

1 Foreword

1.1 The aim of this consultation is to seek the views of interested parties on the proposed changes to Her Majesty's Chief Inspector of Education, Children's Services and Skills (Fees and Frequency of Inspections) (Children's Homes etc.) Regulations 2015.

1.2 This consultation seeks views on:

A 10% increase on current social care inspection and regulation costs where fees are not already at full cost recovery. Annex A sets out the fees for 16/17 and the 10% increase.

A 10% increase on the registration/variation fees charged by Ofsted, so that they also move towards full cost recovery. See Annex B for a list of the proposed registration/variation fees.

2 Fees and Frequency for Inspections Regulations

- 2.1 Since 2010-11, the inspection and regulation fees charged by Ofsted for children's social care providers have been set using a model for calculating fees developed by Ofsted in 2008-09 ("the 2008-09 Ofsted cost model"). The cost of each inspection and regulatory activity is calculated based on a mix of direct and indirect costs, including the tariff of inspection for each inspection type plus inspector day rates.
- 2.2 Ofsted developed this model to give greater transparency to providers on how fees were set, providing a more accurate and readily understandable indication of the time and resource involved in each inspection activity. Alongside this, the policy of moving providers to the 'full cost recovery of fees' was introduced in line with HM Treasury guidance.
- 2.3 The majority of providers are still a long way from paying the full cost of their inspections. This means that the government continues to subsidise these inspections and therefore the market as a whole. We therefore propose to continue with a 10% increase for this coming year with a clear intent to consulting in the near future on a set structure for all fees to be at cost recovery against a set timetable.
- 2.4 This staged approach to fee increases recognises the cost sensitivity of the children's social care market and seeks to avoid too large an increase year on year while still working towards full cost recovery.

- 2.5 Ofsted has achieved efficiencies over the previous spending review as detailed within its 2014/15 Annual Report http://tinyurl.com/nn42ev8. It is also developing proposals for achieving future efficiencies as part of the next spending review with an assumption that the gap between the proposed fees and the full cost will be regularly reviewed. However, future savings are predicated on working towards a full cost recovery model which will not be fully implemented until April 2025. A further consultation will provide a clearer set of proposals when the government's spending review decisions are known.
- 2.6 As in previous years, the inspection fees for settings that have already reached "full-cost recovery" level will be capped at the full-cost rate. This only applies to a small number of larger settings and holiday schemes for disabled children.

2.7 Consultation questions

Proposal – A 10% increase on current social care inspection and regulation costs

An across-the-board 10% increase in all fees, except for settings already at full cost recovery and holiday schemes for disabled children. The current expectation is that all settings will have reached full cost recovery by no later than 2024/25 with the vast majority having achieved this point considerably earlier.

Question 1 - Do you agree with the proposed 10% increase for 2016-2017?

Proposal - Move towards full cost recovery of inspection fees

At the moment there is a wide variety in the starting points for providers paying fees. Some providers are only paying 8% of full cost recovery and the majority of providers are paying less than 50% of full cost recovery.

We are therefore proposing that by 2024 all providers will be paying full cost recovery. We reserve the right to assess this on an annual basis to ensure the anticipated uplift remains appropriate and the full cost amount has not been adjusted in a way that would result in an over cost charge or an under recovery. We do not, however, intend to consult every year where we do not foresee an issue.
