


Performance Indicators in Higher Education: Widening Participation fact sheet

Participation of students who were in receipt of Disabled Students' Allowance (DSA): All undergraduate students - 2016/17

This indicator is designed to provide information about the percentage of disabled students in the sector. For this indicator, a value higher than the benchmark¹ indicates that an institution was performing better than the sector average.

Figure 1: Percentage of full-time undergraduate students who were in receipt of Disabled Students' Allowance - 2016/17



On average, NI HEIs were performing below the UK average of 6.6%, with 5.5% of all full-time undergraduates in receipt of DSA in 2016/17.

St Mary's University College and Queen's University Belfast (QUB) were both performing above their benchmarks, but not significantly so, with 7.0% (benchmark 5.7%) and 6.4% (benchmark 5.9%) of full-time undergraduates in receipt of DSA respectively in 2016/17.

Ulster University (UU) and Stranmillis University College were both performing below their benchmarks, but not significantly so, with 4.7% (benchmark 6.4%) and 4.1% (benchmark 6.1%) of full-time undergraduates in receipt of DSA respectively in 2016/17. The Open University (OU) NI campuses did not have a percentage for this Performance Indicator as all entrants for 2016/17 were part-time.

For part-time undergraduates, NI HEIs were performing higher than the UK average of 3.3%, with 4.8% in receipt of DSA.

¹ The benchmark is a sector average, adjusted to take account of the subject and entry profile of the institution's students. For more information, see page 4 of the <u>Contextual Information</u> document.

Participation of under-represented groups in Higher Education – mature and part-time entrants - 2016/17

This indicator looks at the percentage of entrants who came from low participation neighbourhoods and have no previous HE qualification.
