CONSULTATION DRAFT REGULATIONS AND GUIDANCE FOR INDEPENDENT REVIEWING OFFICERS

Dear Colleague,

Please find enclosed a copy of the consultation draft Regulations and Guidance for Independent Reviewing Officers, a requirement arising from the Adoption and Children Act 2002. The regulations will update the *Review of Children's Cases Regulations 1991* by introducing the role of the IRO on a statutory basis. **Please forward one copy to the IRO and Director of Children's Services (or equivalent). The consultation requires action from both by 31st December 2003.**

Implementation

We intend that the Regulations will come into force in September 2004, dependent on the response to this consultation with regard to the numbers of referrals to CAFCASS, which will inform plans for the provision of legal aid where necessary. At that time all local authorities must have Independent Reviewing Officers in place to chair the review meetings of all looked after children. Local authorities should consider the implications of the Regulations and Guidance now. Although the Regulations and Guidance will not be finalised until March 2004, local authorities should now begin to prepare for implementation to take place from September 2004.
