



## Guidance for providers on publishing information about reviews for educational oversight

We ask that providers use the approved wording, below, to describe your relationship with the Quality Assurance Agency for Higher Education (QAA), and to publicise information relating to your review for educational oversight by QAA.

A QAA educational oversight review graphic is also available for this purpose, from 1 August 2013. The graphic complements the wording below: providers may use either element or both, to suit their requirements.

**Please note that the QAA logo is not available for use by providers.**

### **Text for use on your acceptance for a review by QAA**

[Provider name has/We have] received confirmation that the Quality Assurance Agency for Higher Education (QAA) has scheduled us for a review for educational oversight during 2014.

### **Text for use on receipt of your provisional judgement letter from QAA**

[Provider name has/We have] undergone a review for educational oversight by the Quality Assurance Agency for Higher Education (QAA) and are awaiting publication of its final report.

### **Text for use on receipt of your confirmed judgement letter from QAA**

[Provider name has/We have] undergone a review for educational oversight by the Quality Assurance Agency for Higher Education (QAA) and are awaiting publication of its final report.

### **Text for use on receipt of your email from QAA confirming publication of your review report**

[Provider name has/We have] undergone a review for educational oversight by the Quality Assurance Agency for Higher Education (QAA) and [has/have] received [its/our] final report, which is available in full at: **[you will receive the URL with the email]**.

The monitoring visit resulted in the following outcome:
