

## **Statistical Fact Sheet 1**

# Accredited Enrolments at Further Education Colleges in Northern Ireland during the academic year 2013/14 – February 2014.

The 'Accredited<sup>1</sup> Enrolments at Further Education Colleges in Northern Ireland' factsheet is a new regular quarterly report. Table 1 and Chart 1 show the number and percentage of accredited enrolments at Further Education (FE) colleges across Northern Ireland, by mode of attendance and Sector Subject Area (SSA) during the academic year 2013/14, as at the 7<sup>th</sup> February 2014.

Please note that accredited provision is only a subset of all FE enrolments delivered in FE Colleges. The focus on accredited provision within this factsheet is to present the progress towards the 'Further Education Means Business' strategy, which has as one of its aims to encourage accredited economically focussed provision.

To date in 2013/14, as of 7<sup>th</sup> February:

- there are 133,200 accredited enrolments at FE Colleges in Northern Ireland. This can be disaggregated into 25,750 full time (19%) and 107,450 part time (81%) accredited enrolments.
- the largest proportion (29%) of accredited enrolments at FE colleges in Northern Ireland are in the SSA 'Preparation for life and work' (32,753), which are most likely related to Essential Skills enrolments.
- The highest proportion (15%) of all full time accredited enrolments is within the SSA 'Health, public services and care'.

The figures are a snapshot of the current academic year 2013/14 and include an element of estimation by FE colleges using planned enrolments for courses that are yet to commence and as such the figures are provisional and subject to change.



### **Technical Notes**

- 1. The source of the enrolment information is the Consolidated Data Return (CDR) return provided by all Further Education (FE) Colleges.
- 2. The return lists the enrolment records which are delivered through the FE Colleges.
- 3. The number of enrolments is a count of the number of enrolment records within the CDR return.
- 4. The enrolment information is correct as at 7<sup>th</sup> February 2014.
- 5. An academic year for this analysis has been defined as the 1<sup>st</sup> August 20XX to the 31<sup>st</sup> July 20XX+1.
- Accredited provision is identified if the enrolment record has an official OFQUAL Register of Regulated Qualification or DEL Access/PLAQ code and is 'level 3 or below' or is 'level 4 or above'.
- 7. Previous FE enrolment publications, available at: <u>http://www.delni.gov.uk/index/statsandresearch/further-education-stats/fe-enrolments/all-further-education-provision-enrolments.htm</u>, have used the term 'Professional and Technical' to describe this cohort of FE provision. Professional and Technical were identified as any enrolment not coded as qualification aim '999', '599' or '199' i.e. recreational and Keyskills provision are excluded. The term 'Accredited' will now be used for future publications in regard to this type of provision within FE. This cohort of FE provision is comparable with the previous figures for Professional and Technical.
- 8. All accredited qualifications are assigned a Sector Subject Area (SSA) code by the awarding organisation. The Office of Qualifications & Examinations regulation (OFQUAL) is the lead body for managing this classification system. Those classed as SSA 'Unknown' are those enrolments which are for a qualification/unit which is not on the OFQUAL register, i.e. non-accredited or Access & Prescribed List of Approved Non NQF/QCF Qualification (PLAQ) courses or Higher Education courses and therefore do not have a SSA code associated with them.
- 9. The Mode of Attendance indicates whether the enrolment was full time student or part time study. An enrolment is coded as full time (student mode of attendance = '01') by the FE College as if the student is timetabled to attend for at least 15 hours per week over 7 sessions and for at least 30 weeks in the academic year. Any enrolment record not coded as full time (student mode of attendance NOT EQUAL to '01') is regarded as part time for this analysis.

### **User Consultation**

This is first time this statistical factsheet on Further Education enrolments has been produced using the Consolidated Data Return (CDR) therefore users' comments and/or any issues relating to the statistics are particularly welcomed and encouraged. These will all be considered for incorporation into the next version of this factsheet, which is scheduled to release in July 2014. A more comprehensive bulletin is scheduled for December 2014.
