Providers requesting new learning aims for prescribed higher education provision

for the 2018 to 2019 funding year must submit the completed <u>form and validation</u> <u>approval letter</u> by Friday 27 September to meet the Office for Students timelines.

This allows time to create and upload them to the Learning Aim Reference Service (LARS) database for the R14 ILR submission that opens on Monday 7 October 2019 and closes on Thursday 17 October 2019.

Any requests received after this date for 2018 to 2019 may not be processed in time for the final R14 ILR submission.

Please submit the completed <u>form and validation approval letter</u> using the <u>ESFA</u> online form.
