Under the Local area special educational needs and disabilities inspection framework, inspectors review how local areas meet their responsibilities to children and young

In May 2016, the two inspectorates, Ofsted and the Care Quality Commission (CQC),

started a new type of joint inspection. The aim is to hold local areas to account and

• publish a 'local offer' setting out the support and provision in the area for children and young adults with special educational needs or disabilities (or both)

- provide accessible information to children and young people, as well as parents and carers, about the services and support available in the local area
- to make sure that any special needs or disabilities (or both) are identified as early as possible assess (in co-operation with children and young people and their parents and carers)

work with children and young people, their parents and carers, and service providers

(or both) who may need an education, health and social care plan (EHCP) • produce an EHCP for all children and young people who are assessed as needing one (all relevant agencies should cooperate to do this and involve the children and young
