What's on offer

The [National Centre for Excellence in Language Pedagogy](#) (NCELP) will be running continuing professional development courses throughout 2022. These will focus on modern foreign language (MFL) curriculum design and pedagogy and consist of five 2.5 hour remote learning sessions spread over one term. This is complemented by online peer and instructor support.

Who can join the course

The course is available to either:

- qualified teachers involved in MFL education who are working at an eligible school that teaches at least one of the following:
 - French
 - German
 - Spanish
- a state-funded university-based or SCITT-based teacher trainer providing courses to secondary pre-service teachers or trainees in French, German or Spanish

You must work in a school that receives public funding to be eligible. Private and independent schools are not eligible.

The course may be of interest to:

- heads of modern foreign language departments
- department or trust subject leads
- others in a leadership or decision-making position who can cascade course content to MFL colleagues

Due to limited capacity, only one applicant per school will be accepted. The application window will stay open until all places are filled.

An online self-study version will be available in 2022 and open to everyone.

When to apply

Applications are now open for the summer term courses beginning in

the week commencing 25 April or 2 May 2022.

What it costs

The course is free of charge.
