#### **NEW**

### January 2015: curriculum and qualifications

We will publish updates to the technical and vocational qualifications approved for inclusion in the 2017 school and college performance tables. These qualifications will be available for teaching from September 2015. The lists include qualifications in the following categories:

- technical awards (key stage 4, levels 1 and 2)
- tech levels (16 to 19, level 3)
- applied general qualifications (16 to 19, level 3)
- substantial vocational qualifications at level 2 (16 to 19)

Only technical and vocational qualifications included on these lists will appear in school and college performance tables from 2017 onwards.

key stage 5 performance tables.

#### **NEW**

### January 2015: staffing

Maintained schools and academies following the <u>school teachers' pay and</u>
<u>conditions document</u> should ensure that teachers understand the link between
their performance and their pay progression. Mid-year appraisal reviews are a
good opportunity to:

- check that teachers know how they will be assessed
- let them know how they are progressing

 check that arrangements are in place to support evidence-based pay decisions at the end of the year

#### **NEW**

### January 2015: finance

To prepare for its introduction in April 2015, we will put the early years pupil premium in place early in Blackpool, Bristol, Cambridgeshire, Hackney, North Yorkshire, Northamptonshire, and Stoke on Trent, from January 2015.

#### **NEW**

### January 2015: finance

Schools will receive an <u>additional premium</u> of £500 for each year 7 pupil who did not achieve at least level 4 in reading and/or mathematics (maximum £500 per pupil) at key stage 2 in summer 2014.

The premium is available to all state-funded schools with a year 7 cohort, including pupil referral units (PRUs) and maintained special schools.

Local authorities will receive funding for maintained schools for the 2014 to 2015

academic year on 27 February 2015.

The Education Funding Agency (EFA) will send academies and free schools their year 7 catch-up premium funding for the 2014 to 2015 academic year on 2 March 2015.

### January 2015: governance

We have announced plans to supply defibrillators to schools at significantly discounted prices, in partnership with NHS Supply Chain. Details of how to buy a defibrillator under this arrangement are in the <u>automated external defibrillators</u>

(AEDs) guide.

### January 2015: governance

Registration opens for the DfE <u>School Food Excellence Award</u> to be presented in July 2015. The top prizes will go to a primary and a secondary state school in England that have achieved the most exceptional standards in catering and food education in a whole-school environment.

#### **NEW**

### January 2015: pupils and governance

In an <u>open letter to schools</u>, Childcare and Education Minister Sam Gyimah has outlined government reforms that will make it easier for schools to offer nursery provision, including places for 2-year-olds (requires secure access login).

### January 2015: pupils

We invite schools and other organisations to apply to the new <u>character</u> education award scheme.

There will be financial prizes for schools and/or organisations across the 9 regions that can demonstrate innovative activity in character building.

The application window closes on the 30 January.

We are providing the opportunity for 2 pupils and 1 teacher from every statefunded secondary school in England to <u>visit battlefields on the Western</u>

#### **NEW**

### January 2015: pupils

Schools should contact their local authority to find out the deadline for submitting their school census data to them.

The school census is a statutory collection. We use data from the school census to determine how much funding you will receive.

Guidance on submitting your school census return is available.

#### **NEW**

### February 2015: pupils

Schools will be able to register for the 2015 Future Scholar Awards scheme.

#### **NEW**

### Spring term 2015: pupils

As part of changes to the accountability framework, primary schools will be able to use a <u>reception baseline</u> to measure children's progress from September 2015. We will announce the approved reception baseline suppliers in January for use from September. You will have until the end of April to sign up to your preferred baseline; after this time, your preferred baseline may no longer be available.

### April 2015: finance

The <u>early years pupil premium</u> will be available in all local authority areas. It will provide extra funding to school nurseries and others who deliver government-

funded early education to disadvantaged children.

### January 2015: curriculum and qualifications

The Association of Colleges, Association of School and College leaders (ASCL), Sixth-Form College Association (SFCA) and National Association of Head Teachers (NAHT) will publish guidance to help schools and colleges implement the new linear A levels and decoupled AS level.

### Autumn term 2015

#### **NEW**

### September 2015: governance

We are extending the annual flu immunisation programme in line with recommendations by experts for all children aged 2 to 17. The extension will roll out gradually, with offers to all primary-school-aged children in key stage 1 in England from September 2015.

The NHS will co-ordinate the programme, with the expectation that immunisation will be available in schools in most areas. To be effective, immunisation needs to take place between September and December. Schools may wish to consider this when making their plans for the 2015 to 2016 academic year.

We will use <u>materials from pilots</u> to inform the development of further information and make it available to schools before the end of the 2015 summer term.

First teaching of <u>new AS and A levels</u> in:

- art and design
- biology
- business studies
- chemistry
- computer science
- economics
- English language
- English literature
- English language and literature
- history
- physics
- psychology
- sociology

The first A level examinations in these subjects will be in summer 2017 (AS level in 2016). The last examination of existing A levels in these subjects will be in the summer of 2016.

Schools should be aware of the second wave of <u>new AS and A levels</u> for first teaching from September 2016. Awarding organisations publish accredited specifications in these subjects in autumn 2015.

#### **NEW**

### September 2015: curriculum and qualifications

Reformed GCSEs in English and mathematics will be available for first teaching from September 2015, with the first examinations in summer 2017. These are the only English and mathematics qualifications that will count in the key stage 4 and key stage 5 performance tables in 2017. The last examination of existing GCSEs will be in the summer of 2016, with a single opportunity for retakes in the autumn. Schools prepare for the second wave of new GCSEs for first teaching from September 2016. Awarding organisations will publish accredited specifications in these subjects.

#### **NEW**

### September 2015: curriculum and qualifications

First teaching begins of the vocational qualifications approved for inclusion in the 2017 key stage 4 and 16 to 19 performance tables. These include:

- technical awards at key stage 4
- tech levels at level 3
- applied general qualifications at level 3
- substantial vocational qualifications at level 2 for 16- to 19-year-olds

Only vocational qualifications included in these lists will contribute towards the 2017 school and college performance tables.

#### **NEW**

### September 2015: curriculum and qualifications

Awarding organisations will publish new GCSE specifications based on published subject content for:

- ancient languages
- art and design
- biology, chemistry and physics (single science)
- combined science
- citizenship
- computer science
- cooking and nutrition
- dance
- drama
- geography
- history
- modern foreign languages
- music
- physical education (PE)
- religious studies

These will be first taught from September 2016, with the first examinations in summer 2018. Schools choose specifications, contact awarding organisations and plan for these new qualifications.

#### **NEW**

### **Autumn 2015: curriculum and qualifications**

Publication of the lists of vocational qualifications approved for inclusion in the 2018 key stage 4 and 16 to 19 performance tables.

Only vocational qualifications included in these lists will contribute towards the 2018 school and college performance tables.

#### **NEW**

### September 2015: staffing

Implementation of increased employer contributions for the teachers' pension scheme, following the <a href="mailto:2012 valuation">2012 valuation</a>, subject to consultation and regulatory changes coming into force.

#### **NEW**

### September 2015: pupils

The persistent absence threshold for pupils will change from 15% to 10% from the start of academic year 2015 to 2016. From September 2015 Ofsted will use this new threshold in its inspection regime.

The first examinations in these A levels will be in summer 2018 (AS level in 2017). The last examination of existing A levels in these subjects will be in the summer of 2017.

Schools should be aware of the third wave of new AS and A levels for first teaching from September 2017. Awarding organisations publish accredited specifications in these subjects in autumn 2016.

#### **NEW**

### September 2016: curriculum and qualifications

First teaching of the technical and vocational qualifications newly approved for inclusion in the 2018 school and college performance tables. These include:

- technical awards (key stage 4, levels 1 and 2)
- tech levels (16 to 19, level 3)
- applied general qualifications (16 to 19, level 3)
- substantial vocational qualifications at level 2 (16 to 19)

Only listed technical and vocational qualifications included in these categories will contribute towards the school and college performance tables from 2018 onwards.

#### **NEW**

### September 2016: finance

Funding allocations for the academic year 2016 to 2017 will include an <u>uplift</u> based on students' successful completion, in summer 2014, of large <u>TechBacc</u>

<u>programmes</u> (those that are the size of 4 A levels or larger). TechBacc programmes include a tech level qualification, a level 3 maths qualification and an extended project.
