

1. Information: PE and sport premium funding for 2016 to 2017

We have published funding allocations for the <u>PE and sport premium</u> which primary schools will receive in the academic year 2016 to 2017.

We will pay academies their first instalment (seven-twelfths) of the allocation on 1 November 2016. This will appear as a separate item on your remittance. We will pay the remainder in May 2017.

For schools teaching pupils in years 1 to 6 for the first time, for this academic year we will base the funding on your autumn 2016 census data. Payments will be made in February 2017 and May 2017.

<u>Guidance on the PE and sport premium</u> has links to sources of advice and information on how to effectively use the premium, including a tool to help measure and report on the impact of spending.

2. Information: new energy efficiency loan fund

We've launched, in partnership with Salix Finance, a new energy efficiency loan fund for academies. The Salix Energy Efficiency Fund r (SEEF) is available to all academies applying for loans to carry out capital

works that improve energy efficiency.

3. Reminder: autumn school census return

The deadline for approved submissions for the <u>autumn school census</u> 2016 is 2 November 2016. Please be aware that once you have completed your return, you must press the 'submit' button in COLLECT to allow Department for Education (DfE) to access your return.
