Information: RAISEonline replacement service

[Analyse school performance \(ASP\)](#), DfE's replacement service for RAISEonline, was launched in July. The new system includes 2017 question level analysis (QLA) and named pupil data for those with appropriate access levels.

QLA data enables you to assess how well your pupils performed in different aspects of the curriculum. It also supports secondary schools in identifying the strengths and weaknesses of incoming year 7 pupils.

Additional reports are available and can be found in the 'List of reports' tab. DfE has also made improvements based on user feedback, such as improved printing, navigation and further help text.

Provisional 2017 KS2 data will be available in ASP at the end of September. Data about Looked After Children is not yet available. DfE will add this data at the end of October with the 2017 KS1 and phonics screening check data.

The performance tables [data checking exercise](#) is open until 5pm on Friday 15 September. Schools are asked to check their pupil level data and, if necessary, submit requests to amend the data on which their performance measures are calculated. You must submit confirmation of data even if you have no amendments to make.

Any changes to data made after 4 July, following a marking review or late submission of teacher assessment for example, have not yet been included.
