INTRODUCTION

This statistical publication provides details of the quality of childcare in England. It presents the most recent inspection grade of active childcare provisions as at 30 March 2007. Childcare provisions include all provisions which offer care for children under the age of 8 for a specified duration and are thus inspected under the Childrens Act.

CONTENT

Figures are presented for each national childcare type and are given at England, government office region and local authority level. Where the number of inspections is small care should be taken when intrepreting the data as it may be that any apparent differences between local authority and England figures are not statistically significant. Please note that the percentages may not sum to 100% due to rounding.

SOURCE

All data has been extracted from the Regulatory Support Application as at 03 May 2007.

FURTHER INFORMATION

The content of this publication has been limited to data that is considered robust and of general public interest. However, a variety of other data are held as part of our early years regulatory and inspection function. These include data relating to: outcomes of childcare applications; time taken to registration decisions; actions and conditions imposed at registration and inspection; Childcare and Nursery Education inspections against each of the five children outcomes. (1) Childminder: a childminder is registered to look after 1 or more children under the age of 8 to whom they are not related on domestic premises for reward and for a total of more than 2 hours in any day. (2) Full Day Care: facilities that provide day care for children under 8 for a continuous period of 4 hours or more in any day in premises which are not domestic premises. Includes day nurseries and children's centres, and some family (3) Sessional Day Care: facilities that provide day care for children under eight for a session which is less than a continuous period of four hours in any day in premises that are not domestic premises. Where two sessions are offered in any one day, individual children must not attend more than five sessions in a week. (4) Out of School Care: facilities that provide day care for children under eight which operate during one or more of the following periods: before school, after school, during the school holidays. The total care provided is for more than two hours in any day and for more than five days a year. Open Access Schemes are included. (5) Crèches: facilities that provide occasional care for children under 8 and are provided on particular premises on more than 5 days a year. They need to be registered where they run for more than 2 hours a day, even when individual children attend for shorter periods. (6) Multiple Day Care: facilities that provide more than one type of day care, for example operating full day care and sessional day care in conjunction to each other. This provision is counted only once in the appropriate table to reflect the

total number of inspections completed.
