Updated qualifications regulations for school teachers in Wales

Overview

The Welsh Government is consulting on proposals to introduce an updated replacement for the Education (School Teachers' Qualifications) (Wales) Regulations 2004 in order to make changes to some of the requirements for recognition as a qualified teacher in Wales. This would include some miscellaneous amendments and updating.

1. What are the main issues?

- 1.1 The Welsh Government is consulting on proposals for an updated replacement for the Education (School Teachers' Qualifications) (Wales) Regulations 2004 ("the 2004 Regulations").
- 1.2 We propose to make changes to some of the requirements for recognition as a qualified teacher in Wales:-
 - Under the 2004 Regulations, one of the conditions to be met in gaining Qualified Teacher Status through an initial teacher training ("ITT") course in Wales is that the period of practical teaching experience on the ITT course must be undertaken wholly or mainly in a school or other educational institution (except a pupil referral unit) in Wales. We propose to amend this condition so that this period of practical teaching experience would need to be undertaken wholly or mainly in a school or other educational institution (except a pupil referral unit) in Wales which met the curriculum requirements for the Foundation Phase and Key Stages 2, 3 and 4, as appropriate to the provision at the school.
 - At present, anyone who is a qualified teacher under the School Teachers' Qualifications Regulations made in relation to England is also recognised as a qualified teacher in Wales under the 2004 Regulations.
 We propose to replace this provision with a more specific recognition of certain qualified teachers in England only.
 - We propose to additionally require that persons who have been recognised as a teacher in Scotland or Northern Ireland need to have undertaken a period of practical teaching experience there in order to be recognised as a qualified teacher in Wales.
 - For those who are recognised as a qualified teacher in Wales by virtue of their being recognised as a teacher in Northern Ireland, we now propose to refer to registration with the General Teaching Council for Northern Ireland ("GTCNI").
- 1.3 We also propose to no longer allow qualification as a teacher in Wales for certain independent school or further education teachers who gained qualifications before 1974, or 1989 in specified subjects.
- 1.4 There would also be some miscellaneous changes and updating from the 2004 Regulations generally.
- 1.5 These changes would only affect people qualifying after the new regulations came into effect.
- 1.6 As indicated in paragraphs 3.5-3.13 below, the Department for Education has announced plans for changes in school teachers' qualifications regulations in England, which are intended to come into effect from 1 April 2012. These include provisions which would mean that further education teachers with Qualified Teacher Learning and Skills (QTLS) status and teachers with full qualifications from Australia, Canada, New Zealand and the United States would become qualified teachers in England.

- 1.7 For the reasons set out in paragraphs 3.5-3.13, we do not propose to follow suit in Wales. However, we would like to introduce updated qualifications regulations in Wales by 1 April 2012 (alongside regulations in England). Although the Department for Education is currently consulting on the issue, bringing regulations into force in Wales after regulations have been made in relation to England could lead to further education teachers with QTLS status and teachers with full qualifications from Australia, Canada, New Zealand and the United States who are recognised as qualified teachers in England at that time (and thereafter until our regulations were changed) becoming qualified teachers in Wales. This would thus negate one of the main purposes of our proposed updated qualifications regulations.
- 1.8 Because of this there is compelling public interest in enabling time for a decision on the proposals to be made, subject to the consideration of consultation responses, and for regulations to come into force by 1 April 2012. The consultation period on these proposals is therefore 8 weeks rather than the normal 12 weeks in order to allow for this.

2. Where are we now?

- 2.1 Under the provisions of the Education (Specified Work and Registration) (Wales) Regulations 2010, only qualified teachers, and other persons in limited specific circumstances, may carrying out of 'specified work' (i.e. teaching) in maintained schools or non-maintained special schools in Wales.
- 2.2 Schedule 2 to the 2004 Regulations sets out the requirements to be met by persons to be recognised as qualified teachers in Wales. Requirements are set out for different categories of persons. The 2004 Regulations also provide that to be qualified teachers, persons meeting certain of the requirements in Schedule 2 must be notified to that effect (regulation 5(b) of the 2004 Regulations refers). Persons recognised as a qualified teacher have Qualified Teacher Status ("QTS").
- 2.3 Persons who are recognised as qualified teachers under the 2004 Regulations include:-
 - Those who are qualified teachers under corresponding regulations made in relation to England.
 - School teachers from the European Economic Area (European Union member states, plus Iceland, Norway and Liechtenstein) or Switzerland.
 - Those who have successfully completed a course of initial training for teachers at an accredited institution in Wales and have met specified standards. These are the QTS Standards – the current version is The Qualified Teacher Status Standards Wales 2009 (2009 No.25) ("the 2009 QTS Standards").
 - Those who have successfully completed a course of initial training for teachers at an educational institution in Scotland or Northern Ireland.
 - Those who are recognised as teachers in Northern Ireland by the Department of Education, Northern Ireland Office.
 - Those who are registered as teachers of primary or secondary education with the General Teaching Council for Scotland.

- Those recommended for QTS by the States of Guernsey Education Department.
- Those who have successfully completed a period of training on the employment based teacher training scheme and have been assessed as meeting specified standards.
- 2.4 In addition to the categories listed in paragraph 2.3 above, the 2004 Regulations also provide for recognition as qualified teachers in Wales for those who were qualified teachers under the previous qualification regulations (the Education (Teachers' Qualifications and Health Standards) (Wales) Regulations 1999); and those who, but for an oversight by the authorities to give them written notification, would have been qualified teachers under previous regulations. Finally, they also cover recognition as qualified teachers in Wales, in limited circumstances, for certain teachers in independent schools and certain further education teachers employed at further education institutions or in specified roles in schools.
- 2.5 The 2004 Regulations also enable the Higher Education Funding Council for Wales to accredit institutions as providers of courses or programmes of initial school teacher training that satisfy criteria specified by the Welsh Ministers; and allow the Welsh Ministers to establish an employment based teacher training scheme which enables persons to train to gain Qualified Teacher Status whilst being employed as teachers.

- 2.7 The 2004 Regulations have been amended by the Education (Amendments to Regulations regarding the Recognition of Professional Qualifications) (Wales) Regulations 2007, the Education (School Teachers' Qualifications) (Amendment) (Wales) Regulations 2008 and the Local Education Authorities and Children's Services Authorities (Integration of Functions) (Subordinate Legislation) (Wales) Order 2010. 3. Why are we proposing change?

Teachers qualifying in Wales: curriculum provision in schools used by ITT providers

- 3.1 In order to deliver ITT courses leading to QTS, higher education institutions ("HEIs") require accreditation from the Higher Education Funding Council for Wales. All ITT providers must meet the detailed accreditation criteria which includes ensuring that the training meets all the statutory requirements for ITT courses set out in the Criteria for Initial Teacher Training Accreditation by the Higher Education Funding Council for Wales 2006 (as amended).
- 3.2 A provision in the statutory requirements for ITT courses (in the above criteria) makes it mandatory for ITT providers to design the content, structure and delivery of training to enable trainee teachers to demonstrate that they have met the statutory specified standards (as currently set out in the 2009 QTS Standards). Delivery includes both the training provided by the HEI and through its partnership school(s). The 2009 QTS Standards require trainees to demonstrate a secure knowledge and understanding of the subjects within the national curriculum key stage(s) that they are being trained to teach; and that they can teach the required or expected skills, knowledge, and understanding relevant to the curriculum for learners in the age range for which they are trained.
- 3.3 At present, there is no express requirement in the 2004 Regulations for schools or other institutions used by ITT providers for the purposes of practical teaching experience to teach the national curriculum, or a particular phase or stage of the national curriculum. In the majority of cases, ITT providers will be in partnership with maintained schools where this provision would in any event be standard. ITT providers might wish to organise some placement time outside of maintained schools; but if this was the case they would still need to ensure that a significant proportion of trainees' practical teaching experience took place in schools delivering the national curriculum in order to meet their obligations under the statutory requirements for ITT courses.
- 3.4 However, for the avoidance of doubt, we are proposing to require that the period of practical teaching experience for those qualifying as a teacher on ITT courses in Wales would need to be undertaken wholly or mainly in a school or educational institution in Wales (except a pupil referral unit) which met the national curriculum requirements, as appropriate to the provision at the school. This would not mean that the entire period of practical teaching experience had to be in schools which met the national curriculum requirements, as it is recognised that this would not necessarily be required for all training designed to enable trainee teachers to demonstrate that they have met the 2009 QTS Standards. However, for the overall total period of practical teaching experience, the majority would have had to have been in schools or educational institutions which met the national curriculum requirements, as appropriate to the provision there.

Teachers qualifying in England

- 3.5 The 2004 Regulations presently recognise as a qualified teacher in Wales anyone who is recognised under the equivalent regulations in England (currently the Education (School Teachers' Qualifications) (England) Regulations 2003, as amended). This is a long-standing provision, reflecting the fact that both countries' qualification requirements have been very similar for many years.
- 3.6 The Department for Education ("DfE") in England published on 22 September 2011 a consultation on proposals to make changes to the qualifications regulations for teachers there. Because of the way the 2004 Regulations are structured, at present any changes to the requirements for qualification in England would apply automatically in Wales also. DfE is proposing that:-
 - (a) Further education teachers with QTLS status would be recognised as a qualified teacher in England. They would have QTS and would therefore be able to teach in schools in England as qualified teachers on a permanent basis.
 - (b) Fully qualified teachers from Australia, Canada, New Zealand and the United States should be able to gain QTS and teach in schools in England on a permanent basis as qualified teachers without undertaking further training or assessment.
- 3.7 Under the 2004 Regulations, recognition as a qualified teacher in Wales is limited to people who meet specified standards (currently the 2009 QTS Standards), which include elements specifically related to teaching requirements in maintained schools; those who meet similar school teaching standards in other parts of the UK; and qualified school teachers from the European Economic Area or Switzerland, where we have legal obligations to meet. We would not consider it desirable for persons to be recognised as a qualified teacher in Wales if they had not met the 2009 QTS Standards or similar school teaching standards and where there were no over-riding legal obligations.
- 3.8 The 2009 QTS Standards cover the age ranges in maintained schools, from the Foundation Phase to Key Stage 4 and post-16, and gaining QTS provides a teacher with the legal status to teach across those age ranges. Further education teaching qualifications are a legal requirement for persons employed as teachers in institutions within the further education sector, which in relation to young people who might otherwise be in schools essentially covers 16-19 year olds. Although there are a range of common issues relating to teaching skills, the requirements to be met in gaining further education teaching qualifications, they do not cover all the elements contained in the 2009 QTS Standards, which have very specific requirements on being able to know, understand and teach the relevant curriculum for learners in schools.
- 3.9 Given these differences, we do not think that allowing qualified further education teachers to teach in school classrooms in an unrestricted way on the same basis as qualified school teachers would be a realistic or desirable approach. There is a more specific issue within this, about qualified further education teachers being able to teach in schools the vocational courses that they already teach in

further education institutions. But a blanket change in teachers' qualification requirements is not needed here; in Wales, we have already taken action to allow this through the introduction of the Education (Specified Work and Registration) (Wales) Regulations 2010 ("the specified work regulations"). The specified work regulations allow qualified further education teachers to undertake teaching work in maintained schools to deliver vocational courses within the local curriculum under the Learning and Skills (Wales) Measure 2009 – see annex 1 for details.

- 3.10 For overseas trained teachers (that is, teachers from countries outside the European Economic Area or Switzerland), the present position in Wales is that those who have successfully completed an officially recognised programme of professional training for teachers in their countries can teach here on a temporary basis. Under the specified work regulations they may teach in maintained schools and non-maintained special schools in Wales for a maximum of two years. If an overseas trained teacher wishes to teach in Wales on the same basis as a qualified teacher for a longer period than two years, they would need to gain QTS.
- 3.11 Should an overseas trained teacher employed at a maintained school or non-maintained special school in Wales wish to acquire QTS, they can do this through the Graduate Teacher Programme ("GTP"). Each year a number of places on this employment-based route to QTS are made available to overseas trained teachers. We recognise that suitably qualified overseas trained teachers will already possess a range of teaching skills and experience. Depending upon the individual, a GTP placement could be undertaken in as little as one term, with the programme just concentrating on specific issues relevant to the 2009 QTS Standards such as the curriculum-related requirements.
- 3.12 Some overseas countries may have initial teacher training systems and teaching qualifications with comparable standards and quality levels to the UK. However, although this might provide an indicator of the relative suitability of teachers from those countries for teaching in the UK, we would not regard it as meaning that a teaching qualification from those countries could be viewed as fully equivalent in relation to the requirements in the 2009 QTS Standards. We do not think, therefore, that teachers with qualifications from Australia, Canada, New Zealand and the United States should be able to teach in schools in Wales as qualified teachers on a long-term basis without a process leading to assessment against the specified teaching standards.
- 3.13 We therefore propose to replace the current provision in the 2004 Regulations covering teachers qualifying in England which recognises as a qualified teacher in Wales any persons who are qualified teachers under corresponding regulations made in relation to England with a more specific provision recognising specific categories. This would essentially cover persons qualifying as a teacher in England through routes which involved an assessment against the QTS there, which are (i) an ITT course at an accredited institution, (ii) assessment against the specified standards, but without having undertaken a specific ITT course (known as the Assessment Only route); and (iii) successful completion of a period of training on an employment-based teacher training scheme.
- 3.14 If the proposal described in paragraph 3.13 above and the changes proposed by DfE in England were implemented, it would mean that further education teachers

with QTLS status and teachers with full qualifications from Australia, Canada, New Zealand and the United States would have QTS in England and would be able to teach in schools there as qualified teachers. However, they would not be recognised as qualified teachers in Wales and would only be able teach in maintained schools here under the limited provisions allowed by the specified work regulations, as outlined in paragraphs 3.9 and 3.10.

Teachers qualifying in Scotland and Northern Ireland

- 3.15 At present it appears possible for overseas trained teachers to gain prior recognition as a teacher in Scotland or Northern Ireland without having taught in those countries. Under the 2004 Regulations they could then be recognised as a qualified teacher in Wales, without having taught in the UK. We wish to prevent this.
- 3.16 The 2004 Regulations recognise as a qualified teacher in Wales a person who is eligible to teach in schools in Northern Ireland, having been recognised by the Department of Education, Northern Ireland Office (DENI). The GTCNI now has a role in the approval of qualifications required for someone to be regarded as a qualified teacher. Additionally, since 1998, it has been a requirement that a person cannot be employed as a teacher in Northern Ireland unless they are registered with the GTCNI. We propose to replace the current 'confirmation of recognition' approach with a more straightforward requirement that we will recognise as a qualified teacher in Wales a person who is registered as a qualified teacher with the GTCNI.

Recognition as qualified teachers: independent schools and further education teachers

- 3.17 Prior to the present system where QTS is gained via specific initial teacher training courses, those previously gaining education qualifications became qualified teachers by virtue of their first posts being in a maintained school. Those with similar qualifications but whose first posts were in further education colleges or independent schools were not recognised as qualified teachers for legislative purposes.
- 3.18 A provision in the 2004 Regulations (first introduced via an amendment to previous qualifications regulations in 2002) allows for qualification as a teacher by certain independent school or further education teachers who gained qualifications before 1974, or 1989 in certain subjects. This option has been available in Wales now for some 9 years (England's equivalent provision ended in 2004), and the number who have made use of it is small. Given the length of time now since the specified courses were completed (over 20 years or more ago), and the period this option has been available, we do not propose to continue with this provision in the updated regulations.

4. What specific changes are we proposing?

4.1 The main changes from the 2004 Regulations being proposed are in the QTS requirements, set out in Schedule 2 to the 2004 Regulations. Schedule 2 sets out the requirements to be met by persons to be recognised as qualified teachers in Wales – effectively, the categories of persons who would be so recognised.

Teachers qualifying in Wales: curriculum provision in schools used by ITT providers

- 4.2 In order to gain QTS through ITT courses in Wales, Schedule 2 in the 2004 Regulations says that persons must:-
 - (a) Hold a first degree or equivalent qualification granted by a United Kingdom institution or an equivalent degree or other qualification granted by a foreign institution.
 - (b) Have successfully completed a course of initial teacher training at an accredited institution in Wales.
 - (c) In respect only of persons who commence a course of initial teacher training on or after 1 September 2008 have undertaken any period of practical teaching experience for the purposes of that course of initial teacher training wholly or mainly in a school, independent school or other institution (except a pupil referral unit) in Wales.
 - (d) Are assessed by the accredited institution as meeting the specified standards.
- 4.3 In the replacement regulations, we are proposing that the equivalent of subparagraph (c) above would require that the period of practical teaching experience for those qualifying as a teacher on ITT courses in Wales would need to be undertaken wholly or mainly in a school or other educational institution (except a pupil referral unit) in Wales which met the curriculum requirements for the Foundation Phase and Key Stages 2, 3 and 4. The extent to which these would need to be met would be appropriate to the age range of learners at the school.
- 4.4 For the avoidance of doubt, this would not mean that the entire period of practical teaching experience had to be in schools or other educational institutions which met the national curriculum requirements, as it is recognised that this would not necessarily be required for all training designed to enable trainee teachers to demonstrate that they have met the Qualified Teacher Status Standards. The requirement would be that, for the overall total period of practical teaching experience, the majority would have had to have been in schools or other educational institutions (except for pupil referral units) which met the national curriculum requirements.
- 4.5 We would like to know if you agree with the proposal outlined at paragraph 4.3.

Teachers qualifying in England

- 4.6 Schedule 2 in the 2004 Regulations includes "persons who are qualified teachers by virtue of Regulations made in relation to England and from time to time in force under section 132 of the Education Act 2002" (paragraph 3). This blanket recognition of all those who gain QTS under qualification regulations in England would end. Instead there would be provisions which meant that only the following specific categories of persons qualifying as a teacher in England under qualification regulations in force in relation to England would be recognised as a qualified teacher in Wales:-
 - (i) Persons qualifying as a teacher in England through an initial teacher training course at an accredited institution there.
 - (ii) Persons qualifying as a teacher in England after being assessed as meeting the specified standards and having experience as teachers, but without having undertaken a specific ITT course (known as the Assessment Only route).
 - (iii) Persons qualifying as a teacher in England who complete successfully a period of training on an employment-based teacher training scheme there.
- 4.7 We would like to know if you agree with the proposal outlined at paragraph 4.6.

Teachers qualifying in Scotland or Northern Ireland

- 4.8 For those who could be qualified teachers in Wales by virtue of their recognition as a teacher in Scotland or Northern Ireland, we propose to additionally require that they have undertaken a period of practical teaching experience at an educational institution in either Scotland or Northern Ireland. For teachers in Scotland, this would be via a requirement (in line with provision there) that they have gained full registration with the General Teaching Council for Scotland (GTCS), which normally requires completion of a period of probationary service of 60 days working in a school in that country. For those registered in Northern Ireland we propose placing a similar requirement of having to have worked 60 days in an educational institution in that country.
- 4.9 For the avoidance of doubt, the 60 day period is not intended to provide a demonstration of proficiency for teaching purposes in schools in Wales, but to prevent overseas trained teachers with no teaching experience in Britain from gaining QTS by registering in Scotland or Northern Ireland.
- 4.10 For those who could be qualified teachers by virtue of their recognition as teachers in schools in Northern Ireland, we now propose to refer to registration with the GTCNI, rather than recognition as teachers in Northern Ireland by the Department of Education, Northern Ireland Office.
- 4.11 We would like to know if you agree with the proposals outlined at paragraphs 4.8 and 4.10.

Recognition as qualified teachers: independent schools and further education teachers

- 4.12 We are proposing that the provision in the 2004 Regulations for qualification as a teacher by specified teachers in independent schools or specified further education teachers employed at further education institutions or as instructors at schools would not be included in the replacement regulations.
- 4.13 We would like to know if you agree with the proposal outlined at paragraph 4.12

Other changes

- 4.14 A number of miscellaneous changes would be made compared to the 2004 Regulations in order to update and clarify the legislation. These would include introducing references to the Welsh Ministers, rather than the National Assembly, to take account of the changes made by the Government of Wales Act 2006.
- 4.15 Although large parts of the measures introduced in the 2004 Regulations would remain in place, we are proposing to replace the 2004 Regulations completely with a new set of Regulations for ease of use. The 2004 Regulations have been amended three times already, and we think a further set of amending legislation would make for too many complications in trying to establish which parts of the legislation are current.

Annex 1: Provisions for further education teachers to deliver vocational courses in maintained schools within the local curriculum

- 1. The Education (Specified Work and Registration) (Wales) Regulations 2010 allows qualified further education teachers to deliver vocational courses in maintained schools within the local curriculum under the Learning and Skills (Wales) Measure 2009. A local curriculum is one which has been formed by a local authority under section 116A of the Education Act 2002 (for 14 to 16 year olds); or by the Welsh Ministers under section 33A of the Learning and Skills Act 2000 (for 16 to 18 year olds). Essentially, this provision allows qualified further education teachers to undertake aspects of further education teaching in relation to vocational courses within a maintained school.
- 2. The further education teaching qualifications needed under this provision of the 2010 Specified Work Regulations are those required by the Further Education Teachers' Qualifications (Wales) Regulations 2002 ("the 2002 Regulations"). These qualifications include:-
 - Qualifications gained through further education teacher training courses in Wales meeting specified standards.
 - Qualifications required in England (including a Diploma in Teaching in the Lifelong Learning Sector, which someone who gains QTLS must have already achieved).
 - Relevant qualifications gained in the European Economic Area or Switzerland.

Details are set out below.

- 3. The 2002 Regulations impose requirements on certain persons employed as teachers in institutions in the further education sector in Wales after 1 July 2002 to have, or to be working toward, relevant teaching qualifications. The principal present qualification, depending on the post being held, is a stage 1, stage 2 or stage 3 further education teaching qualification, the standards for which are specified by the Welsh Ministers. Other acceptable qualifications which are set out in the 2002 Regulations are Qualified Teacher Status, or a Certificate of Education awarded prior to 1 August 2002.
- 4. The qualifications available in Wales are usually a Certificate in Education (Post-compulsory Education and Training) or a PGCE(FE) at either Professional Graduate Certificate in Education or Post-Graduate Certificate in Education level. The Professional Standards for Teachers, Tutors and Trainers in the Lifelong Learning Sector in Wales published by Lifelong Learning UK were specified by the Welsh Ministers as the standards for the purpose of the 2002 Regulations in June 2008.
- 5. The 2002 Regulations also include as acceptable further education qualifications ones that are equivalent to a stage 1, stage 2 or stage 3 further education teaching qualification. Under the 2002 Regulations, another FE

qualification is 'equivalent' if it appears to the Welsh Ministers to be of equivalent standard to, or higher standard than, those qualifications and if it is specified by the Welsh Ministers for the purpose of the 2002 Regulations.

- 6. The Welsh Ministers have specified for the purpose of the 2002 Regulations that the following qualifications are an equivalent standard to a stage 1, stage 2 or stage 3 further education teaching qualification in Wales, as appropriate:-
 - Qualifications obtained at a higher education institution in Wales between 1 July 2002 and 31 July 2008 for a Certificate in Education, a Professional Graduate Certificate in Education or Post Graduate Certificate in Education in relation to post-compulsory education and training or further education teaching.
 - A qualification which met the requirements of the Further Education Teachers' Qualifications (England) Regulations 2001 for a stage 1, stage 2 or stage 3 further education teaching qualification.
 - A Certificate in Teaching in the Lifelong Learning Sector (CTLLS) or a Diploma in Teaching in the Lifelong Learning Sector (DTLLS) which meet the requirements of the Further Education Teachers' Qualifications (England) Regulations 2007.
 - relevant qualifications recognised in accordance with the provisions of the European Communities (Recognition of Professional Qualifications)
 Regulations 2007 – these cover the position of further education teacher qualifications gained in the European Economic Area or Switzerland.
