# User Consultation of Statistical Publications – School Destinations of Secondary School Pupils Resident in London Boroughs

#### **Introduction and Summary**

The Department for Education (DfE) aims to keep its statistics relevant and useful. In Autumn 2010 the DfE sought feedback from users of the 'School Destinations of Secondary School Pupils Resident in London Boroughs' statistical bulletin to get their feedback on the publication.

The user questionnaire was publicised in the Information about Children, Education and Schools (ICES) Bulletin in October 2010. The ICES bulletin keeps Local Authorities and their schools, academies and other partners updated on data collections and data related developments and events. The questionnaire was also publicised on the RS gateway and advertised to users of the Departments Statistical publications who had registered an interest in participating in DfE consultations.

In total there were 30 respondents to the survey, of which 4 completed the whole survey. A large proportion (22) of the people who took part in the survey use the publication for work purposes. We also received responses from people using the publication for studies and people using it for personal interest. Of those using the publication for work purposes the majority (15) work in Local Government, whilst there were also responses from central government, academia and a government agency. We would like to thank all individuals who participated in the survey.

#### Recommendations

We are concerned that the low response rate is an indication that the publication is of interest to a niche audience and that meeting this requirement may not be the most effective use of our resources. With this in mind the recommended course of action is to consult with users to assess the impact of dropping the publication from the schedule on a permanent basis.

A summary of the feedback survey results can be found below.

#### **Summary of key points**

- 1. The publication has a specialist rather than a mainstream audience and they use the publication infrequently over the year.
- 2. The results from the feedback make it difficult to assess how widely used the publication is. 30 people took part in the survey but only a very small number 4 completed the full survey. Admittedly, this may be because the questionnaire contained too many questions.
- 3. The publication is used primarily for the information on the cross border movement of pupils and to school place planning by local authorities. The publication is also used by a wider audience.

- 4. Users find the publication easy to read with the level of detail pitched at the right level for the audience, and the majority do not think it too technical.
- 5. Users use the Excel tables, LA summary and commentary, with the most popular areas of the publication being the destination of pupils/cross border movement, and pupil inflows/outflows to and from Local Authorities.
- 6. As expected, users from Local Authorities are interested in the destination of pupils, inflows and outflows and pupil retention from year 6 to year 7, all of which support their school place planning activities.
- 7. The information about where pupils live and go to school is the most popular information in the publication. The new information added for the first time in the last edition of the publication was less popular. This information was brand new at the time of the consultation so it may be too early to form conclusions about the usefulness of tables only added this year.
- 8. Users did not identify any additional information, not already in the publication, that they would like to see included in the publication, nor did they identify anything in particular they would like to change. Users confirmed that the publications format and timing meets their needs.
- 9. The responses indicate that users prefer to consume the information in the publication in tables and text rather than in maps. However, the low response rate makes it hard to form definite conclusions about the effectiveness of any of the different ways of making the information available.
- 10. It was too early to form any conclusions about the usefulness of the underlying data. It had only been used by one of the respondents at the time of the consultation. It should be noted that the underlying data was published after the main publication, just before the user consultation began.

# **Background - The School Destinations of Secondary School Pupils Resident in London Boroughs Statistical Bulletin**

The Department has published this Statistical Bulletin on an annual basis since 2005. Its main purpose is to bring together and make available to a wider audience, including London Local Authorities, a single comprehensive picture of the secondary school destinations of pupils across London using data collected in the School Census. It contains information about the pupils living and / or attending maintained secondary schools (including middle deemed), City Technology Colleges and Academies in London.

The scope and content of the bulletin has changed over time to reflect developments in the scope of the DfE data collection programme and user interests. Notable examples include;

2006 - The publication of a cross-border matrix showing movement within and across local authorities (Tables 2 and 2a in the latest bulletin).

#### 2008 - The publication of information about

- i. pupil inflows and outflows by school characteristics (Tables 3 and 4 in the latest bulletin).
- ii. pupil movement at the transition between year 6 and year 7 (Table 6 in the latest bulletin),
- iii. distance travelled and mode of travel (Tables 7, 7a and 9 and 9a in the latest bulletin), and

2010 – The publication of Information about cross border movement, distance travelled and mode of travel by pupil and school characteristics (Tables 10 – 18 in the latest bulletin).






### 1. How often do you use the publication?

### 2. For what reasons(s) do you use the publication?




## 3. Do you find the publication easy to read?


# 4. Do you consider the material too technical?


#### 5. Do you use the written commentary?














