Executive Summary

This document provides guidance to local authorities on the preparation of a funding and expenditure statement, showing their spending of the Agency's allocations of ASL and associated funding for the contract year ending 31 July 2012. In addition, the funding statement will also identify how much unspent funding the Agency could recover. The statement is at Annex A to this document and is for completion and return to the relevant Skills Funding Agency office by **28 September 2012**.

The local authority's Chief Finance Officer must sign Annex A.

ASL includes Personal and Community Development Learning (PCDL), Family, Literacy, Language and Numeracy (FLLN), Wider Family Learning (WFL) and Neighbourhood Learning in Deprived Communities (NLDC). In addition to ASL the Safeguard, Formal First Step (FFS) should also be included on this statement.

The local authority's Chief Finance Officer must sign Annex A. The local authority should then return it to their Relationship Manager at the relevant Skills Funding Agency office by **28 September 2012**. The statement should be either a signed original or a copy with original signatures.

The document does not apply to other organisations, including further education colleges that are receiving direct funding from the Agency for adult learning provision, or those providers under contract to local authorities, including colleges. Different arrangements apply to these organisations.

Funding and Expenditure Statement for Adult Safeguarded Learning and Associated Funding for 2011/12

Section 1: Introduction

- Local authorities are required to provide information to the Agency on funding income and expenditure for ASL and associated funds allocated to them annually. Accordingly, local authorities should have in place financial systems that allow the identification of all costs and expenditure relating to the use of these funds.
- 2 The following organisations are not covered by this document:
 - former external institutions that are commercial or voluntary sector learning providers
 - colleges incorporated under the Further and Higher Education Act 1992
 - other Agency-funded providers of further education that are not colleges.

Section 2: Statement of Funding and Expenditure of Skills Funding Agency Funds

Introduction

- Annex A is a table which is to be completed to show the local authority's expenditure of the ASL and associated funding for the academic year 1 August 2011 to 31 July 2012. The columns on this table record:
 - Column 2: Skills Funding Agency 2011/12 allocation

Funding and Expenditure Statement for Adult Safeguarded Learning and Associated Funding for 2011/12

- Column 3: the local authority's expenditure during the year to 31 July 2012
- Column 4: where applicable, cash to be recovered.

The Agency will require the balance of funding not spent at 31 July 2012 to be recovered. Funding cannot be carried forward from the previous year.

7 Claims submitted to the Agency should be either signed originals or copies bearing an original signature.

Responsible officers

The local authority's Chief Finance Officer (designated officer under section 151 of the Local Government Act 1972) is required to sign the declarations at Annex A.

- 9 By **28 September 2012**, local authority Chief Finance Officers should send the fully completed Annex A to their relationship manager at the relevant Agency office.
- 10 The Agency reserves the right to stop funding payments where there is a failure to follow this submission timetable.
