Consultation Document

Introduction

- 1. The General Teaching Council for Northern Ireland (GTCNI) is a statutory, regulatory professional body, established by the *Education (Northern Ireland) Order* 1998 (as amended) (the 1998 Order). Under the 1998 Order, the GTCNI is responsible for:
 - the registration of teachers:
 - the development of a code of professional values and practice for the profession; and
 - the provision of advice to the Department of Education (DE) and employing authorities, on the training, career development and performance management of teachers, standards of teaching, registration issues, standards of conduct for teachers.
- 2. The GTCNI has a statutory duty to determine who should be a member of the teaching profession in Northern Ireland. The 1998 Order authorises the GTCNI to establish and maintain a Register of Teachers. Registration is required for all teachers who wish to be employed in grant-aided schools, including peripatetic teachers and those in substitute/temporary positions; employing authorities are required to ensure that they only employ teachers who are registered with the GTCNI.
- 3. The onus for regulating teaching staff in the Further Education (FE) sector is on the Department for Employment and Learning (DEL). The regulatory powers are set out in the Further Education Teachers (Eligibility) Regulations (Northern Ireland) 2007 (as amended).

Rationale for change

- 4. The GTCNI does not currently hold the complete spectrum of legislative powers, which are necessary to enable the Council to regulate the teaching profession, in an independent manner. The original stated aim of Government, when consulting on the establishment of the GTCNI in 1997, was to give the Council maximum autonomy in discharging its functions within the parameters set by legislation. The Council argues that its authority, in the eyes of teachers, other education bodies and the public, will be eroded if the Council is not fully independent of Government.
- 5. The disciplinary powers of the GTCNI, as provided for by the 1998 Order (as amended), provide only for the removal of teachers from the register for misconduct or serious professional incompetence. The Council has no powers to sanction disciplinary orders short of prohibition from teaching. In recognition of the need to extend the Council's disciplinary powers in this manner, amendments were consulted on and included in the Education Bill presented to the previous Assembly mandate. A new Education Bill is being taken forward without the GTCNI provisions and it is therefore necessary to accommodate the amendments under a bespoke GTCNI Bill.

- 6. While DEL is responsible for the regulation of the FE sector, the current legislation provides only for the setting of qualification requirements and the ability to restrict or prohibit employment on health or misconduct grounds. The current powers do not enable the FE sector to be independently regulated.
- 7. The increasing synergy between the two sectors to deliver the Entitlement Framework reinforces the need for a similar level of consistent, independent regulation across both workforces. DE and DEL believe that parents and the wider public are entitled to reassurance that all of those employed within the teaching professions, whether schools or institutions of further education, are subject to appropriate independent regulation and aspire to the highest professional standards.
- 8. Given the size of Northern Ireland and prevailing economic conditions, the creation of a separate body to regulate FE lecturers is not deemed to be either appropriate or justifiable, from a value for money perspective. The need for an autonomous body, which operates independently from government and has the appropriate powers to regulate all those employed in the teaching profession, is deemed to be both necessary and timely. This will play a vital role in delivering the Departments' key agenda, to improve quality and raise standards through the teaching/ lecturing profession.

Proposal under consultation

9. It is proposed that the existing GTCNI legislation under the 1998 Order (as amended) be repealed and replaced with a GTCNI bill, with the aim of providing independent status for the Council; the extension of its remit to include the registration of FE lecturers as a separate, distinct staff grouping in its own right; and the widening of its disciplinary powers to include disciplinary orders short of prohibition from teaching. As an independent, self funded body, the Council will charge annual registration fees.

Powers

- 10. In order to secure the GTCNI's future operation as a fully independent regulator for both the schools and the FE sectors, it will be necessary to amend elements of the current legislation.
- 11. Currently, the GTCNI has the power to:
 - establish and maintain an annual register of teachers in relation to grant-aided schools and peripatetic teachers;
 - provide advice to DE and employing authorities on the training, career development and performance management of teachers; standards of teaching; and standards of conduct for teachers;

- determine the qualification requirements for teachers; and
- set its fee rate for registration of school teachers (subject to prior consultation with DE).

Through this consultation, it is proposed to extend all these powers to the FE sector.

- 12. Additionally, it is proposed to amend the existing GTCNI legislation to:
 - provide for the Council to investigate cases of misconduct, criminal conviction, serious professional incompetence amongst school teachers and FE lecturers, and to make disciplinary orders as appropriate; and
 - provide for the independent status, associated constitution and operation of the Council.

Equality Impact Assessment

13. In line with the requirements of its Departmental Equality Scheme, DEL has conducted a Preliminary Equality Impact Assessment (PEQIA) on the proposals set out in this consultation document. As a result of this exercise, a full Equality Impact Assessment is not deemed necessary.
