## Key findings

There were 176 recognised awarding organisations operating across England, Wales and Northern Ireland between April and June 2012. During this period, the Register of Regulated Qualifications<sup>1</sup> held 17,331 regulated qualifications that were available for certification.

# Regulated qualifications (excluding GCSEs, GCEs and the Diploma and its components)

There were 60,828 achievements awarded in Northern Ireland, covering 1,327 individual qualifications offered by 73 different awarding organisations.

The awarding organisation with the most achievements was City & Guilds with 20,125 (33 per cent of achievements during April to June 2012).

The qualification with the greatest number of achievements in Northern Ireland in other regulated qualifications was the City & Guilds Level 2 Certificate in Essential Skills – Application of Number with 2,753 achievements.

The type of qualification with the most achievements was the Qualifications and Credit Framework (QCF) with 36,478 (representing 60 per cent of total achievements).

The sector subject area with the most achievements was preparation for life and work with 17,493 (representing 29 per cent of the total).

The level of qualification with the most achievements was level 2, which awarded 30,709 achievements (representing 50 per cent of the total in Northern Ireland).

#### **Qualifications and Credit Framework qualifications**

There were 36,478 QCF achievements awarded in Northern Ireland, covering 934 individual QCF qualifications offered by 62 different awarding organisations.

The QCF qualification with the most achievements in Northern Ireland was the Chartered Institute in Environmental Health (CIEH) Level 2 Award in Food Safety in Catering with 2,488 achievements. The awarding organisation with the most achievements was again City & Guilds with 5,944 achievements (16 per cent of achievements in QCF qualifications during April to June 2012).

The sector subject area with the most achievements in QCF qualifications was arts, media and publishing with 11,575 (representing 32 per cent of the total QCF achievements).

The level with the most achievements was level 2, which awarded 18,773 achievements (51 per cent of the total QCF achievements).

## Introduction

This Northern Ireland Qualifications Quarterly bulletin is published jointly by the Office of Qualifications and Examinations Regulation (Ofqual) and the Council for the Curriculum, Examinations and Assessment (CCEA). In this bulletin we present achievements for all regulated qualifications in Northern Ireland (excluding GCSEs, GCEs<sup>2</sup> and the Diploma and its components,) for the quarter April to June 2012. For the purposes of this bulletin, these qualifications are termed regulated qualifications and include qualifications regulated by Ofqual and by CCEA.<sup>3</sup>

Each quarter awarding organisations submit data to Ofqual on the number of achievements for regulated qualifications (excluding GCSEs and GCEs) during the quarter. For Northern Ireland, we also collect this data on behalf of CCEA. Achievements are recorded in the quarter during which the final certificates are issued. This bulletin presents this data, giving information on the number of achievements recorded by awarding organisations, the sector subject area, qualification types and the level of achievements. All regulated qualifications are included, regardless of age of student, centre type and funding status of the qualification.

#### **Geographical coverage**

This bulletin covers the achievements in regulated qualifications of all awarding organisations recognised by Ofqual and/or CCEA for Northern Ireland. There are four such awarding organisations based in Ireland. These are CCEA, Engineering Training Council Awards Limited (ETCAL), Open College Network Northern Ireland (OCNNI) and Accounting Technicians Ireland (ATI).

The remaining awarding organisations recognised by Ofqual and/or CCEA to award qualifications in Northern Ireland have their headquarters elsewhere. This bulletin is the second quarterly edition.

#### **Qualification type**

At the point of accreditation, regulated qualifications are classified into 18 qualification types. We recognise that the classification system is not ideal, as very similar qualifications may appear under different types, for example NVQs and the QCF, and some qualifications are miscoded. We are working with experts to investigate how this situation might be improved in the future. This bulletin presents figures on all types of qualification, except GCSEs, GCEs and the Diploma.

This bulletin begins by presenting an overview of achievements during April to June 2012 in Northern Ireland by qualification, awarding organisation, sector subject area and level. Due to the size of the QCF, there is then further analysis of qualifications of this type in Northern Ireland.

#### Revisions

Once published, data on the number of achievements for any qualification is not usually subject to revision. However, data may be revised in subsequent bulletins due to data received late or if an error is identified. Qualifications may also be recategorised to a different type, level, sector subject area or awarding organisation. In some cases, this may result in previous data being amended to reflect the new categorisation.

#### **Completeness of the data**

Data is sent to Ofqual every quarter by each awarding organisation. Any awarding organisation that does not return a complete set of data within the collection period is contacted to ensure that the data is as complete as possible. For this quarter we received data from all awarding organisations and each organisation submitted data on achievements awarded in Northern Ireland.

Due to seasonal variation in the number of achievements over the year, it is only possible to make comparisons with data in the same quarter of the previous year. The collection of country-level data was introduced at the beginning of 2011, with a complete data set being achieved for the first time at the beginning of 2012, so currently it is not possible to make such comparisons.

#### Definitions

Some of the key terms used in this bulletin are defined as follows:

- Accreditation a process that reviews and confirms achievement to specific criteria and standards.
- Achievement any award that is not graded as U, Absent or X

- Available qualification a qualification eligible for an award
- Awarding organisation organisations recognised to develop, deliver and award descriptions of qualifications.
- Active qualification a qualification eligible for award to students, even if the qualification is no longer available for enrolment
- Certification a formal acknowledgement of student achievement
- Recognition an evidence-based process of achieving compliance with the criteria for recognition.

In this bulletin 'quarter' refers to calendar quarters. So quarter 1 (Q1) refers to January to March, quarter 2 (Q2) to April to June, quarter 3 (Q3) to July to September, and quarter 4 (Q4) to October to December.

We are continually striving to improve the quality and coverage of information in these quarterly updates, and we welcome any suggestions or comments regarding this bulletin. Our contact details are at the end of this document.

## Achievements this quarter

At the point of accreditation, all regulated qualifications are classified into 18 qualification types, including GCSE, GCE and Diploma types (see glossary<sup>4</sup> for a full listing).

There were 60,828 achievements awarded in Northern Ireland during April to June 2012 for all qualification types except GCSE, GCE and the Diploma. This number represents 4 per cent of all achievements awarded across England, Wales and Northern Ireland in the same period (see figure 1).




Figure 2: Achievements in Northern Ireland by qualification type, April to June 2012

From Figure 1 above and figure 2 below, we can see that QCF qualifications dominate in Northern Ireland (60 per cent), and in England, Wales and Northern Ireland (59 per cent). The second most frequently awarded type of qualification was key skills, with 12,093 achievements, representing 20 per cent of all achievements in Northern Ireland.

Key skills and other general qualifications have a greater percentage of the achievements in Northern Ireland than they do in England, Wales and Northern Ireland. In contrast, across the three countries vocationally related, basic skills and functional skills qualifications have a greater proportion of the achievements than they do in Northern Ireland alone.

The qualification with the greatest number of achievements was the City & Guilds Level 2 Certificate in Essential Skills – Application of Number (2,753). Seven of the top ten qualifications were Essential Skills qualifications. Table 2 in the appendix shows the 40 qualifications with the greatest number of achievements.

#### Awarding organisations

In April to June 2012 there were 17,331 available qualifications (excluding GCSEs, GCEs and the Diploma) in England, Wales and Northern Ireland, offered by 164 awarding organisations.

In Northern Ireland, there were 73 organisations awarding achievements across 1,327 qualifications.


**Figure 4:** The 20 awarding organisations with the most achievements across all qualification types (excluding GCSEs, GCEs and the Diploma) for Northern Ireland, April to June 2012

The organisation awarding the most achievements in Northern Ireland during April to June 2012 was City & Guilds with 20,125 (33 per cent of all achievements in Northern Ireland). See figures 4 and 5.



There are several awarding organisations whose levels of achievements differ significantly between Northern Ireland and England, Wales and Northern Ireland. CCEA (the awarding organisation with the second greatest number of achievements in Northern Ireland) is ranked 35<sup>th</sup> in the three-country totals and the New Era Academy of Drama and Music (12<sup>th</sup> in Northern Ireland) is outside the top 50 awarding organisations for all three countries combined. Four awarding organisations with a lesser presence in Northern Ireland than in England, Wales and Northern Ireland, are University of Cambridge ESOL Examinations, Sports Leaders UK, Excellence, Achievement & Learning Limited and LAMDA Examinations.

Figure 5 shows the percentage share of the achievements of the top ten awarding organisations compared with all other awarding organisations.






#### Sector subject area

Regulated qualifications are allocated to one of 15 sector subject area codes (see  $glossary^5$  for further details).

The sector subject area that awarded the greatest number of achievements in Northern Ireland during April to June 2012 was preparation for life and work with 17,493. This represents 29 per cent of all achievements in Northern Ireland in the period. Second was arts, media and publishing with 11,665 achievements, representing 19 per cent of all achievements (see figure 6). Full details of the number of achievements for each sector subject area are given in table 4 in the appendix.

#### Level of qualification

All regulated qualifications are assigned a level, ranging from entry, then 1 to 8 (see glossary<sup>6</sup> for full details).




Figure 7: Achievements in Northern Ireland by level, April to June 2012

In Northern Ireland, level 2 saw the greatest proportion of achievements with 30,709 in April to June 2012, representing 50 per cent of achievements (see figure 7). Full details of the number of achievements for each level are given in table 5 in the appendix.

# Qualifications and Credit Framework in Northern Ireland

Please note: these figures refer to full qualifications, not units.

The QCF is a credit-based framework that enables students to accumulate and transfer credit towards a regulated qualification. It is designed to provide students, learning providers and employers with an inclusive and flexible regulated qualifications framework, containing units and qualifications that recognise the widest possible range of quality-assured student achievements. The QCF introduces a standard currency for student achievement across the qualifications systems through the award of credits. One credit is equivalent to ten hours of learning. There are three sizes of QCF qualification: award, certificate and diploma. Awards consist of 1 to 12 credits, certificates 13 to 36 credits and diplomas 37 credits or more.

In April to June 2012, 36,478 QCF achievements were recorded at all levels in Northern Ireland. The QCF achievements covered 934 different qualifications, offered by 62 awarding organisations. In April to June 2012, achievements in QCF qualifications represented 60 per cent of the achievements in regulated qualifications in Northern Ireland.


The QCF qualification with the greatest number of achievements was the CIEH Level 2 Award in Food Safety in Catering, with 2,488. The 20 QCF qualifications with the greatest number of achievements are shown in figure 8 below. The top 40 QCF qualifications are detailed in table 6 in the appendix.

The awarding organisation that recorded the greatest number of achievements for the QCF in Northern Ireland was City & Guilds with 5,944 (16 per cent of all QCF achievements).



The sector subject area with the most achievements in the QCF was arts, media and publishing with 11,575 (representing 32 per cent of QCF achievements in April to June 2012). This area had the second greatest number of achievements for all regulated qualifications. The next area with next highest number of achievements was retail and commercial enterprise with 8,354 (representing 23 per cent of QCF achievements (see figure 10)). This sector subject area had the third highest number of achievements for all regulated qualifications. Full details of the number of achievements for each sector subject area are in table 8 in the appendix.




Figure 11: QCF achievements in Northern Ireland by level, April to June 2012
