

# Project Development Fund Application Guidance

December 2012

Of interest to further education colleges

#### 1.0 Introduction

1.1 The Autumn Statement 2012 confirms that £270 million of additional capital funding has been made available for FE college capital in 2013-14. This will supplement the existing £280 million in 2014-15. The *FE College Capital Investment Strategy* (CIS)(December 2012) outlines the Government's capital investment plans for the remainder of this Parliament, sets out key priorities, an outline delivery plan and announces the creation of the College Capital Investment Fund (CCIF). The Agency will continue to work with the Department to secure additional capital funding in the next Spending Review period.

1.2 Colleges play a vital role in the delivery of the skills needed to support economic growth and personal wellbeing. Government wants to help the FE college sector achieve the position where all colleges operate with estate which is in at least 'Good' condition, which is fit for purpose, and is versatile enough to efficiently accommodate changes in curriculum, social and economic needs and/ or educational delivery.

## 2.0 Project Development Fund

2.1 A key component of the CIS is the creation of a Project Development
Fund (PDF) for allocation between the end of December 2012 and March
2013. In particular, funding is available to assist colleges with the
implementation of their property strategies and in developing capital projects
that can benefit from the CCIF. This fund will:

- make some funding available to colleges identified as in the greatest need, through a simple formula allocation
- provide colleges with sufficient capital resources to obtain professional help to develop strategic capital projects

 create a 'pipeline' of potential projects, some of which are capable of benefiting from Agency capital grant. CCIF funding will be available on a competitive basis for projects that can be implemented and operational by September 2015. However, PDF funding may be used for developing projects capable of implementation through selffinancing opportunities or any further capital grants announced by the Government.

2.2 To maximise the benefit of public funds, colleges will be required to demonstrate that they have a robust and deliverable property strategy which is driven by the strategic requirements of the institution and Government policy. Strategies should be capable of being implemented in phases to minimise exposure to risk and take account of self-funding opportunities and availability of capital grant.

2.3 This fund aims to encourage colleges that might otherwise be reluctant to develop robust capital projects and applications by offering limited grant funding at an early stage in the capital process, thereby reducing the financial burden on colleges wishing to prepare strong capital proposals.

2.4 The Project Development Fund will be available to cover colleges' external professional costs incurred in developing capital strategies, projects and/or applications for funding support. Examples of eligible spend include:

- preparation of capital strategies which are under-pinned and driven by the strategic requirements of the college, including robust option appraisals with realistic delivery/implementation plans
- undertaking specialist surveys (for example asbestos, services, building condition and structural surveys) required to develop a capital project

- professional fees for preparing a feasibility study to assess options identified in the property strategy
- professional fees for developing a capital project design team, cost consultants, town planning and procurement
- any external costs of developing a capital application for submission to the Agency for grant support, including updating of ERG3 applications and/or preparing Expressions of Interest
- improving the value for money of the bid.

## 3.0 Eligibility

3.1 All colleges with 20 per cent or over of their estate in poor and/or inoperable building condition will be eligible for support through the Project Development Fund. As per the Renewal Grant approach, the latest eMandate returns, based on 2010/11 data, will be used as a base line; colleges that have not submitted an eMandate return can make a case to the Agency for inclusion. Annex A lists the colleges that have estates that fall into this category, based on their 2010/11 eMandate returns.

3.2 Colleges with less than 20 per cent of their estate in poor and/or inoperable building condition will have the opportunity to apply to the Project Development Fund if they have an individual campus with in excess of 20 per cent of the accommodation in poor/inoperable condition (this could be particularly beneficial to merged colleges where one site or campus is in need of urgent attention).

## 4.0 **Project Development Fund Allocation Arrangements**

4.1 Eligible colleges will receive an allocation of £110,000 (or less if requested).

4.2 Colleges will normally be expected to make a 50 per cent contribution towards the professional project development fees (that is 50 per cent Agency funding and 50 per cent college funding). Colleges will be able to submit a financial case to the Agency to justify a higher proportion of funding which will be considered on its merits<sup>1</sup>.

4.3 Colleges will need to complete an <u>Acknowledgement Form</u> (similar to that of the Renewal Grant acknowledgement form). On the form the college will need to state:

- > the amount of Project Development funding requested
- > a description of the work to be undertaken
- confirmation that costs will be incurred in sufficient time for funding in 2012-13
- that the target date for operational completion of any subsequent development that is to be part of an Expression of Interest or detailed application to CCIF is expected to be September 2015
- that, as at 1 August 2012, the college's estate condition remained in the eligible category - colleges will be required to confirm that at least 20 per cent of their estate remained in condition category C and/or D for the start of the 2012/13 academic year.

4.4 As part of this confirmation, colleges must provide an expenditure plan setting out how they intend to apply the stage 1 funds in the period to the end of March 2013.

4.5 Colleges requesting the funding on the basis of having an unimproved site acquired through merger (since April 2001) which has more than 20 per

cent of its estate in poor condition will need to complete the acknowledgement form, also confirming the basis of the request for funding.

4.6 The Agency has a policy of prioritising its capital investment in those colleges which have appropriate estate management systems in place to help facilitate the effective running of the estate; the Agency would normally expect an appropriate estate management benchmarking system such as eMandate to be utilised by colleges wanting to apply for capital grant support.

4.7 The <u>Acknowledgement Form</u> is included at Annex 2 and is available on the Agency's website. The form needs to be returned to the Agency by 31 January 2013. Instructions for submission are included on the form itself.

4.8 Colleges will be required to submit, to the Agency, a use of funds statement by 31 August 2013 to confirm the amount of Project Development Fund spent and the outputs achieved.

4.9 The Agency may make a second tranche of Project Development Funding available to those colleges that submit successful Expressions of to CCIF. Further information will be provided on this early in 2013.

4.10 The Agency will require that colleges' financial statements provided by their auditors, as part of the normal regularity audit opinion, contain confirmation that the PDF funds have been used for the intended purposes.

4.11 Colleges receiving a PDF allocation must have complied with all reporting requirements for previous Skills Funding Agency and/or Learning and Skills Council capital grant support (including post project reviews, use of funds statements/final cost reconciliations etc). PDF allocations will not be released to colleges where such information is outstanding.

4.12 Project Development Support Grant is only available for eligible costs incurred after 6 December 2012.

4.13 Colleges will have to confirm that the funding will be used in accordance with the above conditions and that funding from the Agency can be spent by 31 July 2013. The Agency will reserve the right to claw-back any funds that have not been used in accordance with these criteria.

#### Annex 1

**Project Development Fund** 

Colleges that have provided 2010/11 eMandate data indicating that they have estates with at least 20 per cent in eMandate condition categories C and D.

Note: Eligible colleges will need to confirm that at least 20 per cent of their estate remained in Emandate condition category C and/or D for the start of the 2012/13 academic year.
