Key findings

Latest inspection outcome

- At 31 December 2012, there were 381 colleges which had received an Ofsted inspection and were in receipt of funding¹. Three per cent of the 381 colleges were inadequate for overall effectiveness at their latest inspection. A further 68% were either good or outstanding for overall effectiveness. The remaining 29% were judged satisfactory or to require improvement at their most recent inspection².
- Variations exist amongst outcomes for different types of college: 37% of sixth form colleges were judged outstanding for overall effectiveness at their most recent inspection, compared to 17% of general further education college/tertiary colleges and 13% of independent specialist colleges. Independent specialist colleges also had the highest proportion of inadequate providers, with 4% inadequate compared to 3% of general further education college/tertiary colleges.
- At 31 December 2012, there were 427 independent learning providers which had received an Ofsted inspection and were in receipt of funding. Of these, 12% were outstanding for overall effectiveness at their most recent inspection and 53% were good. A further 31% were judged to be satisfactory or to require improvement, and 3% were found to be inadequate.
- At 31 December 2012, there were 253 community learning and skills providers which had received an Ofsted inspection and were in receipt of funding. Although a high proportion, 71%, of community learning and skills providers are good or outstanding, only 6% are outstanding. A further 27% of community learning and skills providers were judged satisfactory or found to require improvement. Community learning and skills providers have the lowest proportion of inadequate providers at 2%.

Inspection year 1 September 2012 to 31 December 2012

From 1 September 2012 Ofsted has been inspecting against a new common inspection framework. In the inspection year between 1 September 2012 and 31 December 2012, there have been 143 inspections of learning and skills providers. This included 33 inspections of colleges, 67 inspections of independent learning providers, 38 inspections of community learning and skills providers and five inspections of further education in higher education institutions.

¹The Common Inspection Framework applies to the inspection of provision either wholly or partly funded by the Skills Funding Agency (SFA) or Education Funding Agency (EFA). For colleges this includes general further education/tertiary colleges, specialist further education colleges, sixth form colleges and independent specialist colleges.

² From September 2012 the new inspection framework reports on judgements of outstanding, good, requires improvement and inadequate. Judgements of satisfactory relate only to inspections prior to this date.



- Of the 33 colleges inspected between 1 September 2012 and 31 December 2012, 3% were outstanding for overall effectiveness, 52% were good and 42% were judged to require improvement. The remaining 3% were inadequate.
- Of the 67 independent learning providers inspected between 1 September 2012 and 31
 December 2012, 1% were judged outstanding for overall effectiveness, 45% were good, 43% were found to require improvement and 10% were inadequate.
- Of the 38 community learning and skills providers inspected between 1 September 2012 and 31 December 2012, 58% of providers were judged good or outstanding for overall effectiveness. A further 29% were found to require improvement and 13% were found to be inadequate.
- One sixth form college was judged outstanding for the quality of teaching, learning and assessment. Six were judged to be good and seven were judged to require improvement. Of the 15 general further education college/tertiary colleges, nine were judged good for the quality of teaching, learning and assessment and six were judged to require improvement.
- The quality of teaching, learning and assessment was found to be good or outstanding in more than half (52%) of the 67 independent learning providers inspected in 2012/13. It was found to require improvement in 40% of providers, and was inadequate in 7%.
- Eleven prison inspection reports were published by Her Majesty's Inspectorate of Prisons between 1 September 2012 and 31 December 2012. Of these, Ofsted found that four were good for the leadership and management of learning and skills and work, and five were found to require improvement. The remaining two prisons were judged inadequate for the leadership and management of learning and skills and work.

Methodology

- 1. The data in this release are from inspections undertaken between 1 September 2012 and 31 December 2012. These inspections were undertaken under the *Common Inspection Framework for further education and skills*. There are four main areas against which a provider is assessed:
 - a. Overall effectiveness
 - b. Outcomes for learners
 - c. The quality of teaching, training and assessment
 - d. The effectiveness of leadership and management

There are four main judgements a provider can received against these areas: outstanding, good, requires improvement and inadequate. Further information can be found on the Ofsted website:

- 2. Statistics relating to inspections undertaken in this year are provisional.
- 3. The quarterly selection of learning and skills providers for inspection comprises three elements: compulsory inspections, inspections resulting from risk assessment, and a random selection:
 - The compulsory inspections are carried out for providers that have reached the end point of their inspection window (For example a good provider must be inspected every six years). New providers will also be subject to a compulsory inspection after their first year of operation but within three years.
 - The second element of the year's selection comprises providers selected through risk assessment. This risk assessment looks at a number of current performance measures, and also trends in these performance measures.
 - Finally, random selection is used to try to maintain a balance in the year's inspection programme, and resulting inspection judgements.

Only providers who consistently perform at a high level tend to reach the end point of their inspection window. Risk assessment enables Ofsted to optimise the use of resources, concentrating inspection activity in areas where it is likely to add most value. The result of using a risk based approach to selection is that inspection judgements for providers, in any given year, can look slightly more pessimistic than we know the national picture to be.







Key inspection judgements of learning and skills providers inspected (percentage)









Overall effectiveness of community learning and skills learning providers inspected (percentage)



Glossary

From September 2011 Ofsted categorises providers in the following ways:

Community learning and skills provider

Community learning and skills providers include local authorities, charities, voluntary and community organisations, specially designated institutions, and community interest companies. Their provision is diverse in character and aims to meet the needs and interests of a wide range of communities. Courses include those leading to qualifications; programmes leading to qualifications whilst in employment; provision for informal adult learning; provision for social and personal development.

From 1 September 2012 Ofsted categorised adult and community learning providers as community learning and skills providers.

General further education college

General further education colleges offer a range of education and training opportunities for learners aged from 14 years upwards, including adults.

Independent learning provider

A company which provides government funded education. The category independent learning provider includes employer providers who only offer government funded training to their own employees.

Independent specialist college

Independent specialist colleges provide education and training for students with complex learning difficulties and/or disabilities, whose learning needs cannot be met by their local college or provider.

Offender learning

Ofsted undertakes judicial service inspections in partnership with HMI Prisons. Ofsted HMI evaluate the quality of learning and skills in prisons, including young offender institutions and secure units for young people and also provision in community settings. Since 1 January 2012, Ofsted no longer publishes reports for prison and young offender institutions. These reports can now be found on the HMIP website:

Ofsted contributes to a reduced number of judgements in these reports. From 30 June 2012 Ofsted ceased to inspect probation trusts.



Sector subject areas

Sector subjects are grouped into 15 areas of learning. Each area of learning has a number of tier 2 subject areas. For example area of learning 7 retail and commercial enterprise, includes 7.4 hospitality and catering, 7.2 warehousing and 7.3a hairdressing and beauty therapy. Ofsted inspects teaching and learning in a sample of tier 2 subjects during full inspections and reinspections.

A sixth form college is an educational institution where students aged 16 to 18 typically study for advanced school-level qualifications, such as A-levels, or school-level qualifications such as GCSEs.
