## **Annex B**

### **Impact Assessment – Section 9 Academies Act Duty**

Section 9 of the Academies Act 2010 places a duty upon the Secretary of State to take into account what the impact of establishing the additional school would be likely to be on maintained schools, Academies and institutions within the further education sector in the area in which the additional school is (or is proposed to be) situated. Any adverse impact will need to be balanced against the benefits of establishing the new school. To this end, the assessment below will look at the schools nearby to St Luke's and will discuss any potential impact on these schools in terms of whether they would lose potential pupils to the new Free School.

#### **Background**

There are several maintained schools, Academies and FE institutions within a 1 mile radius of the planned permanent site of St Luke's School. The nearby maintained primary schools may be impacted by the establishment of the proposed schools. The school will be designated Church of England, and in the case of faith schools we may sometimes look to assess the impact further afield, as we know that parents are prepared to travel further for faith education. However, the school will not use faith-based oversubscription criteria, and so we believe that in this case proximate pupils will be admitted rather than pupils from further away specifically prepared to travel for the faith ethos. For this reason, we have made the assessment based on schools within 1-2 miles, as this is the likely area of appeal or catchment for potential pupils. As outlined below, we do not believe that secondary schools, Academies, or FE institutions would be affected by the new schools, given that St Luke's will be a primary school admitting children aged 4-11.

As part of their consultation, St Luke's CofE School Trust have consulted Heads and Chairs of Governors of all state primary schools in Camden, all pre-schools and nurseries in Camden, the three Barnet schools located within walking distance of St Luke's, plus the main unions (NAHT, NASUWT, NUT, Unite and Unison), all Camden councillors and MP Glenda Jackson, all those on the school's mailing list of over 200, including people living in the local community, prospective parents, and those who responded to previous consultations. The school's website also invites responses.

#### **Catchment area**

The school received a total of 54 applications for places in September 2011. 33/54 applicants live within 0.5 miles of the school, and 46/54 live within 1 mile. 15 children will be offered places on 4<sup>th</sup> April. Of these, on the basis of the oversubscription criteria to be adopted, the furthest lives approximately 0.23 miles from the school.

The school has been contacted by Camden Local Authority, who enquired as to

whether the school could take 5 extra children in September 2011 only. Officials are working with the group to understand what implications this would have for the school in terms of budgeting and staffing plans. Officials have made it clear for the group that although additional children would increase the formulaic per-pupil GAG and equipment funding, the school's Start Up grant would be reduced proportionally for the duration of the grant.

Below is a discussion of the likely impact of the proposed school on local schools. Officials have not received any representations from any schools. Our analysis suggests that no single school is likely to suffer uniquely or significantly, and we have not therefore undertaken a detailed assessment of each individual school or sought views directly from individual local schools.

#### Nearby maintained primary schools

The permanent site for the proposed St Luke's Church of England School is at St Luke's Church, Kidderpore Avenue, Hampstead NW3 7SU. The area has many good primary schools. Table 1 details the 9 maintained primary schools located within a 1 mile radius of St Luke's. 6 of the schools are rated at least Good by Ofsted, with 1 demonstrating Outstanding features, and 2 rated Outstanding in their most recent inspections. Four of these most local schools are Church of England schools and one is designated Roman Catholic. None of these most local schools have more than 3% surplus places, which is to be expected given the known shortage of primary places in Camden Local Authority.

As mentioned above, Officials understand that of the 15 children who will be offered places for St Luke's, the furthest will live approximately 0.23 miles away. It is reasonable to assume that the school might attract and offer places to applicants who live up to 1 mile away. Therefore, we have gathered information about the primary schools situation in a 1-2 mile radius of St Luke's. We know that parents tend to be prepared to travel further for a faith-based education, which in other cases has led us to consider a wider impact. However, the school will not use any faith-based oversubscription criteria, and will use proximity as the significant decider after statements of SEN, looked-after children and siblings have been offered places. In light of this, children who are seeking the specific ethos who apply from further away are unlikely to be offered a place. Therefore, we have not considered a wider radius of impact than 2 miles in this case, despite the faith aspect of the proposal. Information about schools within 1-2 miles is shown in Table 2. A map of the maintained primary schools within 2 miles is shown at Annex D.

The table shows that of the 37 schools that are between 1-2 miles from St Luke's, 14 have surplus places at the time the information was gathered. 7 of those with surplus places have surplus of 10% or less. 7 have more than 10% surplus places. Of these, Avigdor Hirsch Torah Temimah School is an Orthodox Jewish school, and as such is unlikely to attract similar applicants to St Luke's. Many of the schools experiencing surpluses of more than 10% serve very diverse and dynamic communities, in which children arrive and leave with more frequency than normal. In light of this, the surpluses they experience are unlikely to be significantly worsened by the new Free School, given that they seem to arise primarily due to family movement.

We understand from the proposer group that Camden Local Authority anticipate being short of at least 150 Reception places this year, even after some children choose to attend school in a different borough. For this reason, there is a strong argument that St Luke's will not have a negative impact on the schools in Camden LA. 7 of those schools showing surplus places are located in Brent LA. However, Brent LA reported on its website<sup>1</sup> in February 2011 that it anticipates a shortage of places in coming years, and that it plans to invest £15.2million creating an additional 840 primary places by 2015. In light of this it is not clear why some Brent schools are showing surpluses, but Officials believe the movement of residents and their children, and disparities in demand for older primary rather than younger primary places may go some way towards explaining these statistics. Again, however, the fact that Brent is anticipating a pressure for places in the coming years indicates that St Luke's is unlikely to have a significant negative impact on any single primary school in Brent's.

#### Nearby maintained secondary schools and post-16 institutions

St Luke's Church of England Primary will be a school admitting children of primary aged children. It will begin with a single Reception class in September 2011, and will build up over the next seven years by admitting a new Reception class each year. As such, St Luke's is unlikely to have any impact on local secondary schools, and even less likely to impact post-16 institutions.

#### Local Authority opinion

Officials have sought opinion from Camden Local Authority, in which the school will be located. In addition, Officials wrote to Barnet Local Authority in order to understand the potential for St Luke's to impact on the three schools in their Borough which fall within a 1 mile radius of St Luke's site. Officials had not received a response from Barnet LA at the time of writing, despite a request do so by 18<sup>th</sup> March. Two Barnet schools are within 1 mile of St Luke's church, and another 6 schools are within 1-2 miles. The nearest two schools both have more pupils on roll than their official admissions number allows for, as do 5 out of 6 of the Barnet schools falling within 1-2 miles of St Luke's. In light of this, we do not believe that the new school will significantly impact any individual school and so we have not contacted individual schools directly

Camden's response stated that:

*Camden's place planning information shows that there is a need for additional primary pupil places in the north-west of the borough of up to 2FE. A new St. Luke's CofE Primary School could help address some of the need in this area alongside expansion in primary places already being considered by the local authority. We welcome the helpful way that those responsible for the development of these proposals want to work with other local schools, the local authority and the London Diocesan Board for schools*

*The local authority welcomes the fact that the admission policy to the school is broadly in line with the admission policy to Camden's community primary schools. We support the proposal that the school's curriculum will be based on the National Curriculum. We will offer the school access to services that are provided to Camden schools. We will be available to offer any advice that would be helpful on*

*governance and the appointment of a headteacher, including the safeguarding requirements around such an appointment.*

### Camden LA Place Planning Information

Camden Local Authority has not yet published data for September 2011 applications and place allocations. However, Officials understand that Camden LA have approached the proposer group and asked if the school could admit an additional 5 pupils in September 2011. The proposers understand that Camden anticipates being short of at least 150 Reception places in September 2011. The Borough was short of around 60 Reception places in 2010, and is predicting a continual shortage for future years.

### Conclusion

In light of the severe and persistent shortage of primary school places in the area and the fairly small size of the proposed Free School, the new school is unlikely to have any negative impact on any local school. Indeed given the place shortage in the area it could be argued that the new school will have a positive impact on the overall availability of primary education in the area and provide much-needed places.
