	Institution considers what it wishes to achieve from the ELIR and shares this with QAA Scotland (QAAS) officer (<i>ELIR Handbook</i> , paragraph 26 refers)	About 12 months prior to the ELIR visit
Prior to the Part 1 visit	Institution shares draft RA (including case study/ies) and agrees content of advance information set with QAAS officer (sharing a draft RA is optional)	Date to be agreed with the QAAS officer
	Submission of RA, case study/ies and advance information set	8 working weeks prior to Part 1 visit
	Discussion with QAAS officer to plan Part 1 visit arrangements	Date to be agreed with the QAAS officer
	QAAS officer shares with institution likely themes to be explored during the Part 1 visit (based on ELIR team's reading of RA and related materials)	1 working week before Part 1 visit
	Institution confirms with QAAS officer the programme and plans for the first morning of Part 1 visit	1 working week before Part 1 visit
	QAAS officer and ELIR team hold private team meeting in day preceding the Part 1 visit to the institution	1 day before Part 1 visit

Follow-up reporting and activity	Submission of follow-up report to QAAS and Scottish Funding Council	12 months after publication of ELIR reports
	Follow-up report published on QAA website	18 months (at latest) after publication of ELIR reports
	Institution participates in follow-up event	12-24 months after publication of ELIR reports
Monitoring and evaluation	Institution asked to complete post-ELIR evaluation/provide feedback	Following finalisation of ELIR reports
	Annual sector event for institutions participating in ELIR	Annually
