Analysis of higher education destinations of Welsh high achievers between 2008–13

In the course of the Oxbridge Ambassador Project, the question arose of the range of higher education destinations of Wales' high-achieving students. This research has assisted the Oxbridge Ambassador in assessing the scope of the Oxbridge challenge.

Background

In the course of the Oxbridge Ambassador Project, the question arose of the range of higher education destinations of Wales' high achieving students. This research has assisted the Oxbridge Ambassador in assessing the scope of the Oxbridge challenge. Welsh students are applying to research intensive universities in significant numbers – the 'Oxbridge issue' is not necessarily a Russell Group issue. This paper also explores the attitudes of students to studying outside of Wales. Anecdotally, we were concerned that an unwillingness to move beyond the border was limiting the choices of Wales' high achievers, but this does not appear to be the case.

Data gathered

In order to identify the higher education destinations of Welsh high achievers, a dataset was purchased from UCAS (University and Colleges Admissions Service). UCAS administers undergraduate applications for all UK universities, and collects data on the destination of all higher education applicants. There is no other organisation which collects and distributes this information.

We requested a dataset of the higher education destinations of high achieving students. These are Welsh domiciled students who achieved AAA or above at A-level between 2008-13. We requested data to be provided on a local authority basis, in order to identify any geographical discrepancies in destinations. We identified five categories of destination, and for each local authority, received the number of students in each category. These were:

- Russell Group university outside of Wales (ie excluding Cardiff)
- Russell Group university outside of Wales excluding Oxford and Cambridge
- Russell Group university in Wales (ie Cardiff University)
- Other Welsh university
- Other university (ie non Welsh non Russell Group)

In order to preserve anonymity, UCAS routinely redacts any result of three or fewer students. Where a result of more than three has been returned, we were also given the named university and number of students who were admitted. This has been helpful in explaining some discrepancies in the data presented.

Results of analysis

The table below outlines the average proportion of Welsh high achievers across 22 local authorities who attended each category of university between 2008-13. Almost a quarter of high achievers progress to Cardiff University, which is unsurprising as this is the only Russell Group university in Wales, and has many higher tariff courses¹. Over half of the cohort go to Russell Group universities in the rest of the UK. This group of universities represent the most competitive courses in the UK. Although other higher tariff courses exist in other institutions, the Russell Group is a reasonable proxy for competitive, research intensive universities. Again, the overall proportion of students progressing to these universities is unsurprising given that high achievers may be attracted to higher tariff courses. The remaining fifth of the cohort attended other universities, either in Wales or in the rest of the UK. This may be because a student lives near an excellent local university or has pursued a particular course which is highly rated or only offered in a few institutions.

Regional variation

Having identified the average for Welsh high achievers, we then assessed local variation from this baseline. This data is provided in Annex A. It is not always straightforward to compare the proportion of students attending each category of university by local authority as in some cases, the small number of students in the local authority cohort produce distorting proportions when compared with other local authorities. It is necessary to look at overall number of students alongside the proportions.

An average of 78.8% of high achievers in Wales go to a Russell Group university, either Cardiff University or one of the English, Scottish or Northern Irish Russell Group institutions. In individual local authorities, this figure ranges from 72.1% (Neath Port Talbot) to 87.2% (Blaenau Gwent). These figures are reassuring; three quarters of high achieving students go on to study in Russell Group universities. Where this proportion is slightly below average, for example in Neath Port Talbot, the destination data shows a reasonable explanation for this: a higher proportion of Neath Port Talbot students attend a Welsh university outside the Russell Group, namely Swansea University which is both geographically close, and a highly rated institution.

Annex B identifies the proportions of high achieving students who remain in Wales to study in higher education. As might be expected, there is some regional variation with local authorities closer to the English border reporting lower rates of students remaining in Wales. There are notable exceptions to this, for example the Isle of Anglesey has a below average proportion of students remaining in Wales to study. Equally, areas which are further from the border in either distance or travel time report higher levels of students remaining in Wales. This is by no means a cause for concern: when read alongside the data presented in the previous paragraph we know that a large number of these students will end up studying in Cardiff University, an excellent higher education destination.

Conclusions

This appears to be a positive picture. Three quarters of Welsh high achievers attend Russell Group universities, and geography appears not to be a prohibitive factor in making this decision. We know from the paper published alongside this one "Welsh attainment and admission to Oxford and Cambridge: the evidence base", that Welsh students do not progress to Oxford and Cambridge in the expected levels. As these high achieving students are attending higher tariff courses in other excellent universities, we must explore in greater detail the reasons behind the lack of success in Welsh Oxford and Cambridge admissions.
