Subordinate legislation

The Committee reports to the Parliament as follows—

- 1. At its meeting on 24 June 2014, the Education and Culture Committee considered the Provision of Early Learning and Childcare (Specific Children) (Scotland) Order 2014.
- 2. The instrument replaced an earlier version, which was laid on 19 May 2014. It was subject to the affirmative procedure.
- 3. The instrument specifies those children who are "eligible pre-school children" and therefore entitled to the mandatory amount of early learning and childcare under the Children and Young People (Scotland) Act 2014.
- 4. Aileen Campbell, Minister for Children and Young People, moved motion S4M-10413—

That the Education and Culture Committee recommends that the Provision of Early Learning and Childcare (Specific Children) (Scotland) Order 2014 [draft] be approved.
