## Autumn term 2015

**NEW**

### **September 2015: curriculum and qualifications**

[Reformed GCSEs in English and mathematics](#) will be taught for the first time from September 2015, with the first examinations in summer 2017. These are the only English and mathematics

GCSEs that will count in the key stage 4 performance tables in 2017. The last examination of the existing GCSEs in these subjects will be in the summer of 2016, with a single opportunity for retakes in the autumn. Schools prepare for the second wave of new GCSEs for first teaching from September 2016. Awarding organisations will publish accredited specifications in these subjects.

First teaching of [new AS and A levels](#) in:

- art and design
- biology
- business studies
- chemistry
- computer science
- economics
- English language
- English literature
- English language and literature
- history
- physics
- psychology
- sociology

The first A level examinations in these subjects will be in summer 2017 (AS level in 2016). The last examination of existing A levels in these subjects will be in the summer of 2016. Schools should be aware of the second wave of [new AS and A levels](#) for first teaching from September 2016. Awarding organisations publish accredited specifications in these subjects in autumn 2015.

Awarding organisations will publish new GCSE specifications based on published subject content for:

- ancient languages
- art and design
- biology, chemistry and physics (single science)
- combined science
- citizenship
- computer science
- cooking and nutrition
- dance
- design and technology
- drama
- geography
- history
- modern foreign languages
- music
- physical education (PE)
- religious studies

Schools will teach them from September 2016, with the first examinations in summer 2018. Schools choose specifications, contact awarding organisations, and plan for these new qualifications.

## **NEW**

### **Autumn 2015: curriculum and qualifications**

Awarding organisations will publish new A level specifications based on published subject content in:

- ancient languages
- dance
- drama and theatre
- further mathematics
- geography
- modern languages
- music
- mathematics
- physical education (PE)
- religious studies

These will be first taught from September 2016, with the first A level examinations in summer 2018 (AS level in 2017). Schools choose specifications, contact awarding organisations and plan for these new qualifications.

Our intention is that pupils starting year 7 in September 2015 will take the English Baccalaureate (EBacc) subjects at GCSE:

- English
- maths
- science (including computer science)
- history
- geography
- a language

We plan to consult on detailed proposals in autumn 2015.

## **NEW**

### **Autumn 2015: curriculum and qualifications**

Publication of the lists of vocational qualifications approved for inclusion in the 2018 key stage 4 and 16 to 19 performance tables.

Only vocational qualifications included in these lists will contribute towards the 2018 school and college performance tables.

## **NEW**

### **September 2015: pupils**

Providers of 16 to 19 education and training funded by the Education Funding Agency should submit information by the end of September 2015 on the courses they plan to offer from September 2016. This will ensure young people have information on all the options available to them after 16.

### September 2015: curriculum and qualifications

Teaching of the technical and vocational qualifications approved for inclusion in the 2017 key stage 4 and 16 to 19 performance tables begins. These include:

- technical awards (key stage 4, levels 1 and 2)
- technical certificates (16 to 19, level 2)
- tech levels (16 to 19, level 3)
- applied general qualifications (16 to 19, level 3)

Only technical and vocational qualifications included on the [approved lists](#) will contribute towards the 2017 school and college performance tables.

## UPDATED

### September 2016: curriculum and qualifications

Teaching of the technical and vocational qualifications approved for inclusion in the 2018 key stage 4 and 16 to 19 performance tables. These include:

- technical awards (key stage 4, levels 1 and 2)
- technical certificates (16 to 19, level 2)
- tech levels (16 to 19, level 3)
- applied general qualifications (16 to 19, level 3)

Only technical and vocational qualifications included on the

approved lists will contribute towards the 2018 school and college performance tables.

## **NEW**

### **October 2015: governance**

We will publish the final data for provisional destination measures showing the 2013 to 2014 destinations of students included in the 2012 to 2013 key stage 4 or key stage 5 performance tables in January 2016. [Previous data](#) is also available.

## **NEW**

### **December 2015: governance**

Announcement of interim [minimum standard level](#) for 2015 for schools and colleges at key stage 5. The level will set the percentage of students that have to pass the standard and the number of points they must reach to pass it. These are set separately for academic and vocational qualifications. We will publish a list of institutions falling below the minimum standards in February 2016.

## **NEW**

### **December 2015: curriculum and qualifications**

The expert review of the assessment of pupils working below the standard of national curriculum tests will publish its final report.



## **UPDATED**

### **September 2015: curriculum and qualifications**

We are providing the opportunity for 2 pupils and 1 teacher from every state-funded secondary school in England to [visit](#)

[battlefields on the Western Front](#) \_\_\_\_ . This forms part of commemorations to mark the centenary of the First World War. The next programme of visits is taking place in autumn 2015.

## NEW

### September 2015: curriculum and qualifications

We will publish a new resource for primary schools listing 100 pieces of classical music in October 2015. The Associated Board of the Royal Schools of Music (ABRSM), the exam board of the Royal Schools of Music and Classic FM developed the list. All primary schools will be able to access free resources that support teachers to use the list effectively.

Schools must complete their [summer school final claim form](#) \_\_\_\_ by 9 October 2015. We will not accept claim forms after this date.

## UPDATED

### September 2015: governance

The NHS is extending the annual flu immunisation programme in England, and is phasing this in over a number of years, with



offers to all children whose ages correspond to primary school years 1 and 2 from October 2015. We expect that immunisation will take place at schools in most areas.

Children in eligible age groups should receive the immunisation between October and December. Schools may wish to consider this when planning for the 2015 to 2016 academic year. If there are plans for vaccination to take place in schools in your area, local health service providers should have contacted you between April and July 2015.

## **NEW**

### **September 2015: governance**

The NHS is introducing a new vaccination programme for teenagers to respond to an increase in cases of an aggressive form of meningococcal group W (MenW) disease.

For the 2015 to 2016 academic year, pupils of year 11 school age (date of birth 1 September 1999 to 31 August 2000) will be offered the [MenACWY vaccination](#) from January 2016. We expect vaccination in the majority of areas to take place in schools. MenACWY is also replacing the MenC vaccination as the routine adolescent vaccine given to pupils in school year 9 or 10.

GP practices invited all teenagers who were in school year 13 in the 2014 to 2015 academic year (date of birth 1 September 1996 to 31 August 1997) to have the MenACWY vaccine over the summer. We will confirm a further part of the catch-up campaign to cover those pupils in school years 12 and 13 in the 2015 to 2016 academic year before the end of 2015.

Guidance for schools on [purchasing defibrillators](#) at a discounted price is available. These arrangements are also available to early years and some childcare settings.

## September 2015: governance

The British Heart Foundation has developed a [free resource kit](#) for secondary schools, sixth forms and colleges to teach CPR (cardiopulmonary resuscitation - a first-aid technique that can be used if someone is not breathing properly or if their heart has stopped). The kit covers how and when to perform CPR on an adult or child, put someone in the recovery position and use a defibrillator.

## September 2015: pupils

As part of the government's commitment to improving mental health services for children and young people, NHS England is asking clinical commissioning groups (CCGs) to make local transformation plans for child and adolescent mental health services. CCGs must involve partners, including schools and colleges, in these plans. This will be an opportunity to influence local [mental health provision](#). Your local authority will also be involved. ### September 2015: governance

We will update the [Governors' handbook](#) to reflect changes to the law and policy. The handbook sets out everything governors and trustees need to know about their role and duties.

## NEW

### September 2015: staffing

The [teacher self-service](#) website allows teachers to:

- view their teacher record
- obtain qualified teacher status and induction certificates
- update personal details
- download and print a letter confirming their teacher qualifications
- input employment details

## NEW

### September 2015: staffing

Increased employer contributions for the teachers' pension scheme begin, following the [2012 valuation](#). This is subject to consultation and regulatory changes coming into force.

## NEW

### September 2015: pupils

We will change the persistent absence threshold for pupils from 15% to 10% from the start of academic year 2015 to 2016. From September 2015 Ofsted will use this new threshold in its

inspection regime.

## NEW

### September 2015: governance

We have published revised statutory guidance relating to schools' duty to secure [independent careers guidance](#).

## NEW

### October 2015: pupils

Schools should encourage pupils to use websites with information about the [full range of post-16 opportunities](#) as part of their careers advice and guidance provision.

## NEW

### September 2016: finance

Funding allocations for the academic year 2016 to 2017 will include an increase based on students' successful completion, in summer 2014, of large [TechBacc programmes](#). Large TechBacc programmes are those the size of 4 A levels or larger. The programmes include a tech level qualification, a level 3 maths qualification and an extended project.
