- 1. This is a Department for Business, Innovation and Skills (BIS) report for the 24+ Advanced Learning Loans system and contains information relating to courses starting in the 2014/15 and 2015/16 academic year.
- 2. The report contains an outline of the source of the data, headline information and tables presenting application and processing figures. Information presented is as given in application forms and is subject to change.
- 3. This release of 24+ Advanced Learning Loans Application Information covers applications for courses starting in the 2015/16 academic year. Applications for courses starting in the 2014/15 academic year closed at the end of July 2015 (although changes can be made after July through change of circumstances). In this release an ad-hoc breakdown of applications by sector subject area to the end of July 2015 for the 2014/14 Academic Year has been produced.
- 4. The next release of 24+ Advanced Learning Loans Information will be on 29 October 2015, and will relate to applications submitted to the end of September.

5. Main Headlines

- The total number of applications received for the 2015/16 academic year, to August 2015, was **32,140** (excludes ineligible applications).
- The total number of applications received for the 2015/16 academic year, from 1-31 August 2015, was 16,080 (excludes ineligible).
- The total number of processed applications from 1-31 August 2015 for applications for Loans to fund 2015/16 provision was **11,870** (includes ineligible applications).
- The largest amount of applications received from 1-31 August 2015, to fund provision in the 2015/16 academic year was in the **24-30** age band **(7,150**, excluding ineligible applications).
- For the 2014/15 Academic Year, the Health, Public Services and Care Sector Subject Area received **21,110** applications for QAA access to HE, Certificate and Diploma provision types. This was the largest amount of applications received for a Sector Subject Area.

Data Sources

The statistics published in this release relate to applications for 24+ Advanced Learning Loans for Level 3+ provision starting in the 2015/16 academic year. An ad-hoc table has also been produced for the 2014/15 Academic Year showing applications by sector subject area.

The data used to produce this monthly report are sourced from the Student Loans Company (SLC) application database. It should be noted that the data refer to all received applications for 24+ Loans (both unprocessed and processed, but excluding those ineligible, cancelled, deleted and in data entry) and are subject to change. Therefore, application figures are not necessarily indicative of actual learner starts.

The data used in this report are sourced from an operational database that is updated on an ongoing basis, and therefore month to month application figures may fluctuate due to further processing of received applications. This may sometimes result in total application figures from launch in a particular table category increasing more or less than would be expected based on the previous month's submitted applications, or even decreasing from one month to the next.

Other Related Statistics

On Thursday 25th June 2015 the Department for Business, Innovation and Skills published the Further Education and Skills Statistical First Release, which contains figures relating to learners participating in FE in the first three quarters of the 2014/15 academic year who were funded through the 24+ Advanced Learning Loans system.
