January 2016: pupils

The school census will provide a snapshot of your school as at 21 January 2016. You must send your census data to us no later

21 January 2016: curriculum and qualifications

We will publish key stage 5 school and college performance tables for institutions with students aged 16 to 18, including 2015 exams data. Previous data is available at the school and college performance tables website .

NEW

January 2016: governance

From 1 January 2016, the government will no longer require schools to adopt home-school agreements (HSAs) and associated parental declarations. Schools can decide how to maintain these relationships (including through voluntary HSAs). The government repealed this requirement as part of the Deregulation Act 2015. As a result, we will update our behaviour and discipline advice for schools.

Schools must report a teacher assessment for pupils at the end of key stages 1 and 2 in English reading, English writing, mathematics and science. To do this they must use the interim frameworks for teacher assessment for pupils who have completed the relevant programme of study or the interim pre-key stage standards for pupils - key stage 1 and key stage 2 - who have not completed the programme of study.
