Reporting on SFC Strategic Investments: changes in approach

- 1. I am writing to advise you of changes to the way in which institutions are asked to report progress on awards they hold from SFC Strategic Investment funds. I am drawing this advice to the attention of award leads and institutions' central administrative contacts for outcomes reporting, as they will have more immediate responsibility for action. I would be grateful if you could ensure that anyone else in your institution who has relevant responsibility is also notified.
- 2. The key changes of which you should be aware are:
 - There will be a standard reporting deadline of 30 September annually. Historically, reports have usually been requested on the anniversary of award.

We are phasing this in. Awards which are due to report in 2016 should submit these by the date specified in their grant letter. Awards which are due to report in 2017 (Jan-Dec) should report on or by 30 September 2017. We will notify awards of changes to their reporting requirements.

• There will be a standard return which covers (a) annual reporting on the previous academic year (August to July) and (b) end of award reporting on both the final period of activity and the full period of funding. This return will focus on the outcomes of the funded activity. A financial statement will be incorporated into this return.

This return template is available immediately. It should be used by awards due to report on or after 30 September 2016. It may also be used by awards due to report before then.

- 3. Our intention is that these changes will provide a more efficient and predictable means for you to fulfil your conditions of grant and demonstrate your award achievements to the SFC.
- 4. In developing this approach, we have had the benefit of the advice of a User Group, drawn from institutions' staff with responsibilities for outcomes reporting systems (see Annex A for current membership). However, we welcome ongoing feedback from those who are to use the system.
- 5. We will provide information on the awards to which this new approach applies to the institutional contacts listed in Annex B. We will be holding briefing sessions on the new approach later in the summer and will contact award leads and administrative staff directly about this.
