


Performance Indicators in Higher Education: Widening Participation fact sheet

Participation of students who were in receipt of Disabled Students' Allowance (DSA): All undergraduate students - 2015/16

This indicator is designed to provide information about the percentage of disabled students in the sector. For this indicator a value higher than the benchmark indicates that an institution was performing better than the sector average.

Figure 1: Percentage of full-time undergraduate students who were in receipt of Disabled Students' Allowance - 2015/16



On average, NI HEIs were performing below the UK average of 6.8%, with 5.3% of all full-time undergraduates in receipt of DSA in 2015/16.

Queen's University, Belfast (QUB) and St Mary's University College were both performing above their benchmarks, but not significantly so, with 6.8% (benchmark 6.1%) and 6.2% (benchmark 5.5%) of full-time undergraduates in receipt of DSA respectively in 2015/16.

Stranmillis University College and Ulster University (UU) were both performing below their benchmarks, but not significantly so, with 4.1% (benchmark 5.9%) and 4.0% (benchmark 6.6%) of full-time undergraduates in receipt of DSA respectively in 2015/16. The Open University (OU) NI campuses did not have a percentage for this Performance Indicator as all entrants for 2015/16 were part-time.

For part-time undergraduates, NI HEIs were performing slightly higher than the UK average of 3.5%, with 3.9% in receipt of DSA.

Participation of under-represented groups in Higher Education: Young full-time entrants - 2015/16

Following a fundamental review of the UK Performance Indicators, the use of National Statistics Socio-economic Classification (NS-SEC) as a measure has been discontinued across the UK, following concerns about the quality of the data collected for this variable.

Participation of under-represented groups in Higher Education – mature and part-time entrants - 2015/16

This indicator looks at the percentage of entrants who came from low participation neighbourhoods and have no previous HE qualification. This indicator is not applicable in NI due to the methodological issues around the calculation of low participation areas at the NI institutional level (further information on this is contained in the 'Contextual information' document, which is published alongside this factsheet on the DfE website).
