1. Financial plan submission requirements

Action

Colleges are required to submit a copy of their financial plan, supporting commentary and signed copy of the plan coversheet to the ESFA by Monday, 31 July. Colleges that have a document exchange account should submit their documents using this account, alternatively, documents can be submitted through email to the [pfm@sfa.bis.gov.uk mailbox](mailto:pfm@sfa.bis.gov.uk).

Where a college has completed the restructuring facility model, the college will still need to submit a copy of the financial plan template and supporting documentation by Monday, 31 July.
