Key stage 1

Reminder: submit phonics screening check results by the end of the summer term

Schools must submit their phonics screening check results to their local authority (LA) by the deadline specified by the LA, and by no later than the end of the summer term.

Key stage 2

Information: KS2 results returned on 10 July

Schools' key stage 2 (KS2) test results will be available to view, download and print from the 'Pupil results' section of NCA tools from 7:30am on 10 July. Conversion tables will also be available so schools can understand the relationship between the raw scores and scaled scores for each test.

Information: recruiting temporary roles for 2018 to 2019 standardisation

Information: changes to teacher assessment from the 2018 to 2019 academic year

From 2018 to 2019, the following changes to teacher assessment (TA) arrangements will take effect:

- As set out in the government response to the <u>'Primary assessment in England'</u> public consultation last year, schools will no longer be required to report statutory TA judgements at KS2 in English reading or mathematics. English reading and mathematics test results will continue to be used in school performance measures.
- Schools must use the 2018 to 2019 versions of the TA frameworks at KS1 and KS2. The English writing frameworks are unchanged from the versions used this year, while the other subjects have been refined based on feedback from teachers and other education experts.
- Schools must use the pre-key stage standards to make TA judgements at KS1 and KS2 for pupils who are working below the standard of the national curriculum assessments and above P scale 4. P scales 5 to 8 will no longer be used for statutory assessment. For pupils working below the pre-key stage standards, the department is piloting an alternative approach, the 7 aspects of engagement for cognition and learning, before deciding whether to introduce it as a statutory assessment. In the interim, P scales 1 to 4 will continue to be used for the statutory assessment of these pupils in 2018 to 2019.

Reminder: guidance for writing statutory end of year reports

We recently published <u>guidance</u> for schools about writing statutory end of year reports for parents at the end of KS1 and KS2.

Reports must include comparative information about the attainment of pupils of the same age in your school and nationally.

To help schools, we've published a <u>KS1 template</u> in which you can populate your school's overall results. We'll publish a KS2 template when we return results to schools, on Tuesday 10 July.
