


### Performance Indicators in Higher Education: Widening Participation fact sheet

Participation of students who were in receipt of Disabled Students' Allowance (DSA): All undergraduate students - 2017/18

This indicator is designed to provide information about the percentage of students in receipt of Disabled Students' Allowance. For this indicator, a value higher than the benchmark<sup>1</sup> indicates that an institution was performing better than the sector average.



### Figure 1: Percentage of full-time undergraduate students who were in receipt of Disabled Students' Allowance - 2017/18

On average, NI HEIs were performing below the UK average of 6.6%, with 5.3% of all fulltime undergraduates in receipt of DSA in 2017/18.

St Mary's University College was performing above its benchmark, with 6.9% (benchmark 5.9%) of full-time undergraduates in receipt of DSA in 2017/18.

The percentage of full-time undergraduates in receipt of DSA in 2017/18 in Queen's University Belfast (QUB), Ulster University (UU) and Stranmillis University College were 5.7%, 5.0% and 3.0% respectively. However, all three institutions were performing below their benchmarks of 6.0%, 6.4% and 6.5% respectively. The Open University (OU) NI did not have a percentage for this Performance Indicator as all entrants for 2017/18 were part-time.

For part-time undergraduates, NI HEIs were performing the same as the UK average of 3.4%, with 3.4% in receipt of DSA.
