principles can completely remove the risk of catching coronavirus on their own. You

your household Whilst recognising this will not always be possible, it is important to be aware that the risk of infection increases the closer you are to another person with the virus, and the

amount of time you spend in close contact with them. Therefore, you are unlikely to be infected if you walk past another person in the street. The government recommends that you keep two metres away from people as a precaution or one metre when you can mitigate the risk by taking other precautions in

this list.

bubble You are at higher risk of being directly exposed to respiratory droplets (released by talking or coughing) when you are within two metres of someone and have face-to-face contact with them. You can lower the risk of infection if you stay side-to-side rather than

Evidence suggests that wearing a face covering does not protect you. However, if you are infected but have not yet developed symptoms, it may provide some protection for others you come into close contact with. Face coverings do not replace social distancing. If you have symptoms of COVID-19 (cough, and/or high temperature, and/or loss of, or change in, your normal sense of smell or taste - anosmia), you and your household must isolate at home: wearing a face

covering does not change this. You should <u>arrange to have a test</u> to see if you have

It also includes guidance on hygiene, as evidence suggests that the virus can exist for
