Introduction

- 1. This circular sets out our overall funding for HEFCW-funded higher education (HE) providers in Wales for the academic year (AY) 2020/21 of £171.5m. This includes individual provider allocations for research and innovation; part-time undergraduate (PT UG) and full-time undergraduate (FT UG); and Postgraduate Certificate in Education (PGCE) teaching funding.
- 2. This circular does not include the £27m additional funding, to be provided through a Higher Education Investment and Recovery Fund for Wales to maintain teaching and research in AY 2020/21, announced by the Welsh Government on 22 July 2020.
- 3. HEFCW grant funding does not include payments for tuition fee grants or other student support payments administered by the Welsh Government.
- 4. The Welsh Government allocates funding to HEFCW annually on a financial year (FY) basis from 1 April to 31 March. HEFCW allocates funding to HE providers on an AY basis from 1 August to 31 July.
- 5. For ease of comparison, this circular provides detail of HEFCW's total allocation in the previous AY. The AY 2019/20 figure provided here (£180.6m) is £31.7m higher than that announced in W19/14HE HEFCW's Funding Allocations 2019/20 (£148.9m). This was mainly as the consequence of additional funding allocations in July 2019, December 2019 and January 2020 (totalling £17.1m as detailed in paragraphs 13 to 15) and funding carried forward from AY 2018/19 (£11.6m).
- 6. We do not require providers to directly replicate our approach to establishing allocations when making their own internal allocations. We expect that decisions on detailed resource allocations to departments and courses will be made strategically to reflect local circumstances and priorities and with due regard to the potential impact of allocations in terms of providers' statutory responsibilities, including for equality and diversity, as well as other Welsh Government priorities.

Contents

- 7. This circular covers all elements of our funding allocation for AY 2020/21, but does not include the additional £27m announced by the Welsh Government on 22 July 2020. Each year the Welsh Government publishes the grant for HEFCW and details in its remit letter the priorities we are expected to follow in the distribution of that grant. In April 2020 we received a letter from the Minister for Education including an indicative budget for FY 2020-21. The Welsh Government subsequently confirmed that, due to the Covid-19 crisis, no further remit letter would be issued imminently.
- 8. The circular includes all formula-driven recurrent grants as well as grants allocated subject to the provision of a specific expenditure plan or strategy. The overall budget and funding allocation details are presented in Table 1 (page 17) at the macro level. Capital allocations are announced separately, as are funding allocations for strategic initiatives such as Reaching Wider, and funding provided from UK initiatives such as the Global Challenges Research Fund and Higher Education Research Capital.

Structure

- 9. There are eight sections in this circular:
 - Overall budget distribution AY 2020/21
 - Allocations of funding for research and innovation Quality Research (QR);
 Postgraduate Research (PGR) training allocations; and Research Wales Innovation Fund (RWIF)
 - Allocations of funds for teaching credit-based, per capita and premium funding
 - Overall teaching and research allocations by individual provider
 - Open University in Wales (OU) mitigation funding
 - Royal Welsh College of Music and Drama Performance element funding
 - Postgraduate Taught (PGT) Master's incentivisation bursaries
 - Additional medical places
- 10. This circular also covers such matters as data sources, terms of grant, payment arrangements and audit, where appropriate.

Overall budget distribution AY 2020/21

Financial Year (FY) 2019-20 budget revisions

- 11. Supplementary revisions to HEFCW's budget in FY 2019-20 provided additional funding. As a result of these changes, funding allocations for AY 2019/20 were revised subsequent to the circular published in June 2019 (W19/14HE).
- 12. The comparative funding for AY 2019/20 included in Table 1 (page 17) takes account of all changes to the FY 2019-20 budget compared to the estimates made last year.
- 13. A supplementary revision to the <u>FY 2019-20 remit letter</u> in July 2019 detailed an additional allocation of £1.6m to support the following activities:
 - £104.5k to support the development of Welsh Higher Education Executive Leadership Programme (WHEELP II)
 - £118k to cover additional pressures on HEFCW's running costs arising as a result of changes to the Civil Service Pension Scheme
 - £1.3m to support a postgraduate incentives scheme
 - £80k to support a bursary scheme for Master's students aged 60+
- 14. A supplementary revision to the <u>FY 2019-20 remit letter</u> in December 2019 detailed an additional allocation of £15m to further support reforms arising from the Welsh Government response to the recommendations of its <u>review of higher education funding and student finance arrangements</u> ("the Diamond review") and the <u>Reid review of government funded research and innovation in Wales as outlined below:</u>

- £7.5m for Research Wales Innovation Funding, including civic mission activity, to enable HEFCW to bring forward its plans to reintroduce funding for innovation and knowledge transfer
- £1.5m for Well-being and Equality and Diversity, to enable providers to improve and share effective practice in safeguarding policies and to support further initiatives to address period poverty
- £6m to support research development, by increasing and sustaining levels of Quality Research (QR) and Postgraduate Research (PGR) funding
- 15. A supplementary revision to the <u>FY 2019-20 remit letter</u> in January 2020 detailed an additional allocation of £532,898 to support the following activities:
 - £504,000 to cover additional costs in 2019-20 arising from the increase in undergraduate medical education places
 - £28,898 to support Educational Research undertaken by the Wales Institute of Social and Economic Research and Data (WISERD).¹

FY 2020-21 budget

- 16. In anticipation of the original indicative revenue funding budget for FY 2020-21 and FY 2021-22 of £155m and £170m respectively as set out in the 2019-20 remit letter, we consulted with the higher education sector on our proposals for allocating the increased funding (W19/13HE and W19/33HE). As set out below, due to Covid-19 and the revised budget we have had to re-prioritise our original funding proposals, but we have taken account of the responses to our funding consultations in our revised funding allocations for AY 2020/21.
- 17. The Welsh Government indicated a provisional FY 2020-21 budget for HEFCW in December 2019 of £178m, excluding capital. However, due to the Covid-19 crisis, the Welsh Government subsequently reduced this provisional budget. The Minister for Education wrote to HEFCW in April 2020 to set out a provisional maximum budget of £162m for FY 2020-21, excluding capital allocation, while indicating that HEFCW might receive materially less than this provisional amount. Consequently the AY2020/21 allocation set out in this circular is £21m less than was originally anticipated.
- 18. Capital and revenue allocations provided in the Minister for Education's provisional remit letter are shown in the table below. Paragraphs 13 to 15 detail the funding allocation revisions in FY 2019-20.

Derivation of AY 2020/21 budget

- 19. The academic year budget is calculated using a proportion of one year's financial year budget (usually 60%) and a balancing proportion (usually 40%) of the next.
- 20. The Minister for Education's provisional remit letter for FY 2020-21includes funding allocations for degree apprenticeships, Global Wales, PGT Master's incentivisation bursaries and capital funding, which have been treated as ring-fenced budgets for activity to be delivered within particular academic years. Therefore, these budgets have not been taken into account when determining the proportions of each financial year budget available to resource AY 2020/21. Instead they have been split between academic years in line with our expected expenditure profiles. This is reflected in the table below and in Table 1 on page 17.
- 21. Additional funding for undergraduate medical places and further degree apprenticeship funding is expected during FY 2020-21.
- 22. The FY 2021-22 budget used in our calculations is an estimate that we have made based on the funding we anticipate in FY 2020-21. No indicative budget information has been received from the Welsh Government but, for the purposes of finalising our funding for AY 2020/21, we have assumed that there will be no reduction to our revenue funding in FY 2021-22. It is possible that the actual FY 2021-22 funding allocated to HEFCW by the Welsh Government could be lower than assumed, with the consequent risk that the funding available for AY 2020/21 could be reduced.

23. The distribution of financial year allocations to AY 2020/21 is in the table below

Budget allocation

- 26. Table 1 on page 17 provides an analysis of the total funding allocation by the main budget headings for AY 2020/21.
- 27. The equivalent figures for AY 2019/20 are shown for all budget lines.

Allocation of funding for research and innovation

Quality Research (QR)

- 28. The QR component of the recurrent grant recognises the quality and volume of research, as demonstrated by the 2014 Research Excellence Framework (REF). For AY 2020/21, the funding set aside for QR is £71.077m. This was enhanced by £4.7m in AY 2019/20 by additional funding from the Welsh Government but, due to budget changes, we have been unable to maintain this level of increased funding.
- 29. The QR funding includes £132k that was formerly provided for the University of Wales Press. Since the transfer of that funding to QR in AY 2011/12, it has been ringfenced within provider allocations for the purpose of supporting scholarly publications and related activities in the fields of Welsh culture, history and literature. The ringfenced amounts for individual providers remain at the levels agreed in 2011.
- 30. The AY 2020/21 QR allocations are set out by provider in Table 2a. A breakdown for each provider by unit of assessment (UoA) is provided in **Annex A**. The funding per

unit volume by subject group and quality level is shown at **Annex B**.

Postgraduate Research Training (PGR)

- 31. PGR is supported outside the teaching funding method. We operate a separate funding stream to support the training that providers provide for PGR students. The threshold for a UoA to be included in the calculation of PGR funding is set at the same level as QR: ie only UoAs that qualify for QR funding are allocated PGR support.
- 32. Funding is within an overall maximum amount agreed by HEFCW each year and is based on the most recent confirmed number of actual enrolments. These are the eligible, fundable enrolments in UoAs that qualify for QR funding in AY 2020/21. The enrolment data is taken from the Higher Education Statistics Agency (HESA) student record returns for AY 2018/19.
- 33. For AY 2020/21, HEFCW has set the overall maximum amount of funding for PGR at £6.487m, maintaining the level allocated in AY 2019/20. This allocation differs to that shown in the funding allocations circular for AY 2019/20 (W19/14HE), as an additional £1.3m was allocated to PGR training funding in AY 2019/20 after the circular was published. Using the data taken from the HESA record and the standard unit of funding for the particular subject group, not all PGR recruitment can necessarily be funded within the funding available. Where the funding allocated to providers on the basis of the standard units of funding would exceed the total available, allocations are reduced on a pro-rata basis. For AY 2020/21, this means that the allocations were reduced by £370k (5.4%) to reflect that not all of the provision can be funded at the standard units of funding within the funding available. The PGR allocations are set out in Table 3.

Research Wales Innovation Fund (RWIF)

- 34. RWIF has been designed to support the range of knowledge exchange (KE) activities that result in economic and social impact, including the wider civic mission role of providers. The funding provides support for providers to work with businesses, public and third sector organisations, community bodies and the wider public. KE activities that contribute to economic growth, productivity and supporting the civic role of providers are high priorities.
- 35. RWIF comprises two elements: (i) A capacity grant to enhance performance outcomes and create stability in the sector; and (ii) a formula allocation which rewards performance against HEFCW national measures for innovation.
- 36. The capacity grant had originally been set at £250k per annum based on a total of £15m being available. Following a reduction in available funding due to Covid-19, the capacity grant has been reduced by the same proportion as the reduction in the total funding available. With an indicative budget set at £7.5m, the capacity grant is £125k per provider in AY 2020/21. Should any further innovation funding become available during AY 2020/21, the capacity grant element will be increased proportionately, up to a maximum grant of £250k for AY 2020/21 allocations.

- 37. Similarly, the maximum and minimum allocations have been adjusted pro-rata to the total funding. With a budget of £7.5m, the maximum RWIF allocation a provider can receive in AY 2020/21 is £2m, with the minimum set at £200k.
- 38. The RWIF formula funding method uses three years of data submitted to the Higher Education Business Community Interaction (HEBCI) Survey (AY 2016/17 to AY 2018/19) with the years weighted 2:3:5. This element of the funding calculation will be reviewed annually, with the potential for providers to see an increase of up to 30%, or a decrease to a maximum of -10%. The level of the funding percentage increase will be determined annually based on incentivising performance, and availability of funding.
- 39. RWIF allocations for AY 2020/21 are set out in Table 2b. Further information on RWIF can be found in W20/09HE.

Allocation of funds for teaching

Credit-based teaching funding – part-time undergraduate

- 40. We are continuing to fund PT UG in AY 2020/21 through the credit-based teaching funding method, as in in AY 2019/20.
- 41. Credit-based funding for PT UG teaching has been determined using our teaching funding method. This was established in 1999 and amended in AY 2011/12 with the removal of the recovery element of the method.
- 42. Funding allocations are based on funding cells. A funding cell refers to:
 - Level: undergraduate (not franchised-out); undergraduate franchised out;
 - Mode: part-time; and
 - Academic subject category (ASC): ASCs 1a to 11b and ASC 11a, Initial Teacher Training (ITT) leading to Qualified Teacher Status (QTS), split into Primary and Secondary.
- 43. Funding in each cell is established by multiplying the number of credit values funded in that cell by our standard unit of funding for the ASC.
- 44. The standard units of funding per credit value for each ASC for PT UG in AY 2020/21 are the same as those used in AY 2019/20. These are set out in **Annex C**.
- 45. Total PT UG funding and funded credit value allocations in each cell for each provider are shown in **Annex D**.
- 46. The PT UG core numbers are determined by the funding model. They are calculated by using funded credits from AY 2019/20 and allocating them to funding cells using both the distribution of funded credits for AY 2019/20 and recruited credit values for AY 2019/20, collected directly from providers. Recruitment data is taken from the higher education students' early statistics (HESES) survey 2019/20 (circular W19/39HE).

- 47. The initial run of the AY 2020/21 teaching model resulted in a reduced overall PT UG allocation in AY 2020/21 compared to AY 2019/20, because of under-recruitment compared to funded numbers in some providers. There were, however, some providers that had some unfunded ("fees-only") provision in the initial run.
- 48. Following consultation on the distribution of additional funding for AY 2020/21 (HEFCW circular W19/33HE), for AY 2020/21, as in AY 2019/20, HEFCW's Council agreed to include growth in the credit-based model by converting all fees-only credits into funded credits. This allows for growth in funded credits for some providers and this is included in **Annex D**. Table 4a shows the breakdown between core-funded credits and funding, and growth-funded credits and funding. While we have been able to provide funding for growth in the number of part-time funded credits, the reduced overall funding available (see paragraph 17) has not allowed for any increase to the units of funding.

Premium funding – part-time undergraduate provision

- 49. The Access and Retention and the Welsh medium premium are allocated for PT UG provision only and are set out in Table 4b. These are described below.
 - Welsh medium premium
 The Welsh Medium premium adds a weighting of 0.34 to the AY 2020/21 unit of funding for modules undertaken through the medium of Welsh. The allocations to each provider, based on the average of AY 2017/18 and AY 2018/19 HESA credit value data, are set out in Table 4b.
 - Access and retention premium
 There are two elements to the access and retention premium allocation for part-time undergraduate provision. A premium is awarded in respect of students from areas of low participation in higher education and students from what were previously defined as Communities First clusters. Individual students may attract more than one premium.

In order to reward retention, we have allocated a higher rate of funding with respect to continuing students than to students in their first year. The higher rate is also allocated with respect to students on one year courses who complete or partially complete.

To recognise that the proportion of widening access students within a provider impacts on the extent of support required, providers have been separated into two bands depending on their recruitment in AY 2018/19 from Communities First areas. Providers where students from Communities First areas represent more than 15 per cent of Welsh domiciled students are in band 1 and receive a higher premium, and those where students from Communities First areas represent 15 per cent or less are in band 2 and receive a lower premium.

For AY 2020/21, we are maintaining the level of access and retention premium at the AY 2019/20 levels. Individual allocations are detailed in Table 4b.

Premium funding – full-time undergraduate provision

- 50. For AY 2020/21, the expensive subjects premium (ESP), and the higher cost subjects premium (introduced in AY 2019/20) are being allocated for FT UG provision. The ESP is allocated in respect of Clinical Medicine/Dentistry and Conservatoire Performance Element provision while the higher cost subjects premium is allocated in respect of Non-clinical Medicine/Dentistry, Science & Engineering and Technology, and Mathematical Sciences, IT and Computing.
- 51. The rates of funding used in the allocation of ESP funding are remaining at the same level as in AY 2019/20, at £86.25 for Clinical Medicine and Dentistry provision, and £51 for Performance Element provision. These rates of funding were set in AY 2019/20 and were calculated to provide equivalent rates at the time, to funding allocated by the Office for Students (OfS) in England for similar provision. The allocations are outlined in Table 5a and are based on the two premium rates below, awarded per completed credit value:

Expensive subjects premium:

- Rate 1 £86.25, applied to Clinical Medical/Dentistry subjects (equivalent to ASCs 1b and 1d)
- Rate 2 £51, applied to Conservatoire Performance Element (Performance Element provision in ASC 10)
- 52. In addition, as was the case in AY 2019/20, in AY 2020/21 provision for ESP will be capped by limiting the number of credit values that can be used in the calculation. For Clinical Medicine and Dentistry, this is the credit values equivalent to the number of quota clinical places. For Conservatoire provision, this is the credit values equivalent to the funded student number agreed as part of the special funding arrangement in place, prior to the introduction of the revised tuition fee regime in AY 2012/13.
- 53. Additional funding has been made available for the higher cost subjects premium in AY 2020/21. This was agreed following consultation on the distribution of additional funding for AY 2020/21, HEFCW circular w19/33HE. The additional funding of £4.4m (£1.6m lower than originally proposed in the circular) means that the units of funding for the higher costs subject premium have increased, compared to AY 2019/20. The allocations for the higher cost subjects premium are outlined in Table 5a and are based on the premium rates below, awarded per completed credit value, with the AY 2019/20 rates in brackets for comparison:

Higher cost subjects premium:

- Non-clinical Medicine/Dentistry £4.28 (£1.60)
- Science & Engineering and Technology £2.46 (£0.92)
- Mathematical Sciences, IT and Computing £1.15 (£0.43)
- 54. The subjects included in the higher cost subjects premium are those where the cost of provision is estimated to be higher than the average tuition fee assumed received by providers in Wales in AY 2019/20. Details of the method used to calculate the rates of funding is included in circular <a href="https://www.wise.ncb.nlm.ncb.nl

process. No changes have been made for AY 2020/21 funding other than to update the rates of funding to reflect the increased total funding available. Allocations for providers are calculated by multiplying the rate of funding by completed credit values from EYM 2018/19 for full-time and sandwich undergraduate provision, with sandwich year out credit values counted at 0.5. Table 5b shows the allocations by subject and provider.

55. FT UG premium funding for additional medical places is shown separately in Table 8 and not included in Tables 5a and 5b. Paragraphs 70 and 72 below provide further information on the additional medical places.

Premium funding – all modes and levels

- 56. For AY 2020/21, the disability premium is allocated for all modes and levels of study. This was agreed following consultation on the distribution of additional funding for AY 2020/21 (HEFCW circular W19/33HE). The overall funding for the disability premium has consequently been increased by £1.7m to £1.9m. In AY 2019/20, the disability premium was only allocated to part-time undergraduate and full-time and part-time postgraduate research provision.
- 57. A rate of funding is allocated per eligible student, which are those students recorded as being in receipt of the Disabled Students' Allowance on the HESA student record, and are subject to the minimum 10 credit value study requirement (or 8.3% FTE for PGR students). In AY 2020/21, the rate per student will be £300, the same as that available in AY 2019/20. The allocations are set out in Table 4b for part-time and postgraduate provision and in Table 5a for full-time undergraduate and PGCE provision.

Per capita funding – all taught modes and levels

- 58. The per capita amount for AY 2020/21 has been maintained at a rate of £5 per student for all taught modes and levels of study. This ensures funding at some level for all students. Payments have been determined on the basis of fundable enrolments according to AY 2018/19 HESA student record data, subject to a minimum 10 credit value study requirement. The amount of per capita funding allocated to each Provider is shown in Table 4a for part-time and postgraduate provision and in Table 5a for full-time undergraduate and PGCE provision.
- 59. Per capita funding for additional medical places is shown separately in Table 8 and not included in Table 5a. Paragraphs 70 to 72 below provide further information on the additional medical places.

Overall teaching funding allocations

60. Tables 4a and 5a show the overall teaching funding allocations. Table 4a shows both funded credit numbers and associated funding for PT UG credit-based teaching funding along with per capita and premium funding for part-time and postgraduate provision. Table 5a shows per capita and premium funding for FT UG and PGCE provision.

Part-time fee waiver

61. Our part-time undergraduate fee waiver scheme offers grants to providers that waive fees for part-time undergraduate students studying fewer than 30 credits (ie below 25% full-time equivalent), who are unemployed and registered jobseekers, or who are in receipt of Department for Work and Pensions (DWP) benefits. The figure quoted in Table 1 on page 17 represents an estimate at this stage of the expected call on this budget.

Overall research and teaching funding allocations

- 62. Table 6 sets out the allocations to each provider for teaching and research funding and provides a comparison with the funding allocations in AY 2019/20.
- 63. The AY 2020/21 figures in Table 6 do not include details of the PGT Master's incentivisation bursaries' allocation or the allocation of funding for additional medical places. These allocations are provided in Tables 7 and 8.
- 64. These allocations do not take account of any potential in-year funding adjustments for FY 2020-21 that may be applied by the Welsh Government. Any such funding adjustments will result in a revision to the individual allocations. In addition, if the FY 2021-22 allocation is different to the amount assumed for this allocation, there will be an impact on the resource available in AY 2020/21 and the associated allocations.
- 65. In order to facilitate some flexibility and collaboration, providers are offered the opportunity to redistribute PT UG funded credits between providers on a cost neutral basis. Should providers wish to exercise this option, they should jointly inform us of their intentions by the end of September 2020 by emailing hefcw.ac.uk.

Open University in Wales (OU) Mitigation funding

- 66. As we outlined in our AY 2019/20 funding allocation circular (<u>Circular W19/14HE</u> refers), we awarded transitional funding to the OU in AY 2019/20 to the value of £1.655m. We will continue to allocate this funding in AY 2020/21. However, as the OU in Wales is expected to benefit from new and future strategic funding allocations (eg RWIF, see paragraphs 34 to 39), and as we are proposing to continue to incentivise growth in PT UG provision, we will review any potential strategic funding arrangements for the OU in AY 2020/21 for allocation from AY 2021/22 onwards.
- 67. Table 6 includes the mitigation funding for the OU.

Royal Welsh College of Music and Drama – Performance element funding

68. Performance element funding for conservatoire provision is allocated to the University of South Wales for provision at the Royal Welsh College of Music and Drama (the College), which is part of the University of South Wales Group. An allocation of £585k to support strategic developments at the College is provided in addition to the Performance element funding provided through the ESP shown in

Table 5a. This strategic funding ensures that the overall funding for conservatoire provision, does not decrease below the funding provided in AY 2019/20 and AY 2018/19.

PGT Master's incentivisation bursaries

69. This is the second year of a pilot scheme to increase the number of Welsh graduates who remain in or return to Wales to undertake a Master's degree in Science, Technology, Engineering, Mathematics and Medicine (STEMM) related subjects, and Master's degrees studied through the medium of Welsh. (Circulars W19/27HE and W20/04HE refer). It is also the second year of the scheme to provide bursary funding for those studying for a Master's degree who are aged 60 or over, via HEFCW funding to providers (circular W19/29HE). Funding to be provided to providers for these two schemes is shown in Table 7.

Additional medical places

- 70. From AY 2018/19, additional medical places were funded, a total of 40 places per cohort, 20 at each of Cardiff University and Swansea University. Further cohorts started in AY 2019/20 and will start in AY 2020/21. Funding for these three cohorts for AY 2020/21, consisting of ESP funding for the clinical part of the course, higher cost subjects premium for the non-clinical part of the course and per capita funding, is shown in Table 8.
- 71. The funding is shown separately in Table 8, and not included in Tables 5a and 5b, as currently the funding for FY 2020-21 is not included in the letter from the Minister for Education.
- 72. In Table 1 (page 17), all funding related to additional medical places is shown in the AY in which the funding is made available to us from the Welsh Government for distribution, whereas Table 8 shows the allocations calculated as due for AY 2020/21.

Terms and payment of grant, data sources and audit

Terms of grant

- 73. The basis on which teaching and research funding is being provided to HE providers is set out in the Annual Schedule to the Memorandum of Assurance and Accountability between HEFCW and individual providers, and will reflect the latest Welsh Government conditions of funding. For FE providers, it is set out in their Annual Funding Agreement with HEFCW. The Funding Agreements for AY 2020/21 will be issued no later than the end of November 2020 and will specify the arrangements for adjustment of funding, where providers fail to achieve the PT UG numbers for which they have been funded.
- 74. There will be a leeway of 1% for under-recruitment on the total funded numbers for PT credit-based funding. As in prior years, funding adjustments for AY 2020/21 that are below a threshold of the lesser of £50,000 or 10% of the total teaching

allocations, or an alternative threshold as agreed by HEFCW, will not be applied. If the under-recruitment gives rise to a funding adjustment above the threshold, the threshold will be deducted from the total funding adjustment amount.

Data sources

- 75. The data used for funding have been provided and checked by providers.
- 76. The data for funded credit-based funding for teaching have been taken from data returned to HEFCW on the HESES survey by providers for AY 2019/20.
- 77. Per capita allocations and premium allocations have been based on the HESA AY 2018/19 student record data.
- 78. Welsh medium premium allocations have been based on the average of AY 2017/18 and AY 2018/19 HESA credit value data.
- 79. Funding allocations for PGR have been based on AY 2018/19 HESA student record data.
- 80. The data for funding for research have been taken from the returns to, and the outcomes of, the 2014 REF. In addition, minor volume measures data on research assistants and research students have been taken from the 2013/14 HESA staff and student records, respectively.

Payment of grant

81. In AY 2020/21, our initial payment profile proposals are detailed in the table below.

82. Should there be budget changes or cash management constraints (eg HEFCW's carry forward limit from one FY to the next), we may require this profile to be adjusted in-year.

Audit of data

- 83. The allocations of funds for teaching, PGR and QR are established by applying our funding methods to data supplied by providers. Data provided by providers and used for funding purposes are subject to audit. Details of the current process of audit can be found in circular W18/33HE Audit of Higher Education Data 2018/19 to 2021/22.
- 84. Where, as a result of audit, we find that the data on which allocations have been based, have resulted in any provider receiving an allocation larger than it is due, the

funding for the provider concerned may be adjusted.

Review of HEFCW funding methodologies

- 85. We indicated previously that we were planning a fundamental review of our teaching funding methodology to reflect the outcomes of Professor Sir Ian Diamond's independent review of higher education funding and student finance arrangements and the expectation of increased HEFCW funding. In light of the funding allocations now anticipated, and the pressures caused by the Covid-19 crisis, we are now planning for a partial review of our teaching funding methodology, for implementation from AY 2022/23. This review will be the subject of a consultation in due course.
- 86. We have committed to a review of our research funding method for implementation after <u>REF 2021</u>. This will also be subject to consultation.

Assessing the impact of our policies

87. HEFCW's funding model includes recurrent funding and strategic funding. The recurrent funding methods used for AY 2020/21 are based on historic methodology. Strategic funding for AY 2020/21 include existing and new areas of expenditure are impact assessed to consider impacts on equality, the Welsh language and the Well-Being of Future Generations (Wales) Act 2015. As part of circular (W18/24HE) Consultation on Changes to Funding Methods for AY 2019/20 and Future Developments, we commit to impact assess our new funding methodology.
