Funding Allocations 1999-2000

Introduction

- In accordance with the Council's code on the publication and distribution of information, each year the Council publishes details of its allocation of funds as part of its commitment to operate in an open and accountable way. *Funding Allocations* 1999-2000 presents the allocations by the Council of the funds made available to it by parliament in 1999-2000 and explains how the Council arrived at its decisions. Lists of the allocations are presented in the annexes to this publication.
- The allocations of funds by the Council for the period 1 August 1999 to 31 July 2000 were the sixth to be made using the funding methodology developed by the Council following the publication in December 1992 of its consultation document Funding Learning. The subsequent development of the methodology involved extensive consultation with all of the institutions funded by the Council and with representatives of training and enterprise councils, the Confederation of British Industry, the Department for Education and the Employment Department, as they then were, and other bodies with an interest in further education. Following a fundamental review of the funding methodology and the introduction of *Qualifying for Success* (curriculum 2000) the Council has implemented a revised tariff. The review will be used to inform funding decisions of the Learning and Skills Council, the successor body to the Council.
- 3 Listed in this publication are the allocations made to individual colleges in the further education sector, higher education institutions providing further education, and external institutions maintained by local education authorities and others providing courses covered by schedule 2 to the Further and Higher Education Act 1992 (the Act). The allocation made to the Further Education Development Agency (FEDA)¹ is also shown.

- 4 The Council funds:
 - colleges incorporated under sections 15
 and 16 of the Act, that is, general further
 education colleges, tertiary colleges, sixth
 form colleges other than those which are
 voluntary-aided, agriculture and
 horticulture colleges, and art, design and
 performing arts colleges
 - colleges and institutions designated as part of the further education sector under section 28 of the Act, that is, voluntary-aided sixth form colleges and other specialist designated institutions
 - institutions maintained by local education authorities (LEAs) and others which provide further education courses defined by schedule 2 of the Act (see annex A), under sponsorship arrangements set out in section 6(5) of the Act; these are referred to throughout the publication as 'external institutions'
 - higher education institutions which provide further education
 - individual placements in specialist establishments outside the further education sector for students with learning difficulties and/or disabilities
 - FEDA.
- 5 The funds made available by the secretary of state to the Council for 1999-2000 were announced in the letter of 8 December 1998 from Roger Dawe, Director General for Further and Higher Education and Youth Training at the Department for Education and Employment (DfEE). A copy of the letter was circulated to all Council-funded institutions. The funds were intended by the secretary of state to support a forecast growth in student numbers in 1999-2000 of some 23,000 16-18 year olds and 155,000 adults. Details of the available funding and planned increase in student numbers are shown in tables 1 and 2.

- 6 The Council's allocations may be used by institutions to provide matching funding for the following specific grants:
 - Home Office section 11 and section 210 grants
 - DfEE grants to travellers
 - European Social Fund (ESF) grants.
- 7 To assist students in financial difficulty, the Council received an earmarked grant of £37.36 million for distribution to colleges as access funds during the 1999-2000 teaching year. As required by the secretary of state, the funds have been distributed on the basis of numbers of eligible students at each college, together with a widening participation (WP) factor. The eligibility criteria have been extended to include full and part-time students aged 16–18 and students in external institutions.

General approach

8 The Council's funding methodology is described in full in Circular 99/07, Funding Guidance 1999-2000. The tariff is described in Circular 99/01, Tariff 1999-2000. The funding methodology operates within the Council's general approach to the institutions it funds. This approach recognises that institutions in the further and higher education sectors are independent, self-governing bodies responsible for their own affairs. The Council wishes to foster an environment that will encourage institutions to be enterprising, flexible and responsive to their students, potential students and employers.

- 9 The key features of this general approach are as follows:
 - the Council makes a main allocation of funding to institutions each year to support the provision set out in their strategic plans; institutions are free to apply this to, and between, their programmes as they see fit in accordance with their financial memorandum with the Council; the Council expects institutions to give priority to the needs of their local communities
 - the Council may also make separate allocations of funding to institutions in respect of targeted activity, for example, growth funds in 1999-2000 for 16 to 18-year-old full-time students and for part-time and adult students. Funds may not be vired between the various allocations
 - the Council makes a funding agreement each year with each institution specifying the minimum provision the institution has agreed to make in return for the funding allocated by the Council; institutions are free to enrol additional students as they consider appropriate
 - each institution is responsible for deciding which programmes to offer; the Council, however, has a duty to secure sufficient and adequate facilities for further education in England and may wish, from time to time, to make an agreement with an institution to provide particular provision

- each institution's performance is monitored against its funding agreement each year and its funding may be reduced if it falls short of its agreement.
- 10 The methodology applies to all institutions receiving recurrent funds from the Council. The Council recognises, however, that particular circumstances apply to nine of the 14 specialist designated institutions, which receive block allocations (see paragraphs 36 and 37).

Aims

- 11 The main aims of the Council's funding methodology are to:
 - emphasise the progress made by each student as an individual and in particular their:
 - initial assessment and guidance
 - learning programme and its completion
 - achievement of qualifications, with special reference to national targets
 - reflect fairly the complexity of further education
 - maintain and improve the quality of provision
 - support cost-efficient expansion
 - provide financial and planning stability for institutions
 - increase the responsiveness of institutions to the expectations of students and employers.

Objectives

- 12 The key objectives that the secretary of state set for the FE sector in 1999-2000 on the basis of the comprehensive spending review settlement are:
 - to raise standards
 - to widen participation; and
 - to meet the skills challenge.

Review of the tariff for 1999-2000

13 Institutions were consulted, in Circular 98/34, on the tariff advisory committee's (TAC's) proposals for the tariff for 1999-2000. At its meeting held on 3 December 1998, the Council considered the responses to the proposals and decided to make the following changes to the tariff for 1999-2000:

- a further extension to the number of individually-listed qualifications, including national vocational qualifications (NVQs), this being consistent with the sector's continued strong support for such an extension
- a reduction of one-third in the units available for franchised provision except that which is community based and delivered by a normally not-for-profit organisation.
- 14 The main features of the tariff for 1999-2000 are set out in table 3. The tariff was designed on the basis that a student who completes a full-time, full-year, classroom-based programme and achieves the associated qualification would generate 100 units for the institution, excluding units for tuition fee remission, childcare support and additional support. This is broadly equivalent to one weighted full-time equivalent student (WFTE), the funding measure used in 1993-94.

Table 3. Main features of the tariff for 1999-2000

An institution may claim for each student:

Entry element

A standard value of 8 units for activities leading to the enrolment of students on learning programmes of more than 10 basic on-programme units (BOPUs), or ABE/ESOL programmes of 3.8 or more BOPUs. A standard value of 4 units for programmes between 3.8 and 10 BOPUs, or ABE/ESOL programmes of less than 3.8 BOPUs, and a standard value of 2 units for other programmes of less than 3.8 BOPUs.

On-programme element

The number of BOPUs per year typically ranges between 2 and 84. The tariff value for qualifications listed individually in the tariff reflects the standard value for the qualification, irrespective of the number of guided learning hours required for completion. Other programmes attract tariff values in one of seven bands, according to the number of guided learning hours they require for completion.

The differential costs of programmes are reflected by five cost-weighting factors applied to the BOPUs and ranging from 1.0 to 2.2. One-third of the on-programme units for each year of a programme can be claimed for students deemed to be enrolled and attending on each of three census dates in November, February and May of the teaching year.

Achievement element

The number of units typically ranges between 0.2 and 20, calculated as 9.5% of the BOPUs for the learning programme, that is, excluding the cost-weighting factor.

An additional 2% is available for those qualifications contributing to the national targets (see annex A).

Units may be claimed only after evidence of students' achievements of the qualifications is available.

Tuition fee remission

Supplementary units for eligible students (see annex B) calculated as 39.6% of the basic

on-programme units for the learning programme, that is, excluding the cost-weighting factor, up to a maximum of 33.3 units for the year.

Childcare support

Supplementary units for eligible students (see annex B) calculated as 66% of the basic on-programme units for the learning programme, that is, excluding the cost-weighting factor, up to a maximum of 55.6 units for each child for the year.

Additional support

Units ranging from 19 to 900 for students classified in one of eight cost bands may be claimed in a year towards the cost of additional support for individual students, including specialist initial assessment for students with learning difficulties, up to £18,800. Additional specific funds are available for additional costs in excess of £18,800.

Widening participation uplift

Supplementary units may be claimed for eligible students recruited from areas with postcodes that are in wards qualifying for widening participation uplift. The uplift ranges from 3% to 12% and is applied to entry, on-programme and achievement units. Additionally, units may also be claimed for students in other specific categories:

- those on basic skills courses (excluding subprogramme 10F)
- those living in hostels and residential centres
- the homeless
- travellers
- those whose statutory education has been interrupted
- ullet those in, or who have recently left, care
- asylum seekers
- refugees
- ex-offenders
- full-time carers
- those with mental health problems
- those recovering from alcohol or drug dependency.

Allocations Procedure

15 The Council wishes to achieve year-on-year financial and planning stability for institutions at the same time as achieving cost-efficient growth in student numbers and maintaining and improving quality. At its meeting on 11 December 1997, the Council agreed to converge by the teaching year 2000-01 to a single value, the average levels of funding (ALFs) of all colleges and higher education institutions funded through the funding methodology. In the light of the secretary of state's guidance that the final convergence of ALFs should be delayed, the Council agreed that the target ALF for colleges for 2000-2001 be £17.00 instead of £16.20, with more flexibility for high ALF colleges to converge by 2001-02 to £17.20.

Main allocation of funds and units

- 16 The Council determined the baseline for each institution from the 1998-99 allocation of units with adjustments for:
 - the reduction in units for franchised provision
 - the transfer to the Higher Education
 Funding Council for England (HEFCE) of
 responsibility for the funding of Higher
 National Certificates and Diplomas
 - fully funding the 1997-98 widening participation units
 - additional categories of widening participation students.
- 17 Each institution was offered its 1998-99 baseline number of units plus growth units for 16 to 18-year-old full-time students and for part-time and adult students. The growth units were calculated from each institution's 1997-98 and 1998-99 ISR data. Where the reduction in units for franchised provision led to an institution's 1999-2000 unit allocation being less than its 1998-99 unit allocation, it was also offered additional unfunded units to bring its allocation up to its 1998-99 level.
- 18 Funding allocations were calculated by multiplying the baseline number of units plus additional growth units by the institution's funded ALF for 1999-2000 and, where applicable, by its London weighting factor. An institution that would not have received 90% of its previous year's funding allocation had sufficient additional funds made available to it to achieve an allocation equal to the 90% level.

- 19 The 1999-2000 ALF for colleges was calculated as follows:
 - colleges with a baseline ALF below £16.60 moved up to £16.60
 - colleges with an ALF between £16.60 and £17.00 moved up by one-half of the difference between their ALF and £17.00
 - colleges with an ALF between £17.00 and £17.20 remained constant
 - colleges with an ALF above £17.20 moved down by one-third of the difference between their ALF and £17.20.
- 20 Higher education institutions have previously had a lower convergence target than colleges to take account of the 2% capital element incorporated in colleges' allocations. The Council decided that from 1999-2000 this differential should be removed following an agreement with the HEFCE. Higher education institutions with ALFs above £17.20 were treated in the same way as sector colleges. For those with ALFs below £17.00, the minimum ALF was £16.38.
- The Council did not set a convergence objective for external institutions for 1999-2000. At its meeting on 5 November 1998 members agreed to set up an independent working group chaired by Professor Bob Fryer CBE, to advise it on the contribution of external institutions to the government's lifelong learning objectives and a future approach to funding and quality assurance issues. The group reported in November 1999: External Institutions: Final report of the review group provides the group's recommendations. Following consideration of these recommendations, the Council has determined that external institutions should converge to £17.20, the same as for colleges, in 2001-02 in two equal steps. External institutions with an ALF between £16.80 and £17.20 in 1999-2000 will follow the convergence track for colleges.

Widening participation factor allocations

22 At its meeting held on 29 January 1998, the Council agreed to provide funds over a three-year period in respect of the introduction of a widening participation factor, that is, an increase in tariff units for eligible students recruited from an area with an index of deprivation which qualifies for a widening participation uplift.

23 At its meeting held on 9 December 1998, the Council confirmed that in 1999-2000 it would fund the widening participation factor in full. Fifty million pounds was identified for this purpose.

Additional growth funds

24 For the first time since 1993-94, there was no formal application process for growth funds in the 1999-2000 funding round. However, where an institution believed that its allocation would place the Council's duty to secure sufficient and adequate further education provision at risk, it was asked to inform the Council.

Additional childcare support allocation

25 The Council made an allocation of £6 million to assist Council-funded institutions in providing childcare support for students on low incomes over and above the levels already being claimed. Over 300 institutions received part of the £6 million, including 41 new applicants who had not previously provided childcare support. The funds are to support students, not to increase the number of childcare places institutions provide. This additional allocation was included in the final allocation to institutions issued in September 1999 and does not replace claims already being made for childcare units.

IT for students with disabilities

The DfEE made available £2.5 million for IT equipment for students with disabilities, which was matched by the Council, giving a total allocation of £5 million. An allocation was offered to all Council-funded institutions in February 1999. Over 600 institutions accepted their allocation, providing them with the opportunity to purchase IT equipment and software to facilitate the enrolment of new students and enhance the learning experience of existing students.

Allocations to Sector Colleges

27 The Council considered the provisional allocations by region (see figures 1 to 5) and by institution type (see figures 6 to 10). In doing so, it confirmed that the allocation procedure had not produced any unacceptable outcomes for any region or different types of colleges. Four hundred and thirty-three colleges were notified of their provisional allocations on 26 February 1999 and given the opportunity to comment on the allocations.

Fifty-eight colleges requested that the Council reduce the number of units allocated to them.

- 28 One hundred and twenty-five colleges requested increases in their allocations. The reasons given were maintaining provision at 1998-99 actual levels of activity, meeting increased demand identified in strategic planning data, maintaining special needs provision, additional funds required for students progressing onto the second year of programmes, and meeting legal obligations in respect of religious education.
- 29 The Council delegated authority to the chief executive to determine institutions' allocations in the light of additional information. At the date of publication of this document, the chief executive had agreed amendments to the final allocations of 28 colleges.

Figure 1. Median college units funded by region




Figure 2. Median college funding by region




Figure 3. Median college funded ALF per unit by region




Figure 4. Total units funded in sector colleges by region




Figure 5. Total funding in sector colleges by region




Figure 6. Median units funded by type of institution




Figure 7. Median funding by type of institution




Figure 8. Median funded ALF by type of institution




Figure 9. Percentage of total units funded by type of institution, 1999-2000





Figure 10. Percentage of total funding by type of institution, 1999-2000



Quality

30 In a letter of guidance in July 1992, the secretary of state asked the Council, in determining funding allocations, to take account of the quality of institutions' work. To do this, the Council relied on assessments of college provision, which were available from college inspections. It paid attention to the proportion of a college's work represented by any curriculum area where weaknesses had been assessed as outweighing strengths, that is, grade 4 or 5, as a result of an inspection. In 27 such cases, for the inspection year 1999-2000, the proportion of overall college activity affected was small, that is, less than 20%. In three institutions the overall college activity affected exceeded 20%. The Council agreed that in all cases the low assessment grade, which applied to a specific area of a college's provision, should have no impact on the total number of additional units to be allocated to each of the colleges concerned. However, a condition in the funding agreements for these colleges would require them not to increase the number of new students taken onto the first year of programmes in the relevant curriculum area or areas until the Council was satisfied that the weaknesses identified had been addressed satisfactorily.

Franchising

31 As in previous years, for colleges with franchised provision, the Council also took account of quality assurance arrangements and for the first time also took account of governance and management which had been assessed by the Council's inspectorate as having weaknesses which outweighed strengths, that is, grade 4 or 5. The Council agreed that in 10 such cases a condition in the funding agreements would require them not to enter into new, or extend existing, outward collaborative arrangements until the Council's inspectorate was satisfied that the weaknesses identified had been addressed satisfactorily.

Higher education provision

32 From 1999-2000 the Council has ceased to fund any provision of prescribed HE along with HNCs and HNDs. This provision was transferred to the Higher Education Funding Council for England with associated funds.

Outcomes for sector colleges

33 The final allocations to colleges and the corresponding funded units are shown in annex C.

Key outcomes of the allocations were:

- 50% of colleges received increases in funding of at least 5% – the median for the sector
- a total of £2.95 billion was allocated to colleges, an increase of 3% over 1998-99
- the allocations are expected to achieve for 1999-2000 the rate of convergence in inherited average levels of funding between colleges necessary to reach a single value by the year 2001-02
- the median average level of funding for a college is £16.95.
- 34 Figure 11 shows the distribution of increases in funding from 1998-99 to 1999-2000 allocated to sector colleges.

Allocations to Higher Education Institutions




Figure 12. Distribution of allocations for higher education institutions: allocations

35 The 53 higher education institutions received allocations, which conformed to the detailed procedures approved by the Council, and described above. The allocations of £65.7 million and the corresponding funded units are shown in annex C. Figure 12 shows the distribution of increases in funding from 1998-99 to 1999-2000 for higher education institutions.

Allocations to Specialist Designated Institutions

Allocations of funding to nine of the 14 specialist designated institutions, were made on a block allocation basis, outside the Council's methodology; for the others including the Marine Society College of the Sea, allocations were made on the basis of the Council's funding methodology. However, in applying the methodology, the Council recognises that the particular circumstances of these institutions have to be taken into account. Adjustments were made to take into account the decision taken by the Council at its meeting held on 6 April 1995, to maintain at the 1994-95 level, the funding of non-schedule 2 provision in the inner London institutions and the Workers' Educational Association (WEA). For 1999-2000, their full-time equivalent student numbers were maintained at their 1998-99 levels.

Figure 11. Distribution of allocations for sector colleges: allocations





Figure 13. Distribution of allocations for external institutions: allocations



37 The Council also provides funds, at the six long-term residential colleges, for the long-term residential colleges' adult bursary scheme. This scheme provides financial support to students on low incomes. Allocations to the Marine Society College of the Sea (part), and Hilderstone College were based on their 1998-99 allocations.

Allocations are shown in annex C.

Allocations to External Institutions

- 38 As has been the case since 1994-95, allocations of funding to external institutions were made according to the same procedure used for sector colleges and higher education institutions. External institutions were given the opportunity to comment on their provisional allocations and their responses were considered against the same principles used for the responses by sector colleges and higher education institutions.
- 39 Ninety-one external institutions (41%) received increases in their allocations of 14% or more compared with 14 sector colleges.

New applicants

40 No institutions not previously supported by the Council applied for funding for 1999-2000 under section 6(5) or section 5(1) of the Act.

Outcomes

- 41 A total of £78.8 million was allocated to 220 external institutions in 1999-2000 compared to the £70.4 million allocated to 230 institutions in 1998-99. The provision by external institutions represents 4% of the total units and 3% of the FTEs funded by the Council. The median average level of funding for external institutions for 1999-2000 is £11.61 for each unit compared with £16.95 for colleges. The allocations to external institutions and the corresponding funded units are shown in annex D. Figure 13 shows the distribution of increases in funding from 1998-99 to 1999-2000 for external institutions.
- 42 The Council reviewed its arrangements for funding external institutions in the light of the recommendations of the Fryer Group (see paragraph 21), including those not previously supported, before allocations were made for 2000-01.

Adequacy and Sufficiency

43 In response to the provisional allocations, 28 institutions indicated that they thought the proposed allocations would pose a threat to adequacy and sufficiency. The Council reviewed all these cases, and concluded that 23 of them did not pose a threat to adequacy of facilities.

Funding Agreement

- 44 The Council formalises its funding with each institution in a funding agreement. In the case of sector colleges, this forms Part 2 of the financial memorandum between the Council and colleges. Under the agreement, the Council undertakes to pay the agreed allocation of funds in support of that part of the institution's strategic plan for 1999-2000, or equivalent, subject to responding to unforeseen circumstances. In return, the institution is expected to generate at least the number of funded units allocated to the institution.
- 45 An institution will be allowed to carry forward up to 2% of its funded units in respect of the main allocation and widening participation factor for up to two years, where its failure to deliver its funding agreement is the result of circumstances which it could not reasonably have foreseen. In other cases, including additional growth units provided in respect of 16 to 18-year-old full-time students and widening participation, and where units carried forward are not subsequently delivered, its funding allocation will be reduced for any unit by which it falls short of its funding agreement. Any such reduction shall be made at the rate at which activity has been funded, although any reduction shall be limited so that the institution's allocation for the year is not less than 90% of its funding in respect of the main allocation and widening participation factor.
- 46 Each institution's performance of its funding agreement will be monitored during and at the end of the year. As for 1998-99, the Council requires institutions to provide in 1999-2000 only one in-year return to enable an estimate of likely performance to be calculated. For this purpose the Council will use institutions' ISR15 (1 November 1999; 1999-2000) return. Institutions will not be required to provide a return in the spring 2000 term. Institutions will be required to provide a final funding unit return in respect of 1999-2000 using ISR19 (31 December 2000; 1999-2000).
- 47 The funding for sector colleges and the specialist designated institutions is also subject to the terms and conditions of the financial memorandum between the Council and the college. As set out in *Funding Guidance 1999-2000*, the Council has attached the following general conditions to its funding for colleges in 1999-2000:

- a. no tuition fees shall be charged to students aged 16 to 18 in full-time education in accordance with the secretary of state's condition of grant to the Council. For these purposes '18' means 'under 19 on 31 August in the calendar year when the student commences a programme of study'. It is intended that such a student should continue to receive free tuition in any consecutive subsequent year of study on the same programme;
- b. colleges in the FE sector shall provide the data required by the secretary of state to permit the publication of comparative performance tables on student achievement and other matters in 1999, in the light of consultation. In particular, each college shall:
 - provide to the Department for Education and Employment in a form and at a time to be specified, summary data relating to student achievements in vocational qualifications; and
 - ii. subsequently publish, alongside its own section 50 information, national summary data relating to all qualifications;
- c. colleges in the FE sector shall have a college charter as envisaged in the *Charter for Further Education*;
- d. as required by section 30(3) of the *Disability*Discrimination Act 1995, colleges shall publish a disability statement, as described in the
 Education (Disabilities Statements for Further
 Education Institutions) Regulations 1996;
- e. colleges in the FE sector will be expected to follow public sector pay policy, by taking account of fairness, the need to recruit, retain and reward staff, and the affordability within the limits set by the comprehensive spending review in July 1999;
- f. funds identified in the college's funding agreement as being for capital purposes shall be used solely for direct expenditure on capital equipment and/or premises; and/or to support borrowing and/or finance leases for such purposes;
- g. where the inspectorate has assessed a curriculum area at grade 4 or 5, the college shall not increase the number of students taken onto the first year of programmes in the curriculum area or areas in question until the inspectorate is satisfied that the deficiencies have been remedied and the curriculum area has been regraded;

- h. if the inspectorate has assessed the college's quality assurance arrangements at grade 4 or 5, the college may not enter into new, or extend existing, Council-funded franchise arrangements until the inspectorate is satisfied that the deficiencies have been remedied. The college shall not increase either the student numbers or the funding units for franchise arrangements above the numbers at the date on which the college was notified by the Council of the grading for its quality assurance arrangements. Subject to consultation, this may be extended to include grades 4 or 5 for governance and for management;
- the institution shall endeavour to provide for at least the same number of students with learning difficulties and/or disabilities as it did in 1998-99 and at least to maintain the proportion of such students in its overall enrolment total;
- j. in addition, the Council attached the following specific condition in relation to sponsored institutions: where the sponsored institution is not subject to an OFSTED inspection, the sponsored institution shall provide access to the Council's inspectorate to assess the quality of its provision.
- 48 Conditions (a) to (e) inclusive are requirements of the secretary of state. Only conditions (a), (g) and (i) apply to higher education institutions.
- 49 External institutions are required to comply only with the conditions concerning collaborative arrangements and students with learning difficulties and/or disabilities. Those institutions which are not subject to an OFSTED inspection are also subject to the further condition that the sponsored institution shall provide access to the Council's inspectorate to assess the quality of provision. In accordance with section 6(5)(a) of the Act, the Council does not have the power to fund, in sponsored institutions, provision for 16 to 18-year-old full-time students as defined in section 2(1) of the Act.

Funds for Students with Learning Difficulties and/or Disabilities

50 The Act requires the Council to take into account the needs of students with learning difficulties and/or disabilities when securing facilities for further education. The interpretation of the term 'learning difficulty' used by the Council is

- that given in the Act. The then secretary of state emphasised the importance he attached to the Council's duties towards these students in his letter of guidance to the Council in July 1992. The Council established a committee, chaired by Professor John Tomlinson, to advise it on how best to carry out these responsibilities. The Council published a report *Inclusive Learning* in September 1996 on behalf of the committee.
- 51 Funding for students with learning difficulties and/or disabilities attending sector colleges, higher education institutions and external institutions is included within the funding which comprises each institution's allocation. The Council's funding methodology enables institutions to include units for any costs of additional support provided to the individual (including specialist assessment) associated with the educational programme on which the individual is enrolled, up to £18,800. These units are in one of eight cost bands (see table 3). The Council will provide eligible additional costs above this sum where an institution can demonstrate the need for such additional funds.
- 52 As already described, the Council has included in its funding agreement with colleges and other institutions receiving funds in 1999-2000, a condition that the institution shall endeavour to provide for at least the same number of students with learning difficulties and/or disabilities as it did in 1998-99 and at least to maintain the proportion of such students in its overall enrolment total (see paragraph 47 i).
- 53 The Council is also responsible for securing provision for students with learning difficulties and/or disabilities in establishments outside the sector if there is no suitable provision at a sector college. In 1999-2000, the Council funded 2,140 students to attend 66 specialist establishments at a total cost of some £46.3 million. Decisions are taken in accordance with published criteria. Capital funds of £588,000 were earmarked to support expenditure by specialist establishments on buildings and equipment for students with learning difficulties and/or disabilities. The Council invited these specialist establishments to make proposals for these funds, and gave preference to applications which offered value for money and which related to health and safety matters and the improvement of physical access and security of equipment. The Council allocated funds totalling £588,000 to 19 establishments; one project was subsequently

deferred. Details of the allocations are not included in this publication.

Disability grants

- 54 The secretary of state also proposed in his letter of 8 December 1998 that the Council should set aside some monies in order to assist colleges to comply with the requirements of the *Disability and Discrimination Act 1995*.
- 55 The Council set aside a provisional budget of £12 million, budgeted as £4 million a year for three years. Colleges were invited to apply for the relevant works. One hundred and sixty-two colleges submitted applications of which 144, representing £10.74 million of work to improve disabled access and accessibility, were agreed.

Capital Allocations

56 The secretary of state identified £40 million of the Council's grant for 1999-2000 to be used for capital and IT infrastructure purposes. Of this, some £12 million was allocated to IT infrastructure and £7 million for capital work in respect of rationalisation. The secretary of state looks to the Council to ensure that institutions make sensible provision to maintain and update their equipment and estates, and make maximum use of the private finance initiative (PFI) in support of this. In 1999-2000, £2 million of recurrent funding was earmarked to support the costs of PFI procurement. The Council used these funds to provide a 2-megabit connection to the internet for 425 colleges, so that by April 2000, 42% of colleges would have a high-speed connection to the internet.

Capital project support

57 The government made available an extra £28 million for capital investment. This was added to the existing baseline of £30 million for capital projects. The government also provided a shadow budget, which increased capital funding for the following two years. The Council in consequence raised its contribution to college capital projects to 35% of the allowable capital funds, plus £15,000. Colleges responded to the government's initiative and to that higher funding by producing a much higher level of capital projects. One hundred and fifty-four million pounds of capital projects had come forward for a capital contribution in the financial year 1998-99. During financial year 1999-2000,

134 capital projects valued at about £472 million came forward for determination.

58 The capital project support payments are outside the Council's mainstream funding arrangements and have not been taken into account in determining colleges' average levels of funding. The allocations to the colleges concerned are shown in annex C.

Funds identified for capital purposes

59 For 1999-2000, the Council requires colleges to set aside funds for capital purposes. The capital element included in individual colleges' allocations for 1999-2000 is shown in annex C. This shall be used solely for direct expenditure on capital equipment and/or finance leases for such purposes.

Other Allocations

Access funds

- 60 The Council is responsible for administering the funds provided by the DfEE to assist students who are in financial difficulty. Following a review of access funds by the DfEE, the Council received an earmarked grant of £37.37 million (£12.74 million for 1998-99) for this purpose for distribution to colleges in the 1999-2000 teaching year. The increase in access funds took account of the extension of eligibility for support to full and part-time further education students and to students in external institutions. In 1999-2000 local education authorities (LEAs) will retain responsibility for discretionary awards for further education students eligible for awards in 1998-99. LEAs will also retain responsibility for financial support for transport costs for FE students.
- 61 In 1999-2000, access funds were allocated on the basis of five elements:
 - £5.26 million for 16 to 18 year olds. This has been distributed on the basis of full-time equivalent (FTE) numbers of students aged 16 to 18. Eligible student numbers include both full-time and part-time students. The rate is £10.96 per FTE

- £10.55 million for adult students. This has been distributed on the basis of full-time equivalent numbers of adult students. Eligible student numbers include both full-time and part-time students. The rate is £29.51 per FTE
- £19.3 million for widening participation.

 This has been distributed on the basis of colleges' proportionate shares of the funds provided in respect of widening participation (WP) factors. The rate is £7.72 per unit
- £1 million for external institutions. Half of this sum (£500,000) has been allocated on the basis of FTEs including both full-time and part-time students. The provisional rate is £18.98 per FTE. The remainder has been distributed on the basis of external institutions' shares of the funds provided in respect of widening participation. The rate is £4.68 per unit
- £1.26 million for higher education (HE) students in further education colleges. This has been allocated on the basis of eligible part-time HE student numbers to recognise the purpose for which it has been provided. The rate is £464.40 per FTE.
- 62 The relevant number of students for initial allocations was obtained from the ISR12 return (1 November 1998: 1998-99), or the latest available data where that return had not been provided to the Council.
- 63 Colleges were informed of the initial allocations based on the ISR data, and the terms and conditions attached by the secretary of state to access funds, in Circular 99/27 in June 1999. Details of the allocations are not reproduced now in this publication. Where colleges subsequently revise their data, actual allocations may differ from the initial allocations.

Further Education Development Agency¹

64 The then secretary of state for education and the secretary of state for Wales accepted, in January 1994, the advice of the English and Welsh funding councils to establish the Further Education
Development Agency (FEDA). It succeeded the
Further Education Unit and the Staff College which
were wound up on 31 March 1995. FEDA supports
and develops the management of learning across the
whole of further education to secure improvements
in quality and delivery. The Council has provided
£4 million to support the activities of FEDA up to
31 July 2000 including £2 million for strategic
programmes. In addition it has allocated some
£390,000 for the Quality in Information and
Learning Technology (QUILT) initiative.

The FHE Act 1992 and National Learning Targets

Schedule 2

Courses of Further Education

The description of courses of further education referred to in section 3(1) of this Act are the following:

- a course which prepares students to obtain a vocational qualification which is, or falls within a class, for the time being approved for the purposes of this subparagraph by the secretary of state;
- b. a course which prepares students to qualify for:
 - i. the general certificate of secondary education, or
 - ii. the general certificate of education at advanced level or advanced supplementary level (including special papers);
- a course for the time being approved for the purposes of this subparagraph by the secretary of state which prepares students for entry to a course of higher education;
- a course which prepares students for entry to another course falling within paragraphs (a) to (c) above;
- e. a course for basic literacy in English;
- a course to improve the knowledge of English of those for whom English is not the language spoken at home;
- g. a course to teach the basic principles of mathematics;
- h. in relation to Wales, a course for proficiency or literacy in Welsh;
- j. a course to teach independent living and communication skills to persons having learning difficulties which prepares them for entry to another course falling within paragraphs (d) to (h) above.

The National Learning Targets for England for 2002

Aim

To improve the United Kingdom's international competitiveness by raising standards and attainment levels in education and training to world-class levels through ensuring that:

- all employers invest in employee development to achieve business success
- all individuals have access to education and training opportunities, leading to recognised qualifications, which meet their needs and aspirations
- all education and training develops selfreliance, flexibility and breadth, in particular through fostering competence in core skills.

 A* to C, an NVQ level 2 or a GNVQ
 intermediate or equivalent)
- 60% of 21 year olds with a level 3 qualification (that is, two A levels, an NVQ level 3, a vocational A level or the equivalent).

Targets for 16 year olds

- 50% of 16 year olds gaining five higher grade GCSEs (that is, GCSEs at grades A* to C, or the equivalent)
- 95% gaining at least one GCSE.

Targets for 11 year olds

- 80% of 11 year olds reaching the expected standard for their age in literacy, and
- 75% reaching the standard in numeracy.

Summary of the Funding Methodology

Background

- Before the Council introduced its new methodology, funds were allocated on the basis used by LEAs when they were responsible for the institutions, namely the numbers of enrolments on courses each year. This approach did not take account of the extent to which students dropped out from their courses or failed to achieve their qualifications. Unfinished Business, a report of a joint study by the Audit Commission and the Office for Standards in Education (OFSTED), published in 1993, estimated that the cost of courses taken by students aged 16 to 18 in schools and colleges who did not achieve their intended qualification aims was around £500 million each year. A further difficulty was that part-time student enrolments were classified as block release, part-time day or part-time evening modes of attendance, and counted as proportions of a full-time enrolment, with a variety of weightings used for funding and other purposes. In addition, the classifications used to define student modes of attendance did not adequately reflect the flexible ways in which institutions increasingly were delivering courses and wished to develop learning programmes in the future.
- 2 The Council's funding methodology was designed to address the shortcomings of previous approaches to funding. For example, in addition to student numbers, it also takes into account both the initial guidance and assessment received by students and institutions' effectiveness in supporting student learning and achievement.

Funding Units

3 The education and training for which an institution receives funding from the Council is expressed in terms of a measure called the funding unit, rather than in full-time equivalent enrolments. Standard values of units are generated by an institution for the following elements of each student's learning programme.

Entry Activities

4 Entry activities are defined as 'all activities leading to the enrolment of a student on a learning programme'. The units may be claimed only for students with whom the institution has entered into a learning agreement, signed by both parties, setting out the student's primary learning goal, the support the institution has agreed to provide to help the student achieve it, and confirming that in reaching the agreement the student has had the benefit of adequate initial assessment and guidance.

On-programme Activities

On-programme activities are defined as 'all activities of learning and accreditation of achievement, including assessment, general and specific student support services and enrichment activities'. Programmes are defined in terms of qualification aims (for example, national vocational qualifications (NVQs), general certificate of education (GCE) advanced level qualifications). The standard value of units available for each qualification has a component which reflects the length of the programme (the 'basic on-programme' units) and a component which reflects its relative cost (the 'cost-weighting' factor). For example, the cost of an engineering programme is greater than the cost of a business studies programme. The length of each programme is defined in terms of 'guided learning hours'. These are intended to represent the time during which an institution directly incurs expenditure in support of a student's programme. The on-programme units are accumulated term by term for each term wholly or partly completed by the student. If, for example, a student on a one-year programme dropped out during the second term, the institution would be able to claim on-programme units for only the first two terms of the year.

Achievement

6 A list of eligible qualifications and achievements for this element of funding is provided in Circular 99/01: *Tariff 1999-2000*. The list comprises, in the main, qualifications externally accredited by validating bodies such as the Business and Technology Education Council (BTEC), City & Guilds of London Institute (C&G) and the GCE examining boards. College certificates without

external accreditation are eligible specifically to recognise the achievements of students with learning difficulties and, for the present, certain other specialised qualifications.

Tuition Fee Remission

Institutions and LEAs are free to set their own tuition fee policies, subject to the requirement of the secretary of state that fees may not be charged to students aged 16 to 18 in full-time education. For the purposes of the funding agreement, '18' means 'under 19 on 31 August of the calendar year when the student commences a programme of study'. In addition, to promote access to further education by people on low incomes and to encourage basic education, units may be claimed by institutions which remit 100% of the tuition fee to students receiving unemployment benefit or means-tested state benefits, and their unwaged dependants, and students taking a programme of adult basic education (ABE) or English for speakers of other languages (ESOL).

Childcare Support

8 These units may be claimed for students who are either receiving, or who are unwaged dependants of persons receiving, unemployment benefit or means-tested state benefits; and students taking programmes of ABE or ESOL where an institution provides either a crèche or playgroup facilities at no cost, or meets 100% of the costs incurred in securing the provision of childcare during the student's programme of study.

Additional Support

9 This is defined as 'any activity which provides direct support for learning to individual students, which is over and above that which is normally provided in a standard learning programme which leads to their primary learning goal. The additional support is required to help students gain access to, progress towards and successfully achieve their learning goals. The need for additional support may arise from a learning difficulty or disability or from literacy, numeracy or language support requirements'.

Widening Participation

10 A widening participation uplift may be claimed for any student who is recruited from an area with a postcode which is in a ward considered to be relatively more deprived. The Council has produced an index based on the index of local conditions produced by the Department of Environment, Transport and Regions (DETR), and recognises for an uplift factor wards containing 25% of the most disadvantaged students. The uplift ranges from 3% to 12% and is applied to entry, on-programme and achievement units.

Tariff

- 11 The total number of units generated by each student varies according to the type of programme followed, the student's progress through the programme, their success at the end of it, and the degree of financial and other support made available by the institution. The total activity being supported by funding from the Council at an institution can then be expressed as the sum of units generated for each student. In the same way, the funding agreement between the Council and each institution specifies the minimum number of funding units, which the institution has agreed to generate in return for the funds allocated to it.
- 12 The standard values of units available for each element of a student's programme are set out in a tariff. The Council has established a tariff advisory committee (TAC) which is chaired by Steve Broomhead, chief executive of Warrington Borough Council. Membership of the TAC is made up of senior staff from colleges and other institutions funded by the Council. The TAC advises the chief executive on the elements of provision to be differentiated for funding purposes and on the value of units to be assigned to each element in the light of research and consultation with institutions.
