Schools are required to deliver a minimum number of school sessions in any given school year.

The Education (School Day and School Year) (Wales) Regulations 2003 provides that every day on which a school meets is to be divided into two sessions which are to be separated by a break in the middle of the day unless exceptional circumstances make this undesirable. At least 380 school sessions are required during any school year. This excludes nursery schools.

Actions for schools and local

end of summer term should have already published their revised term dates to account for the extended autumn half term break on their websites. Schools and local authorities should make their 'back to school' plans

ensuring that any further interruption to children and young people's education is kept to an absolute minimum. Consideration of the impact of closing schools for planning and preparation days on learners and their parents should be a priority for all schools and local authorities. The amended required number of sessions must be adhered to, as per

the Regulations. We have also provided advice for schools and local authorities on the

temporary disapplication of the regulations governing changing school session times.


