Introduction

- 1. This circular sets out our overall funding for HEFCW-funded higher education (HE) providers in Wales for the academic year (AY) 2021/22 of £206.5m. This includes individual provider allocations for teaching, research and innovation funding.
- 2. HEFCW grant funding does not include payments for tuition fee grants or other student support payments administered by the Welsh Government.
- 3. The Welsh Government allocates funding to HEFCW annually on a financial year (FY) basis from 1 April to 31 March. HEFCW allocates funding to HE providers on an AY basis from 1 August to 31 July. We use this format FY 2021-22 to denote the financial year to 31 March 2022, and this format AY 2021/22 to denote the academic year to 31 July 2022.
- 4. For ease of comparison, this circular provides detail of HEFCW's total allocation in the previous AY. The AY 2020/21 funding allocation figures provided here (£311.7m) is £140.2m higher than that announced in W20/20HE HEFCW's Funding Allocations 2020/21 (£171.5m). This was mainly as a consequence of additional in-year funding allocations due to Covid-19, contained in the update to Annex 1 of the FY 2020-21 remit letter (totalling £126.4m as detailed in paragraphs 11 to 16), funding carried forward from AY 2019/20 (£11.1m) and additional funding FY 2020/21 as detailed in paragraph 17 (£9.5m). These are offset by degree apprenticeship adjustments (£3.6m).
- We do not require providers to directly replicate our approach to establishing allocations when making their own internal allocations. We expect that decisions on detailed resource allocations to departments and courses will be made strategically to reflect local circumstances and priorities and with due regard to the potential impact of allocations in terms of providers' statutory responsibilities, including those for equality and diversity, as well as other Welsh Government priorities.
- 6. We administer our funding based on powers set out in the Further and Higher Education Act 1992, which determines the nature of activities eligible for funding. The activities eligible for funding are mainly those undertaken by Higher Education Institutions with some funding provided for the provision of prescribed courses of higher education at Further Education Institutions. Separately, we regulate institutions that have approved Fee and Access Plans under powers set out in the Higher Education (Wales) Act 2015. As a result of becoming regulated, institutions will have their full-time undergraduate courses automatically designated for student support. Additionally, we administer a process that allows providers to have courses, not automatically designated for student support, to be specifically designated for student support on a case by case basis. These two aforementioned processes that lead to course designation by Welsh Government, do not relate to our functions to administer funding to institutions. As such, being regulated or having course designation does not result in providers receiving the funds that we administer and have set out the allocations for in this circular.

Contents

- 7. This circular covers all elements of our funding allocation for AY 2021/22. The Welsh Government published its final budget for FY 2021-22 in March 2021; the corresponding <u>remit letter</u> was also received in March 2021. Each year the Welsh Government publishes the grant for HEFCW and details in its remit letter the priorities we are expected to follow in the distribution of that grant.
- 8. This circular includes all formula-driven recurrent grants as well as grants allocated subject to the provision of a specific expenditure plan or strategy. The overall budget and funding allocation details are presented in Table 1 (page 17) at the macro level. Capital allocation details by institution are announced separately, as are funding allocations for strategic initiatives such as Reaching Wider, Postgraduate Bursaries and Degree Apprenticeships.

Structure

- 9. The sections in this circular are:

- 10. This circular also covers such matters as data sources, terms of grant, payment arrangements and audit, where appropriate.

Overall budget distribution AY 2021/22

Financial Year (FY) 2020-21 budget revisions

- 11. The comparative funding for AY 2020/21 included in Table 1 (page 17) takes account of all the changes made to the FY 2020-21 funding allocation in our final remit letter for that year, since the preliminary indication of budget of £171.9m received in April 2020 was the basis for our original funding allocation for AY 2020/21.
- 12. HEFCW subsequently received its FY 2020-21 remit letter in <u>August 2020</u>, which provided additional funding of £31.5m to mitigate the effects of the Covid-19 pandemic:
 - £27m to support the sector through the Higher Education Investment and Recovery Fund, <u>W20/27HE</u>.

- £3m to support Degree Apprenticeships. This funding was subsequently repurposed in the revised March 2021 remit letter to support research and innovation aligned to achieving benefits to the economy (allocated via the Research Wales Innovation Fund).
- £1.5m to provide additional support to GO Wales (Graduate Opportunities 2020).
- 13. As a result of these changes, funding allocations for AY 2020/21 were revised subsequent to the original circular published in August 2020 <u>W20/20HE</u>.
- 14. A revision to the FY 2020-21 remit letter in October 2020 provided an additional allocation of £10m to enable universities to support student mental health services and provide financial hardship funding for their students.
- 15. A further revision to the FY 2020-21 remit letter in <u>January 2021</u> provided an additional allocation of £40m to address student hardship.
- 16. A final revision to the FY 2020-21 remit letter in March 2021 detailed an additional allocation of £44.9m to support the following:
 - £44m capital resource to support capital investments aligned with strategic priorities and to address the financial impact of the Covid-19 pandemic on other funding available for capital investment.
 - £836k to cover additional costs in FY 2020-21 arising from the increase in undergraduate medical education places in place since AY 2018/19.
 - £101.3k expensive subjects and higher cost subjects premium costs for additional medical places and dental places, required for temporary changes in intakes due to the Covid-19 pandemic.
- 17. In addition to the additional funding summarised above in FY 2020-21, the budget is higher than had been originally anticipated in the AY 2020/21 allocations published in W20/20HE. We have therefore been able to increase the AY 2020/21 budget by £9.5m, allocating £4.8m to the higher cost subjects premium and £4.7m to QR. These allocations were made following W19/33HE and W19/45HE consultation responses.

Financial Year (FY) 2021-22 budget

18. The Welsh Government FY 2021-22 budget was finalised in March 2021. The table below provides a comparison of the original FY 2020-21 remit letter, the final FY 2020-21 remit letter and the FY 2021-22 remit letter.

Derivation of AY 2021/22 budget

- 19. The academic year budget is calculated using a proportion of one year's financial year budget (usually 60%) and a balancing proportion (usually 40%) of the next.
- 20. The Minister for Education's <u>remit letter</u> for FY 2021-22 includes funding allocations for degree apprenticeships, Global Wales III, PGT Master's incentivisation bursaries and capital funding, which have been treated as ring-fenced budgets for activity to be delivered within particular academic years and over a fixed time period so they are not included as recurrent annual funding. Therefore, these budgets have not been taken into account when determining the proportions of each financial year budget available to resource AY 2021/22. Instead they have been split between academic years in line with our expected expenditure profiles. This is reflected in the table below and in Table 1 on page 17.
- 21. Additional funding for degree apprenticeships is expected during FY 2021-22.
- 22. The FY 2022-23 budget used in our calculations is an estimate that we have made based on the funding allocated in our remit letter for FY 2021-22. No indicative budget information has been received from the Welsh Government but, for the purposes of finalising our funding for AY 2021/22, we have provided a 10% contingency provision compared to the FY 2021-22 allocation in our funding assumption for FY 2022-23. It is possible that the actual FY 2021-22 funding allocated to HEFCW by the Welsh Government could be lower than assumed, with the consequent risk that the funding available for AY 2021/22 could be reduced. Any significant variance in the FY 2022-23 budget compared to our assumptions could also require changes to the allocation for AY 2021/22.

23. The distribution of financial year allocations to AY 2021/22 is in the table below.

25. The additional funding provided in the remit letter for FY 2021-22 has been allocated in accordance with the recommendations of the <u>Diamond review</u>. As a result, funding for research, innovation and higher cost subject provision has been increased to continue to implement the report's recommendations.

Budget Allocation

- 26. Table 1 on page 17 provides an analysis of the total funding allocation by the main budget headings for AY 2021/22.
- 27. The equivalent figures for AY 2020/21 are shown for all budget lines.

Allocation of funding for research and innovation

Quality Research (QR)

28. The QR component of the recurrent grant recognises the quality and volume of research, as demonstrated by the 2014 Research Excellence Framework (REF). For AY 2021/22, the funding set aside for QR is £81.7m. This represents an increase in AY 2021/22 of £5.9m compared to AY 2020/21.

^{4 –} Includes Investment Recovery Fund, Graduate Support Programme, Support for Student Mental Health, Student Hardship and £900k Well-being and Health. Additional Covid-19 funding of £3m is included as Research Wales Innovation Fund (RWIF) and not included here.

- 29. The QR funding includes £132k that was formerly provided for the University of Wales Press. Since the transfer of that funding to QR in AY 2011/12, it has been ring-fenced within provider allocations for the purpose of supporting scholarly publications and related activities in the fields of Welsh culture, history and literature. The ring-fenced amounts for individual providers remain at the levels agreed for AY 2011/12.
- 30. The AY 2021/22 QR allocations are set out by provider in Table 2a. A breakdown for each provider by unit of assessment (UoA) is provided in **Annex A**. The funding per unit volume by subject group and quality level is shown at **Annex B**.

Postgraduate Research (PGR) Training

- 31. PGR is supported outside the research funding method. We operate a separate funding stream to support the training that providers provide for PGR students. The threshold for a UoA to be included in the calculation of PGR funding is set at the same level as QR: ie only UoAs that qualify for QR funding are allocated PGR support.
- 32. Funding is within an overall maximum amount agreed by HEFCW each year and is based on the most recent confirmed number of actual enrolments. These are the eligible, fundable enrolments in UoAs that qualify for QR funding in AY 2021/22. The enrolment data is taken from the Higher Education Statistics Agency (HESA) student record returns for AY 2019/20.
- 33. For AY 2021/22, HEFCW has set the overall maximum amount of funding for PGR at £6.237m. This is a reduction from the total allocated in AY 2020/21 of £6.487m. That amount was reduced by £250k to take account of the small number of ineligible EU students contained within the data used for allocation. Funding is calculated by multiplying the data taken from the HESA record by the standard unit of funding for the particular subject group. In doing this, not all PGR recruitment can necessarily be funded within the funding available. Where the funding allocated to providers on the basis of the standard units of funding would exceed the total available, allocations are reduced on a pro-rata basis. For AY 2021/22, this means that the allocations were reduced by £256k (3.9%) to reflect that not all of the provision can be funded at the standard units of funding within the funding available. The PGR allocations are set out in Table 3.

Research Wales Innovation Fund (RWIF)

- 34. RWIF has been designed to support the range of knowledge exchange activities that result in economic and social impact, including the wider civic mission role of providers. The funding provides support for providers to work with businesses, public and third sector organisations, community bodies and the wider public. Knowledge exchange activities that contribute to economic growth, productivity and supporting the civic role of providers are high priorities.
- 35. RWIF comprises two elements: (i) A capacity grant to enhance performance outcomes and create stability in the sector; and (ii) a formula allocation which rewards performance against HEFCW national measures for innovation.

- 36. Based on a total budget of £15m, the capacity grant will be set at £250k per institution. The maximum allocation which any institution can receive (combined capacity grant and formula) is £4m per year. The minimum has been set at £400k per institution.
- 37. The RWIF formula funding method uses three years of data submitted to the HESA Higher Education Business Community Interaction (HEBCI) Survey (AY 2017/18 to AY 2019/20) with the years weighted 2:3:5. This element of the funding calculation is reviewed annually, with the potential for providers to see an increase of up to 30%, or a decrease to a maximum of -10%. The level of the funding percentage increase will be determined annually based on incentivising performance, and availability of funding.
- 38. Due to the impact of Covid-19 the availability of verified HESA HEBCI survey data is later than normal this year. Following verification of the data, the finalised RWIF allocations will be published in a separate circular alongside HEFCW's request for monitoring of the AY 2020/21 allocations. Allocations presented in Tables 2b and 6 are therefore **provisional**, and based on unverified data.
- 39. Further information on RWIF metrics and strategy requirements can be found in circular <u>W20/09HE</u>.

Allocation of funding for teaching

Premium funding – full-time undergraduate (FT UG) provision

- 40. For AY 2021/22, the expensive subjects premium (ESP), and the higher cost subjects premium are being allocated for FT UG provision. The ESP is allocated in respect of Clinical Medicine/Dentistry and Conservatoire Performance Element provision while the higher cost subjects premium is allocated in respect of Nonclinical Medicine/Dentistry, Science & Engineering and Technology, and Mathematical Sciences, IT and Computing.
- 41. The rates of funding used in the allocation of ESP funding are remaining at the same level as in AY 2020/21, at £86.25 for Clinical Medicine and Dentistry provision, and £51 for Performance Element provision. These rates of funding were set in AY 2019/20 and were calculated to provide equivalent rates at the time, to funding allocated by the Office for Students in England for similar provision. The allocations are outlined in Table 5a and are based on the two premium rates below, awarded per completed credit value:

Expensive subjects premium:

- Rate 1 £86.25, applied to Clinical Medical/Dentistry subjects (equivalent to ASCs 1b and 1d)
- Rate 2 £51, applied to Conservatoire Performance Element (Performance Element provision in ASC 10).
- 42. In addition, as was the case in AY 2019/20 and AY 2020/21, funding for ESP will be capped by limiting the number of credit values that can be used in the calculation. For Clinical Medicine and Dentistry, this is the credit values equivalent to the number of

- quota clinical places. For Conservatoire provision, this is the credit values equivalent to the funded student number agreed as part of the special funding arrangement in place, prior to the introduction of the revised tuition fee regime in AY 2012/13.
- 43. Additional funding has been made available for the higher cost subjects premium in AY 2021/22. The additional funding of £7.3m, compared to AY 2020/21, means that the units of funding for the higher cost subjects premium have increased in AY 2021/22. It should be noted that the comparison with AY 2020/21 takes into account the additional funding that was allocated to the higher cost subjects premium during AY 2020/21 (see paragraph 17). The allocations for the higher cost subjects premium are outlined in Table 5a and are based on the premium rates below, awarded per completed credit value, with the AY 2020/21 rates in brackets for comparison:

Higher cost subjects premium:

- Non-clinical Medicine/Dentistry £11.43 (£7.13)
- Science & Engineering and Technology £6.57 (£4.10)
- Mathematical Sciences, IT and Computing £3.07 (£1.92)
- 44. The subjects included in the higher cost subjects premium are those where the cost of provision is estimated to be higher than the average tuition fee assumed received by providers in Wales, according to work done in AY 2019/20. Details of the method used to calculate the original rates of funding is included in circular W18/24HE, although it should be noted that the data used in the calculations were updated for implementation in AY 2019/20, and that any rounding of figures was done at the end of the calculation process. No changes have been made to the method for AY 2021/22 funding other than to update the rates of funding to reflect the increased total funding available. Allocations for providers are calculated by multiplying the rate of funding by completed credit values from end of year monitoring data for AY 2019/20 taken from the HESA 2019/20 student record, for full-time and sandwich undergraduate provision, with sandwich year out credit values counted at 0.5. Table 5b shows the allocations by subject and provider.
- 45. FT UG premium funding for additional medical and dental places, both those that are part of the ongoing increase in medical places and additional Covid-19 related places allocated for entrants in AY 2020/21, is shown separately in Table 8 and not included in Tables 5a and 5b. Paragraphs 70 and 71 below provide further information on the additional medical and dental places.

Credit-based teaching funding – part-time undergraduate (PT UG)

- 46. We are continuing to fund PT UG in AY 2021/22 through the credit-based teaching funding method, as in AY 2020/21.
- 47. Credit-based funding for PT UG teaching has been determined using our teaching funding method. This was established in 1999 and amended in AY 2011/12 with the removal of the recovery element of the method. Paragraph 86 below provides information on our plans for a review of our teaching funding methodologies.
- 48. Funding allocations are based on funding cells. A funding cell refers to:
 - Level: undergraduate (not franchised-out); undergraduate franchised out;
 - Mode: part-time; and

- Academic subject category (ASC): ASCs 1a to 11b and ASC 11a, Initial Teacher Education (ITE) leading to Qualified Teacher Status (QTS), split into Primary and Secondary.
- 49. Funding in each cell is established by multiplying the number of credit values funded in that cell by our standard unit of funding for the ASC.
- 50. The standard units of funding per credit value for each ASC for PT UG in AY 2021/22 are the same as those used in AY 2020/21. These are set out in **Annex C**.
- 51. Total PT UG funding and funded credit value allocations in each cell for each provider are shown in **Annex D**.
- 52. The PT UG core numbers are determined by the funding model. They are calculated by using funded credits from AY 2020/21 and allocating them to funding cells using both the distribution of funded credits for AY 2020/21 and recruited credit values for AY 2020/21, collected directly from providers. Recruitment data is taken from the higher education students' early statistics (HESES) survey AY 2020/21 (circular W20/37HE).
- 53. As in AY 2019/20 and AY 2020/21, HEFCW's Council agreed to include growth in the credit-based model by converting all fees-only credits into funded credits. Fees-only credits are where providers have recruited credits over those funded in the previous year. This allows for growth in funded credits for some providers and this is included in Annex D. Table 4a shows the breakdown between core-funded credits and funding, and growth-funded credits and funding. While we have been able to provide funding for growth in the number of part-time funded credits, the funding available (see paragraph 17) has not allowed for any increase to the units of funding.

Premium funding - part-time undergraduate provision

- 54. The Access and Retention and the Welsh medium premium are allocated for PT UG provision only and are set out in Table 4b. These are described below.
 - Welsh medium premium
 The Welsh Medium premium adds a weighting of 0.34 to the AY 2021/22 unit of funding for modules undertaken through the medium of Welsh. The allocations to each provider, based on the average of AY 2018/19 and AY 2019/20 HESA credit value data, are set out in Table 4b.
 - Access and retention premium
 There are two elements to the access and retention premium allocation for PT UG provision. A premium is awarded in respect of students from areas of low participation in higher education and students from what were previously defined as Communities First clusters. Individual students may attract more than one premium.

In order to reward retention, we have allocated a higher rate of funding with respect to continuing students than to students in their first year. The higher rate

is also allocated with respect to students on one year courses who complete or partially complete.

To recognise that the proportion of widening access students within a provider impacts on the demand for support required, providers have been separated into two bands depending on their recruitment in AY 2019/20 from former Communities First areas. Providers where students from former Communities First areas represent more than 15 per cent of Welsh domiciled students are in band 1 and receive a higher premium, and those where students from former Communities First areas represent 15 per cent or less are in band 2 and receive a lower premium.

For AY 2021/22, we are maintaining the level of access and retention premium at the AY 2020/21 levels. Individual allocations are detailed in Table 4b.

Premium funding - all modes and levels

- 55. For AY 2021/22, the disability premium is allocated for all modes and levels of study. This is a continuation of the additional funding allocated in order to include all modes and levels of study, implemented in AY 2020/21 (HEFCW circular w19/33HE). The overall funding for the disability premium has increased slightly in AY 2021/22 compared to AY 2020/21, from £1.9m to £2.0m.
- 56. A rate of funding is allocated per eligible student, which are those students recorded as being in receipt of the Disabled Students' Allowance on the HESA student record, and are subject to the minimum 10 credit value study requirement (or 8.3% FTE for PGR students). In AY 2021/22, the rate per student will be £300, the same as that available in AY 2020/21. The allocations are set out in Table 4b for part-time and postgraduate provision and in Table 5a for FT UG and post graduate certificate in education (PGCE) provision.

Per capita funding – all taught modes and levels

- 57. The per capita amount for AY 2021/22 has been maintained at a rate of £5 per student for all taught modes and levels of study. This ensures funding at some level for all students. Payments have been determined on the basis of fundable enrolments according to AY 2019/20 HESA student record data, subject to a minimum 10 credit value study requirement. The amount of per capita funding allocated to each provider is shown in Table 4a for part-time and postgraduate provision and in Table 5a for FT UG and PGCE provision.
- 58. Per capita funding for additional medical and dental places, both those that are part of the ongoing increase in medical places and the Covid-19 related places, is shown separately in Table 8 and not included in Table 5a. Paragraphs 70 to 71 below provide further information on the additional medical and dental places.

Overall teaching funding allocations

59. Tables 4a and 5a show the overall teaching funding allocations. Table 4a shows both funded credit numbers and associated funding for PT UG credit-based teaching funding along with per capita and premium funding for part-time and postgraduate provision. Table 5a shows per capita and premium funding for FT UG and PGCE provision.

Part-time fee waiver

60. Our PT UG fee waiver scheme offers grants to providers that waive fees for PT UG students studying fewer than 30 credits (ie below 25% full-time equivalent), who are unemployed and registered jobseekers, or who are in receipt of Department for Work and Pensions benefits. The figure quoted in Table 1 on page 17 represents an estimate at this stage of the expected call on this budget.

Overall research and teaching funding allocations

- 61. Table 6 sets out the allocations to each provider for teaching, research and innovation funding and provides a comparison with the funding allocations in AY 2020/21. For AY 2021/22 all universities have been allocated an increase in funding, with the overall increase in funding being 12.3%.
- 62. The AY 2021/22 figures in Table 6 do not include details of the PGT Master's incentivisation bursaries' allocation or the allocation of funding for additional medical and dental places. These allocations are provided in Tables 7 and 8.
- 63. These allocations do not take account of any potential in-year funding adjustments for FY 2021-22 that may be applied by the Welsh Government. Any such funding adjustments will result in a revision to the individual allocations. In addition, if the FY 2022-23 allocation is different to the amount assumed for this allocation, there will be an impact on the resource available in AY 2021/22 and the associated allocations.
- 64. In order to facilitate some flexibility and collaboration, providers are offered the opportunity to redistribute PT UG funded credits between providers on a cost neutral basis. Should providers wish to exercise this option, they should jointly inform us of their intentions by the end of July 2021 by emailing hestats@hefcw.ac.uk.

Open University in Wales (OU) strategic funding

- 65. As we outlined in our AY 2020/21 funding allocation circular (<u>W19/14HE</u> refers), we awarded transitional funding to the OU in AY 2020/21 to the value of £1.655m. We confirmed that we would review our strategic funding arrangements for the OU in AY 2021/22 to take account of emerging funding streams, such as the RWIF and the Capital Fund.
- 66. The University's allocation of strategic funding in AY 2021/22 has been determined using the value of the AY 2020/21 award, less the University's allocation via the Capital Fund and RWIF, making a total strategic funding allocation of £605k. We note above (see paragraph 53) that we will continue to fund growth in PT UG recruitment

- via the credit based method for PT UG provision in AY 2021/22. The OU will also receive additional funding in AY 2021/22 via that mechanism.
- 67. Table 6 includes the strategic funding for the OU.

Royal Welsh College of Music and Drama (RWCMD) performance element funding

68. Performance element funding for conservatoire provision is allocated to the University of South Wales for provision at the RWCMD, which is part of the University of South Wales Group. An allocation of £585k to support strategic developments at the RWCMD is provided in addition to the Performance element funding provided through the ESP shown in Table 5a. This strategic funding ensures that the overall funding for conservatoire provision, does not decrease below the funding provided in AYs 2018/19 to 2020/21.

PGT Master's incentivisation bursaries

69. This is the third year of a pilot scheme to increase the number of Welsh graduates who remain in or return to Wales to undertake a PGT Master's degree in Science, Technology, Engineering, Mathematics and Medicine (STEMM) related subjects, and Master's degrees studied through the medium of Welsh (circular W21/11HE refers). It is also the third year of the scheme to provide bursary funding for those studying for a Master's degree who are aged 60 or over, via HEFCW funding to providers. Funding to be provided to providers for these schemes is shown in Table 7.

Additional medical and dental places

- 70. From AY 2018/19, additional medical places were funded, a total of 40 places per cohort, 20 at each of Cardiff University and Swansea University with further cohorts starting in subsequent years. In addition, as a result of Covid-19, an additional 25 medical places plus 1 dental place were funded in AY 2020/21 and an additional 12 medical places and 2 dental places are to be funded in AY 2021/22.
- 71. Funding for these places in AY 2021/22, consisting of ESP funding for the clinical part of the course, higher cost subjects premium for the non-clinical part of the course and per capita funding, is shown in Table 8, and not included in Tables 5a and 5b, as currently the funding for FY 2021-22 for the additional medical places is not included in the remit letter.

Well-being and health

72. An allocation of £2m has been made for AY 2021/22 to support well-being and health developments. Further guidance will be provided on the purpose and allocation of this funding.

Terms and payment of grant, data sources and audit

Terms of grant

- 73. The basis on which teaching and research funding is being provided to HE providers is set out in the Terms and Conditions of Funding between HEFCW and individual providers, and will reflect the latest Welsh Government conditions of funding. For FE providers, it is also set out in the Terms and Conditions of Funding with HEFCW. The Terms and Conditions of Funding for AY 2021/22 will be issued no later than the end of November 2021.
- 74. HEFCW may adjust the funding awarded to institutions at the end of the AY 2021/22 session to take account of under-recruitment against the PT UG funded numbers allocated. HEFCW will monitor achievement of funded numbers using the actual credits completed at the end of the year. Credits completed will exclude any associated with modules for which all assessment procedures have not been undertaken. The difference between numbers enrolled and numbers funded will be calculated separately for each funding cell and converted into its funding equivalent using the relevant standard unit of funding for AY 2021/22.
- 75. There will be a leeway of 1% for under-recruitment on the total funded numbers for PT UG credit-based funding. As in prior years, funding adjustments for AY 2021/22 that are below a threshold of the lesser of £50,000 or 10% of the total teaching allocations (including per capita, premium and FT UG/PGCE funding), or an alternative threshold as agreed by HEFCW, will not be applied. If the under-recruitment gives rise to a funding adjustment above the threshold, the threshold will be deducted from the total funding adjustment amount.

Data sources

- 76. The data used for funding have been provided and checked by providers.
- 77. The data for credit-based funding for teaching have been taken from data returned to HEFCW on the HESES survey by providers for AY 2020/21.
- 78. Per capita allocations and premium allocations have been based on the HESA AY 2019/20 student record data.
- 79. Welsh medium premium allocations have been based on the average of AY 2018/19 and AY 2019/20 HESA credit value data.
- 80. Funding allocations for PGR have been based on AY 2019/20 HESA student record data.
- 81. The data for funding for research have been taken from the returns to, and the outcomes of, the 2014 REF. In addition, minor volume measures data on research assistants and research students have been taken from the 2013/14 HESA staff and student records, respectively.

Payment of grant

82. In AY 2021/22, our initial payment profile proposals are detailed in the table below.

83. Should there be budget changes or cash management constraints (eg HEFCW's carry forward limit from one FY to the next), we may require this profile to be adjusted in-year.

Audit of data

- 84. The allocations of funds for teaching, RWIF, PGR and QR are established by applying our funding methods to data supplied by providers. Data provided by providers and used for funding purposes are subject to audit. Details of the current process of audit can be found in circular <a href="https://www.wieners.com/wi
- 85. Where, as a result of audit, we find that the data on which allocations have been based, have resulted in any provider receiving an allocation larger than it is due, the funding for the provider concerned may be adjusted.

Review of HEFCW funding methodologies

- 86. We indicated previously that we were planning a fundamental review of our teaching funding methodology to reflect the outcomes of Professor Sir Ian Diamond's independent review of higher education funding and student finance arrangements and the expectation of increased HEFCW funding. In light of the funding allocations now anticipated, and the pressures caused by the Covid-19 crisis, we are conducting a partial review of our teaching funding methodology, to be implemented from AY 2022/23, followed by a full review for implementation from AY 2023/24 onwards. Our proposals will be the subject of consultation in due course. The partial review will include the widening access and retention premium given that an element of this is based on the former Communities First Programme.
- 87. We are reviewing our research funding method for implementation after <u>REF 2021</u> (AY 2022/23). This will also be subject to consultation.

Assessing the impact of our policies

88. HEFCW's funding model includes recurrent funding and strategic funding. The recurrent funding methods used for AY 2021/22 are based on historic methodology. Strategic funding for AY 2021/22 includes existing and new areas of expenditure that

are impact assessed to consider impacts on equality, the Welsh language and the Well-Being of Future Generations (Wales) Act 2015. Following the proposed changes in circular (W18/24HE) Consultation on Changes to Funding Methods for AY 2019/20 and Future Developments, any changes to our funding methodologies will be impact assessed.
