# 1. Registration requirements and independent school standards

Find out if you need to <u>register as an independent school</u> and read the <u>independent school registration requirements and standards</u>.

# 5. Processing your application

The registration process takes approximately 6 months once we receive a complete application.

Incomplete applications, that do not have all the required documents or information, will not be processed. You will need to resubmit your application once you have all the documents and information.

Once we have the required documentation, we will ask Ofsted to carry out a preregistration inspection. The pre-registration inspection report sets out how likely the schools standards will be met and will form part of your application.

Further information on the registration process can be found in the <u>registration of</u> <u>independent school guidance</u>.

#### 6. Registered independent schools

If your application is successful, your independent school will be registered and listed on <u>Get information about schools</u>.

Ofsted will carry out their first standard inspection in the school's first year of operation. Further information on inspections, including the fees payable, is available in the <u>independent school registration guidance</u>.
