General notes for users of the children in need COLLECT reports

1. The purpose of this guide is to provide information on the reports which are available to local authorities in COLLECT (collections online for learning, education, children and teachers).
2. The reports are available to the Collector (Department for Education) and local authority contacts with COLLECT access. The DfE can access the reports for each local authority. Each local authority has access only to their own reports.
3. Reports can be run from the launch reports option within the children in need (CIN) COLLECT blade.
4. The majority of the reports are not live, but instead show the position in COLLECT at close on the previous working day.
5. All reports are exportable in the following formats: xml, csv, tiff, pdf, web archive and MS Excel.
6. The reports in this guide are listed in alphabetical order and match the order shown in COLLECT.
7. Symbols used in this report specification:
 - = 'equal to'
 - >= 'greater than or equal to'
 - > 'greater than'
 - <= 'less than or equal to'

1. Assessments working days list report

1.1 Report description

This report shows the number of working days taken to complete an assessment, from the start of the assessment to the end of the assessment.

The report shows the position at close on the previous day.

1.2 Definitions

The report shows the number of working days taken to complete an assessment, for assessments authorised between 1 April 2024 and 31 March 2025.

The number of working days taken to complete an assessment is calculated by subtracting the assessment start date from the assessment authorisation date and then subtracting any bank holidays and local authority non-working days.

If a start date and authorisation date fall on the same day, the number of working days is counted as zero. If a start date is after an authorisation date, the number of working days will be a negative figure.

When an assessment starts on a weekend or a non-working day (for example a bank holiday) local authorities should return that date. The examples below demonstrate how the number of working days taken to complete the assessment is calculated.

Example 1:

'AssessmentActualStartDate': 26-05-2024

'AssessmentAuthorisationDate': 17-06-2024

The duration of this assessment is calculated as 14 working days. Since the assessment started on a Sunday, we move forward to the next working day which is Tuesday 28 May (since Monday 27 May is a bank holiday) and count this as day zero. We then count the working days to the authorisation date (Monday 17 June), which gives the duration of this assessment as 14 working days.

Example 2:

'AssessmentActualStartDate': 07-05-2024

'AssessmentAuthorisationDate': 11-05-2024

The duration of this assessment is calculated as 4 working days. The assessment started on a Tuesday (7 May), which is counted as day zero. We then count the working days to the authorisation date, which falls on a Saturday (11 May). Since Saturday is not a

working day, we count the assessment as ending on the next working day (Monday 13 May), which gives the duration of this assessment as 4 working days.

1.3 Report format

Component	Description
Rows	When a record meets the selection criteria (assessment authorisation date is $\geq 01/04/2024$ and $\leq 31/03/2025$) it is added as a row in the report. The records are ordered by local authority child id.
Columns	'LACChildID' – the local authority child id; 'Referral date' – referral date of the child; 'Actual start date' – date the assessment started; 'Authorisation date' – date the assessment was authorised; 'No. of working days' – number of working days taken to complete the assessment.

Columns	'Assessments: time completed in' – time taken in working days to complete the assessment; 'Number of assessments' – a count of the number of assessments which fall into the working day banding. A child may be included more than once if they have more than one completed assessment during the year.

3. CIN Plan report

3.1 Report description

This report provides information on CIN plan data. More information on CIN plans is provided in section 4.11 of the latest CIN [census guide](#).

The report is in two parts:

1. Summary: an aggregate count for CIN plans at any point in the year; starting during the year; ending during the year and at 31 March.
2. Details: episode-level CIN plan data for each of the above counts (a value of 1 indicates a plan is counted in the CIN plan measure).

The report shows the current position.

2. Details: population information for each episode of need (a value of 1 indicates an episode is counted in the population measure)

The report shows the current position.

Component	Description
Rows	There is a row for each category of abuse and the total number of records included in the report.
Columns	'Initial category of abuse' – a count of the initial category of abuse recorded for the child; 'Latest category of abuse' – a count of the current category of abuse recorded for the child.

6. Error counts report

6.1 Report description

This report shows a count of the validation rule errors and queries.

The report shows the position at close on the previous day.

6.2 Report format

Component	Description
Rows	The rows in the report show the validation errors and queries ordered by the number of occurrences (highest to lowest).
Columns	'Occurrences' – how many times the error or query occurs; 'Validation rule number' – states the validation code as listed in the technical specification; 'Error message' – displays the validation rule error or query message.

7. Errors report

7.1 Report description

This report lists all the individual validation rule errors and queries for a local authority.

The report shows the position at close on the previous day.

7.2 Report format

Component	Description
Rows	Each occurrence of a validation error or query is added as a row to the report. Errors are listed in order of validation rule number (lowest to highest).
Columns	'LA Number' – the local authority number; 'UPN' – the unique pupil number of the child; 'LA Child ID' – the local authority child id; 'DOB' – the date of birth of the child; 'Expected DOB' – the expected date of birth of the child (if unborn); 'Referral date' – date the child was referred; 'Error/query' – if it is an error or a query; 'Error okayed' – if it is an ok error; 'Validation rule no'. – the associated validation rule number; 'Error message' – what the error message is; 'Record name' – data module that the error/query is associated with; 'Data item name' – specific data item that the error/query relates to; 'Data item value' – value of the data item that the error/query relates to.

8. Factors at assessment report

8.1 Report description

This report provides a count of factors identified at the end of completed assessments. More than one factor can be recorded against the same assessment, which means the total sum of factors may exceed the number of completed assessments in the year.

The report shows the position at close on the previous day.

A child may be included more than once if they have more than one assessment in the year.</p>

9. ICPC Transfer-in working days summary report

9.1 Report description

This report provides a summary of the total number of transfer-in initial child protection conferences (ICPCs) in the year and the time taken from the referral date to the date of the initial child protection conference (recorded in the 'CIN details module') banded by working days. The report is restricted to only those CIN details records where the date of the initial child protection conference is within the census collection year and is not missing.

The report shows a table with the following bandings:

Date of ICPC before referral date

0-10 working days

11-15 working days

16-20 working days

21+ working days

No referral date

Total episodes subject to a transfer-in ICPC in the year

The report shows the position at close on the previous day.

9.2 Definitions

The number of working days is calculated by subtracting the referral date from the date of the ICPC (in the 'CIN details module') and then subtracting any bank holidays and local authority non-working days.

If an ICPC starts on the same day as the child is referred, the number of working days is calculated as zero. If the ICPC starts before the referral date, the number of working days will be a negative figure.

The examples below demonstrate how the number of working days taken from referral to transfer-in ICPC is calculated.

Example 1:

'ReferralDate': 26-05-2024

'DateOfInitialCPC' ('CIN details module'): 17-06-2024

The time taken between referral date and initial ICPC is calculated as 14 working days. Since the referral was on a Sunday (26 May), we move forward to the next working day which is Tuesday 28 May (since Monday 27 May is a bank holiday) and count this as day

zero. We then count the working days to the date of the initial ICPC (Monday 17 June), which gives the time taken from referral to initial ICPC as 14 working days.

Example 2:

'ReferralDate': 07-05-2024

'DateOfInitialCPC' ('CINDetailsModule'): 11-05-2024

The time taken between referral date and initial ICPC is calculated as 4 working days. The referral was on a Tuesday (7 May), which is counted as day zero. We then count the working days to the date of the initial ICPC, which falls on a Saturday (11 May). Since Saturday is not a working day, we count the date of the initial ICPC as the next working day (Monday 13 May), which gives the time taken from referral to initial ICPC as 4 working days.

Actual start dates have been collected since 2012 to 2013. When a S47 enquiry starts on a weekend or a non-working day (for example a bank holiday) local authorities should return that date.

The examples below demonstrate how the number of working days from S47 start date to date of ICPC is calculated.

Example 1:

'S47ActualStartDate': 26-05-2024

'DateOfInitialCPC': 17-06-2024

The time taken between the S47 start date and initial ICPC is calculated as 14 working days. Since the section 47 started on a Sunday (26 May), we move forward to the next working day which is Tuesday 28 May (since Monday 27 May a bank holiday) and count this as day zero. We then count the working days to the date of the initial ICPC, which gives the time taken from the S47 start date to initial ICPC as 14 working days.

Example 2:

‘S47ActualStartDate’: 07-05-2024

‘DateOfInitialCPC’: 11-05-2024

The time taken between the S47 start date the date of initial ICPC is calculated as 4 working days. The referral was on a Tuesday (7 May), which is counted as day zero. We then count the working days to the date of the initial ICPC, which falls on a Saturday (11 May). Since Saturday is not a working day, we count the date of the initial ICPC as the next working day (Monday 13 May), which means the time taken from the S47 start date to initial ICPC is 4 working days.
