# Education is changing



In Wales, it's our [National Mission](#) to achieve high standards and aspirations for all.

We introduced the [Curriculum for Wales](#) to support children and young people to be healthy, engaged, enterprising and ethical citizens of Wales and the world - ready to play a full part in life and work. In 2022 we began rolling out this new way of teaching, and from September 2026 all children will be learning under the Curriculum for Wales.

The Curriculum for Wales covers learners aged 3-16, but we know requirements for young people aged 14-16 are different to those for younger learners. Learners at this age will consider their options in relation to qualifications and the opportunity to specialise, as well as identifying and starting to realise their individual pathways.

There can be many choices for young people at the end of year 11 as they transition to further education, training, and employment.


We want to make their transition to life after year 11 easier, with support to overcome any barriers<sup>1</sup> on their journey.

## New National 14 to 16 Qualifications


To support the Curriculum for Wales, [Qualifications Wales](#)<sup>2</sup> is reforming qualifications in Wales. This covers the full 14 to 16 qualifications offer, including GCSEs, as set out in their [Qualified for the Future reform](#) programme. New GCSEs will be available for first teaching for year 10 from September 2025.

# Key features of the 14 to 16 Learning Guidance



**We want all learners completing their education at 16 to have the skills, knowledge, and wider understanding that enables them to develop the capacities, dispositions and attributes described in the four purposes of the Curriculum for Wales. This will also support learner transitions post-16.**

To achieve this, it is important that learners in year 10 and 11 continue to benefit from a broad and balanced curriculum, with learning continuing across all Areas of Learning and Experience and in the mandatory elements of the curriculum, no matter their choices of study for qualifications.

**The 14 to 16 Learner Entitlement aims to support this.** It outlines the curriculum that all learners in years 10 and 11 will be entitled to. Specifically, they will be offered teaching and learning across the following four components:

- **Qualifications in literacy and numeracy** - the best possible literacy (reading and writing) and numeracy (mathematics) education before they finish school.
- **Qualifications to encourage breadth** - broad and balanced choices, including general, vocational and skills-based qualifications, at all appropriate levels. This will include a qualification in the sciences. All learners should also continue to have the opportunity to study towards a suitably challenging and ambitious qualification in Welsh – to meet goals set by Cymraeg2050.

- **Wider Learning and Experiences across the Curriculum** - in all areas and mandatory elements (including [RSE and RVE](#)), no matter their chosen qualifications. Not all learning experiences will result in a formal qualification; however, wider learning across the curriculum will encourage deeper learning and independence.
- **Post-16 planning** - dedicated time to focus on next steps and understand all options available to them as they move into post-16 education, training or employment, across all aspects of life. This means that learners will be given the support they need to reflect on their strengths, areas of improvement, goals and ambitions, which will set high standards and develop learner effectiveness.

**The entitlement will guide schools when choosing the qualifications they offer to year 10 and 11 learners. A challenging and ambitious offer will need to be provided for each learner, and account for individual needs.**

**Learners will also be supported by their 14 to 16 learning to:**

- Understand the full range of options available to them in both vocational and general qualifications post-16.
- Understand the implications of their choices within and beyond compulsory education.
- Encounter authentic and meaningful experiences of work.
- Make the right choices for their individual pathway.

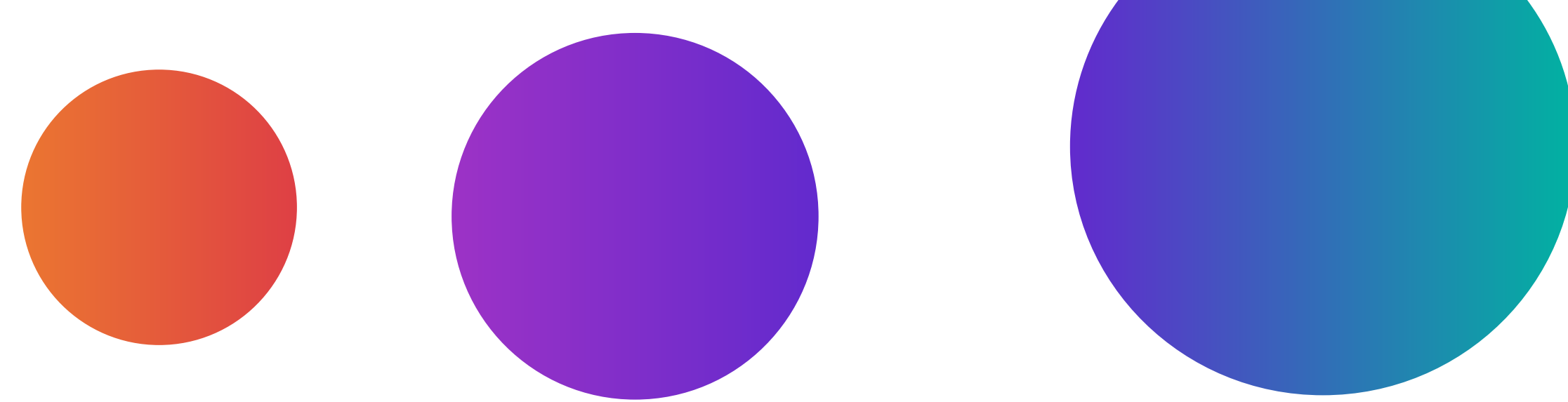
