# Introduction

#### About us

The Education Workforce Council (EWC) is an independent regulator, established by the Education (Wales) Act 2014. We work with education professionals, in teaching and support roles, from the foundation phase through to further education, youth work and work-based learning. Our Register of Education Practitioners in Wales is the biggest public register of any profession in Wales and the widest of its kind in the world, with almost 80,000 practitioners registered across seven different groups within the education workforce.

#### **Our Vision**

We aim to be a forward-looking, independent regulator that is trusted by registrants, learners, parents and the public to maintain standards and enhance professionalism within the education workforce.

#### **Our Mission**

Learners, parents and the wider public are at the heart of our work. We act on their behalf to register, regulate and support our registrants to maintain high standard of conduct and competence.

We also use our position and knowledge, including the unique data from our Register of Education Practitioners, to play a leading role in developing evidence-based education policy advice—helping to drive improvement across the education system in Wales.

# Introduction

#### **Legislative framework**

The Education (Wales) Act 2014 formally sets out our role as a regulator and strategic leader in the education sector in Wales and the obligations that we have to registrants, learners, parents and the public. Our aims and functions, as defined by the Act, are summarised below.

Under the Education (Wales) Act 2014, our principal aims are to:

- contribute to improving the standards of teaching and the quality of learning in Wales;
- maintain and improve standards of professional conduct amongst teachers and persons who support teaching and learning in Wales; and
- safeguard the interests of learners, parents and the public and maintain public trust and confidence in the education workforce.

Under the Education (Wales) Act 2014, our main functions are to:

- establish and maintain a Register of Education Practitioners;
- maintain a Code of Professional Conduct and Practice for the education workforce;
- investigate and hear allegations of unacceptable professional conduct, serious professional incompetence or relevant criminal offences that might call into question a registrant's fitness to practise;
- accredit programmes of initial teacher education, and monitor compliance with national criteria;
- provide advice to the Welsh Government and others on matters related to the education workforce and teaching and learning;

- monitor induction and hear induction appeals (where applicable) for teachers;
- promote careers in the education workforce; and
- undertake specific work in relation to teaching and learning at the request of the Welsh Government.

We are not a Welsh Government sponsored body and we are primarily funded by registration fees. However, we also receive grant funding from the Welsh Government for certain specific activities undertaken on its behalf which include:

- administering the award of Qualified Teacher Status (QTS);
- administering funding, tracking and recording arrangements for induction;
- developing and hosting the Professional Learning Passport (PLP);
- hearing induction appeals and issuing Induction certificates;
- promoting careers in the education professions;
- acting as the Secretariat to the Independent Welsh Pay Review Body (IWPRB); and
- undertaking ad-hoc research projects

We also undertake other work in addition to that funded by registration fees or grant. These activities (for which the Council recoups its costs) include:

- responsibility for the delivery and further development of the Quality
   Mark for
- Youth Work in Wales, in partnership with a range of stakeholders;
- preparing bespoke statistical analyses, using the data from the Register, for other organisations.

#### Introduction to the Annual Education Workforce Statistics for Wales 2021

These statistics have been produced from the Register of Education Practitioners and the information that we are able to hold on the Register is set out in the Education Workforce Council (Main Functions) (Wales) Regulations 2015, as amended. Further information and our privacy notice are available at <a href="https://www.ewc.wales">www.ewc.wales</a>.

Regulations require a practitioner to be registered in the category or categories for the work that they undertake or intend to undertake. Consequently, some practitioners are registered in multiple categories. More information is available at www.ewc.wales "Applying for registration". There are mandatory minimum qualification requirements in order to register a school teacher, youth worker or youth support worker but not in one of the remaining four groups; further education teacher, further education learning support worker, school learning support worker, or work based learning practitioners.

The Register is real time and provides a unique source of data about the seven registered education groups in Wales. No equivalent data is available from any other body or organisation. Consequently, comparison should not be made with other sources such as the Welsh Government school workforce annual census (SWAC) also published annually. For the school sector in particular, unlike SWAC, EWC data includes all supply teachers, peripatetic workers, freelance workers and others who provide education or training in a school as well as other education settings. We also hold significant historic data which enables us to provide trend information. Previous copies of our statistics (dating back to March 2002) are available to download from our website, www.ewc.wales.

The statistics are based on the following criteria:

- Registrant numbers are recorded as actuals, rather than full-time equivalent.
- Barring the all registrant section (section 1), which indicates the number of individuals on the Register, practitioners registered in multiple categories (e.g. school and FE teacher) are included in all relevant sections;
- The census date used for the data taken from the Register is 1 March each year.
   However, the employment data in each section is extracted in May and mapped
   to the 1 March registrants. The majority of employer and practitioner record
   updates are made between February and the end of April as part of the annual
   fee renewal. This approach ensures the accuracy of the employment data in
   these tables;
- Where a registrant has more than one employment record on the Register (e.g. school teacher in a school and an FE teacher in a college) the employment information in section 2 is derived from the school employment record and in section 4 the employment is derived from the FE employment record. In all sections, there are registered practitioners who may not be working but have chosen to register with their professional body. Supply registrants are counted once only in each section regardless of the number of employers they may work for;
- The information recorded on the Register is obtained and subsequently updated by the employer or directly from the registrant. The Council worked with employers to register their existing staff "en masse" to establish the Register for the newer registrant groups: FE, support staff and the youth work sector. A minimal amount of data on each practitioner was required to complete the initial registration. Practitioners have further populated their records and any new registrants have been required to provide full information. We undertake programmes of work to continue to populate records particularly for the newer registrant groups;
- Percentages may not total 100 due to rounding.

### All registrants

As at 1 March 2021, there were 78,626 individual registrants on the EWC Register of Educational Practitioners. Registrants are able to register in one or more of the following categories: school teacher, school learning support worker, FE teacher, FE learning support worker, WBL practitioner, Qualified youth worker and Qualified youth support worker.











# Number of FE teachers registered with EWC by employer - 2021



## Number of FE learning support workers registered with EWC by employer - 2021



# Number of WBL practitioners registered with EWC by employer - 2021





## 9. Data definitions and assumptions

The data contained in these statistics are based on a number of specific criteria. The following assumptions apply to all tables in the report:

Supply registrants in each section are only counted once regardless of the number of employers/agencies they undertake supply work for;

As indicated the census date used for the data taken from the Register is 1 March each year. However, the employment data in each section is extracted in May (since 2018) and mapped to the 1 March registrants. Prior to 2018 the employment census data is 1 March. The majority of employer and practitioner record updates are made between February and the end of April as part of the annual fee renewal. This approach ensures the accuracy of the employment data in these tables.

In considering the data it should be noted that there is no legal obligation for registrants or employers to notify EWC of the posts within their setting.
