# Introduction

## About us

The Education Workforce Council (EWC), is the independent, professional regulator for the education workforce in Wales. We regulate education practitioners across schools, further education, youth work, and adult/work -based learning.

## Introduction to the Annual Education Workforce Statistics for Wales 2024

These statistics have been produced using data from the Register of Education Practitioners. The information that we are able to hold on the Register is set out in the Education Workforce Council (Main Functions) (Wales) Regulations 2015, as amended.

The Register is real time and provides a unique source of data about the 13 registered education groups in Wales. No equivalent data is available from any other body or organisation. Consequently, comparison should not be made with other sources such as the Welsh Government School Workforce Annual Census (SWAC), also published annually. For the school sector in particular, unlike SWAC, our data includes all supply staff, peripatetic workers, freelance workers, and others who provide education or training in a school, as well as other education settings. We also hold significant historic data which enables us to provide trend information. [Previous copies of our reports](#) are available to download from our website.

### The statistics in this report are based on the following criteria:

- registrant numbers are recorded as actuals, rather than full-time equivalent.
- barring the all registrant section (section 1), which indicates the number of individuals on the Register, practitioners registered in multiple categories (e.g. school and further education teacher) are included in all relevant sections.
- the census date used for the data taken from the Register is 1 March each year.
- where a registrant has more than one employment record on the Register (e.g. school teacher in a school and a further education teacher in a college) the relevant employment information is recorded in each category they are registered in.
- supply registrants in each section are only counted once regardless of the number of employers/agencies they undertake supply work for.
- the information recorded on the Register is obtained directly from the practitioner and/or their employer.
- percentages may not total 100 due to rounding.



## Considerations while reading the report

Practitioners in adult learning, and principles or senior leaders working in further education institutions have been required to register with us since further legislative changes came into effect in May 2024. As this was after the date of our data extraction, they are not included in this publication, but will be included in future publications from 2025.

Legislation requires a practitioner to be registered in the category, or categories, for the work that they undertake, or intend to undertake. As a result, some practitioners are registered in multiple categories. [Further information can be found on our website.](#)

Since May 2023, new legislation has required teachers and learning support staff in independent schools and colleges to register with us. As a result, for the first time, data relating to independent school teachers, independent school learning support workers, independent special post-16 institution teachers, and independent special post-16 institution learning support worker, is included in this publication. Independent school teachers will be included in 'others in service' within the employment tables in both the school teacher and school learning support worker registration categories.

## 1. All registrants

As at 1 March 2024, there were 90,812 individual registrants on the EWC Register of Educational Practitioners. Registrants are able to register in one or more of the following categories: school teacher, school learning support worker, further education teacher, further education learning support worker, work-based learning practitioner, qualified youth worker, qualified youth support worker, independent school teacher, independent school learning support worker, independent special post-16 institution teacher and independent special post-16 institution learning support worker.

Individuals registered in multiple categories are counted in each applicable category i.e. if a school teacher is also registered as a school learning support worker and further education teacher they will be counted in all relevant sections as they are eligible to work or may be working (if part time) in all three categories.

Registrants who are eligible to work in all the categories in which they are registered.

The table below is a two-way matrix showing specifically where individuals are registered singularly (highlighted in green) and which other categories those who are eligible to practice are also registered in. To emphasise, Individuals registered in multiple categories are counted in each applicable category i.e. if a school teacher is also registered as a school learning support worker and further education teacher they will be counted in all relevant sections as they are eligible to work or may be working (if part time) in all three categories.

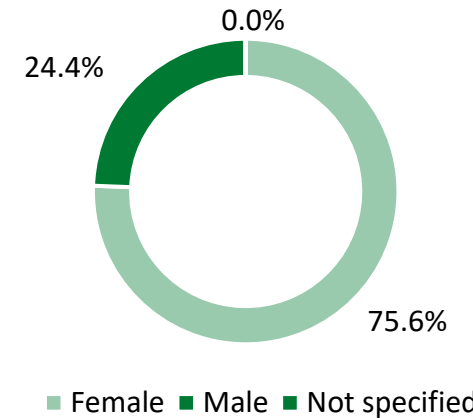


Chart 1: The gender of school teachers in 2024.

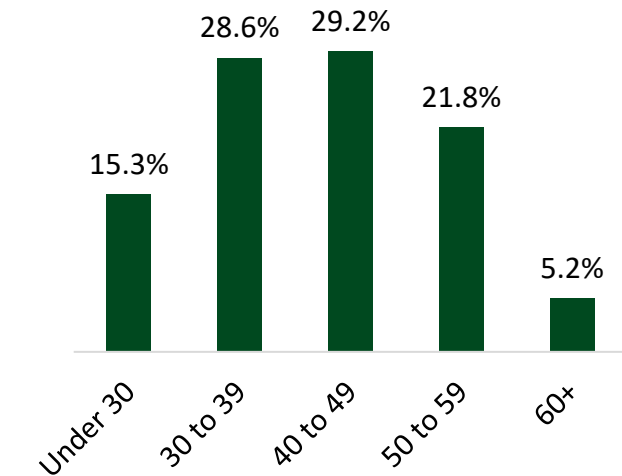


Chart 2: The age of school teachers in 2024.

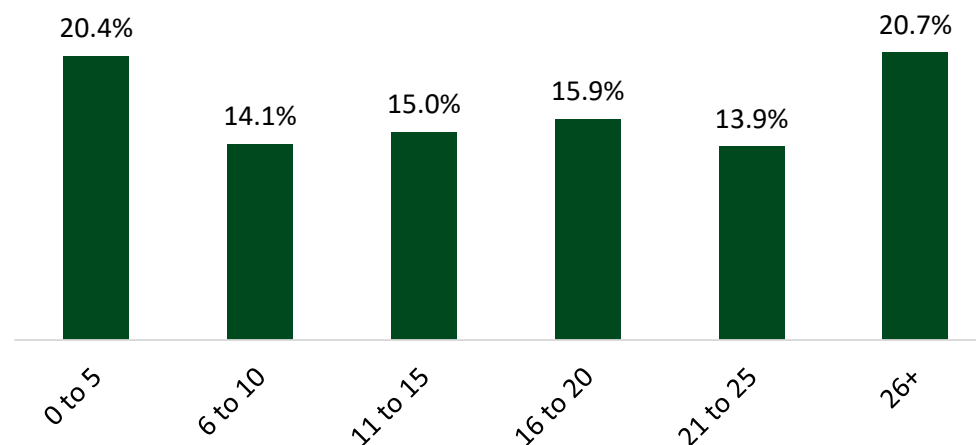


Chart 3: Years since qualified teacher status for registered school teachers in 2024.

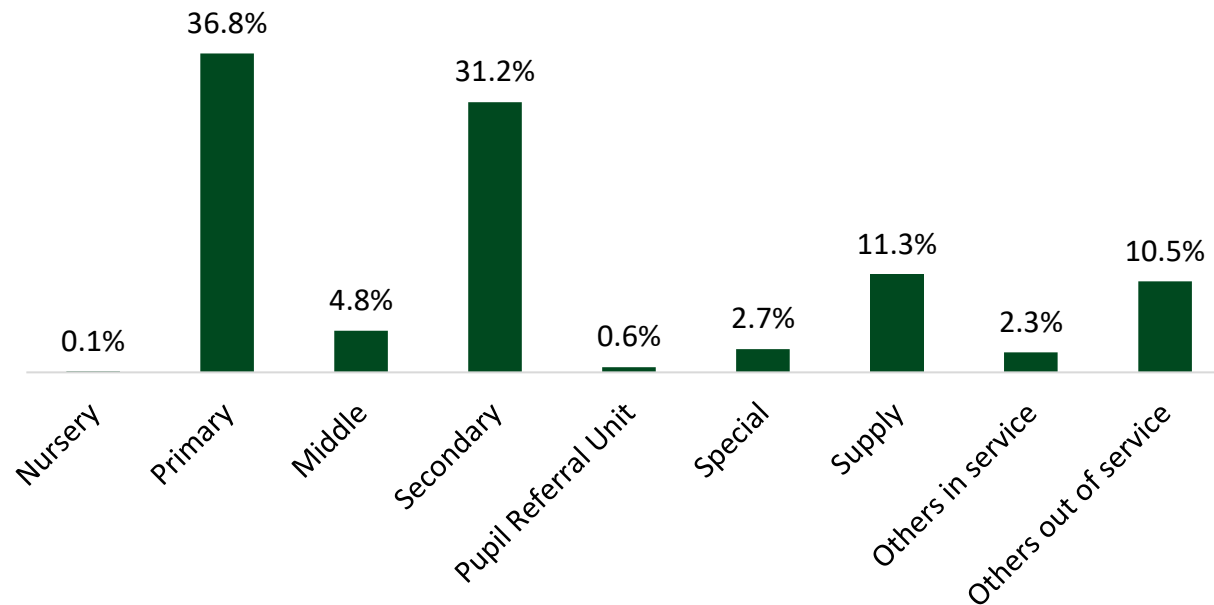


Chart 4: Percent school teachers by phase employed in 2024.

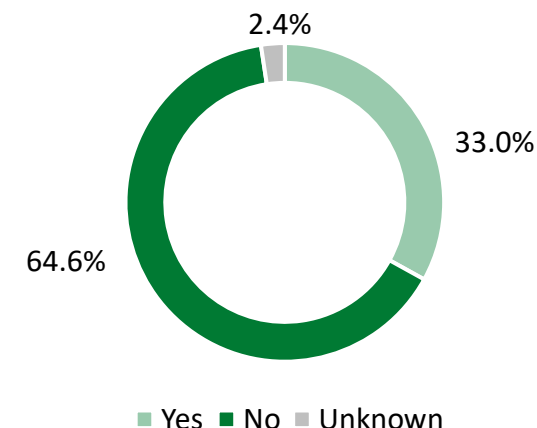

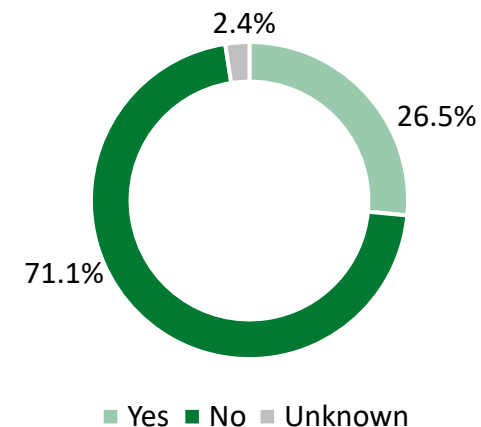
**Chart 5: School teachers ability to speak Welsh in 2024.**

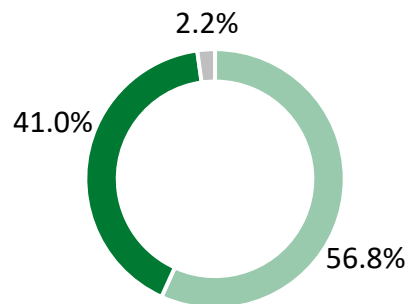


Chart 7: Biology

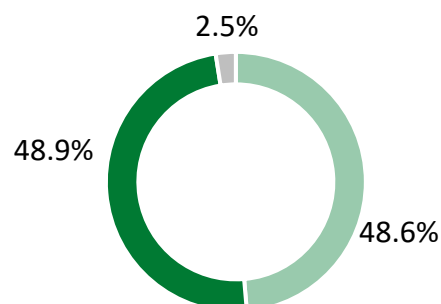


Chart 8: Chemistry

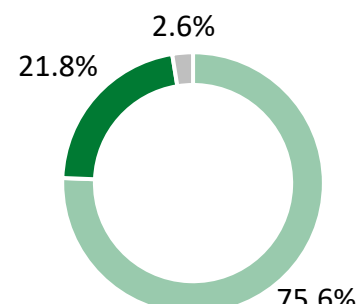


Chart 9: English

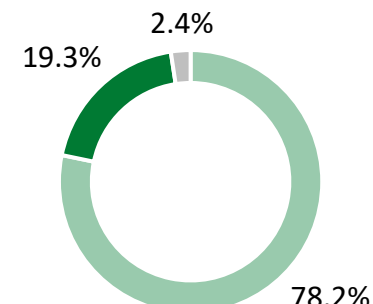


Chart 10: Mathematics

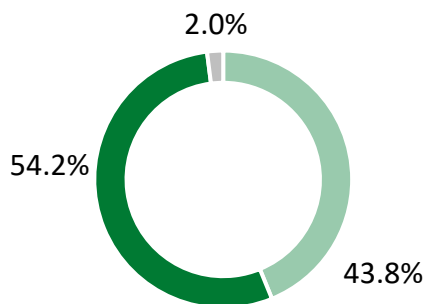


Chart 11: Physics

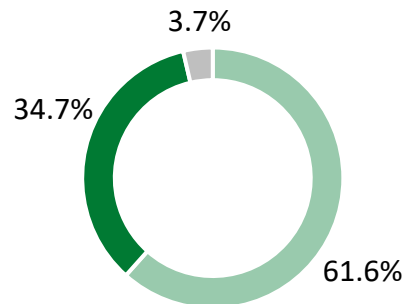


Chart 12: Religious Education

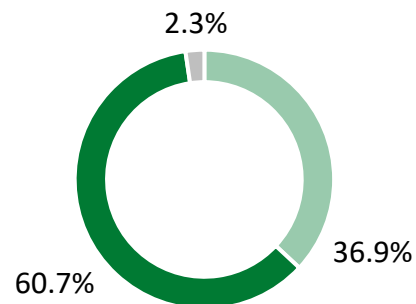

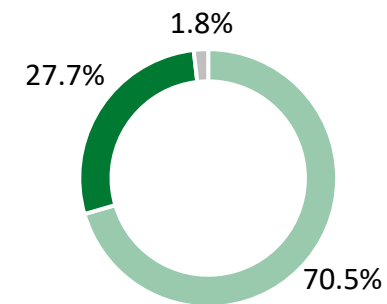

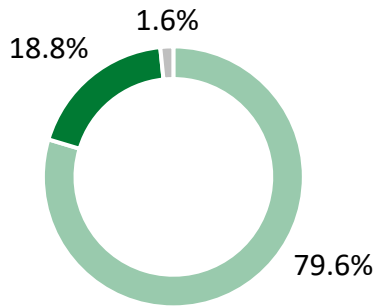


Chart 15: Art

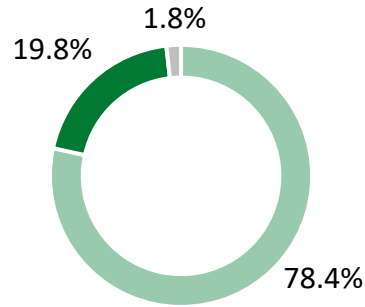


Chart 16: Design & Technology

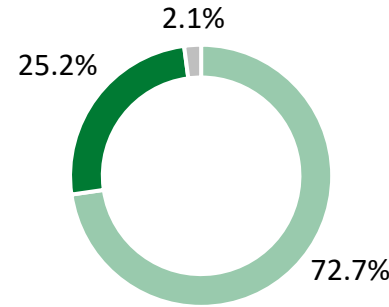


Chart 17: Geography

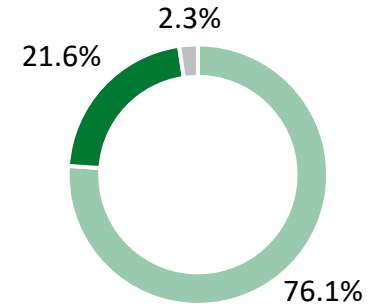


Chart 18: History

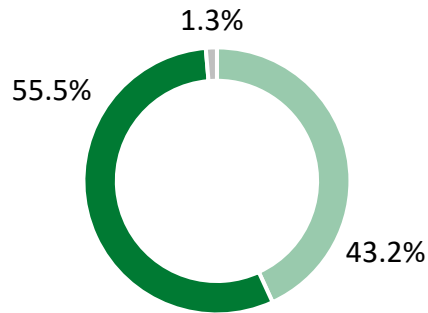


Chart 19: Information Technology

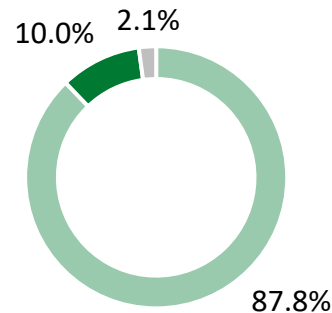


Chart 20: Modern Foreign Languages

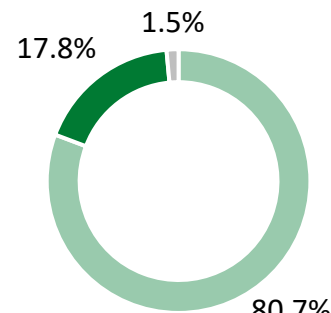


Chart 21: Music

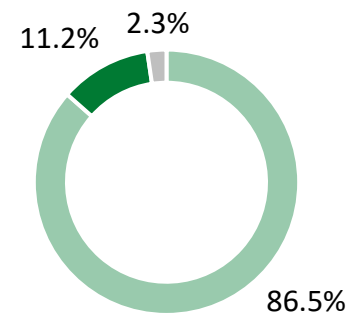

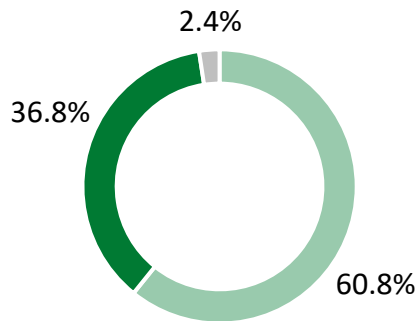


Chart 23: Business Studies

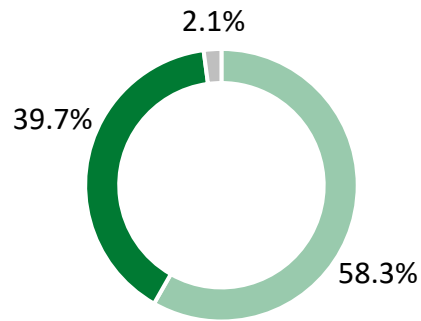


Chart 24: Drama

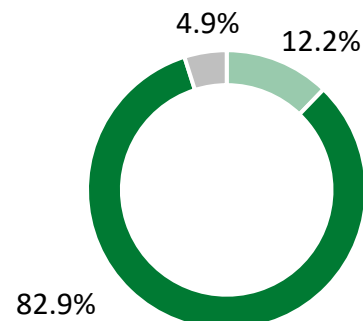


Chart 25: Economics

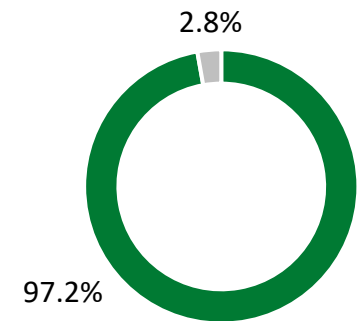


Chart 26: Engineering

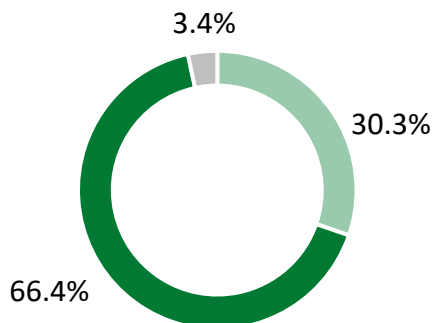


Chart 27: Home Economics

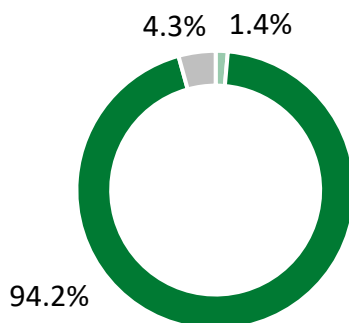


Chart 28: Humanities

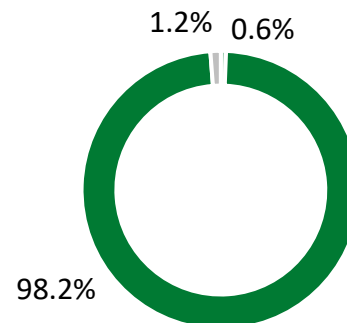


Chart 29: Media Studies

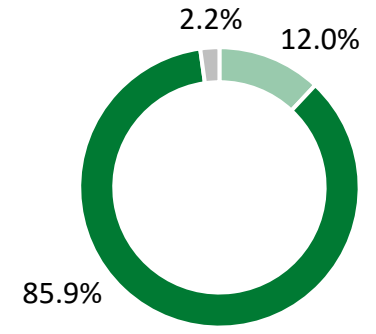


Chart 30: Sociology

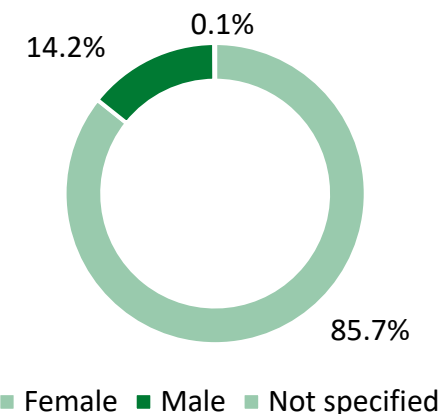


Chart 31: The gender of school learning support workers in 2024.

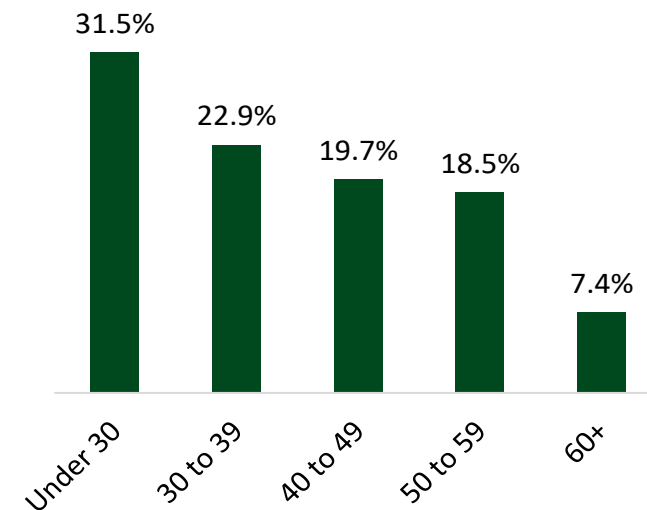


Chart 32: The age of school learning support workers in 2024.

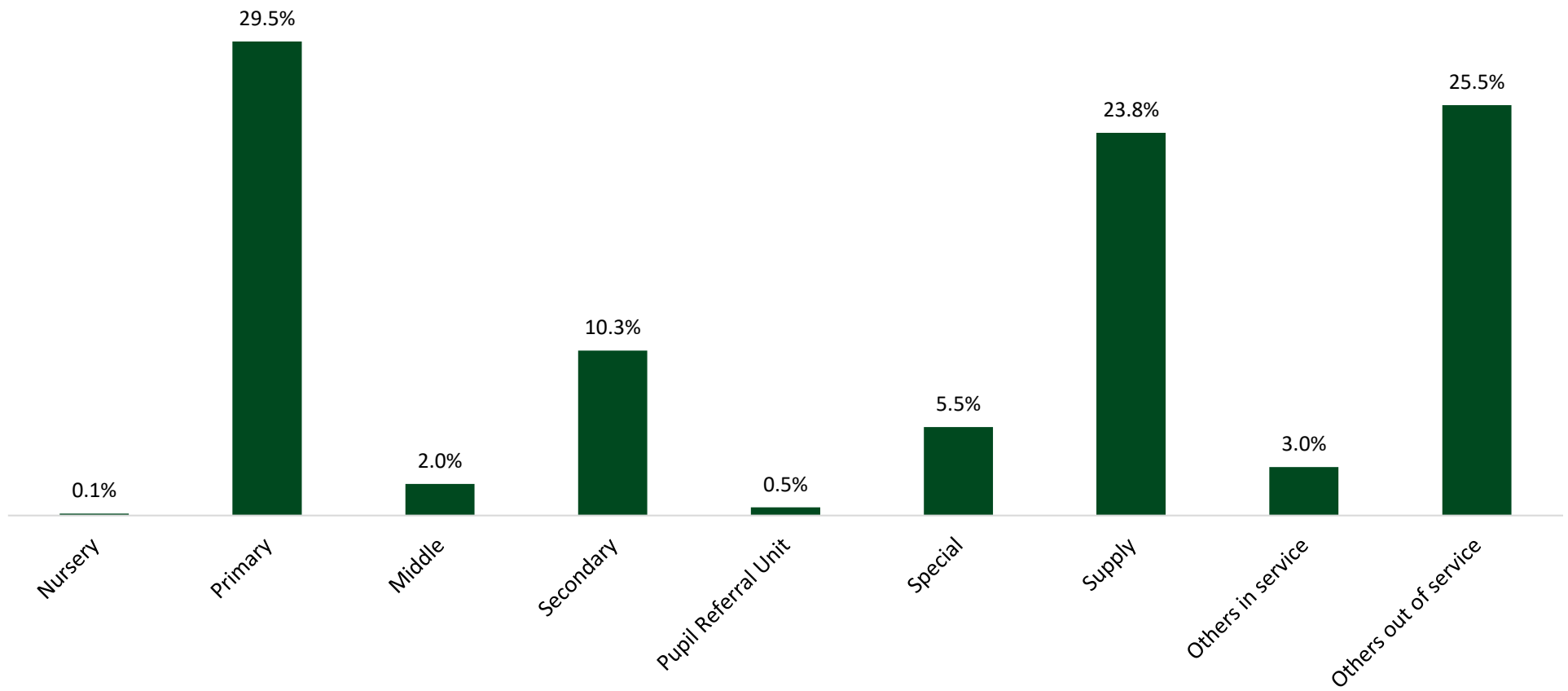

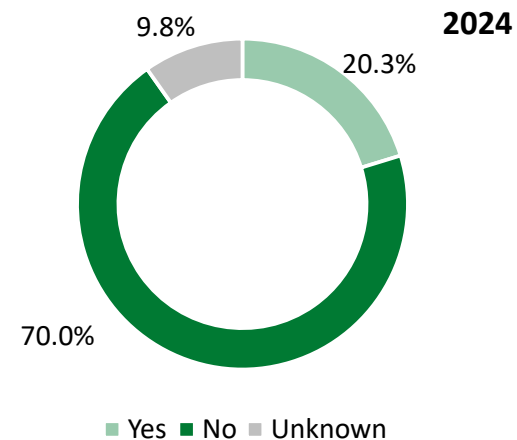

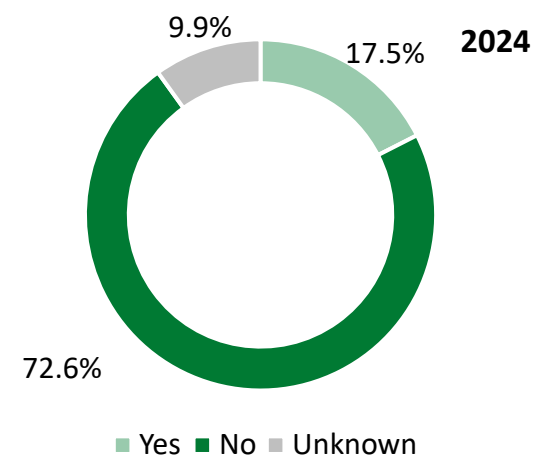
**Chart 34: School learning support workers by ability to speak Welsh.**

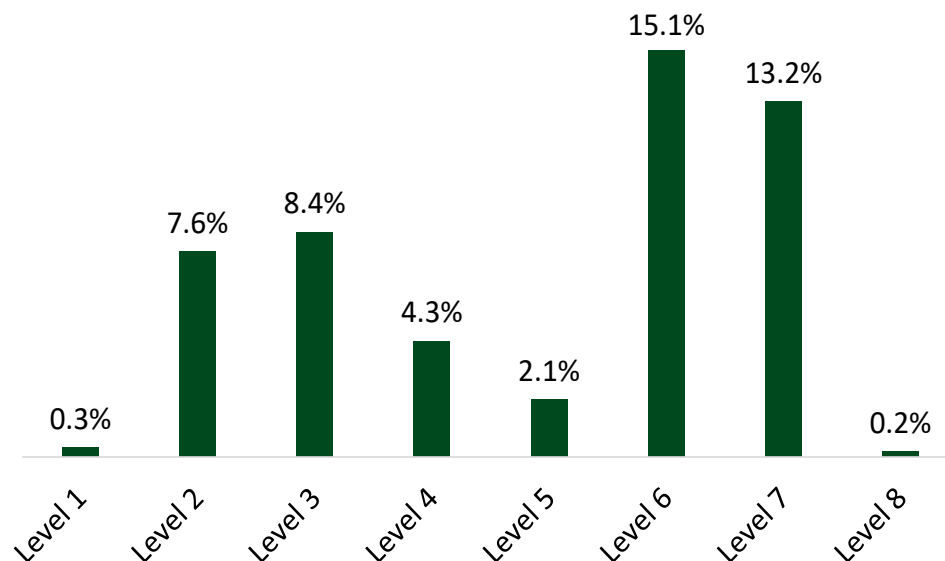


Chart 36: Percentage of school learning support workers highest level of qualifications in 2024.

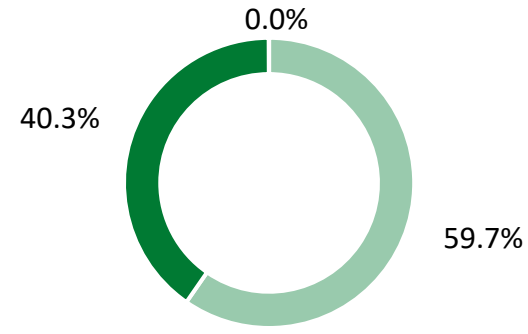


Chart 37: The gender of further education teachers in 2024.

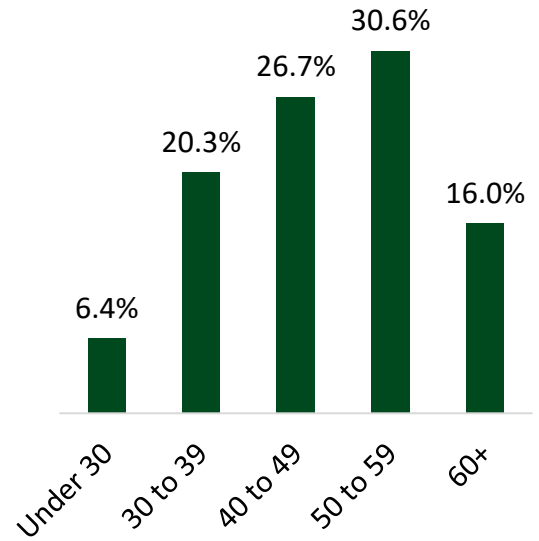


Chart 38: The age of further education teachers in 2024.

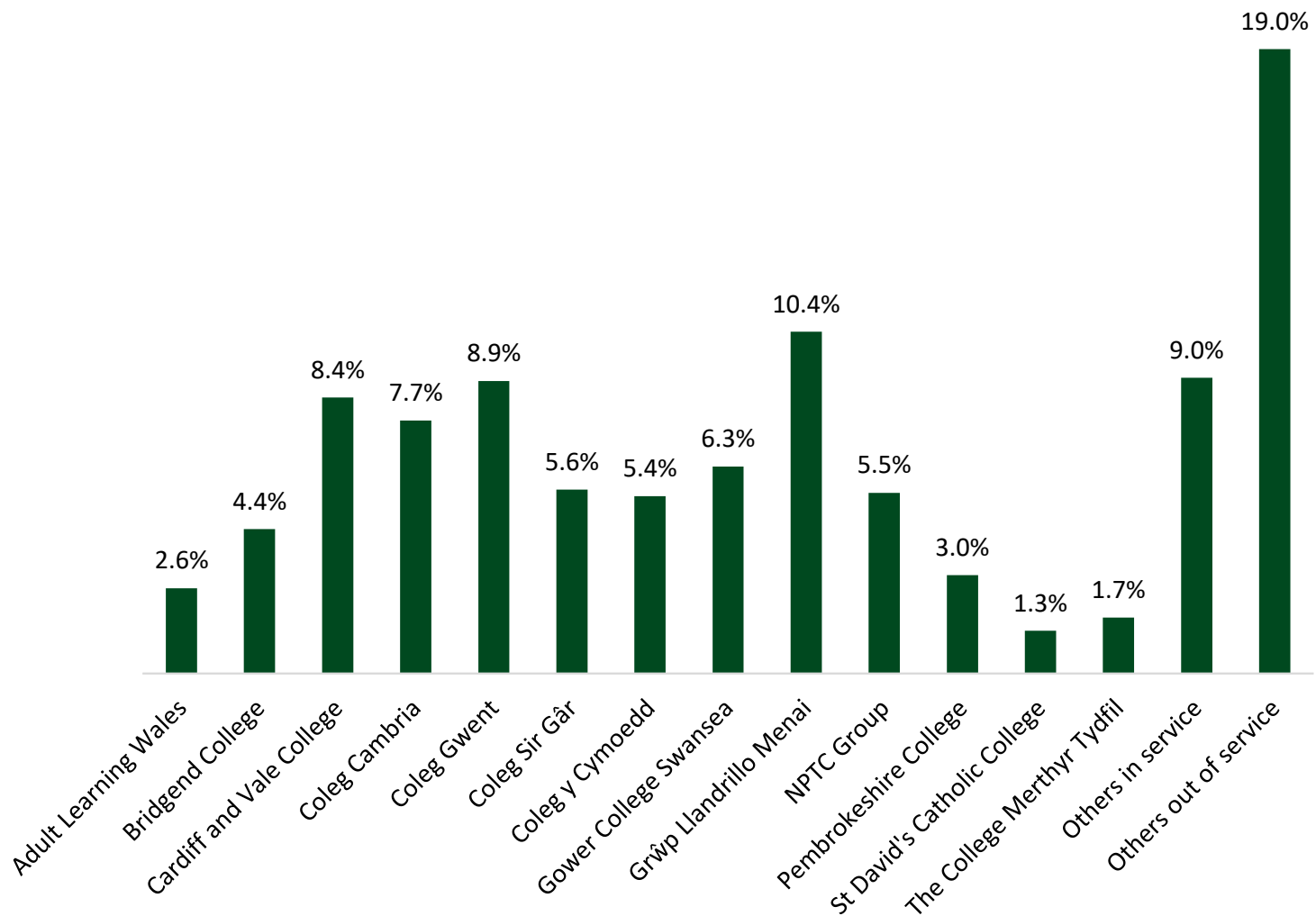

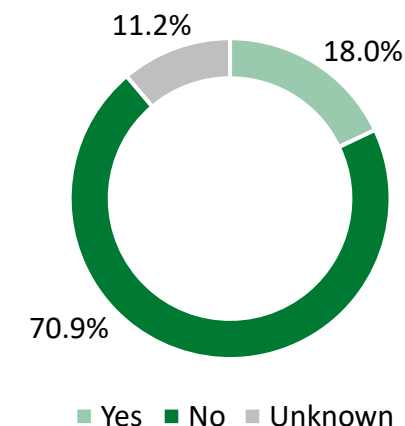
**Chart 39: Percentage of further education teachers by employer.**

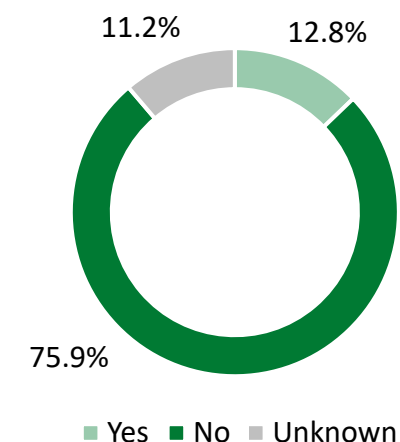
**Chart 40: Further education teachers ability to speak Welsh in 2024.**

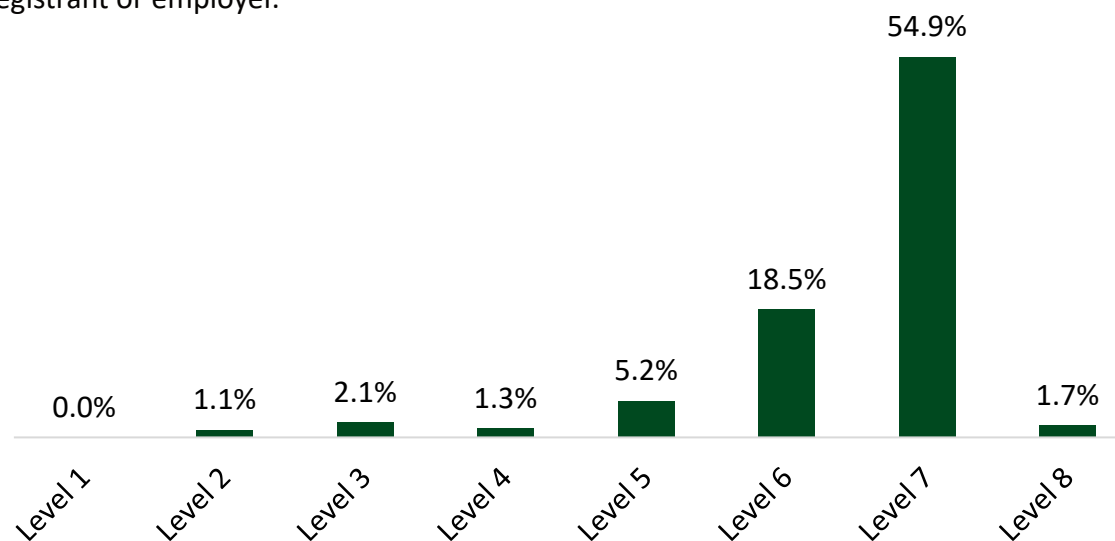


Chart 42: Percentage of registered further education teachers by highest level of qualification in 2024.

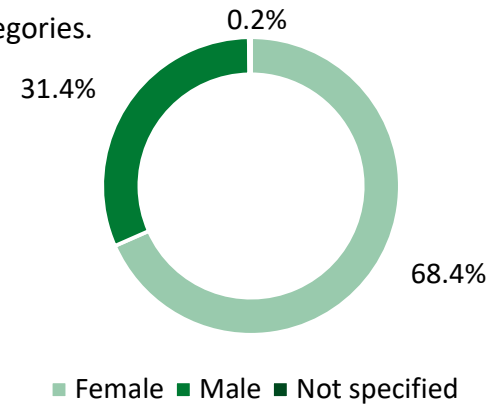


Chart 43: The gender of further education learning support in 2024.

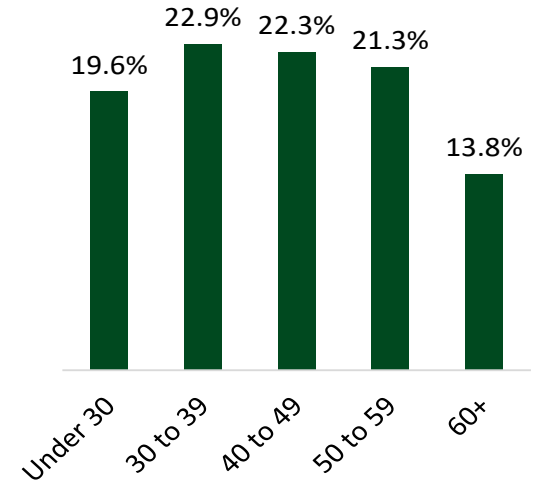


Chart 44: The age of further education learning support workers in 2024.

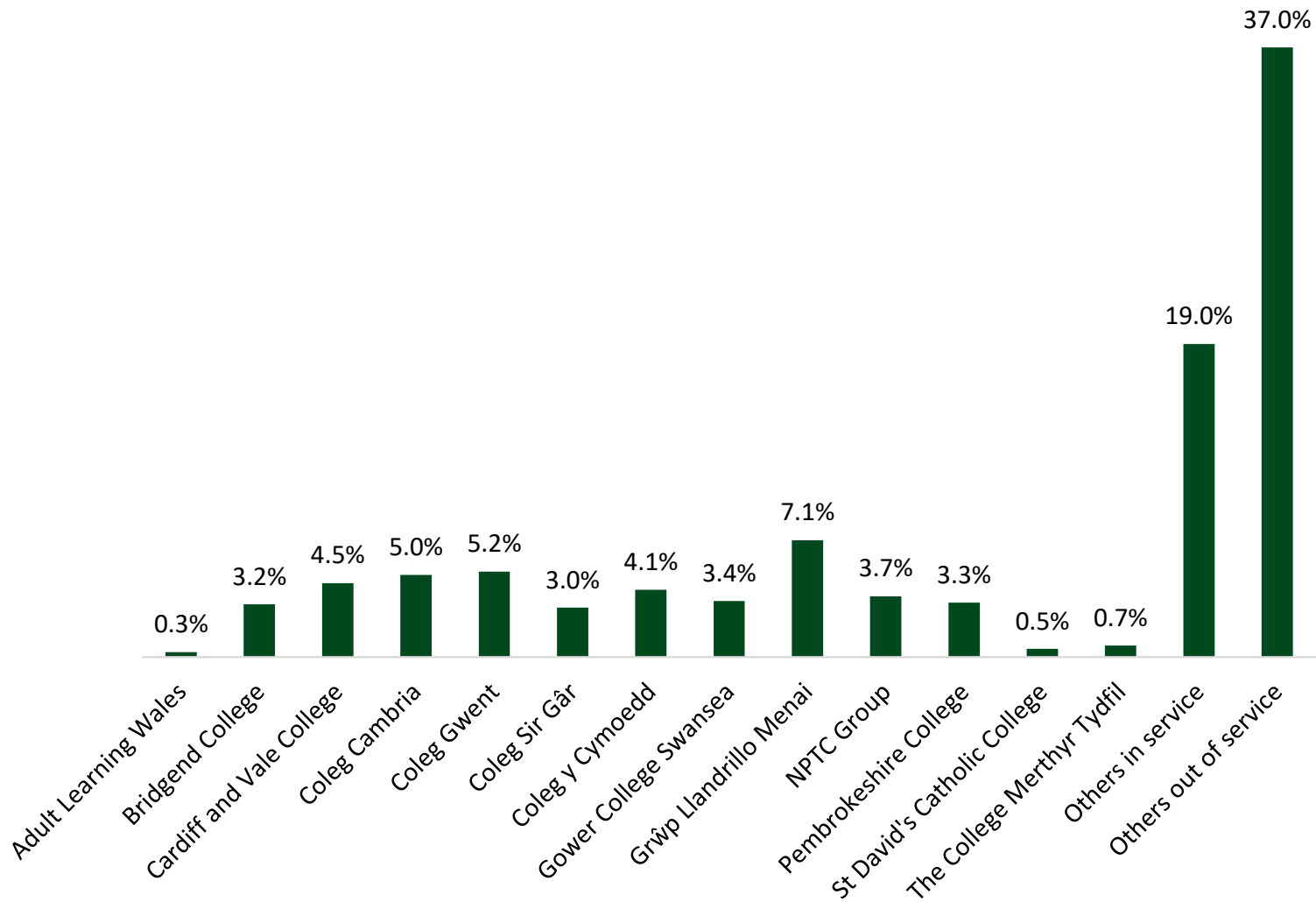

**Chart 45: Percentage of further education learning support workers by employer in 2024.**

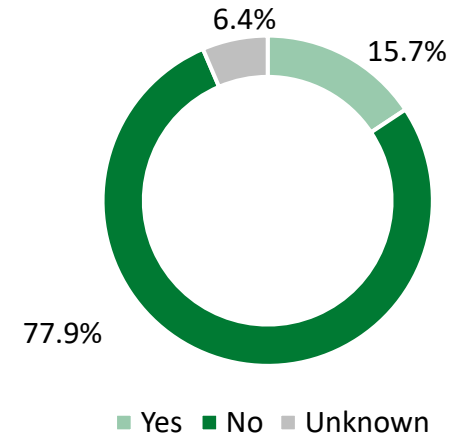

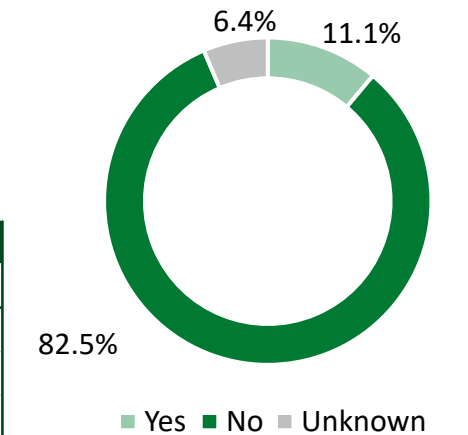

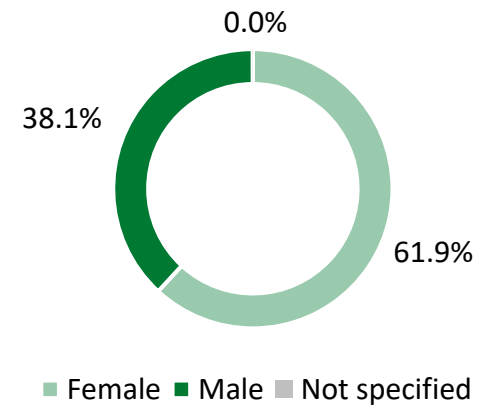


Chart 48: The gender of registered work-based learning practitioners in 2024.

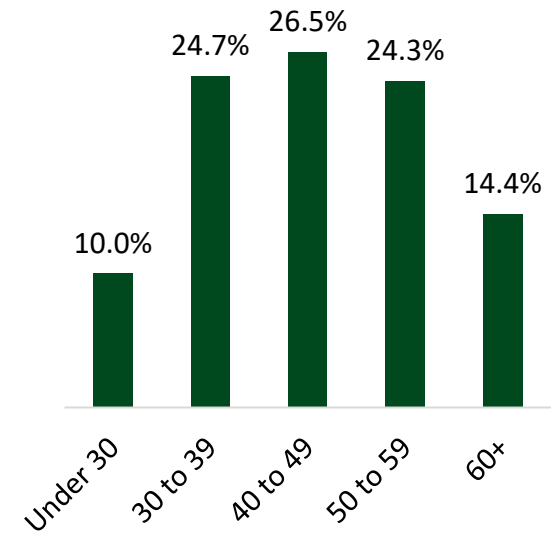


Chart 49: The age of registered work-based learning practitioners in 2024.

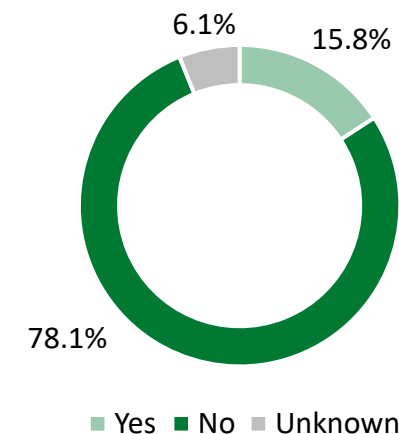


Chart 50: Welsh language ability of work-based learning practitioners in 2024.

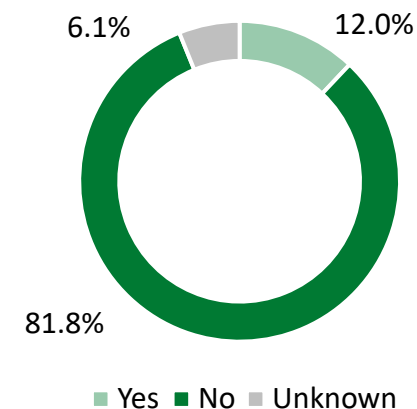


Chart 51: Work-based learning practitioners ability to work through the medium of Welsh in 2024.

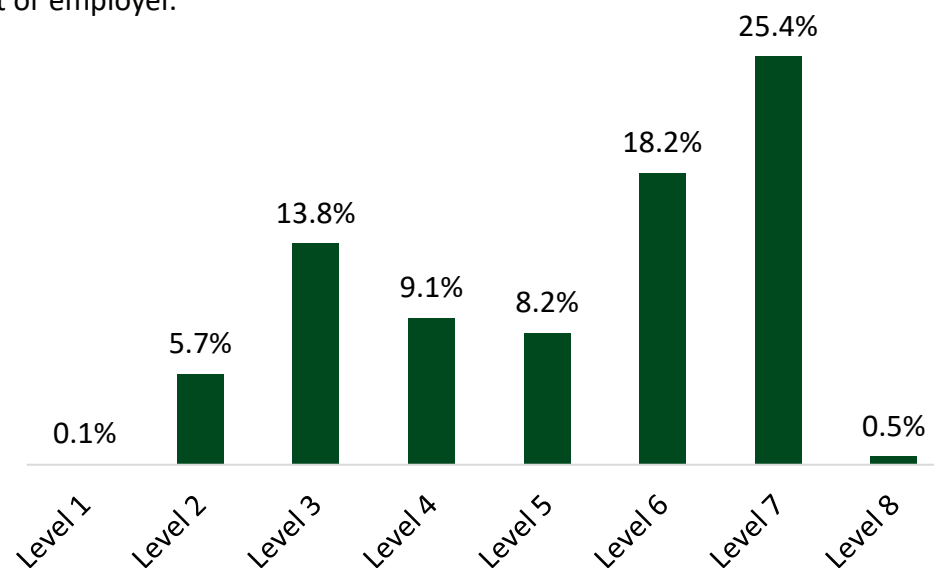


Chart 52: Percentage of highest level of education held by work-based learning practitioners in 2024.

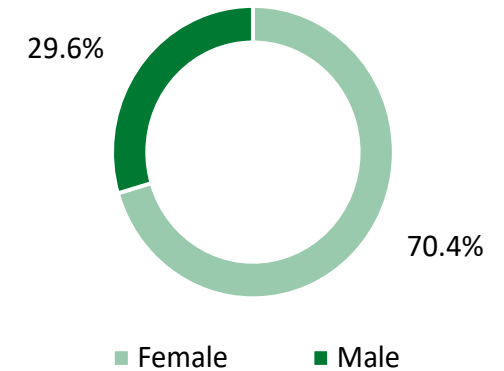


Chart 53: The gender of qualified youth workers in 2024.

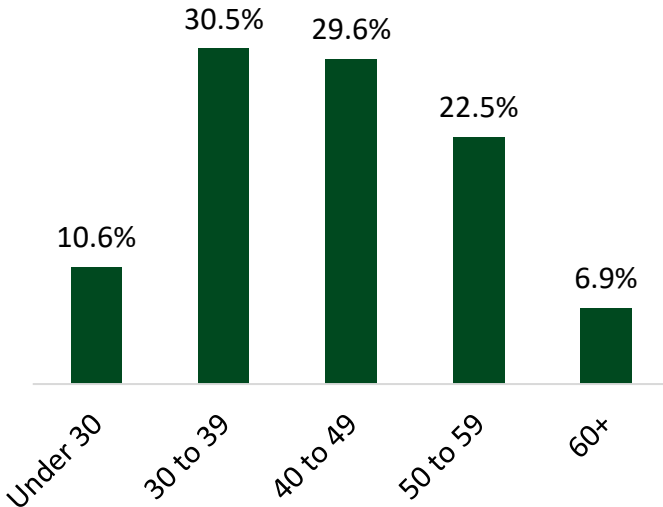


Chart 54: The age of qualified youth workers in 2024.

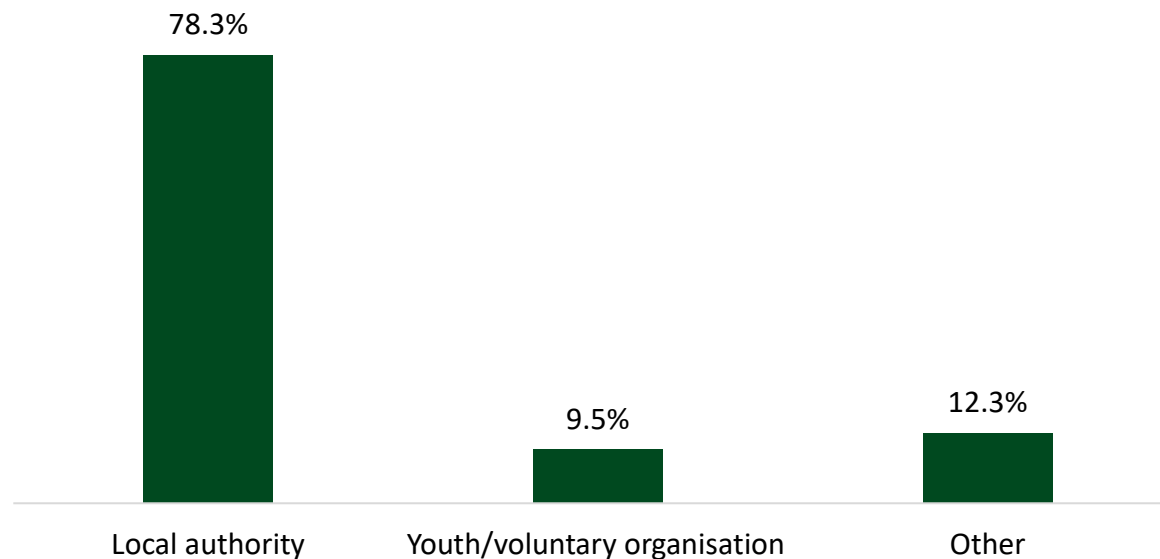


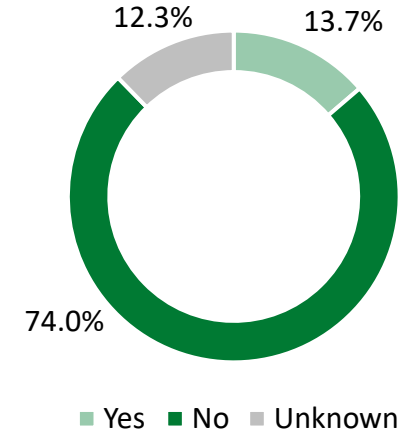
Chart 55: The employer of qualified youth workers in 2024.

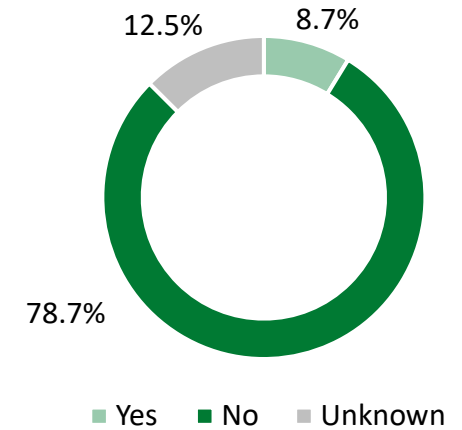
**Chart 56: The ability to speak Welsh of qualified youth workers in 2024.**

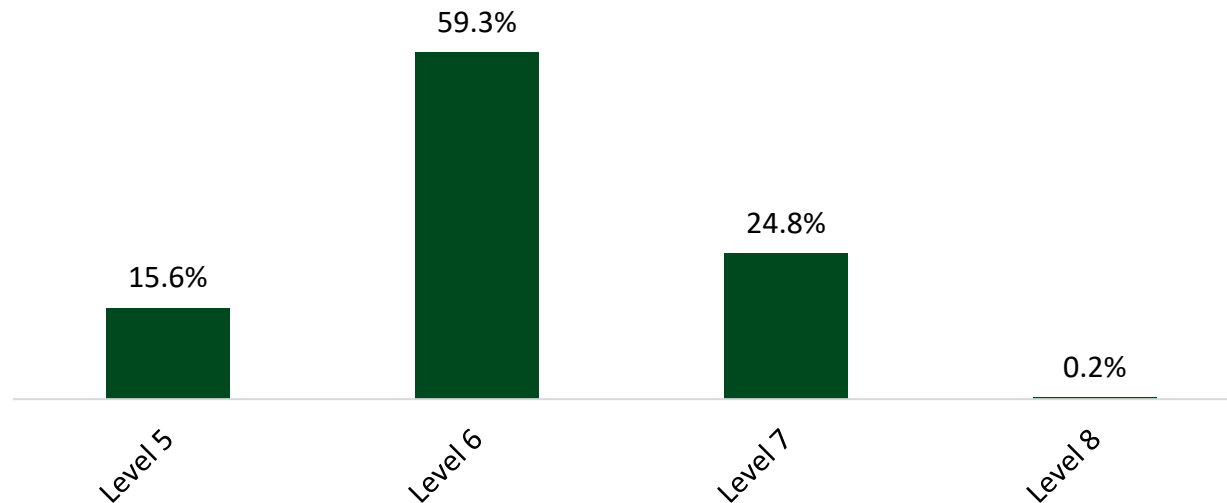


Chart 58: The highest level of qualification of qualified youth support workers in 2024.

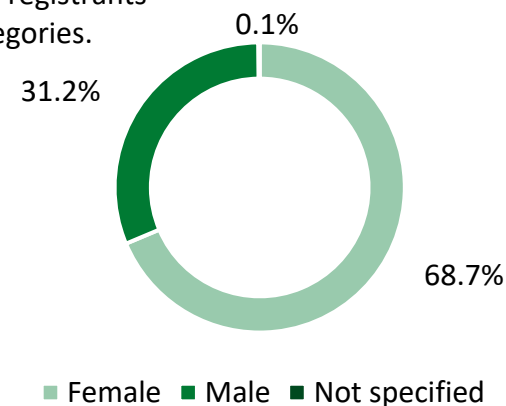


Chart 59: The gender of qualified youth support workers in 2024.

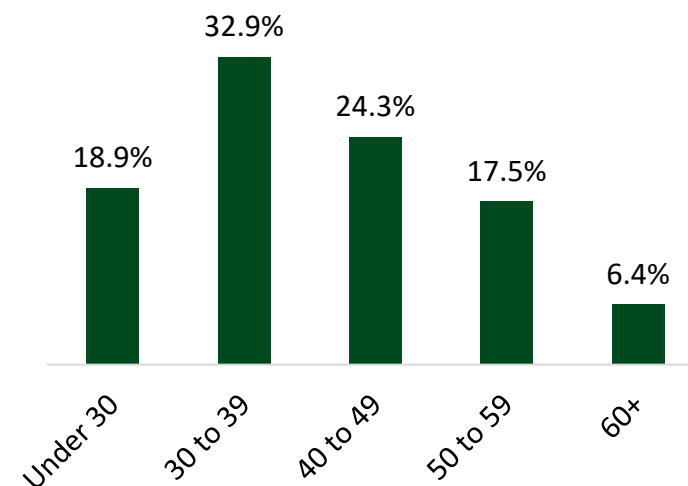


Chart 60: The age of qualified youth support workers in 2024.

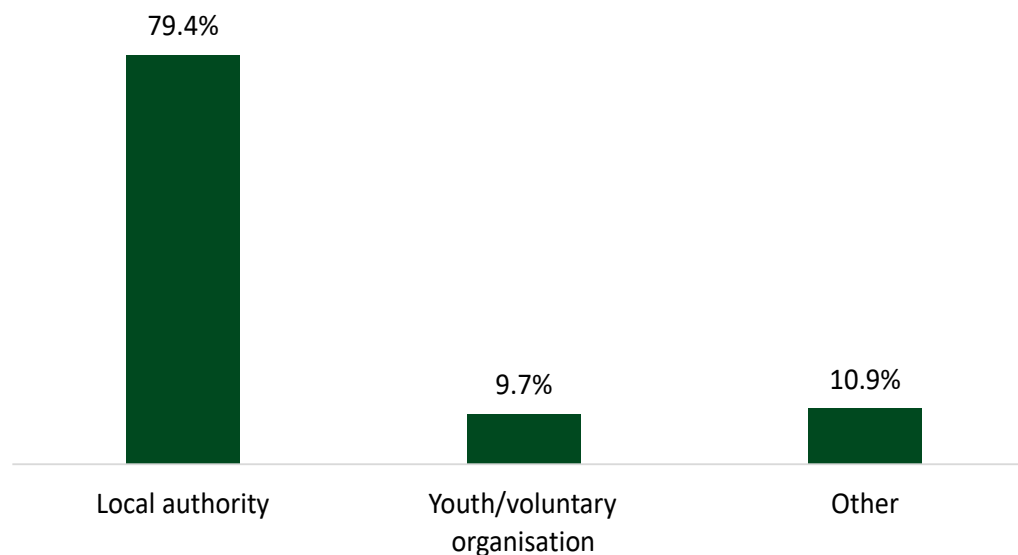


Chart 61: Percentage of registered qualified youth support workers by employer in 2024.

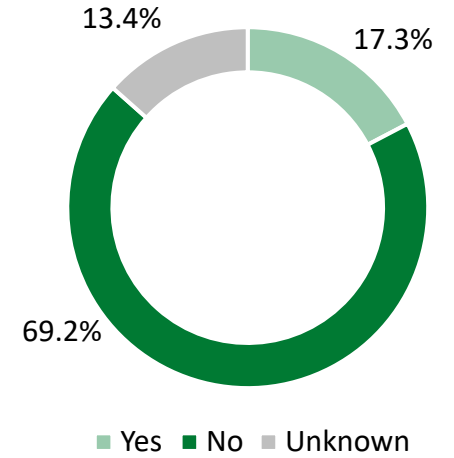

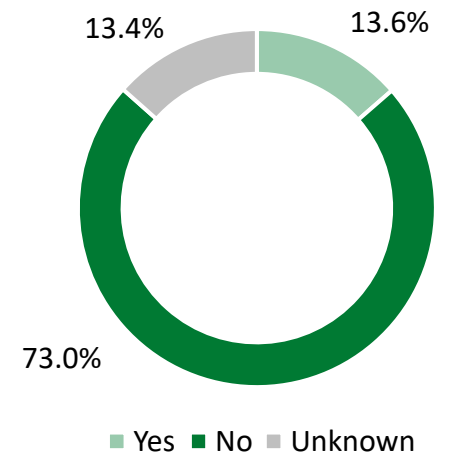
**Chart 62: Welsh language ability of qualified youth support workers in 2024.**

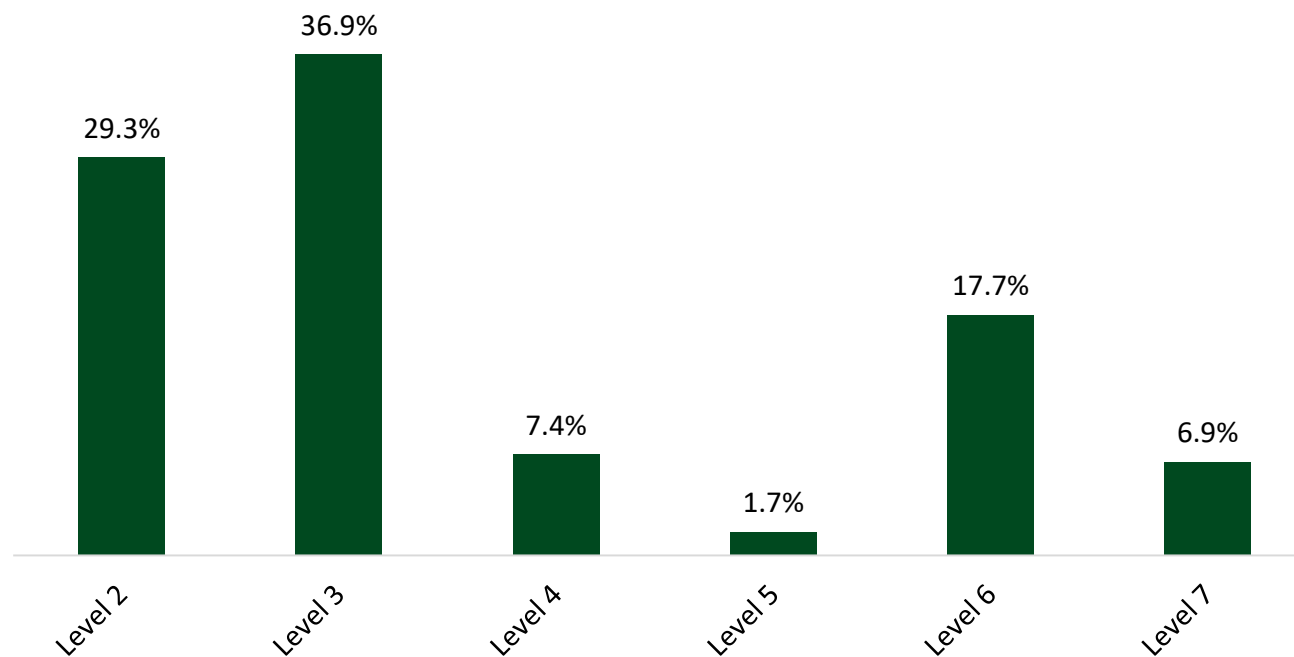


Chart 64: Percentage qualified youth support workers highest youth work qualification in 2024.

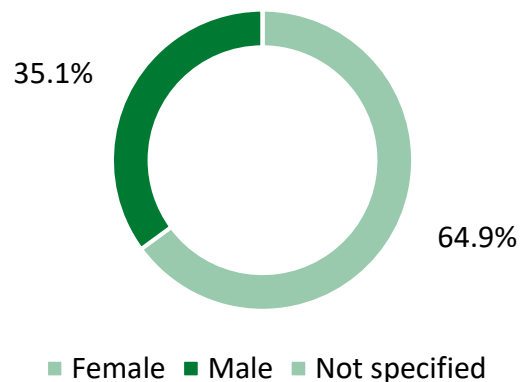

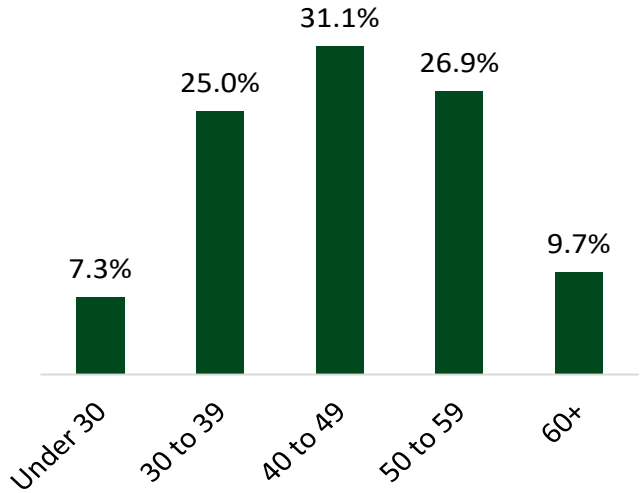


**Chart 65: The gender of independent school teachers in 2024.**

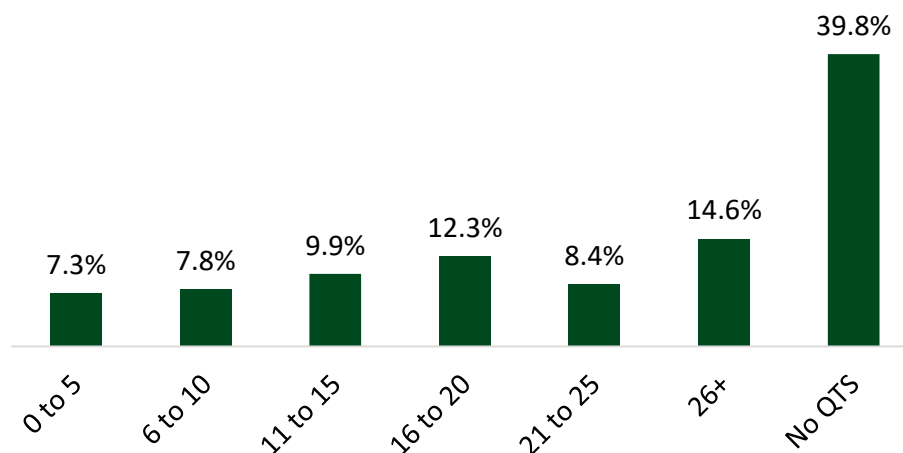


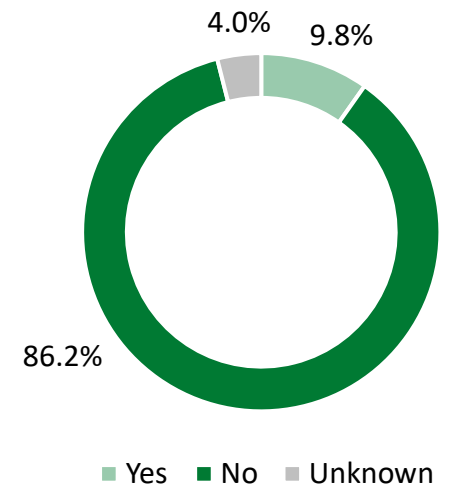
Chart 67: Percentage of independent school teachers by years since qualified teacher status in 2024.

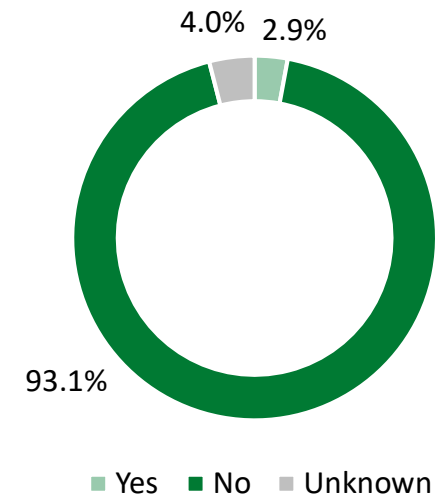
**Chart 68: Independent school teachers ability to speak Welsh in 2024.**

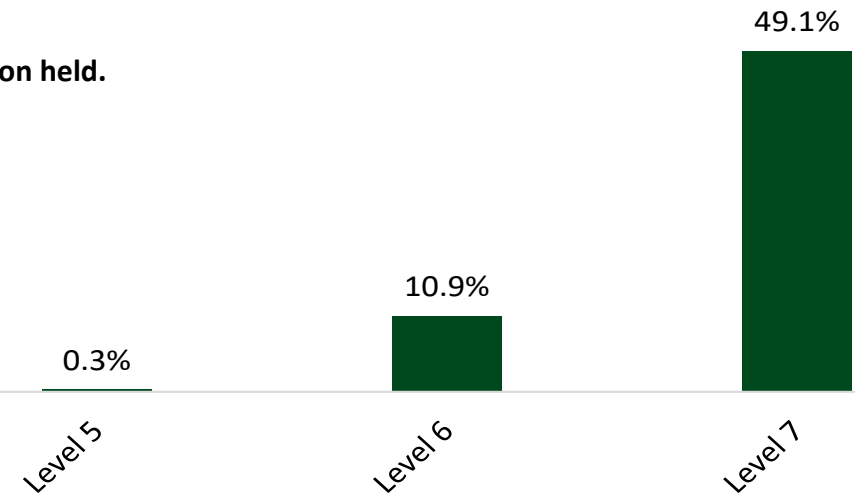

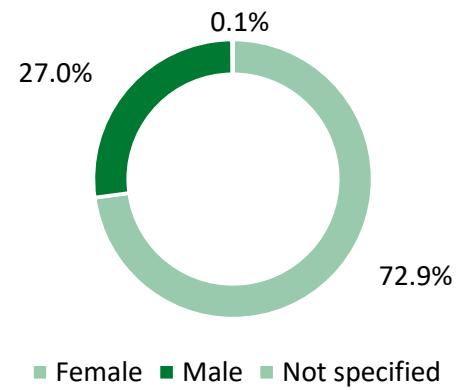

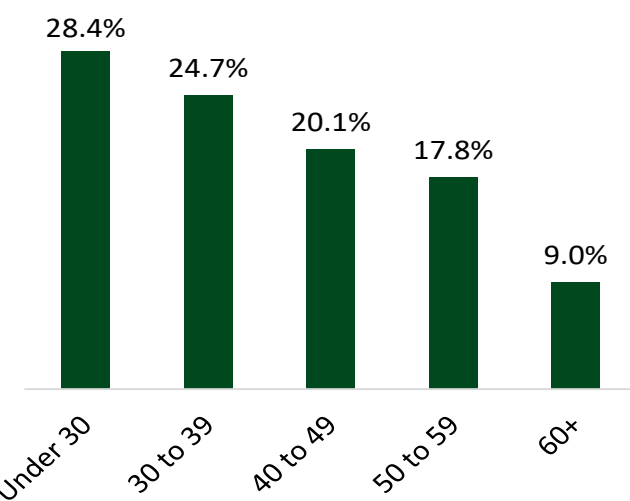


**Chart 71: The gender of independent school learning support workers in 2024.**

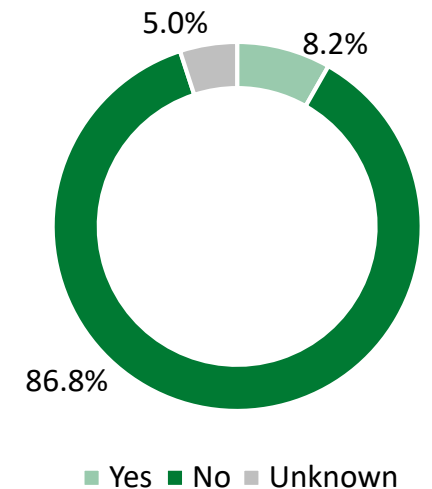


Chart 73: Independent school learning support workers by ability to speak Welsh in 2024.

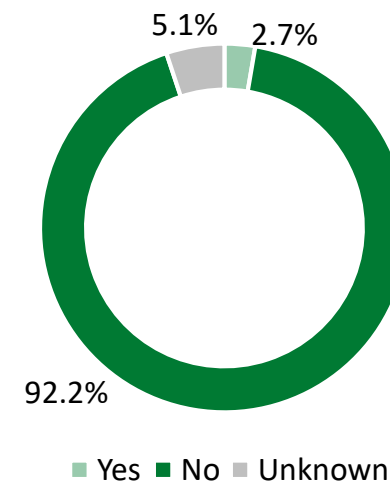

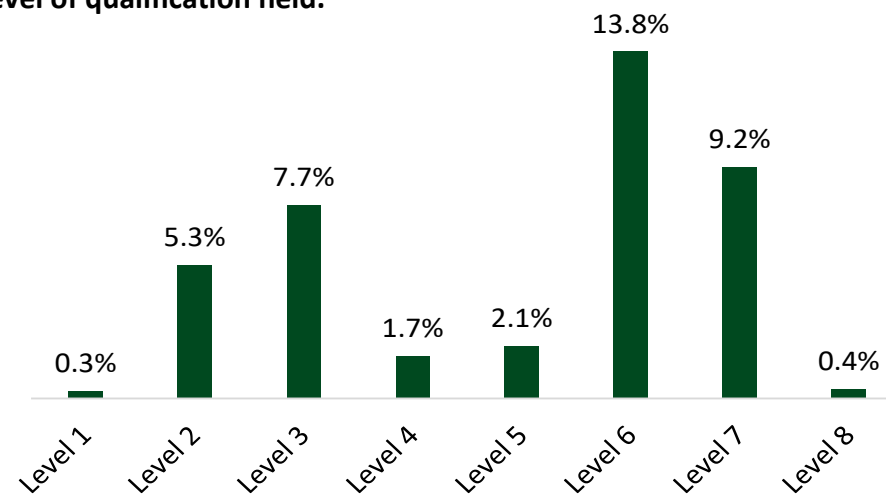


**Chart 74: Independent school learning support workers ability to work through the medium of Welsh in 2024.**

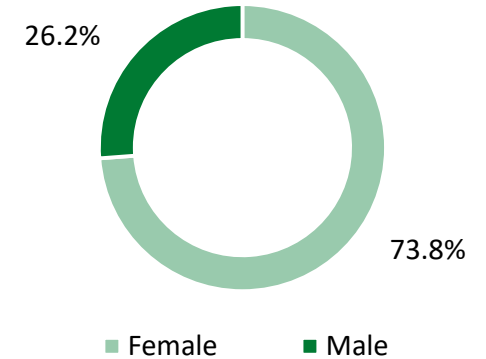

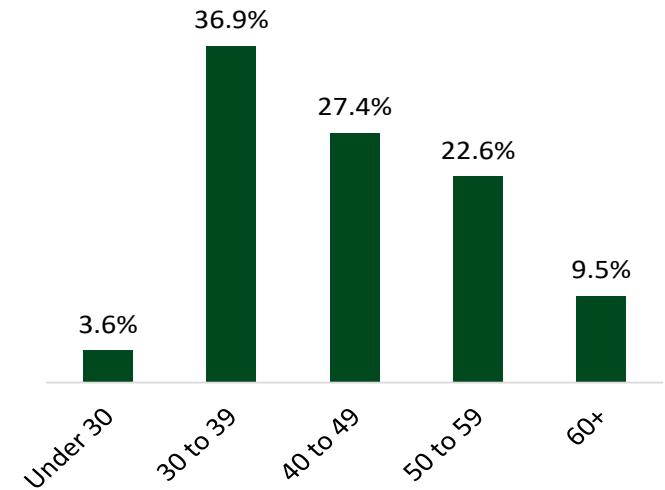


**Chart 76: The gender of independent special post-16 institution teachers in 2024.**

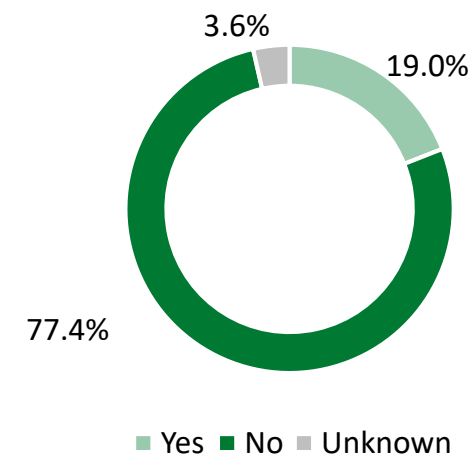

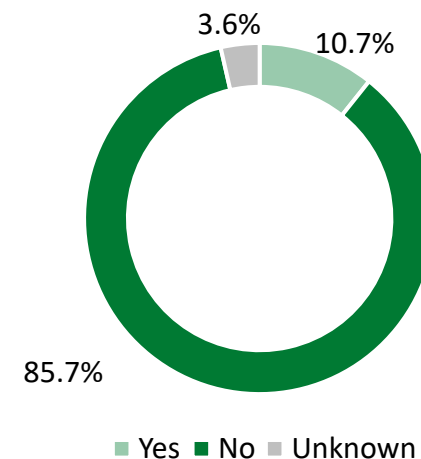
**Chart 78: Independent special post-16 institution teachers by ability to speak Welsh in 2024.**

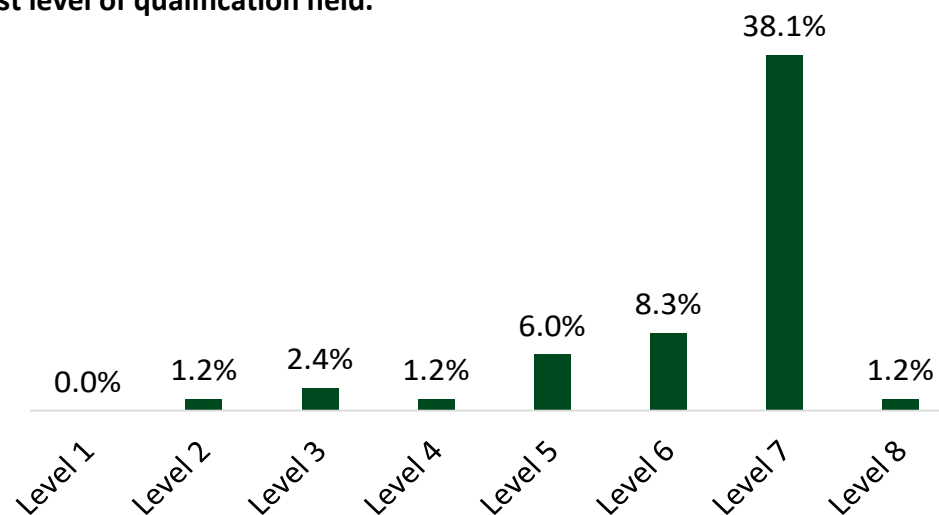


**Chart 79: Independent special post-16 institution teachers by ability to work through the medium of Welsh in 2024.**

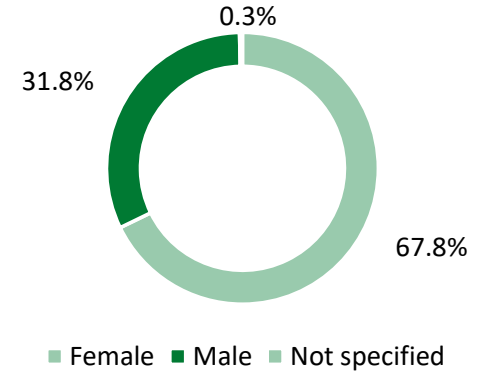

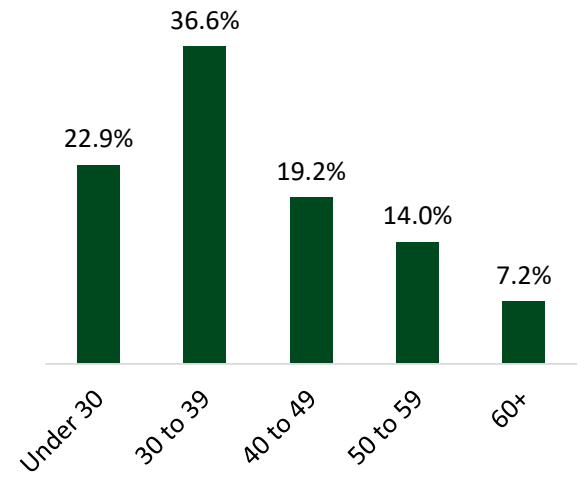


**Chart 81 The gender of independent special post-16 institution learning support workers in 2024.**

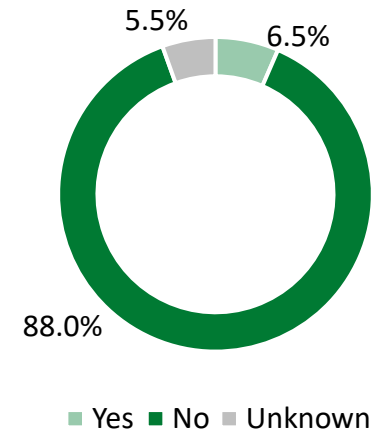

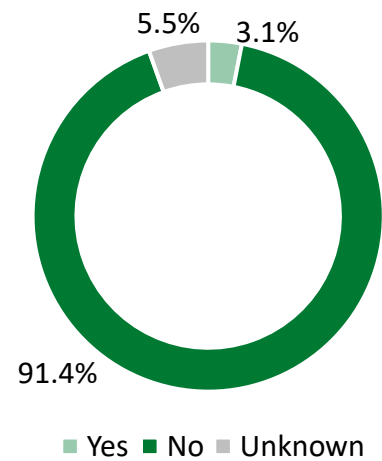

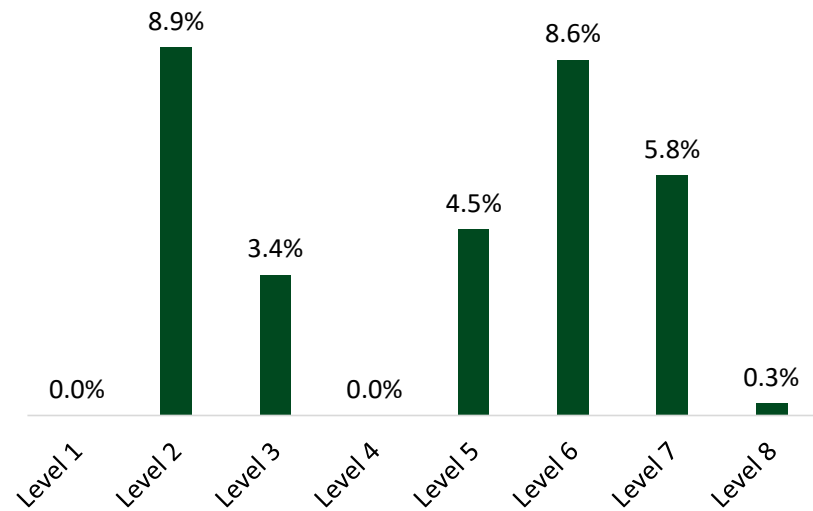
