# Benchmark Data for Integrated Education Strategy

## Assessing Indicators

The table below lists the indicators that will measure progress towards achieving the outcomes of the strategy and action plan. They have been identified in consultation with persons with knowledge and experience of Integrated schools including teachers, governors, pupils, families, and sectoral and community bodies.

The indicators will be monitored annually and compared against the baseline year. The baseline year for the majority of indicators is 2022/23, but this may vary where data was not available at that time. Annual monitoring will report on changes over time including comparisons with the baseline year. Four categories will be used to indicate progress:

- Positive change
- No change

- Negative change
- Data under development or not available

The indicators in this document are mainly measured using administrative sources or statistical surveys. As statistical survey estimates are subject to sampling error, differences between estimates from successive years or between population subgroups may occur by chance. It is possible to measure whether this is likely to be the case using standard statistical tests and conclude whether differences are likely to be due to chance or represent a real difference. For the purposes of this exercise, where differences have emerged as being statistically significant, these will be reported at the 5% ( $p<0.05$ ) level of probability (two-tailed tests). This means that, for any observed result that is found to be statistically significant, one can be 95% confident that this has not happened by chance. Data is not yet available for some indicators and these will develop over time.
