Terms of reference

The Steering Group is asked to advise the Chief Executives of HEFCE, HEFCW and SHEFC on the practical means of implementing the following recommendation arising from the Review of Research:

The HEFCE, together with the Research Councils and other stakeholders such as industry and charities, should develop minimum requirements which departments would need to satisfy in order to be eligible for HEFCE funding for postgraduate research training. The research assessment process should be extended to establish whether departments comply with these minimum standards.

The Steering Group is asked to advise on:

- The approach to a good practice guide for HEIs on postgraduate research training
- Possible indicators of good practice
- Threshold standards
- Assessment and assurance systems utilising standards
- Funding implications.

This will be a three-stage process with:

Phase one a review of good practice in HEIs, requirements of research funders, and identification of indicators that might form the basis of possible threshold standards

Phase two would be, in consultation with all interested stakeholders, developing these indicators into threshold standards, and how such standards might be deployed

Phase three would be assessing the costs of implementing such a system and possible funding models to support it.

At the end of each phase the steering group will be asked to advise whether to proceed to the next phase.
