Consultation on proposed amendments to the General Teaching Council for Wales (Constitution) Regulations 1999, as amended

Summary

This consultation invites comments on proposed amendments to the General Teaching Council for Wales (Constitution) Regulations 1999 http://www.opsi.gov.uk/legislation/wales/wsi1999/993185e.htm as amended, that govern the arrangements by which members of the General Teaching Council for Wales are elected and appointed.

It is intended that new regulations will come into force by March 2006 in readiness for a new round of appointments to the Council, which need to be made to commence in September 2006. The draft regulations are not included with this consultation but will be developed in the light of the views that come forward.

Comments are also invited on the draft regulatory appraisal at Annex A.

The closing date for this consultation is 14 October 2005.

N.B. prior to public consultation this document has been considered by the School Workforce Advisory Panel (SWAP) whose members have agreed that there appear to be no significant workload issues.

Section 1: Background

1.1 The General Teaching Council for Wales was established by the National Assembly for Wales on 1 September 2000. It provides an independent and authoritative voice for teachers, and was established to maintain and enhance high standards of teaching.

1.2 The General Teaching Council for Wales (Constitution) Regulations 1999 http://www.opsi.gov.uk/si/si1999/19991619.htm, as amended, (the 1999 Regulations) provide for the constitution of the GTCW. The Council consists of 25 members; twelve are elected by their peers, nine are appointed by the National Assembly for Wales following nominations made by teacher unions and other educational organisations as set out in the Schedule to the 1999 Regulations, and four members are appointed directly by the National Assembly for Wales.

1.3 Prior to the Council's establishment, the first election of Council members was completed in April 2000 in accordance with an election scheme drawn up by the National Assembly for Wales. The 1999 Regulations currently provide that subsequent elections shall be conducted in accordance with an electoral scheme set out in rules made by the Council with the approval of the National Assembly for Wales. Election schemes prepared by the Council require the approval of the National Assembly for Wales. Details of the Council's election scheme can be found on the Council's website www.gtcw.org.uk

1.4 Schedule to the 1999 Regulations, which sets out the list of organisations entitled to nominate persons for appointment by the National Assembly for Wales, was replaced by a new Schedule in March 2003 following consultation with interested bodies to take account of changes to those organisations listed, for example, in terms of title or changes to constitution. The current list of bodies as included the General (Constitution) (Amendment) Regulations 2003 can be accessed at http://www.opsi.gov.uk/legislation/wales/wsi2003/20030389e.htm

Section 2: Issues to be addressed

2.1 In accordance with the 1999 Regulations, the Council carried out an election in 2004 to elect 12 new members to the Council. Following the election, a review and evaluation was undertaken by the Council to determine the conduct of future elections. In the light of the Council's evaluation report the Welsh Assembly Government has looked again at the constitution of the Council, and in consultation with the Council, is proposing to amend the current legislation as follows:

Election categories

2.2 The existing election categories for elected members to the Council were included in the General Teaching Council for Wales (Constitution) (Amendment) Regulations 1999 http://www.opsi.gov.uk/legislation/wales/wsi1999/993185e.htm . They are:

- four teachers of junior pupils (children who have not attained the age of 12);
- four teachers of senior pupils (persons who have attained the age of 12) and
- four head or deputy head teachers.

2.3 At present the head/deputy head category excludes assistant head teachers from standing or voting in this category, despite the fact that some schools, particularly primary schools, no longer have a deputy head teacher, but instead have an assistant head. Assistant head teachers are qualified teachers with leadership responsibilities across the whole school, who are appointed to the post of assistant head teacher (as set out in the School Teachers' Pay and Conditions Document). The Welsh Assembly Government considers that assistant head teachers should be able to stand or vote for election in a capacity that more aptly reflects their role, and proposes, therefore, to amend the 1999 Regulations to include assistant heads alongside headteachers and deputy heads.

Q1. Do you agree that the existing election category of head/deputy head teacher should be amended to include assistant head teachers?

Titles of election categories

2.4 There is evidence to suggest from the Council's evaluation of the 2004 elections that the existing election titles of "teachers of senior pupils", and "teachers of junior pupils" has caused some confusion. The Welsh Assembly Government is keen to know your views on whether the existing titles of the voting categories of elected members are easily understood, or whether further clarification is needed.

2.5 Originally the titles of these categories (as set out in the 1999 Regulations) were "teachers of secondary school pupils" and "teachers of primary school pupils". It very quickly became clear, however, that this definition would not allow teachers in nursery schools, special schools and in further education to vote or be elected to the Council and the categories were amended to those we now use.

Q2. Do you consider that the existing titles of the voting categories of 'teacher of senior pupils' and 'teacher of junior pupils' as replaced by the General Teaching Council for Wales (Constitution) (Amendment) Regulations 1999 should be retained? Is further clarification needed to spell out precisely what each title means?

Q3. If you consider that these titles should be renamed, do you agree that the titles should be "teachers of secondary school pupils" and "teachers of primary school pupils"? If not in what way should the categories be differentiated e.g. by age of the pupils taught?

Representation of the secondary school sector

2.6 There is some evidence to suggest that the single category for head teacher/deputy head teacher may disadvantage candidates in the teachers of senior pupils' category. As there are a relatively small number of secondary schools in this sector (approximately 230) compared to primary schools (1700), there is less likelihood of a head teacher of senior pupils being elected under the current electoral system. The Welsh Assembly Government would like to know your views on whether the head/deputy head category should include at least one teacher of secondary/senior pupils.

Q4. Do you support the proposal that the head/deputy head category should include at least one teacher of secondary/senior pupils at the head/deputy/assistant head level?

Who may stand as a candidate for election

2.7 The 2004 elections raised some issues in terms of interpretation of the definition of a teacher under regulation 5(1) of the 1999 Regulations. The intention of the 1999 Regulations is that only qualified teachers who carry out work specified in regulation 6 of the Education (Specified Work and Registration) (Wales) Regulations 2004 http://www.opsi.gov.uk/legislation/wales/wsi2004/20041744e.htm in a school should be eligible for election. As currently drafted, however, the 1999 Regulations allow teachers who are not required to be registered with the Council but who chose to do so to stand for election. The Welsh Assembly Government therefore intends to amend the existing legislation so that only those teachers who are required to be registered teachers can stand for election.

Q5. Do you agree that an amendment should be made to the 1999 Regulations so that candidates standing for election may only be those persons who are required to be registered with the Council? 2.8 If an amendment is made to regulation 5(1) of the 1999 Regulations then this would impact on regulation 7 of the 1999 Regulations, so as to require organisations in Part 1 of the Schedule to the 1999 Regulations (the teaching unions) to only nominate persons who are required to be registered with the Council.

Q6. Do you agree that an amendment should be made to the 1999 Regulations so as to require organisations in Part 1 of the Schedule (the teaching unions) to only nominate persons who are required to be registered with the Council?

Approval of the Council election scheme

2.9 The 1999 Regulations require the National Assembly for Wales to approve the Council's election scheme. In view of the smooth running of the 2004 elections, the Welsh Assembly Government is proposing to remove the requirement that the National Assembly for Wales approves the Council's election scheme given that the election arrangements are governed by regulations and that the Council's election scheme includes:

- a. provision for the appointment of a returning officer and other staff in connection with the holding of the election;
- b. the making of an electoral roll;
- c. the determination of the category of elected member for which each elector is entitled to vote;
- d. the giving of notice of an election;
- e. the nomination of candidates; and
- f. any other matter relating to the election.

2.10 The removal of this requirement reflects the Council's growing independent status and follows an earlier relaxation of National Assembly for Wales' control over some of the Council's executive functions as covered in the General Teaching Council for Wales (Amendment) Order 2002 e.g. the removal of the National Assembly's power to determine Council members' salaries, allowances, pensions and other payments.

Q7. Do you agree that an amendment should be made to the existing regulations to remove the requirement for the Council to seek the National Assembly for Wales' approval to its election scheme? If you agree, should provision be made in the proposed regulations to ensure that the Council's election scheme must include the points shown at a-f?

Organisations entitled to nominate persons for appointment by the National Assembly for Wales

2.11 In considering making amendments to the 1999 Regulations that govern the arrangements by which members of the Council are elected, the Welsh Assembly Government has used the opportunity to look again at the status of the list of organisations entitled to nominate persons for appointment by the National Assembly for Wales as set out in the Schedule. 2.12 Five of the Assembly appointments are made from nominations from the listed bodies, and it is therefore important that the list remains accurate and up to date. Although the Schedule was last updated in 2003 it is highly likely that some of the organisations listed may change their name in the future or cease to exist. To avoid having to amend the Regulations each time such a change is made, the Welsh Assembly Government is considering making provision to allow changes of names (providing that there are no other changes to the nature of the organisation) or removal of organisations that have ceased to exist, without recourse to regulation. The Welsh Assembly Government will ensure that the list remains up-to- date and will make it available on the Welsh Assembly Government's Learning Wales website.

Q8. Do you agree that the Schedule to the 1999 Regulations should be amended to allow changes of names to those organisations listed (providing that there are no other changes to the nature of the organisation) or removal of organisations that have ceased to exist and without the need for further legislation to amend the regulations?

Annex A: Draft Regulatory Appraisal

REGULATORY APPRAISAL

EDUCATION, WALES

THE GENERAL TEACHING COUNCIL FOR WALES (CONSTITUTION) (AMENDMENT) REGULATIONS 2006

Purpose and intended effect of the Regulations

1. The Regulations will amend the General Teaching Council for Wales (Constitution) (Amendment) Regulations 1999, as amended, which govern the arrangements by which members of the Council are elected and appointed. The exact wording of the amending Regulations has yet to be decided and will be subject to views expressed in the consultation. Issues for consideration, however, are:

(i) amendments to the existing election categories in the Head/Deputy category to include Assistant Head Teachers;

(ii) any other necessary amendments to the existing election categories in the interests of clarity;

(iii) an amendment to try and ensure that at least one of the elected candidates in the Head/Deputy Head and Assistant Head category is from the primary sector, and one is from the secondary sector ;

(iv) to make an amendment to clarify who is eligible to stand as a candidate for election;

(v) to remove the requirement for the Minister to approve the Council's Election Scheme;

(vi) to make any necessary changes to the bodies listed in Schedule 1 to the Regulations.

Risk Assessment

2. Following the last GTCW election in 2004, a review and evaluation was undertaken by the GTCW to determine the conduct of future elections and several recommendations were made requiring amendments to the Regulations. These were :

- to amend the existing election categories to include Assistant Headteachers; to ensure that at least one of the elected candidates in the Head/Deputy Head and Assistant Head category is from the primary sector and one from the secondary sector;
- to amend the existing election categories for teachers of senior pupils and teachers of junior pupils to avoid confusion;

- to clarify who may stand as a candidate for election;
- to remove the requirement for the Minister to approve the GTCW election scheme.

3. If the amendments to the Regulations are not put in place then there could be confusion when the next appointments/elections arise. Having identified possible areas of confusion it is only proper to take the opportunity to aid understanding. To do otherwise could adversely affect the future elections/appointments to the Council. This would result in the GTCW being unable to operate which would impact negatively on all the GTCW's functions including the statutory registration of teachers, teacher disciplinary procedures and the administration of the individually focussed Continuing Professional Development programme for teachers.

Options

4. There are two options:

(a) Do nothing

If we do not make these amendments there is likely to be confusion during the next GTCW elections in 2008. There is also the possibility that the list of nominating bodies will not be accurate, which could result in a reduced pool of candidates from which to select the Assembly appointed Council members in 2006.

(b) Make the Legislation

If we make these amendments we ensure that :

- the next round of Assembly appointments in 2006 is carried out on the basis of an accurate and up to date list of nominating bodies and that all appointments are made from the largest pool of candidates possible;
- some types of teacher, previously under-represented on the Council (e.g. assistant head teacher and head teacher/deputy head teacher in the senior pupils category) are no longer disadvantaged;
- the titles of the election categories are clear so as to avoid confusion in the GTCW elections in 2008;
- the criteria to stand as a candidate for election is clear;
- burdens upon the Council, in terms of having to seek the Assembly's approval to the election scheme, are removed in line with the Council's growing independent status.

Costs

5. There are no financial implications for the Assembly. Any changes to guidance as a result of these amendments will be met from within existing budgets.

Consultation

6. We intend to consult electronically for a thirteen week period from mid July. All bodies listed in Schedule 1 to the Regulations plus other interested bodies will be consulted together. The views expressed in the consultation will be taken into account in drafting the amending Regulations.

Enforcement, Monitoring and Review

7. The Assembly Government holds regular meetings with the GTCW to discuss a wide variety of issues impacting on the Council including its statutory obligations. This will continue if the proposals are implemented.

Summary

8. The proposed Regulations will ensure that the Assembly appointment exercise in 2006 and the GTCW elections in 2008, run as smoothly as possible.
