# The General Teaching Council for Wales (Constitution) (Amendment) Regulations 2007 – a consultation on the composition of the Council

# **Summary**

This consultation invites views on proposals to amend The General Teaching Council of Wales (Constitution) Regulations 1999, as amended, by The General Teaching Council for Wales (Constitution) (Amendment) Regulations 2003 http://www.opsi.gov.uk/legislation/wales/wsi1999/993185e.htm , that govern the arrangements by which members of the General Teaching Council for Wales (GTCW) are elected and appointed.

A consultation previously took place in July 2005. This suggested minor amendments to the regulations in the light of experiences of running two elections and two rounds of appointments to the Council, the aim being to introduce the regulations in March 2006. From the comments we received during the consultation that ended on 14 October 2005 we clearly had the support to amend the regulations in the way we had proposed. Three issues, however, were raised about the composition of the Council that had not been included in the consultation. Given the importance of the issues raised it was decided to put the amending regulations on hold that so that we could undertake a full and thorough consultation on the additional issues. These additional issues are fully described in Section 2.

It is intended that the new regulations will come into force in March 2007 in readiness for a new round of appointments to the Council, which need to be made to commence in September 2007. The draft regulations are not included with this consultation but will be developed in the light of the views that come forward.

Comments are also invited on the draft Regulatory Appraisal at Annex C.

The closing date for this consultation is 8 September 2006.

N.B prior to public consultation this document has been considered by the School Workforce Advisory Panel (SWAP) whose members have agreed that there appear to be no significant workload issues.

# **Section 1: Background**

- 1. The General Teaching Council for Wales was established by the National Assembly for Wales on 1 September 2000. It provides an independent and authoritative voice for teachers, and was established to maintain and enhance high standards of teaching.
- 2. The General Teaching Council for Wales (Constitution) Regulations 1999 http://www.opsi.gov.uk/si/si1999/19991619.htm, as amended, (the 1999 Regulations) provide for the constitution of the GTCW. The Council consists of 25 members:
  - Category 1: twelve are teachers elected by their fellow professionals;
  - Category 2: nine are appointed by the Assembly Minister for Education, Lifelong Learning and Skills from nominations made from a list of organisations with interests in the education field (including 4 members from nominations from the 8 teacher unions);
  - Category 3: four members are appointed directly by the Minister for Education, Lifelong Learning and Skills.
- 3. The Schedule to the 1999 Regulations, which sets out the list of organisations entitled to nominate persons for appointment by the National Assembly for Wales, was replaced by a new Schedule in March 2003 following consultation with interested bodies to take account of changes to those organisations listed, for example, in terms of title or changes to constitution (Annex D). The current list of bodies as included in the General (Constitution) (Amendment) Regulations 2003 can be accessed at http://www.opsi.gov.uk/legislation/wales/wsi2003/20030389e.htm
- 4. It is nearly six years since the General Teaching Council for Wales was established. In that time 37 people have served on the Council, having been elected or appointed by the Minister for Education, Lifelong Learning and Skills, either following a nomination or an open advertisement. There have been two elections, one administered by the Welsh Assembly Government, one by the General Teaching Council for Wales, and two rounds of appointments.

# 2005 Consultation on the composition of the Council

5. In the light of the experience gained to date and following an evaluation that was undertaken by the Council of the 2004 elections in July 2005, the Welsh Assembly Government consulted widely on proposed amendments to the regulations that govern the arrangements by which members of the General Teaching Council for Wales are elected and appointed. Our overall aim was to bring some clarity to the various voting categories as set out in legislation.

- 6. The 2005 consultation sought views on the Assembly Government's plans to:
  - amend the existing election categories to include Assistant
     Headteachers; to ensure that at least one of the elected candidates in
     the Head/Deputy Head and Assistant Head category is from the primary
     sector and one from the secondary sector;
  - amend the existing election categories for teachers of pupils to avoid confusion;
  - clarify who may stand as a candidate for election;
  - remove the requirement for the Minister for Education, Lifelong Learning and Skills to approve the Council's election scheme.
- 7. From the comments we received we clearly had support to develop regulations based on the plans outlined. A summary of the responses has been published on the Assembly's web-site http://new.wales.gov.uk/topics/educationandskills/education\_and\_skills\_consult atio/42571641111?lang=en
- 8. Three additional issues, however, were also raised about the composition of the Council that were not included in the consultation and these are:
  - the need to clarify the position of elected and directly appointed members;
  - a call for all teacher unions in Wales to be given a guaranteed place on the Council;
  - a request that consideration be given to providing representation based on the linguistic nature of the education system in Wales.
- 9. Given the significance of these issues, and after careful consideration, it was decided to put the proposed regulations on hold and to undertake a full and thorough consultation on the additional issues. In order for us to be in a position to do this we asked 13 members of the Council, whose term of appointment was due to end in August 2006, to serve for a further year. Without exception they all agreed, and we are grateful to them for doing this.
- 10. Our intention is to introduce one set of new regulations to come into force in March 2007 that will reflect the outcome of both the 2005 consultation and this current consultation on the additional issues.

# Section 2: Additional issues

11. As previously mentioned, there were three issues that fell outside the scope of the 2005 consultation on which we would welcome further views.

### Issue 1

- 12. Two organisations, the General Teaching Council for Wales and the National Association for Head Teachers (NAHT) asked if we could clarify the position of elected and directly appointed members.
- 13. As the regulations currently stand only nominated members appointed by the Assembly (ie those in category 2 see para 2) are required to "act as individual members and not as representatives of the organisations which nominated them". The Council finds this requirement very helpful in clarifying the capacity in which members approach the Council table and Council business in general, but feel that this could be extended so that it applies to all members of the Council i.e. those elected (category 1), those appointed from nomination (category 2) and those directly appointed (category 3). This, they say, would reflect and strengthen the Council's own 'Code of Conduct and Best Practice for Members' which already says that 'members observe the relevant Regulations which govern their membership of the Council and act as individuals in their own right and not as representatives of any organisations to which they may be belong.'
- 14. From the outset, it was expected that the General Teaching Council for Wales would be an independent organisation which was objective and able to speak with a distinct voice free of vested interest. This still remains our view.
- Q1. Do you agree that the current requirement that applies only to nominated members which requires them to "act as individual members and not as representatives of the organisations which nominated them" should be extended to cover all members of the Council?

# Issue 2

- 15. The National Union for Teachers (NUT) and National Association for Schoolmasters Union of Women Teachers (NASUWT) called for all teacher unions in Wales to be given a guaranteed place on the Council.
- 16. Both of these teaching unions have suggested that teachers would be better served if teacher unions in Wales were given a guaranteed place on the Council as is the case with the General Teaching Council for England. The NUT argue that at present, union representatives could be drawn from the minority unions only, despite the fact that the NUT represents 50% of teachers in Wales.

- 17. The General Teaching Council for Wales currently has 25 members -
  - Category 1 twelve are teachers elected by their fellow professionals;
  - Category 2 nine are appointed by the Assembly Minister for Education,
    Lifelong Learning and Skills from nominations made from a list of
    organisations with interests in the education field (including 4 members
    from nominations from the 8 teacher unions who must be teachers); All
    nominees are invited to interview and decisions on appointments are
    made on the basis of fair and open competition and in line with the
    Assembly Code of Practice on Public Appointments.
  - Category 3 four members are appointed directly by the Assembly
     Minister for Education, Lifelong Learning and Skills. Again applicants are
     invited to interview and decisions on appointments are made on the
     basis of fair and open competition.

The changes proposed, therefore, by the NUT and NASUWT only apply to those members in Category 2.

- 18. Since its establishment in September 2000, the Council has worked well as an organisation and the composition outlined above has ensured that the Council has a broad range of expertise among its members; has not been unwieldy and has been effective in its decision making. It has also ensured that consideration has been given to the geographic, linguistic and gender balance of the Council.
- 19. The Council represents a broad spectrum of interests across the education field which allows it to act independently from any one cause or interest group. Its wide variety of membership which reflects both the teaching profession and the public interest through its lay members has been a key factor in the success of the Council in terms of its regulatory, advisory and operational functions.
- 20. We believe that a key strength of the Council's current composition is that in addition to ensuring that there is a majority of teacher members on the Council (the Welsh General Teaching Council currently has the highest percentage of teacher members compared to its overall membership of all the UK Teaching Councils), it also provides for an outward looking professional body with a diverse range of members from the education service and other walks of life. Moreover, we have never been led to believe that the current operating constitution has caused any difficulties and is in need of modification. We would, however, welcome your views. In doing so we would ask you to bear in mind the following points.
- 21. Currently there are 8 teacher unions listed in Part 1 of Schedule of the General Teaching Council for Wales (Constitution) (Amendment) Regulations 2003). Giving guaranteed seats to the each of these unions would increase the size of the Council from 25 to 29 members. At present four members are selected by the Assembly Government from nominations made by each of the eight teaching unions. This mechanism ensures that these appointments are made on merit in accordance with the Assembly's Code of Practice on Public Appointments.

- 22. Agreeing to the NUT/NASUWT's proposal would ensure that all teaching unions have a seat on the Council at all times, which is not the case under the present system. For example, in the Council's first term the NUT was not represented, and currently the NASUWT does not have a seat on the Council.
- 23. An increase in the number of Council members would mean additional costs for the Council and it is possible, therefore, that this could mean an increase in the fee paid by teachers.
- 24. Giving every teaching union a place on the Council could also affect the balance of the Council and result in there being less influence from other organisations with an interest in education. The current system works by limiting the size of the Council and maintaining a balance of two thirds from within the teaching profession and one third lay membership. Your views are invited.
- Q2. Do you feel that all the teacher unions in Wales should be given a guaranteed place on the Council?
- Q3. Would this better serve the teaching profession?
- Q4. Do you think the status quo should be maintained?

# Other options

- 25. If you support Q2. we would welcome your views on how this can be achieved. There are a number of options.
- 26. At present, in category 2 of the membership, the Assembly Government appoints nine members from nominations made by organisations with an interest in education including teaching unions. Four of these are union nominees, from Part 1 of the Schedule to the Regulations, and five are nominees made by interested bodies in the education sector from Part 2 of the Schedule to the Regulations. All appointments are made on merit and in accordance with the Assembly Code on Public Appointments.

A number of possible options are presented below for your consideration.

# **Option A**

- 27. One place on the Council could be allocated to each teacher union listed in Part 1 of the Schedule to the Regulations. This would mean either increasing the size of the Council from 25 to 29 members, or reducing the number of members that are selected from Part 2 of the Schedule (nominated by interested bodies) from 5 to 1. We welcome your views.
- Q5. Do you think the size of the Council should be increased to include a member from each of the unions currently listed in Part 1 of the Schedule to the Regulations?

- Q6. Do you think the list of organisations in Part 1 of the Schedule to the Regulations accurately reflects the teaching unions in Wales? If not, who do you suggest should be listed?
- Q7. Do you think that the number of nominated places for interested bodies should be reduced so that we can give automatic places to the teaching unions?

# **Option B**

- 28. Rather than give automatic places to all the teacher unions, which could increase the size of the Council, we could give automatic places to the two largest teaching unions (in terms of the number of teachers represented) i.e. the NUT and NASUWT and determine the other two union members as now, following nomination and interview.
- 29. This would satisfy the requests that have been made by the NUT and NASUWT and ensure that there continued to be a majority of teachers on the Council. It would, however, lessen the opportunities for the smaller unions (in terms of the number of teachers they represent) to play a part.
- Q8. Do you think there would be any benefit to be achieved in giving automatic places to the two largest teaching unions, and selecting the other two union places by interview following nomination?

# **Option C**

- 30. We could merge Part 1 and 2 of the Schedule to the Regulations. This would mean that there would be one list of nominating bodies from which the Assembly Government could select nine members to the Council. This would, however, also mean that there would be no limit on the number of appointments being made from nominations submitted by the teaching unions. As the appointments are, however, made on the basis of a successful interview, there would be no automatic places for union nominees and, if less than the current four nominees were successful, this would affect the balance of teacher representation on the Council (currently there is a requirement that nominees put forward by the teaching unions in Part 1 of the Schedule to the Regulations are teachers. These together with the elected teacher members (Category 1) ensures there is always a majority of teacher members on the Council).
- Q9. Do you think it would be helpful to merge Part 1 and Part 2 of the Schedule to the 1999 Regulations, as amended, so that there is one list from which the Assembly Government could select nine members?

# **Option D**

31. We could amend the Regulations so that the unions listed in Part 1 of the Schedule determine between themselves who should fill the four places on the Council reserved for union members. An extension of this idea may be to allocate union places on the Council on a rotational basis so that all unions were represented over a period of time.

- 32. This would give autonomy to the unions who would need to set up an appropriate mechanism for the selection process ensuring openness and transparency within the selection system.
- Q10. Do you think there is merit in the decision making process being handed to the unions themselves or should the Assembly Government continue to make these appointments on the basis of nominations made?
- Q11. If the unions were to decide the appointments, do you think that places should be determined on a rotational basis?

#### Issue 3

- 33. The Welsh Language Board has asked if consideration could be given to providing representation based on the linguistic nature of the education system in Wales.
- 34. This is not an issue about the ability of members to speak Welsh, rather about them being representative of the Welsh-Medium education sector. The appointments made by the Assembly Government both directly and from nominations ensure that the linguistic balance of the Council is adequate and in fact, at present, 8 out of 25 Council members speak Welsh. There is, however, no specific representation from the Welsh-medium education sector. The Welsh Medium education sector does not have a specific opportunity to nominate a member for appointment to the Council.
- 35. While there is not a specific election category for teachers in the Welsh medium sector, there is nothing to preclude teachers from this sector from seeking election under any of the categories. Alternatively it is open to any person to apply for one of the appointments made directly by the Assembly Government.
- 36. We could address the Welsh Language Board's concern by amending the Regulations to include a representative body from the Welsh Medium Sector in Part 2 of the Schedule to the Regulations so that they can nominate a person who will be considered for appointment. We welcome your views.
- Q12. Do you think the existing opportunities are adequate for the Welsh medium sector to be represented on the Council, and that the Regulations should remain as they are?
- Q13. Do you think there would be benefit in adding a body which is representative of the Welsh -medium Sector to the list of bodies able to nominate candidates for appointment? If yes, can you make a suggestion as to which body this should be?

# **REGULATORY APPRAISAL**

# **EDUCATION, WALES**

# THE GENERAL TEACHING COUNCIL FOR WALES (CONSTITUTION) (AMENDMENT) REGULATIONS 2007

# Purpose and intended effect of the Regulations

- 1. The Regulations will amend the General Teaching Council for Wales (Constitution) (Amendment) Regulations 1999, as amended, which govern the arrangements by which members of the Council are elected and appointed. The exact wording of the amending Regulations has yet to be decided and will be subject to views expressed in the consultation.
- 2. A consultation previously took place in July 2005. This suggested minor amendments to the regulations in the light of experiences of running two elections and two rounds of appointments to the GTCW, the aim being to introduce the regulations in March 2006. The consultation ended on 14 October 2005 and from the comments received we clearly had the support to amend the regulations in the way we had proposed.
- 3. Three issues, however, were raised about the composition of the Council that had not been included in the consultation, and it was decided to put the amending regulations on hold that so that we could undertake a full and thorough consultation on the additional issues.
- 4. The new regulations which we will be introducing, to come into force in March 2007, will reflect the outcome of the current consultation on the additional issues, as well as making the following amendments for which we had support in the 2005 consultation:
  - to amend the existing election categories to include Assistant
     Headteachers; to ensure that at least one of the elected candidates in
     the Head/Deputy Head and Assistant Head category is from the primary
     sector and one from the secondary sector;
  - to amend the existing election categories for teachers of senior pupils and teachers of junior pupils to avoid confusion;
  - to clarify who may stand as a candidate for election;
  - to remove the requirement for the Minister to approve the GTCW election scheme.

- 5. The three additional issues that have been raised for consideration, are:
  - (i) the need to clarify the position of elected and directly appointed members;
  - (ii) a call for all teacher unions in Wales to be given a guaranteed place on the Council;
  - (iii) a request that consideration be given to providing representation based on the linguistic nature of the education system in Wales.

#### **Risk Assessment**

6. If the amendments to the Regulations are not put in place then there could be confusion when the next appointments/elections arise. Having identified possible areas of confusion it is only proper to take the opportunity to aid understanding. To do otherwise could adversely affect the future elections/appointments to the Council. This would result in the GTCW being unable to operate which would impact negatively on all the GTCW's functions including the statutory registration of teachers, teacher disciplinary procedures and the administration of the individually focussed Continuing Professional Development programme for teachers.

We could also continue to be pressed by the teacher unions and other bodies in Wales, that the issues they have raised about the composition of the GTCW have not been considered by the Assembly Government.

# **Options**

7. There are two options:

# (a) Do nothing

If we do not make the amendments proposed in 2005 (listed in paragraph 4) there is likely to be confusion during the next GTCW elections in 2008. There is also the possibility that the list of nominating bodies will not be accurate, which could result in a reduced pool of candidates from which to select the Assembly appointed Council members in 2007. If the additional amendments (listed in paragraph 5) are not made, this would not adversely affect the appointments/elections process, which could continue as now.

# (b) Make the Legislation

If we make these amendments we ensure that:

- the next round of Assembly appointments in 2006 is carried out on the basis of an accurate and up to date list of nominating bodies and that all appointments are made from the largest pool of candidates possible;
- some types of teacher, previously under-represented on the Council (e.g. assistant head teacher and head teacher/deputy head teacher in the

- senior pupils category) are no longer disadvantaged;
- the titles of the election categories are clear so as to avoid confusion in the GTCW elections in 2008:
- the criteria to stand as a candidate for election is clear;
- burdens upon the Council, in terms of having to seek the Assembly's approval to the election scheme, are removed in line with the Council's growing independent status;
- we will be sure that the composition of the Council has the support of all the teaching unions and interested bodies.

#### Costs

8. There are no financial implications for the Assembly. Any changes to guidance as a result of these amendments will be met from within existing budgets. If the size of the Council is increased there would be small additional costs in terms expenses paid to members. If these could not be borne within the Council's existing budget, there is a slight possibility that there would need to be an increase in the fee charged to teachers.

# Consultation

9. We intend to consult electronically for a thirteen week period from 26 June. All bodies listed in Schedule 1 to the Regulations plus other interested bodies will be consulted together. The views expressed in the consultation will be taken into account in drafting the amending Regulations.

# **Enforcement, Monitoring and Review**

10. The Assembly Government holds regular meetings with the GTCW to discuss a wide variety of issues impacting on the Council including its statutory obligations. This will continue if the proposals are implemented.

### **Summary**

11. The proposed Regulations will ensure that the Assembly appointment exercise in 2007 and the GTCW elections in 2008, run as smoothly as possible.
