Introduction

- 1 The Learning and Skills Council (LSC) published its Annual Statement of Priorities on 19 October 2006. The document sets out the LSC's priorities, including key actions for 2007/08. The document discusses each priority and explains these within the context of government policy.
- 2 The Annual Statement of Priorities refers to more information being published in a January 2007 document.
- 3 This document provides more detail of the funding rate arrangements for provision delivered in 2007/08 in school sixth forms, further education (FE), work-based learning, Train to Gain and through the European Social Fund (ESF). The document covers funding rates, but not the funding allocations process or operational guidance on the mix and balance of provision, which are being published separately.
- 4 This document is primarily focused on 2007/08, with some early notification of intended specific significant changes for 2008/09. The LSC is consulting separately on the wider arrangements for funding in 2008/09 and beyond, including a new consistent funding methodology across sectors.

School Sixth Forms

5 The funding arrangements for school sixth forms are set out in *School Sixth Forms – Funding Guidance for 2006/07 and 2007/08*.

General increase in funding rates

The funding rates for each qualification will be increased by the minimum funding guarantee (MFG) of 3.7 per cent in 2007/08 that was announced by the Secretary of State for Education and Skills (the Secretary of State) on 6 December 2005.

Early notification of rate changes 2008/09

- 7 The LSC wants to ensure stability and avoid destabilisation of providers wherever possible. Hence significant changes to funding rates should give providers as much notice as possible so that appropriate steps can be taken to ensure financial stability.
- 8 Two such significant rate changes have been considered by the LSC in its annual review of funding rates:
 - AS- and A2-level General Studies. General Studies is currently funded at half the rate of other AS/A2-level qualifications. Analysis has shown that delivery of General Studies is on average significantly below the level of funding afforded to it. The funding rate for AS/A2-level General Studies will therefore be reduced to the equivalent of 30–39 guided learning hours (glh) in 2008/09, subject to the LSC's 2008 review of funding rates.
 - b Level 3 GNVQ successors, specifically Edexcel National Diplomas, National Certificates and National Awards and OCR Extended National Diplomas, National Diplomas and National Certificates. The delivery of these qualifications is consistent with the awarding bodies'

- recommended glh rather than the current funding rates which are significantly higher for historical reasons. Owing to the significance of these qualifications, the LSC will not implement any changes in 2007/08, but will conduct further research on the costs of delivering these qualifications with a view to revising the rates in line with the awarding body recommended glh in 2008/09, which would mean significant reductions in rates, subject to the results of the research. Any changes to these rates in 2008/09 will be kept within the transition arrangements to ensure stability of funding.
- On 30 November 2006, the Prime Minister and Secretary of State announced that schools and colleges will offer more choices to young people over what they study post-16 by providing greater access to the International Baccalaureate (IB) for those who want it. Funding was committed to ensure that there is at least one institution in every local authority where there is currently no provision. This will mean that up to 100 additional institutions will offer the IB by 2010. The LSC already funds the IB in colleges and schools and will continue to do so in 2007/08. The current rate for the IB is set at the equivalent of 4.5 A-levels and will remain at this level for 2007/08. In addition, the funding of the IB will be reviewed in 2007 in order to inform the 2008/09 rate.

Further Education (for LSC FE-funded Providers

General increase in funding rates

- 10 Funding rates of learning aims studied by young people aged 16 to 18 and funded using the FE funding methodology will be increased by the MFG of 3.7 per cent in 2007/08.
- 11 Funding rates of learning aims studied by adults aged 19 and over will be increased by 2.5 per cent in 2007/08.
- 12 The definition of '16 to 18' for funding purposes will continue to be based on when the learners start their programmes this is same as for the current arrangements for fee remission and entitlement as set out in paragraph 35 of Funding Guidance for Further Education in 2006/07. For instance, learners who are aged 19 when they start the second year of their programmes are considered as 16 to 18 for funding purposes and the funding rates for these learners will be increased by the MFG.
- 13 The lower adult rates will continue to be quoted in the 2007/08 funding guidance and in the Learning Aims Database. A multiplier in the Learner Information Suite software will be used to calculate the correct level of funding for each age group. For 2007/08, that multiplier will be:

$$\frac{1.034 \times 1.037}{1.025 \times 1.025} = 1.02059$$

This reflects the minimum funding guarantees of 3.4 per cent in 2006/07 and 3.7 per cent in 2007/08. These are in comparison to the 2.5 per cent increase in the adult base rates in both years.

Tuition fees

14 The tuition fee element of learning aims will be increased in 2007/08 to 37.5 per cent, as set out in the LSC's Annual Statement of Priorities.

Funding rates for individual learning aims

- 15 The funding rates for all learning aims have been considered by the technical sub-group of the LSC's planning, funding and quality group. The group examined data extracted from the Individualised Learner Records (ILR) (F04) in 2005/06 and has recommended changes to the listed rates for 75 learning aims that are already listed. A further 24 aims that are currently loadbanded should become listed. A final 11 aims are currently listed but have glh data in 2005/06 that is inconsistent, and some changes have been made to their listed rates.
- 16 Two significant changes were identified, one of which will be addressed in 2007/08 and the other in 2008/09:
 - a Level 3 GNVQ successors, specifically Edexcel National Diplomas, National Certificates and National Awards and OCR Extended National Diplomas, National Diplomas and National Certificates. The delivery of these qualifications is consistent with the awarding bodies' recommended glh rather than the current funding rates which are significantly higher for historical reasons. Owing to the significance of these qualifications, the LSC will not implement any changes in 2007/08, but will conduct further research on the costs of delivering these qualifications with a view to revising the rates in line with the awarding body recommended glh in 2008/09, which would mean significant reductions in rates, subject to the results of the research. Any changes to these rates in 2008/09 will be kept within the transition arrangements

- to ensure stability of funding. Charts of the distribution of glh across the whole FE sector for each of these qualifications are at Annex C.
- b AS- and A2-level General Studies is delivered in substantially fewer glh than the national rate would imply. Changes to the funding rates for these qualifications have not been introduced in 2007/08. However, subject to the LSC's 2008 review, the rates will be reduced to the equivalent of 30–39 glh, in line with their delivery.
- 17 AS- and A2-level Critical Thinking has also been considered, and will be revisited as part of the LSC's 2008 review of funding rates. AS-level Critical Thinking is currently delivered in approximately half the glh of other AS/A2-level qualifications.
- 18 On 30 November 2006, the Prime Minister and Secretary of State announced that schools and colleges will offer more choices to young people over what they study post-16 by providing greater access to the International Baccalaureate (IB) for those who want it. Funding was committed to ensure that there is at least one institution in every local authority where there is currently no provision. This will mean that up to 100 additional institutions will offer the IB by 2010. The LSC already funds the IB in colleges and schools and will continue to do so in 2007/08. The current rate for the IB is set at the equivalent of 4.5 A-levels and will remain at this level for 2007/08. In addition, the funding of the IB will be reviewed in 2007 in order to inform the 2008/09 rate.
- 19 The review of the Diploma in Foundation Studies (Art and Design) has now been completed. The reduction applied in 2006/07 will stand, but no further reduction is applied to the funding rate in 2007/08.
- 20 Details of all the changes will appear on the LSC's website (www.lsc.gov.uk), and later will be published within the Learning Aims Database.

NVQs

21 The criteria for determining the appropriate funding rate for National Vocational Qualifications (NVQs) have been amended. This is not expected to alter radically the rate applicable to a particular learner; however, it does align the funding policy more directly with the cost basis. Table 1 should be used for determining the delivery method of NVQs from 2007/08 onwards.

Skills for Life

- 22 From 2007/08, at Level 1 and Level 2, the only learning aims that will be eligible for funding as basic skills provision, and funded at the enhanced programme weighting of 1.4, will be the nationally approved Certificates in Adult Literacy, Numeracy and English for Speakers of Other Languages (ESOL) Skills for Life.
- 23 Non-approved basic skills learning aims at Levels 1 and 2 will no longer be eligible for funding as basic skills. In line with our policy on the mix and balance of provision, we expect providers to convert their non-approved provision at these levels to approved qualifications. Although existing non-approved aims at Levels 1 and 2 will be eligible for funding (as other adult provision) at programme weighting A (1.0), we do not expect to give priority to this non-approved provision as it will no longer be part of the Skills for Life offer. Nor will such provision attract automatic fee remission.
- 24 There are no changes to funding arrangements for Entry and Pre-entry Skills for Life provision in literacy or numeracy. At Entry Level, both nationally approved and non-approved aims (where these are based on the National Standards for Adult Literacy and Numeracy) will continue to be funded as basic skills, although we expect providers to continue to offer more approved qualifications at this level. At Pre-entry, provision based on the Skills for Life Pre-entry Curriculum Framework will continue to be eligible for funding as previously.

- 25 ESOL provision will no longer attract automatic fee remission at any level, whether approved or not. However, approved ESOL Skills for Life qualifications at all levels (that is, Entry, Level 1 and Level 2) and non-approved Pre-entry and Entry Level ESOL Skills for Life provision will continue to attract the 1.4 weighting.
- 26 As signalled in our Annual Statement of Priorities, new qualifications are being developed in ESOL to support a shorter, more job-focused, practical approach to English language skills. These new ESOL for work qualifications will be eligible for funding at programme weighting A (1.0), with a listed rate to be announced once the development of the new qualifications has been finalised.
- 27 The race impact process conducted jointly by the LSC and the DfES is due to conclude shortly. Changes to ESOL policy are not expected; however, some minor adjustments may be made as a result.
- 28 The funding arrangements for key skills qualifications in Communications and Application of Number at Levels 1 and 2, and GCSEs in Maths and English are not affected by the above changes.
- 29 Tables 2 and 3 provide a summary of the impact of the above changes on funding rates and eligibility.

30 Disadvantage uplift will continue to be based on provision funded at a 1.4 weighting. Hence all approved literacy, numeracy and ESOL Skills for Life qualifications and Pre-entry or Entry Level non-approved learning aims would count as basic skills for the purposes of claiming disadvantage uplift.

Distance learning

- 31 The LSC's annual review of glh revealed that there is a significant number of learning aims being delivered by distance learning where the level of funding claimed is well in excess of the listed rate.
- 32 Paragraph 525 of Funding Guidance for Further Education in 2006/07 states that 'It is expected that the funding rates for delivery by distributed and electronic learning will be close to the funding rates for delivery by traditional modes'.

- 33 For these reasons, from 2007/08 the funding rates claimed for qualifications with listed rates that are delivered by distance learning should be the listed rate.
- 34 Providers should no longer claim other than the listed rate on the basis of awarding body recommended glh or weighted average glh data.
- 35 In exceptional circumstances, where the costs incurred significantly exceed the listed rate, the provider may submit a proposal to its regional LSC for a higher rate to be applied. This proposal must include the data collections and costs pro forma, along with an explanation of why the costs exceed those associated with delivery of the same qualification by a traditional mode.
- 36 The local or regional LSC will want to satisfy itself that the provision in question represents value for money, and may refer cases as it sees fit to the funding policy implementation team at the LSC National Office.

Entitlement to fee remission for a first full Level 3 for those aged 19 to 25

- 37 The White Paper Further Education: Raising Skills, Improving Life Chances (March 2006) made a commitment to a new entitlement for a first full Level 3 qualification for those aged 19 to 25, supported by an expanded Adult Learning Grant (ALG), new funding for both of which was announced in the Budget on 23 March 2006. The new 19–25 entitlement and national roll-out of ALG will both be implemented from 2007/08, creating a new, integrated package of support for young adults continuing their initial education to Level 3.
- 38 As indicated in our Annual Statement of Priorities *Raising Our Game*, we expect that the entitlement will benefit some 45,000 learners in 2007/08, enabling more young adults to achieve higher-level technical and professional qualifications.
- 39 The details of the arrangements for meeting the terms of the first full Level 3 entitlement for those aged 19 to 25 can be found at Annex D, and will be included in *Funding Guidance for Further Education in 2007/08*.

Funding Rates - Changes for 2007/08

Employer-related Provision

Apprenticeships

General increase in funding rates

- 40 Funding rates of learning aims studied by young people undertaking Apprenticeships aged 16 to 18 will be increased for inflation by 2.5 per cent in 2007/08.
- 41 The expected employer contribution for adults aged 19 and over will be formalised to reflect the projected trajectory towards 50 per cent in 2007/08. See below for more detail.

Expected employer contribution

42 The LSC has been in discussion with the Association of Learning Providers (ALP) and has agreed a method for moving the expected employer contribution towards 50 per cent for NVQs and Technical Certificates in worked-based learning (WBL) by 2010. Based on the difference between the 16–18 and 19+ rate in 2006/07, the expected employer contribution will increase or decrease to the nearest anticipated step along the projected trajectory towards 50 per cent for both WBL and FE (see Table 4).

- 43 If the expected employer contribution is greater than 37.5 per cent once it has been adjusted, it will not be increased until the expected trajectory exceeds it.
- 44 Key skills are unaffected by this change for consistency as they are largely Skills for Life qualifications which attract fee remission in FE. The 16–18 rate for key skills will increase for inflation by 2.5 per cent and the 19+ rate will remain unchanged in 2007/08.

Apprenticeships Rates Review

45 The Apprenticeship Rates Review has been in progress for three years. It was commissioned in part to address concerns from the DfES that elements of an Apprenticeship were being double-funded. The introduction of Technical Certificates led to suggestions that there was overlap in some frameworks between them and the NVQ. There were also concerns about overlap between NVQ Level 2 and NVQ Level 3 in some frameworks. The review was intended to investigate these issues and identify the costs of delivering frameworks in all sector areas.

- 46 The LSC has consulted extensively on the WBL rates for 2007/08 with members of both the ALP and Association of Colleges (AoC) and representatives from Sector Skills Councils (SSCs). The rate changes include changes to NVQ and Technical Certificate rates. The changes have been approved by two external advisory groups, including representatives from providers, SSCs, ALP and AoC.
- 47 The review has based its recommendations on evidence from successful providers and sector specialists and has specifically designed out any overlap between elements of the Apprenticeship programme. The key findings of the review have been implemented as follows.
 - The activity costs of an Apprenticeship have been compared with current funding rates, with recommendations for both increases and decreases in funding rates.
 - The activity costs of an Advanced Apprenticeship where a learner has completed an Apprenticeship have been addressed, with recommendations for reductions in funding rates.
 - The impact on the activity costs of NVQ delivery where part of the underpinning knowledge and skills is delivered through a funded Technical Certificate has been assessed. Adjustments to remove overlap from the NVQ rate have been made where necessary.
- 48 A summary of the NVQ rate changes and funding issues can be found in Annex B. The tables are arranged according to the phase of the project in which the frameworks were reviewed.
 - Phase1 covered the 10 largest frameworks and the first year of changes was implemented in 2006/07 (Tables B1 and B2).
 - Phase 2 covers all the remaining frameworks with over 1,000 learners and the first year of implementation will be 2007/08 (Tables B3 and B4).
 - Phases 3 and 4 cover the remaining frameworks with over 100 learners and the first year of implementation will be 2007/08 (Tables B5 and B6).

Entry to Employment

General increase in funding rates

49 The funding rates for Entry to Employment will be increased by 2.5 per cent in 2007/08.

Train to Gain

General increase in funding rates

- 50 The funding rates for Train to Gain will be increased by 2.5 per cent in 2007/08.
- 51 Further work is being considered on the 2007/08 rates for Train to Gain, which will be published in due course.

European Social Fund

- 52 There will be a new programme of ESF funding (2007–13) that we expect to start tendering for in September 2007 for delivery from January 2008. This new programme will continue to be co-financed in a similar way to the previous programme.
- 53 Further details of the arrangements will be published in *Funding Guidance for Further Education in 2007/08*.



Figure C2: 12 unit Level 3 GNVQ successor: Average glh 2005/06.





Figure C3: 6 unit Level 3 GNVQ successor: Average glh 2005/06.

First Full Level 3 Entitlement for Those Aged 19 to 25

1 This annex details the arrangements for implementing the first full Level 3 entitlement for those aged 19 to 25 studying through the FE funding route. There are separate arrangements for funding Advanced Apprenticeships; these will continue to be free to the young person, though the employer will be expected to contribute to costs, as at present.

Background

- 2 In many other countries, more young adults achieve Level 2 and 3 qualifications between the ages of 19 and 25. In this country, by contrast, there is at present a sharp divide at the age of 19. The proportion of young people in the UK staying on in education post-16 is low: the UK ranks 20th out of 29 developed nations. We lag well behind France and Germany in the proportion of our young adults achieving a Level 3 qualification in their early 20s. At present in Britain education is free up to 19 but not thereafter (except for certain priority groups, such as Skills for Life and basic employability skills provision). The UK therefore has fewer 19–25 year olds improving their qualifications than on the continent, where education in public colleges is free irrespective of age. Introducing free tuition for a first full Level 3 will help to address this problem and build on the existing entitlement to free tuition towards a first full Level 2 qualification for adults aged 19 and over.
- 3 Most 19 to 25 year olds are more likely than older learners to want to study full time and less likely to have an independent full-time source of income to cover the cost of fees. It is therefore also important that young adults seeking to progress towards

achieving a first full Level 3 are not penalised by the increase in fees to around 50 per cent by 2010.

Aims and objectives

- The entitlement is being introduced to encourage young adults, particularly those from disadvantaged backgrounds, to continue studying until they achieve a first full Level 3. This will increase the number of adults with a full Level 3 qualification, improving their life chances, social mobility and contribution to the economy through productive employment.
- 5 To support the introduction of the entitlement, Sector Skills Councils will identify in their Sector Qualification Strategies those Level 3 qualifications they consider to be most valuable. This will help learners to choose Level 3 qualifications that are economically beneficial.
- 6 The key aims of the entitlement are to:
 - provide free full Level 3 tuition for learners from age 19 up to age 25 across England
 - reduce the discontinuity within the funding arrangements that exist for young adults
 - provide seamless progression to a full Level 3 from age 14 through to age 25
 - create a new, integrated package of support for young adults continuing their initial education to Level 3
 - give young adults, particularly disadvantaged young people, an opportunity to prepare themselves for success in life through the education and training system.

- 7 The objectives of the entitlement are to:
 - increase the numbers of 19 to 25 year olds entering full Level 3 learning
 - increase the numbers of disadvantaged young adults entering full Level 3 learning
 - increase the number of young people progressing to higher-level learning after completing a full Level 3.

The entitlement

- The entitlement provides free tuition for adults aged 19 but under 25 to pursue their first full Level 3 qualification through either full-time or part-time provision. This entitlement, together with the Adult Learning Grant (ALG) package, will reduce the discontinuity within funding arrangements that currently exists for young adults. It recognises that many young people complete their initial education in their early 20s and provides for seamless transition from 14 through to 25.
- 9 It is worth noting that an eligible adult learner who is over 25, who does not already have a full Level 2 qualification and who commits to a full Level 3 course would qualify for the entitlement to free tuition through the Level 2 entitlement. Should a learner who is under 25, and who has not already achieved a full Level 2, be commencing a full Level 3 programme, then they will do so under this entitlement, not the Level 2 entitlement.
- 10 This entitlement does not guarantee the availability of a learning place in a chosen subject at any one further education college or provider, but it is a general exclusion from paying tuition fees. The entitlement protects young adults seeking to achieve their first full Level 3 qualification from the increase in fees to 50 per cent by 2010 that they would otherwise have to pay.
- 11 The LSC is currently arranging trials of another White Paper commitment Learner Accounts which will provide an incentive to achieve a full Level 3 qualification; in 2007/08 eligible learners in trial areas may access their Level 3 entitlement through a Learner Account.

Eligibility

- 12 The entitlement applies to learners who:
 - are aged 19 but not yet 25 when they start the learning programme and
 - meet the standard LSC eligibility criteria, which can be found at the link below and
 - have not yet achieved a full Level 3 qualification (for clarity it is not necessary to have already achieved a full Level 2) and
 - are assessed by the college/provider as having the ability and aptitude to complete a full Level 3 programme or
 - meet the criteria above and are part way through a qualifying qualification and are commencing a new phase of the qualification for which they would have to pay fees in autumn 2007.
- 13 LSC Funding Policy internet site: www.lsc.gov.uk/Providers/funding-policy

Eligible qualifications

- 14 To be eligible for the entitlement, an eligible learner must be working towards one of the following qualifications identified as eligible for funding by the LSC on the LSC's Learning Aims Database (LAD):
 - a full Level 3 qualification, that is a qualification equivalent in size and breadth to two GCE A-levels or an NVQ at Level 3;
 - a Level 3 qualification that, if achieved, would mean the learner has reached the full Level 3 threshold
 - a Level 3 qualification that forms part of a full Level 3 qualification programme and would contribute to the achievement of a full Level 3
 - a full Level 3 qualification studied as part of the second phase Qualification and Credit Framework trials which meets the agreed Level 3 design principles.
- 15 Level 3 qualifications that do not directly contribute to the achievement of a first full Level 3 are specifically excluded from the entitlement. To enhance the contribution further education makes to productivity and the economy, sector skills

councils will identify the qualifications employers judge will enhance productivity best, so that learners can be advised accordingly. Increasingly, only these qualifications will be funded by the LSC and therefore the entitlement will progressively only cover these qualifications.

- 16 The following are examples of qualifications of full Level 3 status:
 - NVQs at Level 3
 - two or more A-levels, including vocational A-levels
 - one or more A-level double awards
 - Access to HE certificate (regulated by QAA)
 - OCR National Diplomas and Extended National Diplomas
 - Edexcel National Certificates and National Diplomas
 - International Baccalaureate
- 17 It should be noted that four AS-level qualifications are not regarded as equivalent to a full Level 3 and that AS-level qualifications are eligible within the entitlement only where they form steps towards the achievement of two or more A-levels. Should a learner be taking a qualification that is not a full Level 3, then they are to clearly indicate their intention to achieve a full Level 3 qualification; this could be done effectively through the self-declaration statement outlined in paragraph 19 below.
- 18 The LAD contains classifications to indicate full Level 3 qualifications and the contribution other qualifications make towards a full Level 3. These can be found on the 'shared' tab of the database in the 'Level 3 category' and 'Level 3 percentage' fields. The LAD can be accessed via the following link: http://providers.lsc.gov.uk/lad/default.asp

Self-declaration

19 As there is currently no reliable electronic method of identifying a learner's eligibility for the Level 3 entitlement, the LSC requires that colleges or other providers obtain a self-declaration of eligibility. To avoid unnecessary bureaucracy, it is acceptable for providers to include the eligibility for the Level 3 entitlement as part of their normal enrolment documentation in line with the process used for

Level 2 entitlement. The declaration must clearly state that the learner has not already achieved a full Level 3. It must also confirm the learner's intention to complete a full Level 3 qualification. The provider is responsible for ensuring the learner understands the definition of a full Level 3. It is recommended that a checklist of the main full Level 3 qualifications is provided to prompt the learner and avoid misunderstandings. For guidance a sample declaration is:

'I confirm that all the information on this form is correct and I declare that I do not already have a full Level 3 or higher qualification. I confirm that I intend to continue my learning programme to achieve a full Level 3 qualification. I understand that if I have declared false information action may be taken to reclaim the tuition fees and any associated costs from me.'

Completing the ILR

20 The LSC is planning on utilising the prior attainment field on the ILR (L35) to validate the Level 3 entitlement together with field A14 (the reason for full or partial non-payment of tuition fees). This will ensure that only those learners entitled to a free first full Level 3 qualification attract fee remission. It is essential that these two fields are correctly completed for any learner being granted fee remission as part of this entitlement. It is not acceptable to enter 'not known' in field L35 when claiming the entitlement as it is a requirement that the learner's prior attainment is established and a declaration signed to be entitled to the fee remission.
